## Dudley police look at new hires, growth in 2020

DUDLEY – Dudley’s Police Chief has big plans for the department in 2020, with the goal of hiring at least one new position, if not more, to help bolster the police force and lead to the eventual promotion of two higher level officers.

During a meeting on Dec. 16, Police Chief Steve Wojnar said his hope is to hire at least one new officer in 2020 that will set the stage for the department to promote officers to a pair of positions currently not on the books but are sorely needed to keep the force operating effectively and in the best interest of the town.

“We have funding in the budget right now so it should not require any additional funding. I also have some internal grant sources and things to hire a position,” Chief Wojnar told selectmen. “What we’re looking at doing, especially over the next couple years, is hiring an officer and then appoint someone as a detective and then I’d like to go up the line, another year or so, hire another officer and appoint someone as a lieutenant to get that process rolling.”

After 17 years as police chief, Wojnar has seen the force shrink from 16 officers, including himself, to as few as 11 and eventually rebuild to the current 14 on staff. However, the department lacks a detective to be specifically designated for higher level investigations or a second in command to act in Wojnar’s absence. Looking at the current status of the force and the department’s budget,

Wojnar feels now is a perfect time to set the groundwork for these promotions and build the force back up to where it was when he started.

“Hiring one person right now is within my budget for the existing year. I have some officers at step one salaries going forward into the coming year. That’s where there’s some cost savings. It’s an opportunity to do some hiring with the vacancies that were created by a couple of higher paid officers that left our service over the last few years combined with hiring newer people,” said the Chief. “The community has changed (since 2003) and it’s time for us to get back up to levels where we should be able to provide the service to the community. We’ve needed a detective position for a long time. We have a lot of activity we have to follow up on and it’s best to be able to focus a person on those tasks and get those jobs done while saving some overtime.”

The chief presented the information more for selectmen to digest and think over for upcoming discussions. Town Administrator Jonathan Ruda said he supported the chief’s endeavors but agreed that everyone needed to take some time to understand what this would cost and how it would be funded.

“Operationally, I absolutely support the request. It makes all the sense in the world that the police department have a deputy second-in-command. It makes all the sense in the world particularly based on some

## Dudley puts focus on security upgrades

DUDLEY – Security has become a big priority for the town of Dudley over the last year, whether it’s cyber security or increased awareness of what’s happening around town properties and buildings. In early 2020 a multi-phase initiative will kick off that will see Dudley take the next step in improving its security measures by upgrading and adding to its fleet of security cameras at town buildings and proper-

ties.

During a meeting on Dec. 16, Town Administrator Jonathan Ruda told selectmen that they can expect upgrades and additional installations for its security cameras to take place in the opening weeks of 2020 including five new cameras at the town municipal building, Dudley’s version of a town hall.

“I appreciate the help of the police chief to go around and do an audit of the cameras that work, need repair, need to be replaced or need to be repositions in the town hall,”

Ruda said. “This is Phase 1 of a multi-year project that will incorporate other town buildings into one central location.”

Ruda said this project will see upgrades to the network server, new areas receiving security cameras, and formatting all of these cameras to be visible at the regional dispatch center in Webster. The project caught the attention of selectmen who supported the idea but questioned the extent of the project. Selectman Paul Joseph said he wanted to make sure that the town beach was

included in the plans and, according to Ruda, the beach and plenty more are all in line to be monitored for unlawful activity in the near future.

“I actually have that scheduled for Phase 2,” said Ruda of the beach cameras. “I’m actually using maintenance funds, \$16,300, to get everything up to speed here at the town hall. It’s going to be additional spending for the next phase, but it will include the beach. It will include the highway department, the fuel pumps, the recycling center. We’re going to

incorporate the library. We’re going to add the exterior cameras from the fire department onto the server. It’s going to probably take us three years.”

Ruda noted that the first phase is actually the least expensive part of the project. Funding for the second phase was not discussed during the board’s meeting but Ruda did indicate that it’s possible Phase 2 could begin as early as spring 2020.

## Firefighters make quick work of car fire

DUDLEY – The Dudley Fire Department had their hands full on Thursday, Dec. 19, when they were charged with dousing a vehicle fire adjacent to a local business.

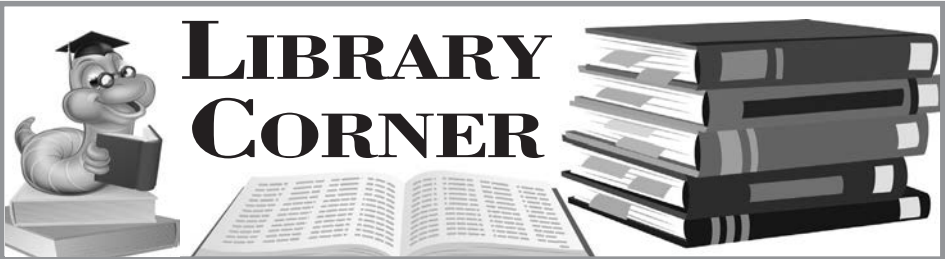
According to a release from the Dudley Fire Department the call came in at around 3:15 p.m. reporting a fire in close proximity to the Kwik Stop at 55 Schofield Ave. Firefighters reported seeing a large column of black smoke on their way to the scene and arrived to find a vehicle fully involved mere feet away from the Quick Mart building.

Dudley Fire Engine 3 arrived and began working on controlling the blaze.

A single handline was deployed, and water was quickly applied to the fire as firefighters worked to prevent the flames to impacting the nearby building. Fire officials reported that the fire was quickly brought under control and only minor cosmetic damage was reported to the Kwik Stop. However, the vehicle was a total loss. No injuries were reported following the blaze.

While initial reports from the Dudley Fire Department indicated that the cause was under investigation, subsequent reports have stated that a vape pen may have been the primary cause of the fire however fire officials have made it clear that the fire is still under investigation due to the extensive damage done to the vehicle.

# School district joins with Dudley to go green

DUDLEY/CHARLTON — The Dudley-Charlton Regional School Committee has decided to work with the town of Dudley as it has with the town of Charlton in joining the municipalities green communities filing efforts.

The school committee voted on Dec. 11 to add three Dudley Schools, Dudley Elementary School, Dudley Middle School and Mason Road Elementary

School, to the green communities filing in a move that will allow the district to benefit from grant funding through the town of Dudley.

“We did this in Charlton, I believe, two years ago,” said District Director of Finance and Operations Richard Mathieu. “At one of the meetings in January, we’ll bring forward the appropriate vehicle policy and anything else that might be needed for the School Committee to vote to make this formal and approved.”

On Dec. 16, the Dudley Board of Selectmen voted to approve the addition of the three schools indicating that this would allow the district to maintain its own green initiatives separate from the town but benefit from grant funding the town could obtain as a green community. However, the plan excludes Shepherd Hill Regional High School, the main high school for both Dudley and Charlton. Mathieu said this is due to a technicality but does not mean the high

school will be left out of the district’s goals to embrace cost effective green energy.

“This is one of those complex regional issues. The town of Dudley doesn’t own Shepherd Hill, nor does the town of Charlton. It’s the joint collaboration of the two. In speaking with people from Green Communities and Central Massachusetts Regional Planning, it seems like this is what a lot of regional schools do. The two towns kind of figure it out and take care of

their schools and then at some point in the future we’ll work with them on how to include Shepherd Hill as well where that’s appropriate,” said Mathieu.

The School Committee and town of Dudley are expected to further discuss this new partnership in early 2020. With this move both Dudley and Charlton are now in partnership with the school district to bring green energy initiatives to the area schools.

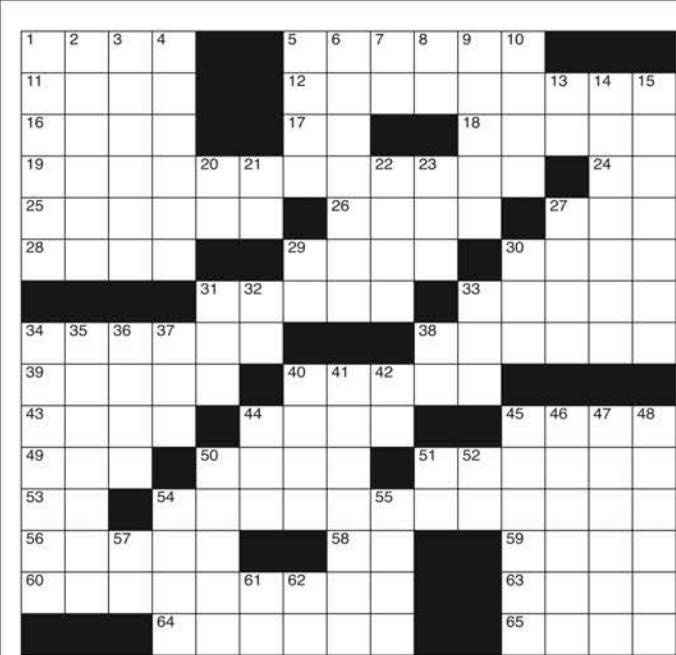

This thoughtful reader makes life easier (and safer) for those around her. Check out her two very different strategies to prevent injuries and viruses:

I have been doing this so long I don't think about it, but with the crew at the office from an adult training center (disability) I am always protecting them. The empty our kitchen co-mingled bins, where we often have soup cans and other canned goods that were consumed for lunches. I have employees only use the can-opener around the top, leaving about a half inch of lid connected to the can (don't cut off the whole top), then after rinsing they can tuck the sharp edged portion inside the can and smash the top together, protecting fingers from cuts.

Cans with pull-tops, we drop the whole lid inside the can and press the sides together at the top, keeping all sharp edges away from the cleaning crew.

Make those resolutions stick

Skating on thin ice

We are in a very dangerous time involving ice on local waters. Weather fluctuations cause some ponds to freeze, thaw, then re-freeze. A frequent question we as police

receive during the winter is, "Is the ice safe?" People want to use the ponds for activities such as skating, ice fishing, hockey, or other recreation. Before winter gets into full swing, I wanted to take a moment to remind people to exercise proper precautions when using the ice.

Certainly, the police will not declare any ice "safe" unless it is a controlled rink or another known location. Any time water is moving below ice, there is the possibility of thin spots and dangerous areas. This is even more critical at times when varying weather conditions are involved. Cold weather followed by warming can cause thawing and re-freezing. The ice can be thinner in some locations. It may appear to be thick; however, there is no true way to be certain.

It is especially important to exercise caution if you make the decision to venture out. Please avoid areas near open water or any places where you can see under the ice. You should stay near shore or in places where the water is not deep. This will allow you to make it back to shore easier and allow you to stand in the event you should fall through. Whenever children are involved, ice should always be checked by an adult. Children should always have supervision before using these areas. It is also critical to avoid using recreational vehicles of any kind. In addition to environmental concerns and risk of crashes, the mere weight of these vehicles contributes to the possibility of accidents.

It is important to use your best judgment when using the ice, especially at these times of changing weather. We have experienced some tragic events in the past and we hope to prevent future occurrences. Please exercise the necessary precautions and be safe.

This past week, I had a person contact me about a program they use to listen to the content of this column and a wide variety of news subjects from around the area. The person who reached out is visually impaired. They told me they review this column every Thursday afternoon through the Audio Journal (www.audiojournal.net). This is a broadcast network for visually-impaired residents living in Central Massachusetts. This service provides access to several area newspapers and other publications. I was unaware this column was available through this service. For those who struggle with these issues, this appears to be a great way to stay informed. I thank this person for sending me this information and I wanted to take a moment to pass it along to all of you.

On behalf of everyone at the Dudley Police Department, we hope you enjoyed Christmas and the holiday season. We wish you all the best for a Happy, Healthy, and Safe New Year.

# Be careful not to fish on thin ice



Ice fishing was enjoyed by many anglers Christmas week, but extreme caution needed to be practiced, as most ice thickness ranged between three and four inches, on most ponds. A good cold blast of two or three days is needed to insure safe ice on most lakes and ponds. The rain that was predicted for this past week-end, could stop all ice fishing in the valley. Numerous Rod & Gun clubs are planning ice fishing derbies as soon as the ice is four inches or better. This week's picture shows a huge Northern pike caught a few years ago by an angler that was ice fishing. Numerous anglers that enjoy fishing for

Northern Pike are constantly asking Mass. Fish & Wildlife to include a few local ponds in the valley to be included in the pike stocking program. Manchaug Pond did very well with pike stockings in the past, but MF&W still ignores the request of local anglers to stock pike in it. The state often trades trout for pike from states that have an abundance of them. Many pike were stocked in the Western & Northern part of the state, but it is a long drive for some of the older residents and some handicapped fishermen of the valley. Neighboring states like Rhode island and Connecticut have numerous bodies of water that sustain

Northern pike and are fished by many local anglers annually. Fishing licenses in both states are reasonable for out of state anglers to purchase. This writer is completely satisfied with my jig fishing in local ponds for yellow perch, bass, & pickerel. The excitement of catching a dozen yellow perch from just one hole, and an occasional bass or pickerel provides all of the fishing pleasure I can handle in one day. The great eating of the yellow perch can provide a good meal when pan fried, & served with a good order of shrimp fried rice and a couple of egg rolls from my favorite Chinese Restaurant, the Food Works in North Uxbridge. Local deer hunters did very well during the two weeks of black powder season in Massachusetts! The season closed this past Tuesday, Dec. 31, but not before Phil Harper of Uxbridge harvested a huge eight-point buck in the Uxbridge area with his bow. The buck weighed in at 246 pounds live weight and sported a huge set of antlers, as shown in this week's second photo. Local residents are still having problems with deer eating there expensive ornamental bushes, but they will need



to wait until next year for any relief by sportsmen. Coyote season in Massachusetts remains open until March 7, 2020 for sportsmen that enjoy hunting them. There is no shortage of these animals, which have become overpopulated in many areas of the state. Groups of hunters were holding coyote hunting contests, but were stopped by anti hunting protesters. These killing machines are responsible for killing numerous deer and wild turkeys throughout Massachusetts, as well as killing residents pets annually. The situation is only going to get worse as the coyote packs increase annually.

With the possibility of a substantial increase on most all fishing and hunting licenses in Massachusetts in 2021, many sportsmen feel that some type of permit fee for residents and non residents that use Fish & wildlife property for walking, bird watching, hiking, etc. should be required to pay an annual fee also. It would sure help MF&W with their annual budget, and could alleviate the pending licenses increases for the sportsmen, that have paid millions of dollars over the years to purchase open land throughout the state. *Take A Kid Fishing & Keep Them Rods Bending!*

## Year-end – time for some New Year’s financial resolutions

And one of these roadblocks could come in the form of large, unexpected

# Create a festive centerpiece from your indoor and outdoor garden

Take a break from the holiday rush for a bit of gardening relief. Grab a pruner and basket then wander through your landscape gathering a few evergreen branches, berry-laden stems and cones to create a holiday centerpiece.

Most gardeners are used to walking into their summer garden collecting blossoms to create a bouquet or arrangement for their summer parties. Winter should be no exception. Start by gathering some greens. The fan-like sprays of arborvitae, blue-green sprigs of juniper and stems of other evergreens like yews, boxwood, pines, and spruces provide all the greenery you'll need.

Now look for items with interesting color or shapes. Red and yellow twig dogwoods, curly willow, contorted filbert

and fantail willow provide interesting color and form.

Next, gather cones, berries and fruits such as rose hips, the blue berry-like cones of junipers, sweet gum seed-pods, alder's cone-like fruit, and of course evergreen cones as substitutes for summer blooms.

Don't overlook purple cone-flower, black berry lily, penstemon and other seed heads and pods. Fluffy seed heads of ornamental and native grasses make nice fillers. All these make beautiful additions to any arrangement and can be painted or glittered for some added glitz. And don't be afraid to add a few shiny ornaments for a bit of holiday flare.

Look for decorating possibilities that your indoor garden can provide. Dress up small plants to create a centerpiece and larger plants to provide a bit of seasonal color and decor.

Stop by your favorite florist or garden center and purchase a few water picks and cut flowers. Place the cut flowers in the picks and sink them into the pots of your favorite houseplants. This adds some color and seasonal interest to any

green plant.

Consider creating a changeable houseplant container. Plant several compatible indoor plants in a large container. Sink a small empty pot in the space where you want to create a focal point. Set a small potted flowering plant inside this empty one. Replace the flowering plant occasionally to

freshen up the container garden or create a seasonal display. Miniature poinsettias, azaleas, African violets and cyclamen allow you to change out the display throughout the year and for any special occasion.

Make it even easier to change the display by filling a large basket with a collection of pot-

ted houseplants and flowering plants. Switch out the flowers as they fade and foliage plants as the holidays, your mood or the décor changes.

Use silk flowers, glittery spikes and decorative ornaments to add a splash of color and sparkle to your indoor garden as needed. Exchange these for red, pink and white hearts on Valentine's Day, colorful Easter eggs, or faux fall leaves as the seasons change.

Once you've created your first arrangement, you'll be looking for additional opportunities to create more. And as you plan this year's garden, consider growing more plants that can be used to dress up your dinner table and other rooms in your home.

## Late-game magic again for Spartans, this time against Bartlett

WEBSTER — Grace Orr poured in a game-high 16 points and hit 4-of-5 free throw attempts in the fourth quarter to help lead visiting Uxbridge High to a come-from-behind, 38-33 victory over the Bartlett High girls' varsity basketball team on Thursday, Dec. 19.

With the win the Spartans improved to 3-0 overall and 2-0 in the B Division of the Southern Worcester County League (SWCL). Bartlett fell to 1-2 overall and in SWCL B Division play with the loss.

After three quarters of play this back-and-forth game was tied at 28-28.

Uxbridge took a 30-28 lead 24 seconds into the fourth quarter on a drive and layup by eighth-grader Kathryn Cahill

(5 points). Bartlett, however, tied the game 30-30 with 7:01 remaining in the game on a put-back of an offensive rebound by sophomore Cam Heenan (a team-high 14 points). Heenan, who was fouled on the play, then put the Indians in front 31-30 when she swished the ensuing free throw.

Orr, a freshman who also pulled down 7 rebounds, put the Spartans ahead for good 32-31 with 4:10 to play by hitting a pair of free throws. Orr finished the game 6-of-7 from the foul line. With 3:35 left Cahill pushed the Uxbridge lead to 34-31 with a baseline drive and layup. Sophomore Chloe Kaeller (5 points) added to the Spartans' lead with a free throw, making the score 35-31 with 1:38 to play.

Bartlett senior Brittany

Ward (6 points) cut the Indians' deficit to two, 35-33, with a slicing drive to the hoop with 49 seconds remaining. That was as close as Bartlett would get, however. Orr canned another pair of free throws with 24.6 seconds remaining and Cahill went 1-for-2 from the line with 10.5 seconds to play to account for the 38-33 final.

"Grace got us going early with 8 first-quarter points and then she hit some big foul shots for us down the stretch," said Uxbridge head coach Dr. Jeff LaCure, who also praised the play of junior Sarah Johnston, who scored all 7 of her points in the first half. "Sarah is our offensive and defensive leader; she's our quarterback out there. She probably had more turnovers than she wanted to have, but I thought she did a

good job on both ends of the floor."

LaCure said he thought a big key to beating Bartlett was the fact the Spartans' first two wins were close games that were decided late.

"We've won the fourth quarter in all three of these games," LaCure said. "The kids are starting to believe if it's close — whether we're up or down — at the end of three, we've got a real good shot to win, and that's a great mentality for a team to have."

Senior forward Ella Correa added 5 points to the winning score for Uxbridge.

Both teams made the other work for each and every point they scored. Uxbridge forced Bartlett into 24 turnovers while the Indians forced the Spartans into 25 turnovers.

Bartlett head coach Kashawn Hampton was not as gregarious as he usually is after the game.

"I'm upset. This was a very winnable game; we definitely had them," Hampton said.

"The difference tonight was not being able to take advantage of several scoring opportunities, especially in the second half and the fourth quarter. We ran a lot of good plays that we didn't capitalize on. We had many opportunities to hit easy shots and we didn't, so we feel it right now; we're disappointed."

Junior Kayla Berthiaume scored 5 points for the Indians while classmate Gabriela Piwowarczyk and sophomore Madison Nutall added 4 each.

"This team is very capable of winning a lot of games, but we've got to capitalize on the chances we get. We can't afford to go 60 percent at times. We've got to go 100 percent, 100 percent of the time," Hampton said. "It's the little things we need to concentrate on. We fought hard, but at the end of the day we need to capitalize on layups and free throws, and we didn't do that tonight. If we hit our free throws and the easy shots we got, we would have won this game by 10 points."

SOUTHBRIDGE — In the grand scheme of things, Bay Path Regional very well could be an average sized girls' varsity basketball team, but the Minutemen took advantage of their extreme height advantage when taking on Southbridge High on Wednesday, Dec. 18.

"We had a height advantage across the board," said Bay Path head coach John Selen.

And the Minutemen worked the ball down low as much as possible, finishing with 28 two-point baskets — plus two 3-pointers — in a 62-32 victory versus the Pioneers.

"That was the game plan, pump it inside and try to get it to our bigs inside," said Selen. "We are a pretty good rebounding team and have a couple kids with a nice touch around the basket."

Two interior players, Christin Pink and Terry Simon, finished with double-doubles. Pink had game-high totals of 14 points and 18 rebounds, while Simon, a freshman, registered 10 points and pulled down 10 boards.

"She had the kind of game we need her to have every game," Selen said of Pink's play in order for the Minutemen to be successful. "She's a rebounding machine. She has perhaps the best jumping ability."

Pink, one of only three Bay Path players with any returning varsity experience, got going right away. She finished the first quarter with 6 points and 7 rebounds and was just a rebound away from a double-double at the half, which the Minutemen led 37-19.

With Pink and Simon having such strong games inside the paint, that could be the offensive direction Bay Path goes in as the calendar shifts to 2020.

"We're still trying to figure out who we are," explained Selen, who lost the majority of last year's 16-4 3-point shooting team to graduation. "Maybe we're an inside team this year. We'll take what we get and we'll build upon it."

Bethany Lasell was another offensive contributor for the Minutemen — who improved to 1-1 in the young season — as she scored 8 points. In all, 11 Bay Path players made at least one basket.

For Southbridge, which got outrebounded by a 52-37 total, the height differential will be a common trend this season.

"There's a chance that we're the smallest team throughout the whole state, but the girls don't give up," said head coach Elvin Rodriguez. "They keep fighting, and that's what I love about these girls."

"No seniors, that's two years in a row with no seniors, so we're a work in progress," added Rodriguez. "We had a few flashes of the offense working. I have no post presence, so it's basically going to be pass and cut."

What the Pioneers lack in height they make up for in heart. Eight players made at least a basket, with Haily Coburn's 7 points being a team-high total. Melanie Figueroa pulled down a team-best 13 rebounds.

Rodriguez is confident that Southbridge will remain positive and continue to show fight against the taller competition.

"It definitely is frustrating when we can't get a round, but at the end of the day you see what we have — my starting lineup averages 5-foot-2, if that — and it's tough. I just tell the girls to box out and we're going to get the over-the-back calls. They [the referees] will call it," said Rodriguez, whose team slipped to 0-3.

A unique twist to the game saw at least four Southbridge residents playing for Bay Path. That makes for a nice, yet competitive rivalry among the two teams.

"It's nice to play Southbridge because there's a lot of connection between the two schools. It's nice because there's some camaraderie — they compete on the court but afterward there's smiles," said Selen.

The rematch at Bay Path is scheduled for Jan. 8.

DUDLEY — Way back on Dec. 12, teams were allowed to open up their high school varsity basketball seasons. For Tantasqua Regional, its season-opener was set for five days later, but a snow day halted the game with Bartlett High. The Warriors were then set to play at Millbury High on Dec. 20, but a water pipe had burst, so that game was called off.

Finally, on Monday, Dec. 23, Tantasqua was ready to play at Shepherd Hill Regional, a team that has already been able to play three games.

“We’ve had more practices than most college teams in the preseason,” said Tantasqua head coach Scott Dion. “We’ve tried to do some different

things in practice to make it not monotonous for the boys because they were starting to get sick of listening to me. Certain practices I let these guys [assistant coaches Nate Orzech and Dan Lavin] run it and I just officiated and we let them hear a different voice. Some of our alumni came in and scrimmaged us.”

Dion wondered how his team would come out in this first contest of the 2019-2020 season. “You always worry about your conditioning, you worry certainly about your execution...and I think our guys responded pretty well,” he said.

The Warriors led at all the stops — 16-15 after a quarter, 34-25 at the half and 49-32 through three quarters — before pulling away and win-

ning by 21 points, 58-37.

“Their length and their athleticism posed problems for us,” Dion said of the early going. “They played exclusively between a 2-3 zone and a 3-2 zone. We don’t do a lot of that ourselves, so we hadn’t really practiced against it all that much. We were able to figure out a little bit there, certainly in the second half.”

Tantasqua took what Shepherd Hill was giving them, which was the outside shot, and the Warriors made those attempts count. By halftime, Tantasqua had connected on

seven shots from 3-point land. They finished with nine 3s as the Warriors then went inside effectively in the second half.

“When you make shots, it certainly helps open everything else up because then they have to extend [defensively], you can get some dribble-drive and it opens up other areas,” explained Dion.

Tantasqua saw nine of its players register at least one basket, with Cameron Varney (15 points), Troy Lee (10 points, 7 rebounds), Will Pieczynski (8 points) and Joe Groccia (7 points) leading the charge.

“I think you will see with this team that on any night I’ve got five guys that could go for 15 and I think the other seven or eight guys are going to get their 6 to 9, which can make us dangerous,” Dion said of his spread-the-wealth offense. “Who do you match up with?”

Simply put, the Rams could not, as they dropped to 0-4. Leading the charge offensively for Shepherd Hill with double-digit point performances were Brandon De Jesus (11) and Cam Hackett (10).

That was the theme that played out in the Tantasqua Regional girls' varsity basketball team's 58-42 victory over Shepherd Hill Regional on Monday, Dec. 23.

The Warriors, who improved to 2-1 with the victory, were led offensively by the 1-2 punch of senior Lydia Boland and sophomore Sophie Law, who tied for team-high scoring honors with 14 points each. In addition, eight of the 12 Warriors who got into the game scored.

The Warriors' pressing defense — which helped to force Shepherd Hill into 19 turnovers in the game — paid dividends in the second quarter, limiting the Rams to just six points in the period, after which Tantasqua was in control of the game. The Warriors led by 15, 28-13, at halftime

"I thought we were really strong defensively," Goyette said. "We played great man defense and we limited their scoring opportunities, especially in the first half. I thought we really shut them down."

Making it into the scoring column for Tantasqua, in addition to Boland and Law, were junior Emerson Cherry (8 points), freshman Haley Courtney (7), junior Ainsley Way (5), senior Kylee Fortuna (4), and junior Madison Varney and sophomore Shea Coleman (3 each).

"I thought it was just an overall good team effort out there. They worked well as a unit. We had a lot of good passing, we ran the floor well,

we broke their press and we were able to score off breaking the press, too," Goyette said. "They're a Division 1, Mid-Wach A team, so this is a huge, huge win for us."

Mullen led Shepherd Hill in scoring, pouring in a game-high 16 points. Her seven baskets included a pair of 3-pointers, four drives to the basket and an in-lane jumper.

"Emery has a natural basketball ability," said Shepherd Hill head coach Maura Hackenson, who has replaced longtime coach Jim Hackenson on the bench for the Rams due to Jim Hackenson retiring last summer. "Emery works hard. We're very excited to have her."

Burdett also scored in double figures for Shepherd Hill, tossing in 10 points. Junior Emma Lanpher scored 4 points, classmate Flora Marderosian added 3, and senior Kerry Greenough and junior Triniti Sughrue added 2 points each.

Hackenson seemed most please by the Rams' defensive effort, which resulted in 20 Tantasqua turnovers.

"We're a defensive team, for sure. They really work hard on defense; that's all I care about right now," Hackenson said. "Our offense will come. We're working on taking baby steps, but it will come. We're a young, inexperienced team but I've got great kids who work hard and they're going to make it happen."
