Leicester voters say no to school proposal

LEICESTER – Special Town Meeting voters last week overwhelmingly rejected the proposal for a new school.

A two thirds majority vote was needed at the Sept. 26 Special Town Meeting for the proposal to move forward, but instead it was rejected by nearly two thirds of voters. The final vote was 506-315 in opposition to the project.

The proposed \$91.4 million school on Paxton Street would have served students in pre-kindergarten through the eighth grade. The Massachusetts School Building Authority (MSBA) had already pledged \$41.9 million for the project, but residents strongly opposed the town's plan to secure the remaining funds through a debt exclusion.

Now, with the proposal scrapped, it's back to the drawing board for school leaders. The new school would have solved the issue of major repairs and upgrades needed at aging buildings, but officials will now have to revisit talks of costly renovations.

"I'm very disappointed in the vote. I felt the plan that had been developed over years, with community involvement, was a good one," said Leicester School Committee member Tom Lauder. "Our kids deserve better schools, and trying to renovate what we have is a waste of time and money, in my opinion."

School officials are especially frustrated by the missed opportunity to partner with the MSBA on a new school. The proposal went through several stages of approvals with the MSBA before ultimately derailing at Town Meeting.

"I'm not happy that we hand back \$42 million from the MSBA and basically say, no thanks, we're not ready to make the investment in our schools. Now we're on our own," Lauder added. "Leicester is a proud town. We have a new fire and EMS station, a new library, and a relatively new police station. Apparently, a new school was too much and not a priority for us. I'm afraid we will regret this vote."

Leicester Public Schools Superintendent Marilyn Tencza could not be reached for comment by press time.

Meanwhile, voters who opposed the proposal are relieved that Leicester's many struggling residents will not face an additional financial burden. The combination of existing challenges for residents and the Covid-19 pandemic created an insurmountable barrier for the new school proposal.

"This project was not only fiscally irresponsible in itself, but Covid-19 has caused so many uncertainties with the economy, unemployment, and the future of learning," said resident Joel Hart, who voted against the proposal. "Not to mention the devastating effects it would have on our aging population of fixed income seniors and the people of Cherry Valley that are suffering from \$300-600 a month in water/ sewer bills."

Several opponents of the proposal were frustrated by the district's decisions in recent years, including the closure of the Memorial School.

"If the school department did not close the options on renovating Memorial School with MSBA eligible reimbursement, we may have had a different outcome," Hart added. "In our opinion, that lack of open-mindedness – and putting wants before needs – caused the people to say no."

The Special Town Meeting was nearly called off two days before the meeting, as selectmen held an emergency session to discuss a possible postponement due to a positive Covid-19 case at the high school. Selectmen wound up voting 3-2 to move forward with the meeting.

School district pays off deficit loan

SPENCER – School officials recently announced that the Spencer-East Brookfield Regional School District has paid off its deficit loan.

In a Sept. 15 announcement, SEBRSD Superintendent Paul Haughey said the district has paid off the loan. Back in 2013, newly approved legislation authorized the district to issue up to \$3 million in deficit obligations, to be amortized over a period of up to 10 years. The monies funded the district's fiscal year 2013 budget deficit.

On July 11, 2013, the district

Commissioner of Education to issue \$2 million of authorized debt. Within six months, roughly \$837,000 was already paid back, officials said.

State legislation also required the district to set aside funds each year for a fiscal stabilization fund. Over the last seven years, the district has been paying down the remaining \$1,163,000 balance from the 2013 budget-financing obligation, officials said.

"It is with great pleasure that I inform you and the District Committee that on Sept. 1, 2020, payment of \$170,000 has retired the district's definit financing chligtion pursuant to Chapter 24 of the Acts of 2013 – nearly three years early," wrote District Treasurer William Schlosstein in a recent correspondence to Superintendent Haughey.

Additionally, the district's Fiscal Stabilization Reserve Fund now holds nearly \$390,000.

"Congratulations to the district for its perseverance and rigorous discipline in seeing through a difficult chapter in its history," Schlosstein added.

District officials thank the entire financial team within the Spencer-East Brookfield



Local students and school staff adjust to the new normal

REGION – With masks, social distancing, and partially remote learning in effect, students and staff at local schools continue to adjust to a new normal.

It's been a challenge for area districts to implement

and enforce all of the new policies, but staffs are working hard to ensure safety. The process starts at home, officials said, with parents and guardians asked to perform a daily symptom check of students and keep those who aren't feeling well at home.

In the classroom, mean-

while, kids are slowly getting used to life at school with social distancing and specialized "cohorts" of students who attend classes together to limit greater exposure. The majority of local districts are only currently featuring

Local veteran turns 100

WEST BROOKFIELD – A decorated veteran and local legend was honored last month in a centenarian celebration.

Everett Allen, a World War II hero and longtime West Brookfield resident, turned 100 on Sept. 16. His family, friends, and First Congregational Church members helped him celebrate by displaying a special sign that was visible from the road outside his house. Passing drivers, many of whom know Allen personally, sounded their horns in celebration.

Last week, the New Leader spent some time with local historian William Jankins, a close friend of Allen who discussed his service and heroism during the Second World War.

Allen was a member of the U.S. Army and 8th Air Force 458th Bomb Group, which helped destroy French bridges to prevent Nazi forces from advancing on D-Day. Weeks later, serving as a tail gunner during a mission in late June of 1944, Allen was forced to evacuate his aircraft after taking enemy fire. He was eventually captured by the Nazis and imprisoned in a POW camp. After enduring almost a year in confinement, he was liberated by Russian forces in the spring of 1945.

For his valor in combat, Allen earned the European-African-Middle Eastern Campaign Medal, the Prisoner of War Medal, and the World War II Victory Medal.

Now, 75 years later, residents continue to be inspired by Allen's service and patriotism. Up until a few years ago, he marched in the town's Memorial Day parade every year, in full uniform (he is now greeted by paradegoers as he passes by in a vehicle). And residents are always excited to see him out and about in town.

"Everyone in town knows Everett. He still drives to the post office every day and meets new people," Jankins

Fire Station Building Committee provides progress updates

NORTH BROOKFIELD - Officials continue to update the community on the efforts of the Fire Station Building Committee.

In 2017, selectmen directed the seven-member committee to study the needs of the fire department moving forward and produce a building design concept. Among several other tasks, the committee was charged with hiring a designer and project manager to identify the scope and cost of a new fire department headquarters that would be located on Grove Street, adjacent to the police station.

Extensive evaluations have taken place over the last three years, and officials want to make sure residents are apprised of the latest actions.

'We're educating the public on the preliminary design that we have, and roughly what it will cost the community," said North Brookfield Fire Chief Joseph Holway. "All of this information is extremely important for residents to see."

The current fire station was built in the 1800s. Despite a pair of major additions, the building does not meet the space requirements for housing the department's equipment. The hovercraft and trailer, dive rescue boat, and the forestry truck are currently stored outside and exposed to the weather. Additionally, the aerial tower unit is taking up a bay from the Highway Department and is exposed to dust, grindings, and damaging humidity.

Moreover, the fire station does not meet OSHA health and safety guidelines that the Department of Public Safety adopted this past year.

"There is no exhaust system to vent the bays when the diesel trucks are started for calls," read a statement from the fire department. "This carbon buildup is very evident when we wash the station walls and floors. The existing facility is no longer able to support the needs of today's firefighting operations, training, and life safety.'

In recent weeks, fire department officials decided to reduce their communications about the project in an effort

Regional School District, as well as the School Committee for its support.

"Combined with the completion of single and end-of-year audits of the past four years by Melanson-Heath, Spencer-East Brookfield RSD is in solid financial standing to move forward, focused upon teaching and learning with purpose while carving out a college, career, and life readiness niche in Southern

to allow residents to focus instead on the state-mandated upgrades needed for the wastewater treatment facility. A debt exclusion ballot vote, scheduled for the Nov. 3 election, must be successful for the project to proceed. Town Meeting voters approved \$13.1 million for the project on August 18, and the preliminary design for the upgrades was approved by the MassDEP and USDA.

Recognizing that the wastewater treatment facility upgrades should take precedence, Chief Holway and his team are patiently waiting before advancing their project to residents for consideration.

'Right now, the Fire Department is supporting the Sewer Commission

regarding the mandatory requirements for the upgrades," Holway added.

Meanwhile, residents interested in learning more about the need for a new fire headquarters are invited to tour the existing facility. Please call 508-867-0210 to schedule a tour; the department also plans to hold an open house in the near future.

If the project is ultimately approved, the new headquarters would also house the North Brookfield Emergency Medical Squad.

Previously, selectmen authorized \$40,000 for the project design architect (Tecton Architects) and \$20,000 for the project manager (Colliers Project Leaders). Specialists have also explored whether the existing facility could be upgraded to meet the needs of the department, but they determined that a new structure is needed.

"The current fire station has served the community well for over 100 years, but times have changed and the North Brookfield Fire Department has changed as well," the department's statement read. "We have more and larger equipment to help us provide better service. We must be better trained to address the challenges we face in our community, and we need the facilities to support the staff when they remain at the station ready to provide service.'

Over the last decade-plus, several studies have detailed the occupational hazards firefighters face related to

cancer and other illnesses. A new headquarters would go a long way toward protecting North Brookfield firefighters from the unseen dangers of the job.

"It is important to keep those contaminants out of our living and office space until all our gear has been cleaned," read the department's statement. "In this way, we can maintain a safe and healthy working environment as we strive to protect our community.'

The current design proposal for the new building would allow for the future addition of solar panels on the bay roof. The building would also meet all current energy guidelines and code requirements, officials said, including mandates on insulation, lighting controls, and indoor air quality.

Pending approval from voters, the project would likely be bid in 2021. Construction could possibly be completed by the summer or fall of 2022.

Before taking the project to voters, officials are still working on securing additional funding.

"We continue to work closely with Senator Gobi's office to advise on our current status and funding issues,' the department's statement read. "The committee is also working with State Rep. Donald Berthiaume's office. The committee will work with many organizations to seek additional funding sources, from utility rebates to federal grants.'

ahead, the Building Looking Committee plans to eventually ask voters to approve an estimated \$8.2 million for the building construction and soft costs for the project. The town would need to borrow this money as a municipal bonded project, officials said.


"This is a new program for the food service staff, and we hope you will grow with us as we continue to feed the children in the SEBRSD community," read a statement released by SEBRSD Superintendent Paul Haughey.

"This program brings a huge relief to families who might not qualify for free meals, yet are still going through a difficult time," read a statement issued by Pulver. The program is made possible by the U.S. Department of Agriculture, which has extended several assistance opportunities through Dec. 31.

Since March, the Spencer-East Brookfield Regional School District has served nearly 24,000 free meals to members of the community. hybrid learning for elementary school students, with middle schools and high schools operating remotely.

The Spencer-East Brookfield Regional School District is offering a hybrid learning model to students in pre-kindergarten through the third grade.

"A hybrid model of learning with safety precautions means Monday through Thursday following an A-Week / B-Week schedule and school year calendar – with the understanding that every possible resource is brought to bear to ensure the safety, health, and wellness of our students and staff," read a statement issued by SEBRSD Superintendent Paul Haughey.

The SEBRSD recently released data on attendance for each cohort at the two schools currently offering hybrid learning – East Brookfield Elementary School and Wire Village School in Spencer.

At EBES, a total of 190 students in grades pre-K-3 are taking part in some

form of education. This includes Cohort A (31 students); Cohort B (21 students); Cohort C (12 full-time students); Cohort D (81 fully remote students); and 45 preK students.

The overall attendance rate for all EBES students during the first week of school was 99 percent, officials said.

At Wire Village School, 334 students in grades K-3 are attending some form of classes. This includes Cohort A (116 students); Cohort B (100 students); Cohort C (18 full-time students); and Cohort D (100 fully remote students).

Like EBES, Wire Village also saw a 99 percent attendance rate for in-person and remote learners.

In Leicester, 275 students are participating in fully remote learning. The district is using the Florida Virtual School platform to provide curriculum lessons to those students.

Additionally, Leicester's hybrid learning structure has been a successful tool for students looking to return to the classroom.

"The hybrid model is going very well so far. It has been an adjustment

for staff and students, but everyone has been very cooperative and we are all learning to navigate the new normal at school," said Leicester Public Schools Superintendent Marilyn Tencza. "Having students back in small groups has been a positive in this difficult educational environment. We are all happy to see them in person."

The Quaboag Regional School District is currently running a hybrid model at its elementary schools in Warren and West Brookfield. Combined, the schools have seen 419 students in grades K-6 participate in hybrid learning, plus another 205 students who are receiving a fully remote education this year.

"Everything is going well as teachers and students adjust to the new normal and education in 2020," said QRSD Superintendent Brett Kustigian. "Our teachers and staff are really stepping up to the plate, and they are working harder than ever before in adapting to remote instruction. The increased time with professional development really helped, and our dedicated staff are making a positive difference in the lives of our students."

Leaders of the North Brookfield Public Schools have seen about 15 percent of students take part in the fully remote model. The district has benefited from having all students learning remotely on Wednesdays to provide proper sanitation. On the other four days, assigned groups of students alternate between in-person and remote learning to ensure enough space for social distancing.

"Things have gone very well. It is definitely strange to have so few students in the building at any one time, but everyone is adjusting," said North Brookfield Public Schools Superintendent Richard Lind. "There are problems that pop up, and we are addressing those things as they arise. The students and staff are doing a really good job with masks and physical distancing."

Officials at all area school districts have also made preparations for a potential return to fully remote learning if Covid-19 conditions worsen. They will continue to rely on state guidance and data as the year progresses.

It's Apple Season!



It's apple season and apple offerings are plentiful in our area. New England grown apples have been pleasing the palate since the 1700s. The area's hot summers, cool fall days, and rocky soil are credited with the production of big, red apples with a unique mix of sweet and tart flavors. Read on for a lesson on "apple-ology!"

If the various varieties of apples have you confused, the following guide identifies some of the most popular regional apples:

Native New England Apples: New England apples boast a unique blend of sweet and tart flavors, attributed to the region's long, hot summers and crisp fall days. About 40 varieties of apples are commonly grown in New England apple orchards. The most popular today are McIntosh, Cortland, New England Red Delicious, Macoun, Empire, and Rome. aligned where we had black man running for president who was objectively a great candidate but we also had a pointless war that turned into a quagmire and an economy in freefall of what was the worst recession since the great depression. The 2012 election was comical as the Republicans tried to find their way and they ended up going with a Mormon Northeast moderate elite turned deplorable-panderer that honestly nobody liked by the end. As we barreled through Obama's second term with a hostile opposition party that was taking America hostage and seemed willing to shoot the hostage, we ended up at the first time in history that a Supreme Court seat would be intentionally left open for a full year in hopes that they could roll the seat to the next president. Mitch McConnell is a genius, evil, but genius nonetheless. Who would have thought he was willing to break everything to shift the power on the court for a generation?

Throughout the Trump presidency, the inappropriate behavior, the inappropriate language, the cronyism, the corruption, the violation of norms, the extortion, the impeachment... We are about to enter a new phase - il fascismo. Donald Trump is behaving like Benito Mussolini and despots that the U.S. usually condemns.

The topic came up again this week and again Trump has refused to commit to a peaceful transition of power if he loses the election and shatter a tradition

that lies at the heart of the democratic process in the United States and places our republic in mortal danger. Combine that with Trump's relentless disinformation campaign, celebration of violence against journalists, and incitement of armed militias, and scheming to pressure Republican controlled state legislatures of swing states to overturn their elections if Biden wins. Trump's behavior would be swiftly and unequivocally condemned by the entire world if it was happening elsewhere.

"We'll have to see what happens," Trump said when asked if he would accept the final results of the election. He has given the country myriad signs he will not concede under any circumstances, placing the US on the precipice of a political crisis like nothing we have ever experienced.

No other American president ever played with this kind of fire in advance of an election, suggesting that the results of the upcoming election ought to be disregarded. There has never been anything remotely similar. To find an example of this in history we have to look at leaders like Mussolini. Mussolini started as a man of the people and slowly consolidated power over 3 years. This is the way dictators come to power. This is not a drill.

To respond to Mr. Herholz - The term "China-virus" is racist. This has been explained many times, from many angles, from many people. Your insistence on continuing to use it is illuminating. Let's not forget that the confirmed COVID-19 cases in the U.S. per capita are 332 times higher and the confirmed COVID-19 deaths per capita are 183 times higher than China...and growing... Go ahead and hate China, having a villain you don't understand can make explaining a complex world a lot easier.

Mr. Herholz made a false comparison between COVID-19 and the 2009 H1N1 pandemic. He is absolutely correct, there were an estimated 60 million cases. He is also correct, there were about 13,000 confirmed deaths from that flu. He is also correct that we did not impose social distancing, masks, close things down, etc. Think about that though... While the H1N1 looked dangerous at the outset, President Obama started filling up the national stockpiles with medical equipment and PPE, and took a wait and see approach. It proved to have a 0.02 percent death rate early on and the reason we got to 60 million cases is because it wasn't deemed worth draconian measures to control. It seems like President Obama handled the H1N1 like a conservative/Republican dream, background government preparation without major disruptions to daily life.

Juxtapose COVID-19, the estimated death rate is 2 percent, or 100x the H1N1 flu. We have seen 7 million cases with 200,000 deaths, or 142 times the rate we observed with H1N1. Based on antibody studies it looks like letting COVID-19 rip would result in more than two million American deaths – a far cry from the 12.000 we saw with H1N1. We don't even know if we can make a vaccine for it, never mind how long that will take whereas we knew we could make a new influenza vaccine within months. There are also the long-term effects months out something like 25 percent of COVID-19 patients under 40 without preexisting conditions have ongoing symptoms such as fatigue, headaches, organ inflammation, etc. If we didn't have Obamacare, recovered COVID-19 would be a pre-existing condition that would justify either higher rates or no-bids on health insurance. We know that humans that recover from influenza have truly recovered.

Mr. Herholz – I encourage you to save every letter you have written. Put them in a box and promise not to read them for at least 10 years after Trump (or any vestige of the dynasty) is gone. Promise me you will read them. I wonder how supporters of Mussolini and Hitler felt in 1955 looking back at their prior selves...

Mr. Robillard – For starters, Donald Trump become a politician the day he descended that escalator. Secondly, he is a career con-man and objectively a terrible businessman. He ran a casino. and airline, and a football league bankrupt. He made his money off of being a celebrity, a TV star, a gameshow host. He would be five times richer if he put his inheritance in an S&P 500 index fund and literally did nothing his entire career.

As for supply and demand, you are


looking at microeconomics as opposed to macroeconomics. Donald Trump's understanding of economics is that of Mercantilism or "fixed pie theory" and was the dominant economic theory of the 16th-18th centuries - i.e., before the industrial revolution. Mercantilism operates under the concept that there is only so much "stuff," value, or money and for every winner there is a loser. It doesn't recognize that the economy, or the pie, can grow. The theory was rejected by Adam Smith and Capitalism, which is the theory of which capital can be used to grow more capital, is the dominant theory now. No mainstream economist still believes in Mercantilism but of course it is simpler than reality.

At the nation's founding, we had four million people. We have grown the population to 328 million and we are far richer as a country today... How could this be? The reason is our economy grew. As our economy grew, we needed more workers. Our country actively sought immigrants (from Europe) because without workers our industrial base couldn't grow. With more workers were more consumers who grew other industries.

Mr. McRae - How do you think James Madison would feel about President Trump labelling the press as "the enemy of the people?" How do you think Madison would feel about Trump's open threats to turn the United States into an autocracy if not a monarchy?

Finally, COVID stats... We now have 7,081,505 confirmed cases and 204,527 deaths. We are still #1 on both counts, but within a month India will likely take our crown. Antibody studies have indicated that 10% of Americans have had COVID, either confirmed, symptomatically without a test, or asymptomatically. We have started to see the fall increase already; daily cases are up 22 percent since two weeks ago. We can expect 2 million total deaths if we continue on this path. This is sad. It is pathetic. There's nothing else to say about it.

power since Scalia was such a conservative icon. It seems that RBG being a liberal icon has not meant that "the next president" should pick her successor.

Assuming Mitch McConnell even allows questions at the confirmation hearings (he didn't allow evidence to be presented at the impeachment)... Listen for answers to the hard questions. People care about Healthcare and the Affordable Care Act faces extinction in the court yet again. I hope that an aroused citizenry will not tolerate the kind of behavior Trump is openly talking about, and Republicans as a party won't tolerate it either.

Daffodils are having their day. Floral designers are opening our eyes to a world of gorgeous daffodils that extends far beyond the iconic vellow trumpets. These unexpected varieties include doubles, bi-colors and split cups, in colors such as creamy white, peach, pink, gold and orange. Plant the bulbs in fall to see these beauties emerge in your spring garden. Then enjoy how they elevate all your spring bouquets.

A benefit of planting some of these more unusual varieties is being able to stretch the daffodil season. Be sure to include some early bloomers such as miniature Tete a Tete. Another early bloomer is Barrett Browning. This heirloom variety's orange-red cup has a yellow halo at the base, set off by bright white petals. Silver Smiles is a subtle beauty. A cluster of two or three little flowers tops each stem. Greenish-white petals surround a pale-yellow cup that fades to buff and then white.

Pink-cupped daffodils have been around for almost 100 years yet are still relatively unusual. Grow them in filtered sunlight to accentuate the color. Blushing Lady has yellow petals and a flared, salmon-pink cup. Turn up the pink even more with Pink Pride. Another early-blooming variety, it features a ruffled cup that opens apricot

Trend-setting daffodils for gardens and bouquets

and gradually turns coral pink.

As early daffodils begin to fade, midseason varieties take center stage. This is the time for split corona and double daffodils. Both types work well with the more traditional daffodils, while adding flair to gardens and arrangements.

Instead of a trumpet, the cup of a split corona daffodil is split into sections. These split cups may be ruffled or pleated and often lay flat against the outer petals. One of the showiest split cup daffodils is Cum Laude. Its white petals frame a frilly, peachy-yellow cup with a green eye. Include other splitcup varieties such as Cassata, with a delicate ruffled yellow split cup and white petals, or Lemon Beauty with a star-like yellow cup set against white petals. Can't decide? Plant a split-cup assortment to find your favorites.

Close out the season with double daffodils. Their fluffy flowers resemble roses, and most varieties are fragrant. Delnashaugh (longfield-gardens.com) is one of the most impressive doubles. Its enormous, 4" flowers feature layers of frilly white and peach-pink petals. Tahiti is just as large, with soft vellow petals and red-orange ruffles.

Two of the latest bloomers are also two of the most fragrant: Cheerfulness and Yellow Cheerfulness. Each stem is topped with a mini bouquet of three or four little rose-like flowers, each the size of a cherry tomato. They are incredibly beautiful and extremely long-lasting.

In a vase, daffodils can essentially arrange themselves. The more flower forms and colors you include, the better. Have a little more time? Add a few stems of forsythia or curly willow and some other spring favorites such as bleeding heart, tulips and hyacinths.

The stems of freshly cut daffodils release a clear sap that can shorten the life of other flowers. Conditioning your daffodils is easy and eliminates this risk. Cut the stems to the final length and stand them in a clean container of cool water for four to six hours. After that, they can be combined with tulips and other blooms. Just remember to not recut the stems.

Nothing says spring like a yellow trumpet daffodil. But with so many other flower styles and colors to choose from, why not stretch your boundaries and discover some new favorites?
