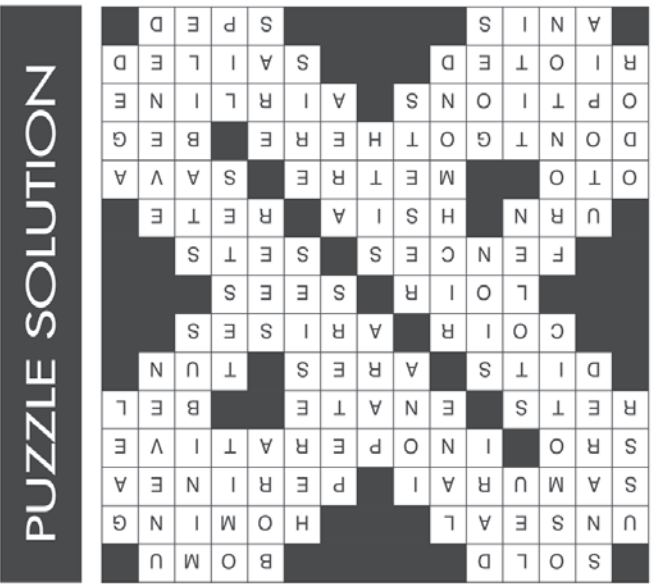

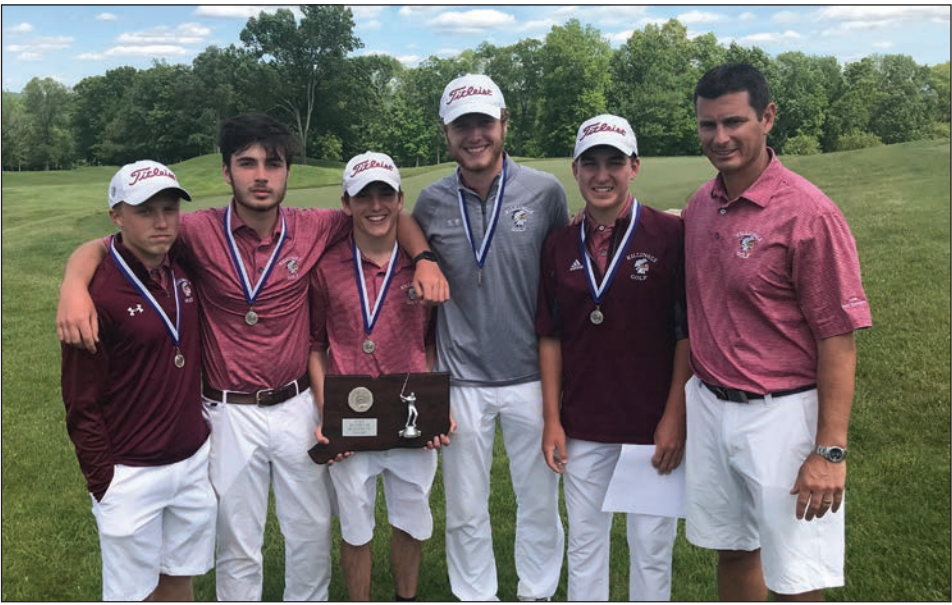

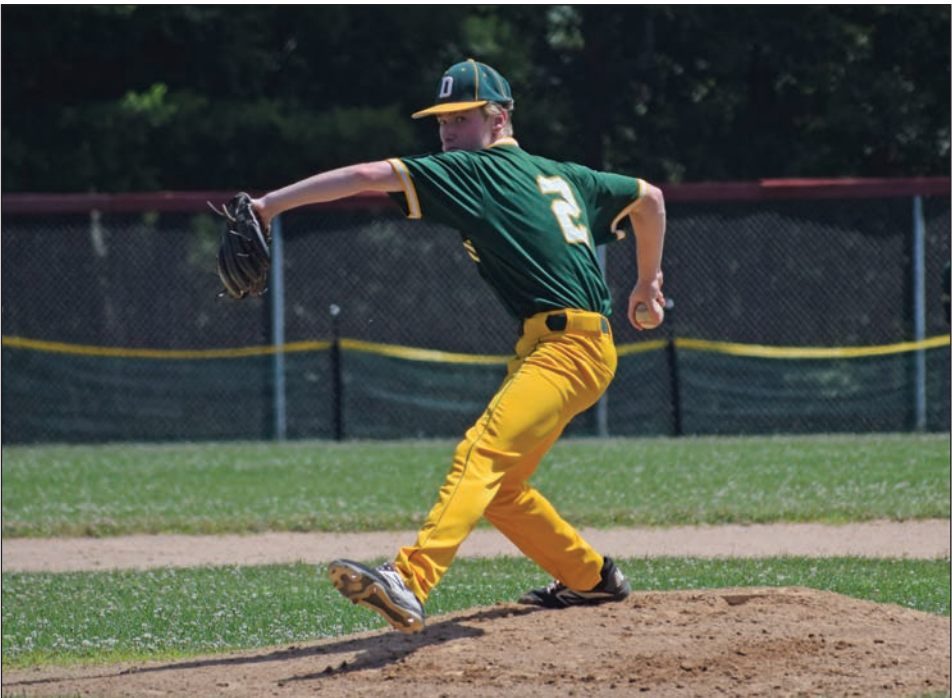

# Weston tops Killingly in championship game

NEW BRITAIN — Surrounded by his teammates Killingly High senior linebacker Jonathan Creswell presented coach Chad Neal with a football signed by all the players following the Class M state championship at Veterans Stadium last Saturday. It wasn’t the game ball that Killingly wanted badly — Weston High defeated the Red Hawks 27-6 — but that autographed football represented a journey some thought Killingly could never make.

“I think we overachieved. Going into the season we knew we could be decent but we knew we had to get better throughout — and they got better throughout,” Neal said. “They just started believing in each other.”

That belief ran into a chilly reality on a rainy Saturday in December. Weston put Killingly on its heels on the opening snap — with senior quarterback James Goetz tossing a 50-yard touchdown pass to junior John Cassol on the Trojans first play from scrimmage.

“The very first play, it definitely hurt,” said Killingly senior safety Jackson Lopes. “But we responded. We just didn’t have enough in us.”

Only 17 seconds had ticked off the scoreboard and Weston led 7-0. Killingly pulled to within one point with 2:10 left in the first quarter, with senior quarterback Jacob Nurse bulling in from the 1-yard line. Chris Jax’s extra point attempt was blocked and Killingly trailed 7-6. It was a quick answer to the Trojans score but Nurse’s touchdown was the only time Killingly found the end zone on at Veterans Stadium.

“We couldn’t finish today. We couldn’t finish on third and fourth down,” Neal said. “They had so much team speed. Even when there was something it closed so quickly. And they did a great job of closing the gaps down and recognizing formations, and what we did.”

Killingly never got its running game in gear. Killingly’s featured back, sophomore Jack Sharpe, was limited to 55 yards on 15 carries.

“They were just physical,” Neal said. “Whatever we tried to do they had an answer for it.”

Lopes picked up 61 yards on 14 carries.

“They brought everything. They game-planned us well,” Lopes said. “Sometimes they just got the best of us.”

With its run game stalling — Killingly could not effectively pass. Nurse completed 6-of-9 passes for just 37 yards.

“They were just doing a good job of filling the holes and being physical and doing what they’re supposed to do,” Nurse said. “Usually the run sets up

the play-action pass and today with the run not working it was hard for the play action to work a lot.”

Killingly could not contain Weston’s senior quarterback — Goetz rushed for 102 yards on 15 carries and passed for another 117 yards.

“The kid’s just slick,” said Lopes, Killingly’s safety. “I mean (Goetz) read our defensive ends well, made great plays. Hats off to him. He was the best we’ve seen all year, riding with the fullback and pulling away. Sometimes I thought the fullback had the ball four yards down the field — next thing, I turn around and (Goetz) is on the outside.”

Goetz craftily executed the Trojans’ read-option offense — either handing off to senior fullback Tyler Bower (21 carries for 91 yards and three touchdowns) or keeping the ball himself.

“I thought we could win the battle in between the tackles and we didn’t today,” Neal said. “(Bower) was an absolute

nightmare for us today. He just ran physically through us and was a difficult player to tackle.”

Creswell and Chris Jax — both linebackers — were tasked with reading Goetz. They said he was the best they’ve faced all season, running the Trojans offense to near perfection.

“They’re a really good football team, a well-coached football team. They have a really strong offense, a good line, and they ran that zone and (Goetz) is hard to read. Half the time you’d think (Goetz) had the ball in and then he wouldn’t have the ball in, he’d run down field on the other side,” Jax said. “But this senior year was something special. Making it here, it’s something to cherish. We came up short. They’re a really good football team, well coached. At the end of the day they played better than us.”

Goetz’s deception and split-second decisions kept Killingly off-balance. Killingly was able to sack Goetz just once, for a four-yard loss with

2:10 left in the game, when the outcome was decided.

“(Goetz) was really good with his fakes and he read our ends really well, even read me. They had a block coming around and there would be a jet sweep and he would just pull it out, keep it, and go right up the middle. He was creating lanes up the middle and he was really good — he was probably the best runner we’ve played all year,” Creswell said. “He had great hips and he was making guys miss.”

Following Nurse’s 1-yard touchdown run that pulled Killingly within 7-6 with 2:10 left in the first quarter — Weston scored twice before halftime. Bower scored on runs of eight

Just this past Thanksgiving Gram took one last trip back home to Connecticut where she visited her family and celebrated her 91st birthday with all of her children, grandchildren

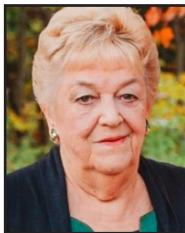

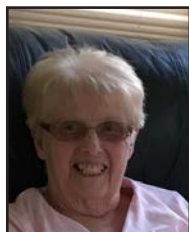

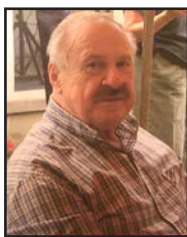
