# Volunteers needed for fall cleanup at Manchaug Pond



SUTTON/DOUGLAS — The Manchaug Pond Foundation will be holding their Fall Clean Up of scenic Manchaug Pond on Saturday, Oct. 24, volunteers are invited to join members and Friends of the Manchaug Pond Foundation in cleaning up Manchaug Pond and its watershed. Volunteers with boats are also welcome to help us clean up coves.

The effort is scheduled to take place Saturday, Oct. 24 from 9 a.m. to noon, with volunteers meeting at the state Public Access Boat Ramp on Torrey Road in Sutton. Volunteers will hit the pavement with garbage bags in hand to

clean the roadsides, shoreline, and boat ramp - all areas within the Manchaug Pond watershed. Good company, beautiful scenery, safety vests, rubber gloves, and garbage bags will be provided. Masks will be required while at the boat ramp meeting area, hand sanitizer will be available, and we ask that everyone follow state regulations for social distancing when possible. Rain date will be Sunday, October 25th and the rain date notice will be posted on the Manchaug Pond Foundation's Facebook page and website.

The Manchaug Pond Foundation's educational events look to improve the water quality of the picturesque

380 acre community lake, which lies within Douglas and Sutton, through the education of the many users and watershed residents. # Vietnam veteran assaulted while promoting Trump

DOUGLAS — Police say a 73-year-old Vietnam veteran was recently assaulted in Douglas while promoting Donald Trump.

As a result of the incident, police have arrested 34-year-old Douglas resident Kiara R. Dudley. Dudley is being charged with Assault and Battery on an Elderly Person Causing Injury, according to reports.

Last Saturday, the Douglas Police Department received several 911 calls for a disturbance at the intersection of Main and Webster Streets in town. Upon arriving at the scene, officers learned that a couple from Douglas were located at the intersection promoting Donald Trump with their flags and signs. Approximately 30 minutes after the couple arrived, they were approached by a party opposing their support of Donald Trump, police said in a statement.

According to police, the party began to “berate them with insults and demanded that they leave.”

“As the couple tried to move away, the party continued to follow them and bumped the gentlemen with her body,” Douglas police said. “At one point, the party stepped on the [victim’s] Veterans for Trump sign and as he bent over to pick it up the party knocked him to the ground causing an injury to his finger.”

The incident has garnered much attention on social media, being shared more than one thousand times from the Douglas Police Department’s Facebook page.

Dudley was released on \$250 cash bail, and was arraigned in Uxbridge District Court earlier this week.

# Milford police to hold prescription drug take back day

MILLBURY — National Prescription Drug Take Back Day is Saturday, Oct. 24, from 10 a.m. to 2 p.m. The event is described as one of the U.S. Drug Enforcement Administration’s “most popular community programs,” and the Milford Police Department is participating by holding its Prescription Drug Take Back Day this weekend.

The event is slated for tomorrow at the Milford Senior Center.

“The public can dispose of their unwanted prescription medications at the Milford Senior Center located at 60 North Bow Street, with the assistance of the Milford Police

Department,” the department released in a statement. “The collection site will be located outside the front entrance to the Milford Senior Center.”

This initiative addresses a vital public safety and health issue. According to the 2018 National Survey on Drug Use and Health, 9.9 million Americans misused controlled prescription drugs. The study shows that a majority of abused prescription drugs were obtained from family and friends, often from the home medicine cabinet.

“Medicines that languish in home cabinets are highly susceptible to diversion, misuse, and abuse,” police said. “Rates of prescription drug abuse in the U.S. are

alarmingly high, as are the number of accidental poisonings and overdoses due to these drugs.”

DEA launched its prescription drug take back program when both the Environmental Protection Agency and the Food and Drug Administration advised the public that flushing these drugs down the toilet or throwing them in the trash posed potential safety and health hazards.

Last October, during the Take Back Day, the DEA New England Field Division participated in the event, according to reports. Nationwide, a total of 4,896 law enforcement agencies participated, and over the course of four hours, 882,819 lbs. of expired, unused, unwanted prescription drugs were collected at 6,174 collection sites throughout the country. In Massachusetts, 183 law enforcement agencies participated, collecting a total of 30,959 lbs. of unwanted and unused prescription drugs.

“Please help us in keeping our community safe from this dangerous hazard,” police added.

As per Covid-19 protocols, police are asking participants to practice proper social distancing and wear a face mask.

# Small Stones Festival announces Juliet Feibel as awards ceremony’s keynote speaker

GRAFTON — Small Stones Festival of the Arts (SSFA) presents Juliet Feibel, executive director of ArtsWorcester as the keynote speaker for the Festival’s live awards ceremony Oct. 23, 7 p.m. The winning artists will be declared in the fine art painting and drawing and photography categories for first (\$500); second \$250 and third (\$100) place, juror choice and popular choice awards. Feibel will discuss how the COVID-19 pandemic has impacted the local arts community from a positive and negative perspective. A native of St. Louis, Mo., Juliet Feibel has worked across nonprofit management, membership organizations, the arts and higher education. Leading ArtsWorcester since 2011, she previously served as director of education for the Ann Arbor Art Center and as associate director of Imagining America, a national arts and humanities project and worked for non-governmental organizations in Vietnam and Thailand.

Feibel participated as a juror in the fine arts painting and drawing category during the Festival’s 2018 inaugural year when three art associations – Apple Tree Arts, Worcester County Camera Club and the Blackstone Valley Art Association collaborated to create a regional juried arts and music festival.

The 2020 Festival is newly envisioned to comply with pandemic safety requirements. In early October, the online exhibit opened and several fine art and photography live virtual talks were held. Donna Dufault and Scott Erb of Erb/Dufault photography will present the basics of marketing for artist workshop Oct. 21. Juror talks with fine art juror Jim Welu, director emeritus of Worcester Art Museum and photography juror Ron Rosenstock, a renowned photographer are slated for Oct. 23. The Festival concludes Oct. 25 with an extraordinary piano concert with Stephen Drury who will perform

Rzewski’s masterpiece “The People United Will Never Be Defeated” and the world premiere of “Apology” by Anthony Green.

A panel of six independent art professionals have curated the show. For this year only, the first 500 entries submitted have been displayed online. The jurors will select 144 pieces of artwork to be published in the Festival’s catalog as well the prize winners and juror choices. The Festival’s printed catalog may be purchased after Oct. 23.

The mission of the Small Stones Festival of the Arts is to elevate the practice and appreciation of fine art and photography in the Blackstone Valley and beyond. # Online auction takes place of Douglas library book sale

DOUGLAS — Every year, the Friends of the Simon Fairfield Public Library host an annual book sale during Oktoberfest in Douglas. It is always the biggest event of the year, and brings in donations that help fund Library programs, community outreach and much, much more.

Due to COVID, there was no Oktoberfest this year. The Friends still wanted to do something, though. The idea of a socially distanced book sale was briefly floated and sunk. Anything physical was just too risky. With so much happening online already, though, what's left that can get people excited? The Friends were brainstorming this one Saturday morning on Zoom when Ellie Chesebrough had a grand idea.

Ironically, the idea for an online auction didn't start with

books. The thought was to gather donations of items from local craftspeople, businesses, and individuals to place for bid and then have those items available for pickup at the Library. It wasn't until after the fact that it occurred to someone to make bundles of books to add as auction lots in lieu of the Oktoberfest book sale, start the auction on the date Oktoberfest would have been, and call it the Fall Online Auction.

Spearheaded tirelessly and relentlessly by Donna Kmetz, local library super-patron, the Friends created an online auction Web site and began soliciting donations with the help of Paul Peterson, Bettina Simpson, and many other volunteers. As word got out, it seemed almost everyone who got wind of the auction had something they wanted to put in. It became a wonderful community showcase for our local merchants, talents, and pure generosity from all who contributed and bid. In a matter of weeks, the Friends accumulated an impressive catalog of 219 items from 55 total donors: gift certificates, antiques, vacation rentals, folk art, book bundles, golf rounds, and more!

The auction started Oct. 3. In 11 days, 103 people registered to bid, 502 bids were placed, and the Friends of the Library ended up netting \$10,197 in high bids! The Friends are going to donate all the proceeds from this auction into the Douglas Library's interest-bearing building fund, where it will bring the Library ever closer to its goal of handicap accessibility. This won't be the last auction, though. Many people heard about this one too late, and there are already people offering items to go in "the next one." So stay tuned! And thank you to everyone who donated and everyone who placed bids.

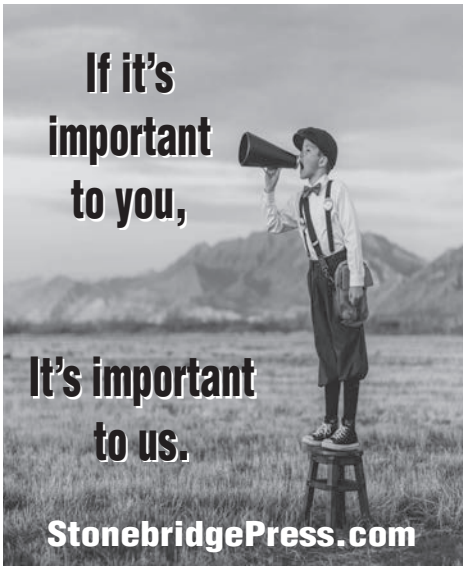

## One dead after accident in Mendon

MENDON — One man has died after being involved in a recent motor vehicle accident in Mendon.

According to police, emergency personnel from the Mendon Police Department and Mendon Fire Department responded to reports of a motor vehicle collision on Providence Street at the intersection of Hartford Avenue East. The accident took place last Sunday at approximately 1:40 p.m.

Upon their arrival, officers found that a 2003 Harley Davidson motorcycle and a 2004 Hyundai Santa Fe were involved in a collision at that location.

"Both vehicles had sustained significant damage from this collision. The female operator of the Hyundai was evaluated by Fire Department personnel. This vehicle also contained two juvenile occupants who were also evaluated," police said. "The male operator of the

Harley Davidson was found lying next to his motorcycle with serious injuries. He was later transported by the Mendon Fire Department to UMass Hospital in Worcester."

Later that evening, the Mendon Police Department received notification that the male operator had passed away at UMass Medical Center, according to reports.

The preliminary investigation indicates that when the vehicles collided, the Harley Davidson was traveling Southbound on Providence Street, while the Hyundai Santa Fe was performing a left-hand turn to travel Northbound on Providence Street.

The immediate area of Providence Street and Hartford Avenue was closed and traffic was detoured during the crash. Police said the remaining facts and circumstances remain under investigation by the Mendon Police Department and Worcester County District Attorney's Office.

# New water restrictions issued for Aquarion customers in Millbury

MILLBURY — Due to months of below-normal rainfall, the Massachusetts Executive Office of Energy and Environmental Affairs (EEA) declared a Level 3 - Critical Drought in the Southeast Region. The other six regions across the state — the Western, Connecticut River Valley, Central, Northeast, Cape Cod, and Islands regions— remain at a Level 2. At a Level 2 – Significant Drought, conditions are becoming significantly dry and warrant an emphasis on water conservation and more stringent watering restrictions.

Aquarion’s water system serving Millbury, MA receives a portion of its water supply from the City of Worcester. Due to

the drought conditions, the City of Worcester is now at a Stage 1 Water Supply Alert. As such, Aquarion is enacting water use restrictions with the goal of reducing water use by 10%. The specific restrictions are listed below.

Stage 1 Water Restrictions

For All Water Users

As it is late in the year and most irrigation systems will soon be shut off for the season, residents with irrigation systems are encouraged to shut them off immediately.

Water waste is prohibited, including:

Failure to repair a controllable leak, including, broken sprinkler heads, water services, fire pipes, leaking valves, leaking or broken pipes or faucets;

Knowingly operating an irrigation system with (A) a broken head; (B) a head that is out of adjustment and spraying into the street, parking area, or sidewalk; or (C) a system that is misting/fogging due to excessive water pressure; or

Allowing irrigation water to: (A)run off property forming a stream of water for a distance of 50 feet or greater; (B) run into a storm drain; (C) pond to a depth of 1/4 inch or greater; or

Allowing or causing an irrigation system or lawn watering device to operate while it is raining or when temperatures are at or below 32 degrees Fahrenheit.

For Government

Reduce non-essential water use. As used here-

in, non-essential water uses are those that do not have a health or safety impact and are not needed to meet the core function of the department.

Shut down all town operated irrigation systems and fountains For Commercial, Industrial, and Institutional Business

Identify and repair leaks on private plumbing, automatic irrigation systems and service lines.

Reduce exterior washing of vehicles at commercial facilities such as automobile rental, sales and service operations, taxi companies, trucking facilities and commercial garages where less than 50% of the water used is recycled.

The washing of garbage

trucks and vehicles used to transport food and/or other perishables may take place as necessary for health, sanitation, or public safety reasons.

Prohibit washing of paved areas by any means except where a variance is granted to alleviate a possible public health and safety risk.

For Residential Properties

- Identify and repair leaks on private plumbing, automatic irrigation systems and service lines.
- Prohibit washing of paved areas by any means.

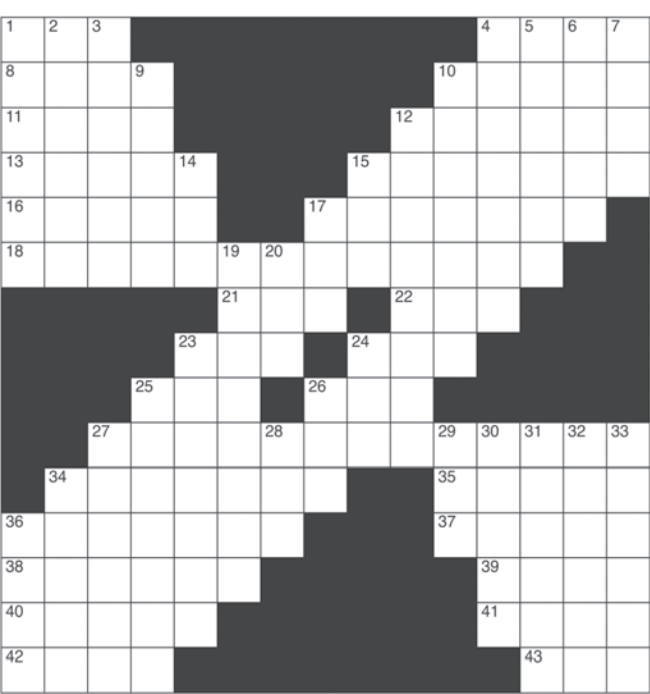

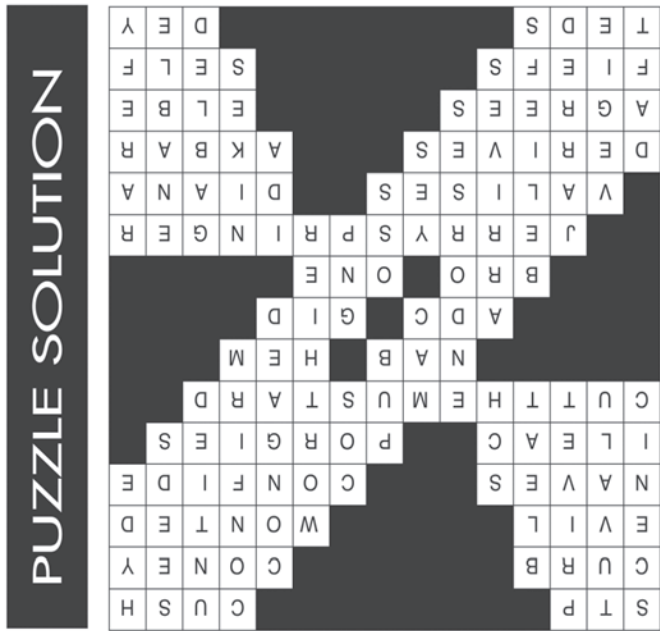

# Although “Born in the USA,” The Boss may be packing his bags

I guess his hit song, “Born to Run” may turn out to be prophetic. Bruce Springsteen announced last week that if President Trump wins re-election, he’ll be on the next plane to Australia.

It seems to happen every election cycle. A celebrity ... usually an actor or singer ... makes the grand announcement that if the election does not go as they wish, they will move to Canada, France, Australia, or some distant land. Like a spoiled child, their threats are made as if they honestly believe it will change voting hearts and minds.

Barbara Streisand and other celebrities have made similar threats during past elections. Mötley Crüe’s Tommy Lee told The Big Issue recently that he’ll go “back to my Motherland.” (Wherever that is.) But is there any evidence that they ever really leave? Do their threats change anything?

There is a pattern. It’s almost always a musical performer or actress/actor ... and it’s usually someone from left of center making the threat. The next part of the pattern is that it always seems to back-

fire, having the opposite of the desired impact, and the final step of the pattern is ... they never actually leave.

I’m always surprised by how much political power celebrities believe they carry. Why would Springsteen think we care about his political views and what would bring him to the conclusion he would sway a single vote?

Arrogance, maybe?

When Bruce, Barbara, Tommy Lee and others spend years stepping onto a stage to standing ovations and adoring crowds, I think the thrill of the adoration gives them a false sense that because we enjoy their performance, that we are willing to take their directions on politics and general life. I respect the views of Bruce and his activist group of entertainers, but their successful lifestyle is nothing like the life that those without the same talents and opportu-

nities live. In my opinion, the only thing to come from Bruce Springsteen’s threat to leave the USA is that he has totally shattered his “blue-collar-common-man persona” forever.

So why do we look to Bruce for direction?

We don’t.

Only Bruce, and a few others are narcissistic enough to believe we do.

And it has nothing in my mind to do with left or right ideology. I read this morning that President Trump said, “If Biden wins, maybe I’ll have to leave the country.” My response is the same to our President as it is to the celebrities on the left ... “Go!” If President Trump loses the election, I don’t care where he lives, if he leaves the White House in an orderly and peaceful transition ... and I believe he will.

I’m not an America, “Love it or leave it” kind of guy, but these kind of threats from entertainers have grown tiring and I believe ineffective.

We assume Bruce lives somewhere in New Jersey, but we really don’t know. I

always assume Streisand is somewhere in California, but it doesn’t matter to us where they live. Does their address impact our lives in any way?

When the Beatles exploded into our lives, we heard and saw them so often, they could have been the garage band next door. The fact they lived across the ocean didn’t limit their exposure. If Bruce moves to Australia and releases a new album, does he think the distance will somehow limit the play in the USA and therefore punish us by depriving us of his music? If the album is good, it will get just as much play as if he were still in New Jersey.

So, what’s the point?

The point is that this exposes the false sense of influence and power entertainers believe they hold over our lives. Arrogance is never attractive. I think entertainers who become activists become less popular in their genre and often have the opposite impact on the public. Think not? Ask the “Dixie Chicks.”

I think comedian, Michael Loftus, said it best. “They really think they’re that important,” he said.

almost two-hundred and fifty years.

Vote. Make your choice heard. Don’t threaten anyone. Don’t lose friends. Don’t damage family relationships. Because half the nation, and many people you know and love, may feel and vote differently, it doesn’t make them wrong. It certainly doesn’t make them your enemy. I’ve always been a Streisand fan. I’ll still listen to Springsteen’s music wherever he lives.

Rather than being angry over politics, let’s celebrate the incredible opportunity that the American system provides. And once the final votes are counted and the selection is made ... let’s accept the will of the American people and move forward together.

May God continue to Bless America.

## A Roundup of Timely Tips

Fall is here, and from picking the last of the harvest crops to raking up (and jumping in) piles of fallen leaves, the chores of autumn season are a labor of love. Read on for a medley of seasonal tips that are geared toward making New England's favorite season a little more enjoyable!

While experts agree there's no bad time of day to photograph colorful fall foliage, they note morning and late afternoon often provide the most interesting shadows. And try later too: The golden light just before sunset highlights not only leaves on trees, but those on the ground too.

To preserve colorful fall leaves for decorating try this quick drying tip: Place leaves between two paper towels and microwave on medium one to 1 ½ minutes checking every 30 seconds for dryness. This will remove moisture from the leaves, and they'll retain their brilliant colors!

Outside garden chores are winding down, so here's some help for house plants! Using a flowerpot with large draining holes? Keep water in by placing a large coffee filter in the bottom of the pot. And if you cut and old sponge into small pieces and add it to the potting mix. You won't have to water plants as often.

A good soaking of rain last week sure helped alleviate the threat of brush fires and helped bring some of the small ponds and lakes water table up a bit, but we still need a few more inches of rain to get into the water table before a ground freeze, and it hopefully will happen this week.

The start of the Massachusetts bow hunting season started this past Monday in zones 1-9. Some white oak trees had a good number of acorns this year, while others had very few. Bowhunters setting up tree stands in the areas of a heavy drop of acorns, should increase hunters' chances of harvesting a deer. The heavy winds and rain of last week helped defoliate many trees, and made observing deer a lot easier as they approached a tree stand or ground blind.

Tree stands are the number one choice of most bow hunters, but as some deer hunters age, it is time for them to keep their feet on the ground. Numerous fatal or serious injuries happen every year by hunters falling from a tree stand. If you do hunt from a tree stand you need to be sure you use a safety belt or harness. Even then they do not protect a hunter from falling from a tree stand, as most accidents happen while climbing

into their stand. The most popular tree stand is a ladder stand, but they too can be dangerous. Ground blinds work very well for deer hunting, and keep a hunter a bit warmer and dry during the hunt. They also work very well for deer hunters that bring along their son or daughter, introducing them to the sport of deer hunting. There are more women that hunt deer and birds than ever before. Hunting is not for everyone, but if they enjoy the sport, they will get to enjoy quality time with their adult parent, and will hopefully pass it along to their children.

Hunting during the rut is the most exciting time to be in the woods, and will make your chances of a deer encounter almost a guarantee. It is also the time of year to harvest that big buck that has avoided you for many years. They often let their guard down as they chase a doe in heat, and if you are in the right spot at the right time, you could get lucky and harvest the deer of a life time.

Cleaning and field dressing a deer needs to be done properly, or you could taint the meat, making it uneatable. Many people that do not like eating venison have more than likely had venison that was not properly cleaned and packaged. A lot of venison is ruined during field dress-

ing. There are plenty of videos that can be watched on YouTube. Taking the time to watch one can insure some great eating in the coming weeks and months. Choosing the correct meat cutter to process your deer is very important, and be sure that you are getting your deer meat, and not someone else's.

Proper dressing of the trophy deer that you are planning to take to a taxidermist also needs special care. Be sure to check that out also on YouTube or from your taxidermist. Choose the right Taxidermist & be sure to ask the following questions. What is the final cost? How long will it take before I get my mount back? Ask to see some of his or her work. Ask for references, and never pay in full before you receive your mount back.

Tautog fishing remains great as this week's picture shows. Recently stocked trout are being caught at some local hotspots. Check out the stocked waters by going to Massachusetts Fish Hunt Web site. One local angler caught a huge rainbow trout at an undisclosed site last week.

Goose and duck hunting were great for most hunters last week, but the absence of mallard and black ducks were noticeable in many areas. Wood Duck were providing the best shooting opportunities.

# Fall garden tasks to protect your landscape from winter wildlife damage

To protect plantings from rabbits, use fencing that is at least four feet tall or a repellent that discourages them from dining on plants.

As the seasons change, we adjust our gardening tasks and plantings to match. Animals also make changes this time of year, often changing their eating habits and dining locations. These adjustments can impact your gardens. Reduce the risk of damage by starting in fall to protect your landscape from hungry animals this winter.

Take a walk around your landscape to evaluate plants and plantings for their susceptibility to animal damage. Look for pathways that animals use to access your landscape and areas of potential damage. Note new plantings, animal favorites and those special plantings you would hate to lose. Make sure these are protected. Check mulch around trees and shrubs. Deep layers of mulch and mulch piled around the trunk of trees and the base of shrubs provides shelter for mice and voles. These rodents like to gnaw on the bark of trees and shrubs in winter. Pull mulch off tree trunks and stems and spread out deep mulch so it is only two to four inches deep. Protect young trees and shrubs with

like organic Plantskydd (plantskydd.com), that is rain and snow resistant, lasting up to six months on dormant plants over the winter so you will need to apply it less often.

Scare tactics may be effective depending on where you live. In urban and suburban areas animals are used to human scents and sounds. Gardeners often hang old CDs and shiny ribbons in tree branches to scare hungry animals. If you opt for scare tactics, be sure to employ a variety of options and change their location to increase your chance of success.

Constantly monitor and evaluate the effectiveness of the methods used and check all plantings for damage. When animal populations are high and hungry, they will eat about anything. Be willing to change things up if one method is not working. Using multiple

tactics will help increase your level of success.

Protect your landscape from hungry deer, rabbits, and voles this winter. Start preparing in fall before their winter dining habits begin. If you are vigilant and persistent, you can coexist with these creatures and still have a beautiful landscape.

## Latest antiques, collectibles, and auction news



### ANTIQUES, COLLECTIBLES & ESTATES

It has been over a month since my last antiques, collectibles, and auction news report. A lot has happened since. Let's begin with an upcoming Halloween auction in Ireland.

The Irish Times reports that Mullen's Auctioneers of Dublin, Ireland will be holding a Halloween auction. The auction features many prints, photos and medals related to historical events in Ireland. There are two items fitting for an auction on Halloween. A movie poster from the 1958 film "Dublin Nightmare" which has an estimate of 150 to 200 Euros (approximately \$175 to \$235 U.S. dollars) will be one of the offerings. A death mask of Irish novelist James Joyce is the other. The Irish Times reported that Joyce's wife Nora authorized sculptor Paul Speck to make two death masks of Joyce when he died in 1941. Speck made an additional mask for himself. The two authorized masks are owned by the James Joyce Foundation. The third was sent to the Irish Library of Congress. Speck made 6 bronze castings before he presented the mask to the Library of Congress. Speck gave one of the castings to film director James Huston. Huston in turn had 12 more bronze castings created by Lunt's Castings. One of the 12 Huston created will be auctioned on Halloween. Its auction estimate is 1,500 to 2,000 Euros (approximately \$1,750 to \$2,350).

There are very few paintings by 15th Century Renaissance painter Sandro Botticelli in private hands. It's rare for

one to come up for auction, but this noteworthy event will take place in January, when his "Young Man Holding a Roundel" will be offered. A Mutual Art article states that "Botticelli's striking paintings in the late 15th-century made his work sought after by

some of Europe's richest patrons, and his works' appeal was widespread." CNN reports that this painting was produced in the 1470s or 1480s. According to Mutual Art: "it's reasonable to assume that the sitter is an elite nobleman, due to his high quality clothing and pensive, refined appearance." The current owner purchased it for £810,000 (a little over \$1 million U.S. at the current exchange rate) in 1982. Despite the pandemic, the auction house and the consignor have found the auction market to be resilient. The auction estimate on the painting is \$80 million.

A Kalamazoo, MI couple recently found that their \$5 estate sale buy may be worth thousands, according to WWMT TV. The husband bought a poster rolled up in a tube without a price. He collects movie posters and thought that's what he was purchasing. He offered \$5. The seller accepted and the buyer gave the tube with the poster to his wife. It sat in their basement for five years until their son was searching for some wall art. He looked through the items his parents had accumulated and opened the tube with the poster. It was much larger than the family expected.

WLNS TV reported that the poster they thought to be movie poster size was instead a whopping 8 feet x 13 feet large. The poster was produced by Air France in 1959. Their research determined that it was an original lithograph created by French artist Lucien Boucher. It depicts aircraft flying to destinations around the globe. The couple found auction results for a similar piece that sold for 18,750 British pounds (over \$24,000 U.S.) in 2014. The couple decided to donate the poster. WWMT reported that the airline map is expected to land at the Smithsonian National Air and Space Museum.

Bidding ends on Oct. 28 for our online coin auction. Our next auction featuring gold estate jewelry, sterling silver, pocket watches, World War I and II Red Cross posters, a 1931 Auburn automobile and a wide selection of other antiques and collectibles will be online soon with bidding ending November 17th.
