The project consisted of bags for each child that included blankets, stuffed animals, clothes, hygiene items including a mask and sanitizer, and perhaps most important – a personalized letter of reassurance from Barstow.

“Many of these children going through a very traumatic time,” she said. “Giving them a care package with a blanket, a book, a stuffed animal, and more gives provides a little bit of comfort.”

Her goal was to create 100 bags, but the project ended up doubling that number, all of which she donated to the Department of Children and Families. Barstow said

The Woodstock Academy boys’ and girls’ cross-country teams continued their winning ways, both improving to 4-0 on the season with a pair of recent victories.

In a meet with Tourtellotte on Wednesday, Oct. 21, both teams posted 15-50 scores against the Tigers. Senior Ethan Aspiras won the boys’ race, covering the West Thompson Dam course in 17 minutes, 10 seconds. Tourtellotte’s Brayden Cutler finished second, followed by the Centaur’s Seamus Lippy (third) and Adam Thompson (fourth).

The girls’ race was won by WA’s Brooke Bergevin, who was followed across the finish line by teammates Linsey Arends and Leah Castle.

On Saturday, Oct. 17, both Woodstock Academy teams again won by matching 15-50 scores, this time over Killingly at home. On the boys’ side, Aspiras was again victorious, covering WA’s 5K course in 18:29. He was followed by

teammate Vince Bastura. The Centaur’s Max Auker finished fourth while Lippy was fifth. Lance Groh was 0-2 Killingly’s top finisher, coming in third.

In the girls’ meet with Killingly, Bergevin led the way for WA, finishing first (21:07). She was followed by teammates Tessa Brown, Carah Bruce, Julia Coyle and Talia Tremblay.

Volleyball

It was a Senior Day celebration to remember for the Centaur’s, who enjoyed a straight-set win over the Windham Tech Whippets on Friday, Oct. 16, in front of an intimate gathering of family members.

Leading the way in the 3-0 victory — 4-1 Woodstock’s third straight — were outside hitter Gabby Garbutt, defensive specialist Marissa Mayhew and setter Tabby Bezanson. Garbutt had seven kills and 10 service points in the game while Mayhew recorded 16 digs and 13 service points and Bezanson added 20 assists.

Garbutt, Mayhew, and

Bezanson, along with classmates Sierra Bedard, Amelia Large, Kileigh Gagnon, and Sara Cotillo Soria, were honored before the game for their service to the team and the Woodstock athletic community during their careers.

The Centaur’s made it four wins in a row on Friday, Oct. 23, defeating Putnam High, 3-0. Fours were wild for Garbutt against the Clippers; she finished the match with four kills, four digs and four aces. Also contributing to the win for 5-1 Woodstock Academy were Large (seven kills) and Bezanson (four aces, eight assists). Putnam (1-3) was led by Abby St. Martin, who recorded six kills and three blocks.

Boys’ Soccer

Like its volleyball counterparts, the Woodstock Academy boys’ soccer team celebrated Senior Day in style, defeating Parish Hill, 5-0, on Wednesday, Oct. 21. Seniors Andrew Johnson, Huck Gelhaus, Marco Maluf and Colin Smith all scored for the 6-0 Centaur’s, as did junior Ty Morgan.

Touring Killingly’s cemeteries

Tomorrow is Halloween, so naturally, I have been thinking about the symbolism that accompanies the holiday. One often sees decorations of tombstones engraved with the letters R.I.P. Did you realize that Killingly has 73 known cemeteries/graveyards? The Hale

Cemetery Collection, compiled during the Depression, lists marked burial until the mid 1930’s. Since it is accessible online, and the Web site find-a-grave has additional burials, if you are researching ancestors, it is possible to do so long-distance. I’ve really been enjoying seeing tombstones of my ancestors who died in Pennsylvania.

James A. Slater’s “The Colonial Burying Grounds of Eastern Connecticut and the Men Who Made Them” contains a wealth of information on the men who carved some of the stones in the earliest burying grounds. In Killingly Slater attributes stones to the following: the Killingly egg carver (21), Elijah Sikes (23), Spalding (9), Roberts (4), Soule (8), Bartlett (1), Barker (17), G. Allen 5), Oneco White-stone carver (4), B. Collins (5), Manning (1), and Stephen Hartshorn (2). There are also unknown slates and sunbursts. In Brooklyn there are 32 stones by Sikes in the Old Brooklyn Cemetery and 21 stones by Soule in that same cemetery. In that town there are also stones by Manning, perhaps Barker, R. Kimball, Bartlett, Hodgkins, L. Kimball, G. Allen, J. Stevens, Jr., Haskins, and the Killingly Egg carver. There are 6 Boston-area slates and three sunburst slates.

Another known grave-stone carver from Eastern Connecticut was Joshua Hempstead of New London. Periodically he makes mention of carving them in his diary---Diary of Joshua Hempstead of New London 1711-1758.. “Thursd 2d (February 1720/1), fair. I was at home all day Cutting 1 pr gravestones. Jonat

1678. He lived his entire life in the house built that year by his father. It, along with the addition built by his own son Nathanael in 1728, is still standing and open to the public during the summer. The structure is known as the “Hempsted” House, the spelling used by the first few generations of “Hempsteads. Hempsted married Abigail Bailey of Long Island, probably in 1698. Their first child was born in July of 1699. The Hempsteads had nine children. A few days after the birth of their ninth child in 1716, Abigail died; five days after that their oldest son, aged 17, also died. Hempsted never remarried, bringing up the children with the help of relatives and women hired to do housework and spinning. He died in New London on December 22, 1758, about six weeks after his last diary entry.” (https://connecticut-history.org/joshua-hempsted-diary-a-window-into-colonial-connecticut/).

I find Hempstead’s Diary fascinating since it provides a window into the world of Eastern Connecticut, and indeed even Connecticut itself, since Joshua was a well-respected citizen, involved in the political dealings of the time, frequently appearing at Court. He usually recorded notes on the weather providing a glimpse of what it was like in this area the 1700’s. You may not know that this period has been termed “The Little Ice Age” so the climate was much different than it is today. Since I have no newspapers or diaries from Northeastern Connecticut from this time period, my curiosity sends me to the Diary. For example: Saturday, October 1, fair; Wednesday, 5th, fair; It continued to be fair so “wee mended ye house--& stacked up all ye hay & Spread ye flax &c.” Wednesday, 12, rainy; Sund 16, Rain. Mond. 17, “I set out for Newhaven with Ebe Dart. I lodged at Branford & got to New Haven Tuesd Morn 18ty. Tuesd. 25 I went to Milford in order to go to Stamford. Itt Rain & Some Snow at night, a violent Storm Wednesday night. I got (to) brother Hartshorns. Sister Lucy hath 5 Sons...” (p.103).

Now back to The Little Ice Age. “The Little Ice Age was a time period that saw winters in North America and Europe average approximately two degrees colder than the current era. Its coldest period is largely agreed by scientists to be between 1600 and 1800. A difference of two degrees may not seem like much but, in fact, does make quite a difference to daily life.

“‘A 1-2 degree Celsius temperature drop would have a significant effect on winter weather around North America,’ said Anthony Farnell, chief meteorologist at Global News. “Snow would arrive earlier in the fall and stick around longer in the spring. Borderline storms that now fall as rain or freezing rain would be more likely snow if it was just a couple degrees colder.’

Farnell went on to explain how an increase in snow compounded the situation in the 1600s. ‘When there is more snow on the ground, the albedo of the earth’s surface increases which means more of the sun’s warming rays are reflected back into space. This then leads to even colder temperatures and more snow which is how a series of cold winters can snowball into a little ice age.’ The nearly 200-year cold stretch began to decline soon after the first Industrial Revolution began in the United Kingdom in 1760.”

Will the election sink the markets?

Over the last few months, many people have been beginning to worry about what might happen to the financial markets at election time. The fear is that if we get a disputed election, it could lead to disruption and possibly even violence. If so, we could well see markets take a significant hit.

In 2000, the hanging chad debacle in Florida hit markets, and this election could well be even more disputed than that one. Markets also share the fear, in that expectations of volatility have spiked in November as measured in the options markets. From a political standpoint, unless there is a blowout win by one side or the other, we are almost certain to get litigation and an unresolved election, like in 2000. A substantial market reaction would be quite possible.

Should Investors Do Anything Differently?

Volatility concerns surrounding an unresolved US presidential election raises the following question: what, if anything, should we do about it? We think there are two answers here. For traders, people who actively follow the market, this might be a chance to try to make money off that volatility. This approach is risky—many try and not all succeed. But if you are a trader and want to try your luck, this might be a good opportunity.

For investors who have a longer, goal-focused horizon, my question is this: why should you care? One reader mentioned an 8 percent decline in S&P 500 index during the 2000 unresolved election. Well, we just saw a decline of just about that magnitude in September. We saw a decline about four times as large earlier this year with the COVID pandemic induced economic shut down. And, at some point in almost every year, we see a larger decline. So, we get a decline in November. So what? We see declines all the time. Over time, they seem to matter very little as it relates to long-term market growth.

Will We See Longer-Term Declines?

The real question here, for investors, is if we do see a decline, whether it will be short-lived or long-lived. Short-lived, we shouldn't care. Long-lived? Maybe we should. But will we get a longer-term decline?

We might. Looking at history, however, we probably won't. Every single time the market has dropped in a meaningful way, it has bounced back. The reason for this is that the market depends on the growth of the U.S. economy. Over time, markets will respond to that growth. If the economy keeps growing, so will the market. So, unless the election chaos slows or stops the growth of the U.S. economy over a period of years, it should not derail the market over the long term.

Could the election do just that? We doubt it very much. We could—and very likely will—see a disputed election result. But there are processes in place to resolve that dispute. One way or another, we will have resolution by Inauguration Day. While we will almost certainly have continued political conflict, we will also have a government in place. From a political perspective, any continued conflict should not disrupt the economy and markets any more than we are already seeing.

The political disconnect between the two sides is not going away. But we already are seeing the effects, and the election won't change that. The election will be when that disconnect will spike, but that spike will be around a distinct event with an expiration date. The effects likely will be real and substantial, but also temporary.

What Should Investors Do?

We certainly need to be aware of the effects of the election. But as long term focused, goal-oriented investors, we don't need to do anything. Like any specific event, however damaging, the election will (as others have) pass. We will get through this, although it might be rough.

So, Does Politics Affect the Economy?

If we look at politics in isolation, the effects on the economic growth rate, over the longer term, appear very limited. Does politics influence the economy? Of course. Is that effect significant over time? Not from a long-range perspective.

This discussion is as close—maybe closer—to politics as we like to get. We are not arguing for (or against) any individual politician or policy, which may well have had economic effects at a given time. We are saying that, as investors with a multiyear time horizon, history shows that the effects will likely even out over time.

You can see this with more immediate data as well. When Barack Obama was elected, many wondered what to do when the economy and stock market collapsed. When Donald Trump was elected, people had the same concerns. And, in the leadup to this election, many people are convinced that the end is near if the other side wins.

Look at the Long Term

From an economic point of view, growth comes from population gains, reinvestment of capital, and technological improvement. Regardless of who wins, all of those factors will continue.

So, our response to the Obama panic, the Trump panic, and the current panic is the same: look at the long term. Growth will most likely continue unless something new limits the US economy and the concept of capitalism as a whole.

This kind of analysis, and context, is the key to remaining calm. If we look back over time, we can see what is most likely to happen and why. Who wins the election certainly matters. Vote for your chosen candidate, because it is important. But one of the key reasons behind the success of the U.S. economy is the fact that it is largely independent of politics.

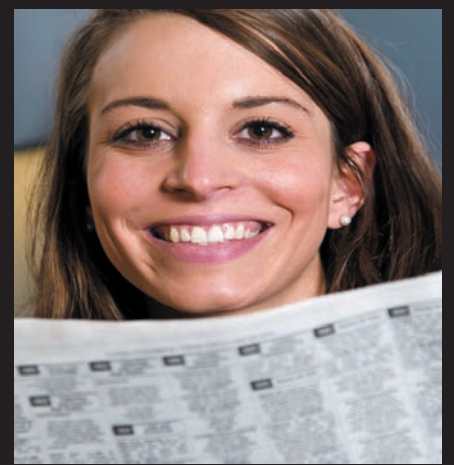

Glimpses Into the Future

In 2020 COVID has demonstrated just how tentative and fragile life can be. We have all witnessed how quickly governments can take liberties, and how quickly people give them up when their health and safety are at stake. The social unrest in our nation has also demonstrated how volatile our society can become and how much hurt lies beneath the surface. The uncertainty can make us wonder what the future holds. Luckily, there is hope.

I grew up on a church pew. As a child, I heard preachers explain Bible passages that predict that the world would become more tumultuous. Their contemporaries scoffed. I heard preachers

use Scripture to point out that someday there will be a global order and that everyone on earth will be given a number in order to buy or sell. Unbelievers mocked such an idea as impossible. Others pointed out that Scripture talks about a short period of peace in the Mideast. Those ideas were also dismissed as improbable. Yet here we are: many of those preachers have passed on, but their predictions are coming to pass. Come to find out, the Bible has accurately predicted the future for millennia, and continues to be a reliable glimpse into the future - and into eternity.

One of the most significant prophecies in the Bible predicts that even as our world experiences turmoil, many people will become believers, just before Jesus Christ (who died and rose from the dead 2000 years ago) comes back to “catch away” those who are looking for Him. Such a claim may seem far-fetched, but God is good enough to give open-minded people little glimpses into eternity by letting them see similar miracles in real time. For example, several years ago a colleague of mine, Lee Stoneking, who lives in upstate New

York, dropped dead in the airport in Sidney Australia. He was pronounced dead on arrival, but forty-five minutes, and ten shock treatments later, he came back to life. His story was so exceptional, that in 2003, he was invited to tell the whole world in a speech to The United Nations General Assembly. To date millions have viewed it on Youtube and other venues.

Jesus gave us all a little glimpse into the future. Here is one of his more famous predictions:

Later, Jesus sat on the Mount of Olives. His disciples came to him privately and said, “Tell us, when will all this happen? What sign will signal your return and the end of the world?”

Jesus told them, “Don’t let anyone mislead you, for many will come in my name, claiming, ‘I am the Messiah.’ They will deceive many. And you will hear of wars and threats of wars, but don’t panic. Yes, these things must take place, but the end won’t follow immediately. Nation will go to war against nation, and king-

dom against kingdom. There will be famines and earthquakes in many parts of the world. But all this is only the first of the birth pains, with more to come.

groups and spent the entirety of the clinic working exclusively in their group with one coach. Coaches and NOW staff kept face masks on throughout the event. Youth participants were allowed to remove masks during active play, as long as they were able to maintain at least six feet of distance from other persons present and were required to bring and play with their own soccer balls. Before being allowed onto the field for the clinic, each participant was asked if they were experiencing any signs or symptoms of COVID-19 and, if symptoms were present, they would have not been admitted to the event. Parents were welcomed to watch the clinic from the sidelines as long as they wore face coverings and maintained social distance from other individuals present.

NOW Executive Director

Sarah Wolfburg expressed the importance of keeping children active despite the limitations presented by the pandemic, commenting “Our organization’s mission is youth wellness and this year has presented unique challenges to keep children engaged in healthy activities. With the cooler weather setting in, it is important not to fall into unhealthy, sedentary habits. We wanted to do our part to offer opportunities for children to play in a safe way and we were grateful that Plainfield Youth Soccer worked with us to make sure this clinic happened. The feedback we’ve received from parents has been overwhelmingly positive. We hope that we can offer more activities as long as we can guarantee the safety of the children we serve.”

This is the second soccer clinic NOW has offered in collaboration with local youth recreation leagues over the summer and fall months. In August, NOW

hosted a clinic with Neconn Soccer Club, which saw 35 children attend. NOW is also in the process of planning additional indoor youth clinics for the fall and winter months in collaboration with the Hale YMCA Youth & Family Center in Putnam.

NOW is a non-profit human services organization focused on youth wellness. NOW provides children with the opportunity to participate in area wellness activities and athletics programs, offering scholarships to the youth of the community with up to 95 percent of the cost being subsidized by NOW. The mission of the organization is to provide ALL children, regardless of financial resources, equal opportunities to achieve & maintain youth wellness, beginning at an early age.

A spiced dessert for Halloween parties

Halloween party hosts may want to have a variety of treats on hand to satisfy the assortment of sweet tooths in attendance. Candy might be the first thing people think of on Halloween, but cakes and cookies can make for delicious treats as well.

Borrowing from the flavors of the season, including pumpkin, cinnamon and nutmeg, “Spiced Pumpkin Cake” from “Real Simple: Easy, Delicious Home Cooking (Time Home Entertainment)” from the editors of Real Simple can be a welcome addition to any Halloween spread.

Spice Pumpkin Cake
Serves 12

1 cup (2 sticks) unsalted butter, at room temperature, plus more for the pan
3 cups all-purpose flour,

spooned and leveled, plus more for the pan
5 teaspoons pumpkin pie spice
1 1/2 teaspoons baking powder
3/4 teaspoon baking soda
1/2 teaspoon kosher salt
1 1/2 cups granulated sugar
3 large eggs
1 15-ounce can pumpkin puree
1/2 cup whole milk
1/4 cup molasses
1 1/4 cups confectioners’ sugar
2 tablespoons fresh lemon juice

Heat oven to 350 F. Butter and flour a 12-cup bundt pan.

In a large bowl, whisk together the flour, pumpkin pie spice, baking powder, baking soda, and salt.

Using an electric mixer, beat the

ed sugar on medium-high heat until fluffy, 2 to 3 minutes. One at a time, beat in the eggs. Beat in the pumpkin puree, milk, and molasses (the mixture may appear curdled). Reduce the mixer speed to low; gradually add the flour mixture and mix until just combined (do not overmix).

Pour the batter into the prepared pan and bake until a toothpick inserted in the center comes out clean, 55 to 65 minutes. Let cool in the pan for 30 minutes, then invert onto a wire rack to cool completely.

In a small bowl, whisk together the confectioners’ sugar and lemon juice until smooth. Drizzle over the cake. Let set before serving.

• Tip: This cake can be baked and glazed up to one day in advance. Store, covered at room temperature.

Extend your enjoyment of nutritious pumpkins

Pumpkin is not just for desert. Consider using this low calorie, flavorful vegetable, botanically classified as a fruit, in any of the courses of your fall or holiday meals.

The beta carotene that gives pumpkin its orange color is an important antioxidant. Increasing the beta carotenes in your diet can reduce the risk of developing some cancers and provide protection against heart disease.

And do not throw the seeds in the compost pile, roast them instead and enjoy the anti-inflammatory benefits of this snack. Remove the pulp by rinsing the seeds in cold water. Spread the seeds in a single layer on a baking sheet treated with a non-stick cooking oil. Lightly salt. Bake at 325 degrees for 25 minutes. Stir the seeds after 10 minutes. Allow to cool and store any leftovers, if there are any, in an airtight

container.

Harvest pumpkins when the fruit is fully colored and the rind has lost its shine and is hard. The curly tendrils near the pumpkin will turn brown and die when the fruit is fully ripe. Use a pruning shear to cut the stem and avoid damage to the plant and your harvest. Leaving several inches of the pumpkin's stem intact increases their storage life. And look for blemish-free fruit with intact stems when buying pumpkins from the grocery store or farmers' market.

Always harvest pumpkins before the first frost. Or cover plantings with floating row covers, old sheets or blankets when frost is in the forecast. Protecting plants from the first few frosty nights can keep them growing until the remaining frost-free days of the season are back in the forecast.

Only store pumpkins free of soft spots, cuts and other damage that can lead to decay. Cleaning them before storing can help extend their shelf life. Wipe them down with a dilute solution of one tablespoon of bleach per gallon of water. Allow them to dry thoroughly before placing them in storage. Washing the fruit removes bac-

teria and fungal spores that can contribute to decay.

Store pumpkins in a dark, dry, cool location between 50 and 60 degrees for storage. Place them in a single layer on cardboard, crates or wooden shelves. Avoid storing them directly on a concrete floor that can lead to rot.

Check pumpkins regularly for rot and soft spots. Remove any that show signs of rot and add them to the compost pile. Pumpkins that are stored properly can last for several months.

Remember to take time this season to enjoy the harvest and flavor as you cook up some tasty, nutritious pumpkin dishes this fall.

How to prepare and cook pumpkin seeds

Nutrition and Halloween do not necessarily go hand in hand. While many parents may go to great lengths to ensure their youngsters' Halloween treats offer at least a little nutritional value, the bulk of costumed kids' hauls still tends to be candy.

Pumpkin seeds are one delicious yet often overlooked Halloween treat. According to Healthline, an online medical resource that aims to educate readers as they pursue their health and overall well-being, pumpkin seeds provide a host of health benefits. Data from the U.S. Department of Agriculture indicates that a single cup of pumpkin seeds can provide as much as 22 percent of a person's daily recommended value of dietary fiber. In addition, pumpkin seeds are loaded with vitamin K, which plays a role in blood clotting and bone metabolisms and helps to regulate blood calcium levels.

Pumpkin seeds tend to be easily accessible come Halloween, as they're right inside the pumpkins many who celebrate this ghoulish holiday turn into jack-o'-lanterns. When carving pumpkins this Halloween, people can forgo relegating pumpkin seeds to the garbage can in favor of cooking them. The following are some tips, courtesy of Whole Foods, to help Halloween celebrants prepare and cook pumpkin seeds.

- Remove seeds from the inner cavity. Pumpkin seeds may sometimes be covered in excess pulp. Upon removing the seeds from the inner cavity, wipe off the pulp and then spread the seeds out evenly on a paper bag, allowing them to dry overnight.
- Place the seeds in a single layer on a cookie sheet. Once the seeds have dried, they can be placed in a single layer on a cookie sheet. Roast the seeds in the oven at

a temperature between 160 and 170 F for 15 to 20 minutes. Whole Foods notes researchers found that roasting pumpkin seeds for more than 20 minutes can lead to unwanted changes in the fat structure of the seeds. To avoid such changes, make sure the seeds are not roasted for more than 20 minutes.

Once they have been roasted, pumpkin seeds can be served as-is as a delicious snack. Whole Foods notes that seeds also can be sprinkled into mixed green salads. Pumpkin seeds can even be ground with fresh garlic, parsley and cilantro leaves and then mixed with olive oil and lemon juice to create a delicious salad dressing. Chopped pumpkin seeds also can be added to cereals.

This Halloween, don't forget to add a little nutrition to celebrations by roasting some pumpkin seeds.

Experiment with Halloween bark

Festive Halloween treats can be easily concocted with a little imagination. Crafting a homemade chocolate and candy bark is one way to incorporate many of the candies and other treats synonymous with Halloween in a single delicious bite.

Let the bark cool and harden. It can then be lifted off of the pan and broken into pieces.

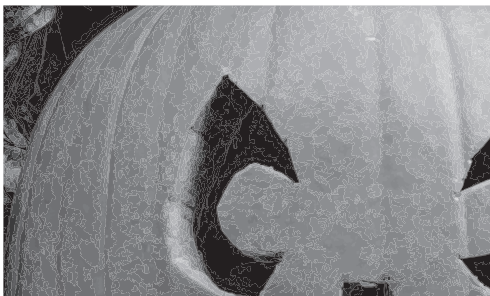

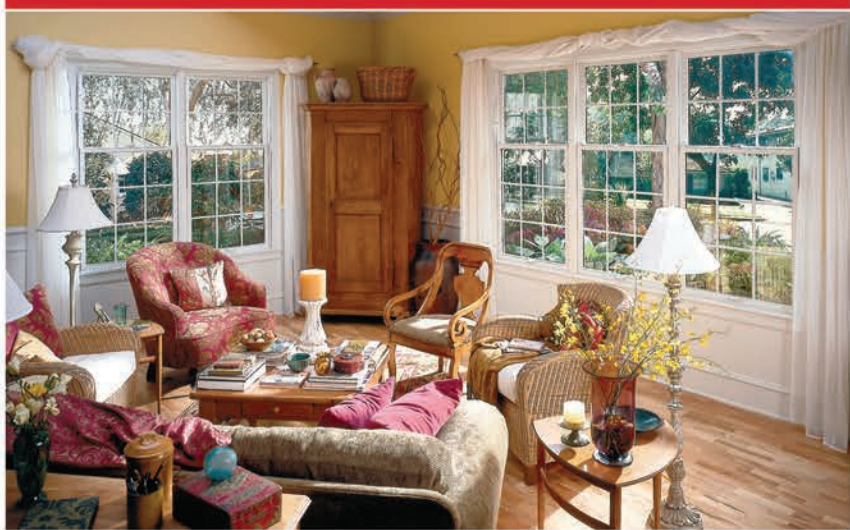
