# Lovvorn returns for rematch with McGovern

REGION – Challenger Tracy Lovvorn is bringing a re-energized platform into her Nov. 3 rematch with Congressman Jim McGovern for the Massachusetts Second Congressional District.

The Grafton Republican fell to McGovern, 67-33, in 2018, but she has since rallied her supporters around a nucleus of regional and state issues. These include healthcare reform, congressional term limits, infrastructure improvements, and protecting constitutional rights.

Frustrated with the ideas and policies of many elected leaders in Washington, D.C., Lovvorn hopes to bring a new voice to the mix.

"I worry about the country. I particularly do not like the direction the extreme left is moving in," Lovvorn said. "Today's Democratic Party is no longer the patriotic, hard-working party of JFK. I want to bring a new energy to Washington – a positive energy focused on unification and solutions. I am tired of being lied to by career poli-

## School District moves forward with reopening plans

SPENCER – School officials recently announced their plans to reopen more buildings this fall, assuming COVID-19 conditions don't significantly worsen

After consulting with the Board of Health, Spencer-East Brookfield Regional School District leaders plan to expand the hybrid model of learning. The district's two elementary schools have seen success with the alternating A-week/B-week hybrid model, which places students into cohorts to help maintain social distancing and reduce transmission risks.

Looking ahead, district leaders are targeting Monday, Oct. 26, as the return date for students in grades 4-8. Students would take part in the same alternating hybrid schedule as the elementary school level. High school students, meanwhile, would return to school on Monday, Nov. 16.

on Monday, Nov. 16.

The district's reopening plans are contingent on local COVID-19 case rates remaining manageable. District officials have been pleased with the use of social distancing and facial coverings in school buildings, which has paved the way for the current plans.

"I have every confidence we can open our schoolhouse doors to the students in these grades," said SEBRSD Superintendent Paul Haughey.

Phone calls, emails, surveys, and other outreach efforts began earlier this month to inform the school community of the reopening updates. School officials urge all parents and students to be aware of the safety policies and schedules ahead of the return dates.

"As we progress forward, it is important that everyone realize it is each and every single person's responsibility to remain vigilant with the safety protocols so that we are able to not only open our schoolhouse doors to the students of these grades, but keep them open," Haughey added.

School principals and administrators are in the process of communicating with each parent or guardian about safety protocols and expectations. For those seeking further guidance, virtual information sessions for families will continue to be held.

In addition to readying the reopening operations at the physical school buildings, district officials have also put together a comprehensive plan for transportation. AA Transportation officials have teamed up with school leaders to develop a plan that focuses on maximizing safety for students and drivers. This will require assistance from parents and guardians, as state COVID-19 regulations limit the number of students who can occupy a bus.

"AA Transportation continues to do an outstanding job of getting our young people to and from school. However, we need your help," Haughey said. "Our regional school district only

ticians. I am done with allowing them to advance their personal agendas and careers, instead of working for us in support of our needs."

Having practiced as a licensed physical therapist since 1997, Lovvorn is currently working to earn her Doctorate degree. As a wife, mother, healthcare provider, operational manager, and a small business owner, she thrives in the arenas of multitasking and planning.

"I grew up on a small farm, and I know the value and results of hard work and sacrifice. I lost both my parents at very young ages, and despite these challenges I worked hard, put myself through school, and attained success in both my personal life and career," Lovvorn said.

# Fall garden tasks to protect your landscape from winter wildlife damage

As the seasons change, we adjust our gardening tasks and plantings to match. Animals also make changes this time of year, often changing their eating habits and dining locations. These adjustments can impact your gardens. Reduce the risk of damage by starting in fall to protect your landscape from hungry animals this winter.

Take a walk around your landscape to evaluate plants and plantings for their susceptibility to animal damage. Look for pathways that animals use to access your landscape and areas of potential damage. Note new plantings, animal favorites and those special plantings you would hate to lose. Make sure these are protected.

Check mulch around trees and shrubs. Deep layers of mulch and mulch piled around the trunk of trees and the base of shrubs provides shelter for mice and voles. These rodents like to gnaw on the bark of trees and shrubs in winter. Pull mulch off tree trunks and stems and spread out deep mulch so it is only two to four inches deep.

Protect young trees and shrubs with a four-feet-tall fence of hardware cloth sunk several inches into the ground to prevent vole damage at ground level and most rabbit damage. Mature trees

are usually only bothered during years where the vole and rabbit populations are high and food is scarce.

Fencing around garden beds filled with animal favorites is another option. Make sure your fence is high enough, tight to the ground and gates are secure. You will need a four-feet-high fence for rabbits and at least five- to six-feet-high fence to keep deer out of small gardens. A fence of several strands of fishing line has proven to be successful for some gardeners.

Repellents are another less obtrusive option. These use smell or taste to discourage animals from dining in your landscape. Check the label to see if the repellent works on the animals and rodents you are trying to manage. Apply repellents before animals start feeding for best results. Then reapply as recommended on the label. Look for one, like organic Plantskydd (plantskydd. com), that is rain and snow resistant, lasting up to six months on dormant plants over the winter so you will need to apply it less often.

Scare tactics may be effective depending on where you live. In urban and suburban areas animals are used to human scents and sounds. Gardeners often hang old CDs and shiny ribbons in tree branches to scare hungry animals. If you opt for scare tactics, be sure to employ a variety of options and change their location to increase your chance of success.

Constantly monitor and evaluate the effectiveness of the methods used and check all plantings for damage. When animal populations are high and hungry, they will eat about anything.




To protect plantings from rabbits, use fencing that is at least four feet tall or a repellent that discourages them from dining on plants.

Be willing to change things up if one method is not working. Using multiple tactics will help increase your level of

Protect your landscape from hungry deer, rabbits, and voles this winter. Start preparing in fall before their winter dining habits begin. If you are vigilant and persistent, you can coexist with these creatures and still have a beautiful landscape.

### A Roundup of Timely Tips

Fall is here, and from picking the last of the harvest crops to raking up (and jumping in) piles of fallen leaves, the chores of autumn season are a labor of love. Read on for a medley of seasonal tips that are geared toward making New England's favorite season a little more enjoyable!

Have some native apples you need to use up? Believe it or not, you can make homemade applesauce in the crock pot. To do: Peel, core and slice ten large apples, add one cup water, one

cup sugar and one teaspoon cinnamon. Cover cook on low for eight to ten hours! Start it in the morning and it'll be done when you get home.

Want to capture your best fall foliage shots on camera this season? While experts agree there's no bad time of day to photograph colorful fall foliage, they note morning and late afternoon often provide the most interesting shadows. And try later too: The golden light just before sunset highlights not only leaves on trees, but those on the ground

To preserve colorful fall leaves for decorating try this quick

drying tip: Place leaves between two paper towels and microwave on medium one to 1 ½ minutes checking every 30 seconds for dryness. This will remove moisture from the leaves, and they'll retain their brilliant colors!

Outside garden chores are winding down, so here's some help for house plants! Using a flowerpot with large draining holes? Keep water in by placing a large coffee filter in the bottom of the pot. And if you cut and old sponge into small pieces and add it to the potting mix. You won't have to water plants as often.

Now's the time to give your neglected indoor plants some TLC. To make your lackluster indoor plants glow feeding them a tablespoon of castor oil, mixed with water. And simply dusting the leaves exposes them to more beneficial light!

## Bowhunting season begins

A good soaking of rain last week sure helped alleviate the threat of brush fires and helped bring some of the small ponds and lakes water table up a bit, but we still need a few more inches of rain to get into the water table before a ground freeze, and it hopefully will happen this week.

 $\bar{T}he start of the Massachus etts$ bow hunting season started this past Monday in zones 1-9. Some white oak trees had a good number of acorns this year, while others had very few. Bowhunters setting up tree stands in the areas of a heavy drop of acorns, should increase hunters' chances of harvesting a deer. The heavy winds and rain of last week helped defoliate many trees, and made observing deer a lot easier as they approached a tree stand or ground blind.

Tree stands are the number one choice of most bow hunters, but as some deer hunters age, it is time for them to keep their feet on the ground. Numerous fatal or serious injuries happen every year by hunters falling from a tree stand. If you do hunt from a tree stand you

need to be sure you use a safety belt or harness. Even then they do not protect a hunter from falling from a tree stand, as most accidents happen while climbing into their stand. The most popular tree stand is a ladder stand, but they too can be dangerous.

Ground blinds work very well for deer hunting, and keep a hunter a bit warmer and dry during the hunt. They also work very well for deer hunters that bring along their son or daughter, introducing them to the sport of deer hunting. There are more women that hunt deer and birds than ever before. Hunting is not for everyone, but if they enjoy the sport, they will get to enjoy quality time with their adult parent, and will hopefully pass it along to their children.

Hunting during the rut is the most exciting time to be in the woods, and will make your chances of a deer encounter almost a guarantee. It is also the time of year to harvest that big buck that has avoided you for many years. They often let their guard down as they chase a doe in heat, and if you are in the right spot at the right time, you could get lucky and harvest the deer of a life time.

Cleaning and field dressing a deer needs to be done properly, or you could taint the meat, making it uneatable. Many people that do not like eating venison have more than likely had venison that was not properly cleaned and packaged. A lot of venison is ruined during field dressing. There are plenty of videos that can be watched on YouTube. Taking the time to watch one can insure some great eating in the coming weeks and months. Choosing the correct meat cutter to process your deer is very important, and be sure that you are getting your deer meat, and not

someone else's. Proper dressing of the trophy deer that you are planning to take to a taxidermist also needs special care. Be sure to check that out also on You -Tube or from your taxidermist. Choose the right Taxidermist & be sure to ask the following questions. What is the final cost? How long will it take before I get my mount back? Ask to see some of his or her work. Ask for references, and never pay in full before you receive your mount back.

Tautog fishing remains great as this week's picture shows. Recently stocked trout are being caught at some local hotspots. Check out the stocked waters by going to Massachusetts Fish Hunt Web site. One local angler caught a huge rainbow trout at an undisclosed site last week.

## Latest antiques, collectibles, and auction news



It has been over a month since my last antiques, collectibles, and auction news report. A lot has happened since. Let's begin with an upcoming Halloween auction in Ireland.

The Irish Times reports that Mullen's Auctioneers of Dublin, Ireland will be holding a Halloween auction. The auction features many prints, photos and medals related to historical events in Ireland. There are two items fitting for an auction on Halloween. A movie poster from the 1958 film "Dublin Nightmare" which has an estimate of 150 to 200 Euros (approximately \$175 to \$235 U.S. dollars) will be one of the offerings. A death mask of Irish novelist James Joyce is the other. The Irish Times reported that Joyce's wife Nora authorized sculptor Paul Speck to make two death masks of Joyce when he died in 1941. Speck made an additional mask for himself. The two authorized masks are owned by the James Joyce Foundation. The third was sent to the Irish Library of Congress. Speck made 6 bronze castings before he presented the mask to the WAYNE TUISKULA er rolled up in a tube without a Library of Congress. Speck gave one of the castings to film



has 16 buses under contract, and given the COVID-19 guidance put forth by the Department of Elementary and Secondary Education – as well as from our medical professionals statewide we are unable to serve more than 22-25 students per bus. This limits us to having only 400 total seats for the elementary bus run and 400 seats, at best, for the secondary bus run."

As a result, district officials ask all guardians who are able to provide transportation for their children to do so this year. School leaders want to reserve the limited number of bus seats for students who have no other transportation options.

Looking long-term, district officials are emphasizing the need for students, guardians, and staff members to not become complacent with mask use and social distancing. Large private gatherings, improper distancing, mask fatigue, and other factors have already led to an increase in COVID-19 cases regionally. If conditions worsen, school reopening plans in those communities could be adversely affected.

'There are local communities in the Southern Worcester County region who have experienced difficulties along the way with reopening," Haughey added. "Our administration, faculty, and staff have done an outstanding job adhering to the safety guidelines and worked diligently to make sure we mitigate the risk of exposure. We ask that you continue to partner with us and support us in this work, as

we prepare to return to school in a measured and phased man-

In a recent letter to the community, school officials highlighted the following ongoing safety protocols in all schools:

Wear face coverings Wash/sanitize hands frequently

Maintain social distancing of at least six feet apart in learning

### Caregivers must also care (financially) for themselves

If you're a caregiver, possibly for a loved one dealing with an illness such as Alzheimer's disease, you're probably already facing some significant emotional and physical challenges - so you don't need any financial ones as well. Evaluate your employment options. If you have to take time away from work - or

Somewhat curiously, even our governor is growing tired of plague management. As the weather gets colder and cases continue to rise, he has relaxed restaurant and other business restrictions. Just this week he changed the threshold for quarantine-free travel from other states from 6 per 100,000 to 10 per 100,000 (both per day). As the weather gets colder our risk goes up, not down, yet our will to control this virus is expiring with time.

How did we get here? How did the USA become the worst specimen among rich countries to manage this global catastrophe? It is sad. It is pathetic. It is a total failure of government.

than a dog-whistle for something horrible and is used with the obvious attempt to delegitimize and dehumanize the BLM movement and all of its supporters. Black Lives Matter is not an organization but a fluid movement; it doesn't actually matter if one of its founders was a liberal, Marxist, socialist, or capitalist.

It is important to recognize that movements evolve. The group's support is broad. The McCarthy style red-scare items several authors have referenced no longer appear on BLM's website. In 2017, 37 percent of registered voters supported BLM. In 2020, 50 percent of registered voters support BLM. Black Lives Matter may be the largest movement in U.S. History with estimates that as many as 26 million people in the US have participated in demonstrations since George Floyd's death. It is time to either get on the right side of history or at least shut up and stop embarrassing vourself.

As for me being a "whiner" - I've been called a lot of things but that's a new one. I believe all I have done is pointed out disturbing trends in our body politic, set the record straight on a few items written about in this publication, and provided much needed context. With all the mud-slinging in these Letters to the Editor pages I take it as a compliment that "whiner" is the best attack so far... I guess my content and context was harder to attack.

It is important that we all understand the news shaping our world as it unfolds. 2020 has been a big year in terms of racial strife and while we can differ in our policy prescriptions we can't move forward unless we all agree on the basic facts of History. The founders of this country saw black folks as property no different from livestock worthy of three fifths representation in congress to be voted on by white folks. We had legalized and official institutional racism for 100 years after slavery was ended. Black folks have only been equal de jure for 50 years.

We need to stop lionizing and revering our founding fathers as demigods but understand they were flawed people with prominent roles in history and their reputation should be considered mixed. Some pushed us in the direction of a better more equitable and just world with limited success. Others fought for the economic interests of the monied elite, fought to protect slavery, and created a new more modern aristocracy than what existed in England. The American War of Independence was sold to the peasants as a freedom fight but it was really a war fought for the interests of the land-owning elite who were unhappy with taxation to pay for the colonies' common defense at rates far below modern levels. We also shouldn't forget that the British Empire abolished slavery peacefully by an act of Parliament in 1833, more than a generation before slavery was ended in the USA as the result of a bloody war.

Fifty years of "on paper equality" might sound like a long time, but it isn't. Wealth passes down through generations. The GI Bill excluded black veterans, so after WWII, they did not obtain educations and buy homes like white veterans did. White people of that generation had an easier time providing for their kids, giving them a start to life, and ultimately passing down property. Even today, black people have a much harder time getting hired, getting promoted, and getting raises even after we adjust for everything. The reality is the black community is more troubled, and because of that people don't want to give them a chance, which only deepens their issues. The black community is so troubled because of hundreds of years of slavery followed by 100 years of second class quasi-citizen, followed by unofficial vet insidious racism.

I demand that everyone understand our history, warts and all. It is a necessary condition to moving forward. Anyone willing to comment on current events or participate in our politics ought to understand what is going on and ought to understand the broader context. If I'm wrong, I encourage anyone to set the record straight. History is written by the victors and purging history is an old Soviet trick to wining over "the people." If you think that making sure people don't understand the full context of our history and current events in order to paint a pretty picture so they can be happy Americans, it sounds like your concept of America is a White Supremacist Ethno-state.

I intend on continuing to highlight the context many wish to ignore. If that makes me a "whiner," I intend to continue whining.

Only Bruce, and a few oth-

ers are narcissistic enough to believe we do.

And it has nothing in my mind to do with left or right ideology. I read this morning that President Trump said, "If Biden wins, maybe I'll have to leave the country." My response is the same to our President as it is to the celebrities on the left ... "Go!" If President Trump loses the election, I don't care where he lives, if he leaves the White House in an orderly and peaceful transition ... and I believe he will.

I'm not an America, "Love it or leave it" kind of guy, but these kind of threats from entertainers have grown tiring and I believe ineffective.

We assume Bruce lives somewhere in New Jersey, but we really don't know. I always assume Streisand is somewhere in California, but it doesn't matter to us where they

live. Does their address impact

our lives in any way? When the Beatles exploded into our lives, we heard and saw them so often, they could have been the garage band next door. The fact they lived across the ocean didn't limit their exposure. If Bruce moves to Australia and releases a new album, does he think the distance will somehow limit the play in the USA and therefore punish us by depriving us of his music? If the album is good, it will get just as much play as if he were still in New Jersey.

So, what's the point? The point is that this exposes the false sense of influence and power entertainers believe they hold over our lives. Arrogance is never attractive. I think entertainers who become activists become less popular in their genre and often have the opposite impact on the public. Think not? Ask the "Dixie

Chicks." I think comedian, Michael Loftus, said it best. "They really think they're that important," he said. "They really think we're walking around going, 'Wait, what? Springsteen's going to leave? And Tommy Lee? Oh, I'm changing my vote!"

So, what's positive about

I believe if we love our country, we will not let the results of an election chase us out. We stay and work hard because we believe in our Declaration of Independence, our Constitution and Bill of Rights ... and we realize the importance of our nation in the balance of the world.

The American people will vote on November 3 based upon

their beliefs and not because an entertainer threatened. Even though I don't always agree, I always trust the will of the voting public and the power of our system. I believe the right person for the job is usually selected and when mistakes are made, we can make a correction in four years. And during those four years, we have a system of checks and balances that can keep things from going horribly wrong. The brilliance of our Founding Fathers still shines through after almost two-hundred and fifty years.

Vote. Make your choice heard. Don't threaten anyone. Don't lose friends. Don't damage family relationships. Because half the nation, and many people you know and love, may feel and vote differently, it doesn't make them wrong. It certainly doesn't make them your enemy. I've always been a Streisand fan. I'll still listen to Springsteen's music wherever he lives.

Rather than being angry over politics, let's celebrate the incredible opportunity that the American system provides. And once the final votes are counted and the selection is made ... let's accept the will of the American people and move forward together.







## Communities continue to work through phased reopening

REGION – After receiving the green light earlier this month from Gov. Charlie Baker, several towns are proceeding through the state's next phase of reopening.

On Oct. 5, communities at low risk for COVID-19 transmission were permitted to enter the second step of the reopening plan's third phase. All towns in the medium-risk and high-risk categories will remain in the first step of Phase 3.

Baker also issued a revised gatherings order as part of his latest announcement. Moreover, industry-specific guidance and protocols were updated.

The order applies only to lower risk communities. Other communities are not permitted to move forward in the reopening process until the data indicates that it is safe to do so," Baker said.

Effective Oct. 5, the following businesses, organizations, and sectors of the economy were authorized to reopen in low-risk towns:

Indoor performance venues will be

permitted to reopen with 50 percent capacity, with a maximum of 250 peo-

The outdoor performance venue capacity will increase to 50 percent, with a maximum of 250 people.

For arcades and indoor and outdoor recreation businesses, additional activities like trampolines, obstacle courses, roller rinks, and laser tag will be permitted to reopen.

Fitting rooms can reopen in all types of retail stores.

Gyms, museums, libraries, and driving and flight schools will also be permitted to increase their capacity to 50

The state's limit for indoor gatherings remains at a maximum of 25 people for all communities. Outdoor gatherings at private residences and in private backyards will remain at a maximum of 50 people for all communities.

Meanwhile, outdoor gatherings at event venues and in public settings will have a limit of 50 people in Step I communities, and a limit of 100 people in lower risk, Step II communities.

Locally, many residents have become confused and frustrated with the ever-changing guidance at the state level. Now, with various communities staggered at different stages of reopening, several businesses have found themselves at competitive disadvantages with their counterparts in neighboring towns.

Meanwhile, multiple area business owners have taken it upon themselves to briefly close for precautionary reasons, even though no state or local mandate required it. Eller's Restaurant in Leicester was recently closed for a week after a kitchen worker tested positive for COVID-19, and other businesses have decided to reduce days and hours for sanitation protocols.

Additionally, area cities and towns have made tough decisions like canceling trick-or-treating. Leicester and Worcester both called off trick-or-treating, and Spencer officials will likely decide on Oct. 19.

Last month, the Baker Administration

began releasing new COVID-19 data to help towns, businesses, and residents make decisions based on the most detailed information possible. Newly released data includes the average daily COVID-19 cases per 100,000 residents, the average percent positivity, and the total case counts for all 351 Massachusetts cities and towns.

As we move deeper into the fall, state leaders urge residents and business owners to follow all COVID-19 guidelines. These include avoiding large gatherings, wearing masks in public spaces when social distancing isn't possible, and maintaining proper spacing.

We have all worked together to fight this disease. As we gradually reopen more of the economy, it is important that businesses and customers continue to follow appropriate protocols," said Lt. Gov. Karyn Polito.

## School District chooses project manager

SPENCER - At an Oct. 5 meeting, the Massachusetts School Building Authority (MSBA) hosted Spencer-East Brookfield Regional School District leaders regarding their owner's project manager selection for the district's David Prouty High School core project.

SEBRSD chose International as their owner's project manager for the next three phases of the high school core project. On Oct. 5, the MSBA approved the award to Colliers International with a contract not to exceed \$250,000.

Six firms originally applied for the DPHS core project. Five firms were chosen by the local owner's project manager subcommittee to interview for the position, based upon recommendations and experience with school building projects.

Following the interview phase, reference checks were conducted by members of the OPM subcommittee. Members reviewed proposals, discussed the relative merits of each firm, and then chose Colliers International on Sept. 8.

International provides Colliers school districts with managerial and technical support for the design and construction of major capital projects. In Massachusetts, the firm has been involved with projects at West Springfield High School, Cape Cod Regional Technical High School, Easthampton High School, Assabet Valley Regional Technical High School,

and Webster's Bartlett High School.

Colliers International employees Alan Minkus, Tim Alix, and Phil Palumbo will now develop a request for qualifications for an architectural firm to create detailed plans for the DPHS renovations.

"Architect selection is critically important, as it forms the foundation for all other work to come," read a statement released by the SEBRSD. "As part of this work, the team will meet with the School Building Committee to discuss the process for architect selection, develop a timeline, and develop and manage the RFQ process.

Colliers International will also work with municipal and district leaders to develop cash flow models to inform bor-

rowing. They will also help maximize reimbursements for all expenditures incurred.

For district leaders, it's exciting to move forward with the process and work with an experienced firm.

Spencer-East Brookfield Regional School District will seek Colliers' input on the eventual construction procurement options, such as the utilization of a general contractor or a construction manager," said SEBRSD Superintendent Paul Haughey. "Finally, they will help the David Prouty High School Building Committee communicate progress with all stakeholders, including the School Committee, local Boards of Selectmen, parents, families, students, and staff."

## Hearty chili for autumn days



People choose to adhere to a vegetarian or vegan diet for various reasons. Some people avoid animal products because of ethics, while others want to control their weight with low-calorie foods. Still others may have food allergies or intolerances that make a vegetable-based diet their best option.

Cooking vegetarian or vegan can introduce a person to a wide variety of new foods and flavors. That's why even people who eat meat like to periodically experiment with vegetarian or vegan foods.

When the weather starts to cool, soups and stews become staples of many people's diets. With this recipe for "Four Bean Chili" from "Vegan Cooking for Beginners" (Publications International, Ltd.) by the PIL editors, home cooks can experiment with a meatless chili that doesn't skimp on flavor even if it isn't brimming with beef, pork or lamb.

Four Bean Chili Makes 8 to 10 servings

tablespoons olive oil

medium carrots, chopped red bell pepper, chopped cloves garlic, minced tablespoons tomato paste 2 tablespoons packed dark brown

sugar 3 2 tablespoons chili powder tablespoons ground cumin tablespoon dried oregano 1

teaspoon salt

can (28 ounces) diced tomatoes can (15 ounces) tomato sauce can (15 ounces) small white beans, rinsed and drained

can (15 ounces) light kidney beans, rinsed and drained

can (15 ounces) dark kidney beans, rinsed and drained can (15 ounces) pinto beans,

rinsed and drained cup vegetable broth

can (4 ounces) diced mild green chiles

ounce unsweetened baking chocolate, chopped

tablespoon cider vinegar.

Heat oil in large saucepan over medium-high heat. Add onions, carrots and bell pepper; cook and stir 10 minutes or until vegetables are tender. Add garlic, tomato paste, brown sugar, chili powder, cumin, oregano and salt; cook and stir 1 minute.

Stir in tomatoes, tomato sauce, beans, broth, chiles, and chocolate; bring to a boil. Reduce heat to medium; simmer 20 minutes, stirring occasionally. Stir in vinegar.

Chili is even better served with cornbread. Make batter while the vegetables are cooking in step one and bake it while the chili is simmering.

Cornbread Makes 12 servings

tablespoons boiling water

tablespoon ground flax-11/4 c u p s

all-purpose flour 3/4 cup yellow cornmeal

cup sugar 1/3teaspoons baking powder

teaspoon salt

plain unsweetened 11/4 cups almond or soymilk

1/4 cup vegetable oil

Preheat oven to 400 F. Spray 8-inch square baking dish or pan with nonstick cooking spray. Combine boiling water and flaxseed in small bowl; let

Combine flour, cornmeal, sugar, baking powder, and salt in large bowl; mix well. Whisk almond milk and oil in medium bowl until well blended. Add to flour mixture with flaxseed mixture; stir just until dry ingredients are moistened. Pour batter into prepared baking
