GILFORD — The Home Possible Project (HPP) is pleased to announce a generous \$1,500 donation from the Laconia-Gilford Lions Club in support of HPP's efforts to create a permanent, supportive home for adults with developmental disabilities in the Lakes Region.

Laconia-Gilford Lions Club President Matt Sousa presented the check to Lisa DiMartino, Chair of the HPP Board of Directors, at HPP's future building site on property generously provided by the First United Methodist Church of Gil-



ford-Laconia. Several HPP Board members, supporters and prospective future residents were also present for the presentation.

"This is the kind of creative and imaginative solu-

tion that we need, and our club is happy to support this effort," said Sousa. "We

hope this will inspire other organizations to follow suit and help address the lack of

housing for adults with developmental disabilities."

The Laconia-Gilford Lions Club is an official affiliate of Lions Clubs International, the world's oldest service organization. Through its fundraising and community service, the club directs its efforts toward making a positive difference in the local community.

The Home Possible Project, a local grassroots nonprofit, is developing an

eight-apartment community residence in Gilford that will provide adults with developmental disabilities with safe, private, accessible homes in a supportive community setting. The residence will include shared living and community spaces and 24/7 staff support, while emphasizing independence, dignity, meaningful relationships and participation in the broader community.

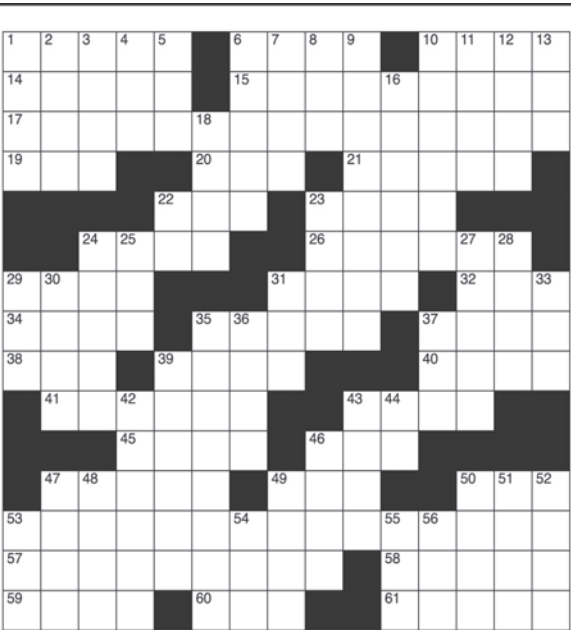

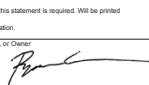

BARNSTEAD — Good to Know Info: We are closed for staff training on the second Thursday of every month until 3 p.m. (Sep. 10). Monday, Sept. 7, is Labor Day!

During the month of September, New Hampshire is running the Granite State Library Card Challenge. As you might already know, we are a small town, but luckily for us, winners are determined by percentage increase, not actual numbers. That being said, we need your help to win that trophy! If you’ve been thinking about getting a library card, September is the month to do it. Maybe you’re sharing a card with a loved one and want your own. And hey, kids aged 6 and up can get their own card! So stop by the library and get a card (or renew it if yours expired - those count), see what services we have to offer (copying, faxing, notary, access to free audiobooks and e-books via Libby, a computer to use, and more!), grab a copy of the Barnstead Banner, and most importantly, check out a book (or a movie or a telescope or a game)!

Home School Group: Run by group members, it takes place at the library meeting room on Fridays from 10:30 a.m.-12:30 p.m. Involves a mix of stories, simple science/learning activities, and a creative art/craft activity that all go along with a theme for the week. The activities are geared towards kids ages 4 and up, and younger siblings are welcome to come along. There will be an event posted ahead of time on the group’s Facebook page (Barnstead NH Library Homeschool Group) for each weekly meet-up, so you’ll always know what to expect and if you need to bring anything.

Music and Movement Storytime, aka Little’s Love to Learn! Join us on Tuesdays at 10:30 a.m. for an interactive storytime filled with group singing, dancing, imaginative play, crafts, and stories, all designed specifically for babies and toddlers.

Every Wednesday at 10:30 a.m. is Children’s Storytime. Visit us at the library for stories, crafts, and singing. Then experience the cozy ambience in the children’s area, which has all sorts of neat

things to do. Make new friends. Set up playdates. Check out books, movies, and games, play with the trains, Legos, and puppets. Come for the learning, stay for the fun!

Start your week off with Yoga Monday! Gentle Hatha-Flow runs from 10:15-11:40 a.m., Senior/Beginner/Chair Yoga is noon to 1 p.m., and Intermediate Hatha-Flow lasts from 5:30-6:50 p.m. Classes are by donation (suggested \$8). All are welcome and encouraged to attend, regardless of ability to donate.

A home is more than four walls

There are some community projects that deserve our attention because of what they will build. Others deserve our attention because of what they will make possible.

The Home Possible Project falls squarely into the second category.

The grassroots nonprofit is working to create an eight-apartment community residence for adults with developmental disabilities — a place designed not simply to provide a roof overhead, but to provide something far more important: a home. That distinction matters.

Across the Lakes Region, families of adults with developmental disabilities face a difficult reality. As parents and other caregivers age, appropriate housing options can be limited. Too often, adults who have spent their lives becoming more independent find themselves with few choices other than continuing to live with family. Home Possible is attempting to change that.

The proposed Gilford residence would provide private, accessible apartments along with shared community spaces and 24/7 staff support. The project emphasizes independence, dignity, meaningful relationships and participation in the broader community. Universal accessibility, smart-home technology and thoughtfully designed indoor and outdoor spaces are all part of the vision.

That is an ambitious undertaking. It is also exactly the kind of undertaking that a community should rally behind.

We were particularly encouraged to see that spirit of community support demonstrated recently when the Laconia-Gilford Lions Club presented Home Possible with a \$1,500 donation. It may be a modest amount compared with the overall cost of constructing the facility, but its significance extends well beyond the number written on the check.

As Lions Club President Matt Sousa put it, the project represents the kind of “creative and imaginative solution” needed to address the shortage of housing for adults with developmental disabilities. He is right.

And perhaps even more importantly, the Lions' contribution sends a message to other civic organizations, businesses, foundations and individuals throughout the Lakes Region: This is a community problem, and it can be addressed through community action.

The project also benefits from a particularly meaningful Gilford connection. The First United Methodist Church of Gilford-Laonia has generously provided the property for the future residence. That contribution, combined with financial support from organizations such as the Lions Club, demonstrates what can happen when a community's resources and goodwill are brought together around a common purpose.

Home Possible still has work to do. The organization is seeking the additional funding necessary to reach its construction goal and turn plans into bricks, mortar and, ultimately, homes.

That means this is a good time for the rest of us to ask a simple question: What can we do to help?

Not everyone can make a large financial contribution. But communities are built through contributions of all sizes. A business might become a sponsor. A civic organization might organize a fundraiser. An individual might make a donation or simply tell a neighbor about the project. Local leaders can help spread the word and encourage others to get involved.

The larger point is that inclusion cannot simply be something we talk about. It has to be something we build. Home Possible is literally trying to do that.

A successful community is one in which people of all abilities have a place to live, a sense of belonging and the opportunity to participate in the life of that community. Adults with developmental disabilities should not have to wonder where they will live as their parents age. Families should have confidence that their loved ones will have safe and supportive options. And those future residents deserve more than a facility — they deserve a home and the independence and dignity that come with it.

The Laconia-Gilford Lions Club deserves credit for recognizing that and stepping forward. Now it is time for others to do the same.

If the Lakes Region truly believes in being a community where people look out for one another, the Home Possible Project gives us an opportunity to put that belief into action.

Because in the end, the most important thing Home Possible is building isn't an apartment building. It is a future. And that is something worth investing in.

Wright Museum to host lecture and book signing by author Katie S. Sanders

WOLFEBORO — On Tuesday, Sept. 1, the Wright Museum will welcome Katie S. Sanders. This is the 15th program of the Wright Museum’s 2026 Education Series.

Peter J. Ortiz’s path to becoming the most battle-decorated member of America’s first spy agency—and one of the most decorated Marines of World War II—was unlike any other. Born in New York and raised between California and France, he would have stints as a merchant seaman, dude ranch manager, race car driver, lion tamer, circus performer, and Hollywood stuntman and actor. As a teenager, Ortiz ran away from boarding school in France to join the French Foreign Legion. He first experienced combat in North Africa against tribesmen in the Sahara. Fighting on the front lines against the Germans in 1940, he was badly wounded and captured. He repeatedly escaped, one time fleeing a hospital train after assuming the identity of a dead soldier.

stead of being deployed to the Pacific like the majority of Marines, Ortiz was recruited by the Office of Strategic Services (OSS)—America’s World War II forerunner to the Central Intelligence Agency—for special operations in North Africa and Europe.

In 1944, Ortiz parachuted into France on two top-secret inter-Allied missions. Operating deep behind enemy lines, he traveled throughout Southeastern France—at times donning his Marine uniform—arming and training the Maquis, blowing up Nazi infrastructure, and aiding downed Allied airmen. Rotating his many covers—including as a fashion designer and minor Vichy government official—he infiltrated Nazi gatherings and funneled intelligence about German positions back to OSS London ahead of D-Day. By the time he escaped across the Pyrenees, he was among the Gestapo’s most wanted.

than one hundred Germans at the village of Centron, Ortiz faced a choice: fight the enemy or save the village from Nazi annihilation.

A rare Marine in the European Theater, he received two Navy Crosses. Ortiz’s story—an untold corner of World War II history—is one of extraordinary courage, resistance, and self-sacrifice.

tenet of loving what he's doing at the time. "I loved it!" peppers his speech when discussing his background and, more importantly, what he's doing now.

Educated at a public military school in England, Branscombe apparently had no real idea of what to do with his life upon graduation. Because of that, "my career officer told me they'd stick me at Lloyd's of London," he said. The renowned insurance market had a student acquisition arrangement with his school. If a graduate didn't have prospects somewhere else, they became an employee there. So at 17, that's where he wound up.

"Iloved it!" he exclaimed.

Around half of Lloyd's premiums are paid from North America and Branscombe worked as a Senior Insurance Broker placing insurance coverages for US clients.

Of course, Lloyd's is known for policies covering unusual items; good examples are a grain of rice engraved with Queen Elizabeth's portrait, Betty Grable's legs, and Bruce Springsteen's vocal cords.

Accordingly, Branscombe has his A-list celebrity story. "I insured Liberace's hands," he declared with a laugh.

It was the public service aspect of the job that appealed to him the most, though.

In 1978, Lloyd's asked Branscombe to open an office in Bermuda. What would seem like a dream locale, Bermuda did not suit him, a man who is always on the move and relishes varied experiences. He contracted what he calls "rock island fe-

ver," exacerbated by driving around and around the small space "on a scooter going twenty miles an hour." Not for him.

New Hampshire was his next stop. From 1986 until 2010, his consulting firm PCB Consulting, LLC handled insurance and reinsurance consulting for Lloyd's with offices in New Jersey, Illinois, Massachusetts, and the United Kingdom.

A diversion from insurance, fueled by a desire for community service, however, was about to happen.

While in Ashland, Branscombe joined the town's budget committee, which then led to a stint on the Planning Board. Following that, he got an unusual request.

"They asked me to be the TA," he said.

Game for anything, as usual, and then retired from insurance, he embarked on basically on-the-job training. "Iloved it!" he exclaimed.

Branscombe served there for five years, then moved on to a TA position in Gilmanston, where he met his wife.

"I realized then how much I enjoyed municipal government," he said, "but I preferred benefitting communities in shorter stretches."

Soon after, Municipal Resources, Inc. (MRI), the leading provider of services to local governments, gave him a call and Branscombe's career as an interim administrator for small towns began.

Throughout the next few years, he would cover a town's needs through MRI from anywhere from three months to a year or so.

"I held seats until a town's new hire was able to fill the position, or to get a town through its Town Meeting," he explained.

Branscombe bounced from Wilton to Rollinsford to New Boston to Raymond to Tilton to Brookline, sometimes moving from Interim TA to TA and hanging around a community for a

longer time.

All of the positions were in small towns.

"They are easier to embrace," he said. "It's easier for people to get to know me, and me, them."

He started in New Durham on June 10 and has spent the summer rapidly getting acquainted. Branscombe's passion for his role is sincere and obvious.

"It's in my DNA," he said. "This isn't just a job if you love what you do; it isn't work. We've made the culture here a happy place."

Others respond to his attitude. A recent Facebook post from the New Durham Parks and Recreation Department extolled him for sending flowers to all Town Hall staff.

Branscombe has a specific strategy with department heads.

"When I first come in to a new place, I don't micromanage. I leave them alone, because I'm here to help them wherever I can," he said.

Working together well happens very quickly "with a good team of people," he said. "When you explain that you're here for them, things change overnight. They know I care about them."

He said he wants employees to enjoy coming to work.

The public rates just as highly with him.

"From day one, I put on the community Facebook page that I have an open door policy and people have taken advantage of that," he said.

Issues ranging from bumpy roads to septic problems to bothersome neighbors find their way into his office.

"I try to discover solutions," he said.

A Town Administrator's role is all encompassing. Branscombe said having a longer period of working for the town now that he has signed a three-year contract is important to him.

"Having more time will allow for working with a cohesive select board and getting involvement of the department heads and Town Hall staff," he explained.

In keeping with his aversion to micromanaging, he went on to say, "I don't make decisions alone. It's a joint effort and joint responsibility; that's what makes it all work."

So far, Branscombe has accomplished "two great things! We've hired a Building Inspector/Code Enforcement Officer through an agency which saved over fifty thousand dollars, and a finance manager."

His vision for the future includes "putting out all of the fires of the past and moving forward." The current issues concerning the local dams and possible water drawdowns will figure heavily in matters at hand.

In addition to his role as TA, he serves as the Health Officer. That's a good thing, in his opinion.

"Since I'm the Health Officer," he said, "we can make the Board of Selectmen the Board of Health and hold meetings to get a better idea of public health."

Branscombe also cites a goal of seeing the Copple Crown District being more involved.

Communication is key for him.

"I'm putting information out on social media to be helpful," he noted.

Another plan is to hold informational resident forums to explain the inner workings of the town and how things come about.

"We could arrange forums that explain how the tax rate is set and things like that," he said. "The more information out there, the better for the residents."

With Branscombe's outlook and dedication to the community, the next three years may very well be a time when everyone can say, "I loved it!"

MIT partners with Lakes Region Community College for pilot Math and AI education program

LACONIA — Lakes Region Community College (LRCC) and Massachusetts Institute of Technology (MIT) launched a new pilot partnership this summer, bringing 16 high school students from towns across New Hampshire together to learn the math behind AI and how to use it to tackle real problems. LRCC is one of only two community colleges nationwide hosting the pilot course; the other is in Wyoming.

The four-week course, “Gateway to AI,” was created by MIT professors led by Arup K. Chakraborty, with input from the teachers at the New Hampshire and Wyoming sites. The aim is to close a gap Chakraborty has long observed: students in rural and small-town America often have far less access than their urban peers to advanced math and science instruction and hands-on exposure to emerging technologies like AI.

"For a long time, I’ve believed that many of our young high school students in rural America do not get the same opportunities to see and take advantage of the future possibilities, compared to people in urban areas," said Chakraborty. "We want to change that. It doesn’t matter what these young people plan to pursue in their lives — if they work in manufacturing, at a CVS, or in agriculture they will encounter AI. It will likely be present in every

aspect of their lives. Also, the need to think deeply and analytically, and ask the right questions, will become even more important than before."

The program prioritized teens from communities with limited access to science, technology, engineering and mathematics (STEM) enrichment. Participants came from towns across the state, including Center Sandwich, Concord, Gilford, Gilmanton, Laconia, Meredith, Moultonborough, Nottingham and Salem.

“AI is a hot topic right now. It’s certainly important to know how to use it properly,” said Gus Glaser, a student from Coe-Brown Northwood Academy in Northwood.

Students spent the first two weeks learning linear algebra — a mathematical foundation of AI systems — in the context of how it’s used in AI tools. They also learned some statistics. In the second half of the course, they applied what they’d learned to hands-on projects including:

- A farm visit, where students photographed crops and used AI to identify plant types and growth stages. The goal was to use an AI tool developed by a company called Ground Truth Analytics to predict plant types and growth stages in neighboring areas.
- A healthcare project using an AI tool developed at MIT that analyzes mammogram data to generate

breast-cancer risk scores. Students had to decide how to schedule further screenings based on these results, and other constraints.

- A financial wellness project for New Hampshire-based St. Mary's Bank, leveraging Allogoy's Capillary platform. Students created an AI chatbot designed to help members navigate real-life financial goals. This tool allows users to navigate topics such as saving for college or starting a business, and explored how changing factors like inflation could influence their financial decisions. The project demonstrates how digital tools can empower members with on-demand insights while complementing the trusted guidance available through in-person member support teams.

“I definitely didn’t expect the program to be so hands-on,” said Asa Buchakjian-Tweedy from Spaulding High School in Rochester. “I knew we would be learning about linear algebra which is the basis of AI models. I thought we’d be mostly sticking to that, but we’ve also been learning the statistics behind it and how to implement it.”

"We were proud to be part of this," said Patrick Cate, president of LRCC. "Students from across New Hampshire had the opportunity to learn about topics that are not typically covered in high school. That's a direct reflection of what LRCC and all of New

Hampshire’s community colleges exist to do: connect our communities to opportunities they might not otherwise have."

The course was taught by Inter-Lakes High School teacher Susan Foss-Finch who traveled to MIT to help shape the curriculum. MIT student Jady Grant served as an on-site teaching assistant. Later this month, MIT will fund a day-long campus visit for participants to tour research labs and meet MIT students.

“I hope students walk away with a better understanding of what AI is as well as its capabilities and limitations. AI is a great tool that will help our society move forward. It’s not something we should fear, but something we should learn to use and use well,” said Foss-Finch.

Sydney Conkling, a student at Inter-Lakes High School in Meredith, summed it up well, stating, “It’s a really good way to spend your summer and broaden your horizons.”

MIT hopes to grow this program and offer it in additional communities across the country.

Blaney makes it back-to-back wins in Loudon

LOUDON — The story at the start of the day at New Hampshire Motor Speedway on Sunday was the weather.

The story at the end of the day was Ryan Blaney.

And in between, fans were treated to a great show on the track as the Dollar Tree 301 took to the Magic Mile.

Blaney, who won last year's NASCAR Cup Series race at the Loudon speedway, went with a gutsy two-tire pit stop call late in the race, battled through lap traffic and held off a great challenge from Bubba Wallace over the last 20 laps or so to take the NHMS win for the second year in a row.

“What a fun day, starting in the rain and it ended up being a beautiful day,” Blaney said after climbing from his car. “Props at everyone at Team Penske who is keeping their heads down and working hard.

“It's cool winning two in a row here, I'm looking forward to getting another lobster,” he added, mentioning the unique trophy given to the winner at New Hampshire Motor Speedway each year.

Rain rolling through the state early in the afternoon on Sunday caused a bit of a change, as drivers started on their wet weather tires and sat on pit road for a while at the start of the day as the rain cleared off and the track workers cleared the pavement of the standing water so the drivers

could get on the track and give the fans the show they were expecting.

The cars went their first 40 laps on the wet weather tires before NASCAR threw a competition caution to allow cars to come down pit road and remove the rain tires and put on the regular tires for the rest of the race.

Wallace finished in second and Josh Berry, who led for a good portion of the race late in the day, finished in third place, multi-time NHMS winner Christopher Bell finished in fourth place, coming back from a scary incident on pit road where a pit crew member got caught on his car as he pulled away from the pit. Kyle Larson rounded out the top five while Denny Hamlin clinched the regular season championship ahead of next week's final race before the NASCAR playoffs kick off.

Blaney praised New Hampshire Motor Speedway for putting on a good race, as traditionally happens in Loudon and is happy that next year NHMS's NASCAR race will be part of the playoffs.

“I've always thought this place was incredibly deserving of a Chase race,” Blaney said. “Just because they put on a really good show, the fans up here are incredibly passionate about racing.

“Just a good atmosphere here and I think it's important to have a playoff race here in the northeast for sure,” he continued. “I was sad it was out of the Chase

this year but I'm excited it's back in next year.”

Polesitter Tyler Reddick led the field to green, but his Toyota spun on the first lap, sparking the first yellow flag and blocking the path of series points leader Denny Hamlin and Chris Buescher. John Hunter Nemechek also continued after a solo spin and wall scrape on lap 22 with his Toyota.

Ross Chastain was the race's first retiree, taking his Trackhouse Racing Chevrolet to the garage with drivetrain issues. Chastain finished last after completing just 41 laps, squashing his faint post-season hopes.

Larson sealed a stage one victory, leading 14 of the 70 laps in the Hendrick Motorsports Chevrolet, notching his fifth stage win of the 2026 season. Bell finished second at the stage one break, Carson Hocevar was third, with William Byron fourth and Berry completing the top five.

Blaney marched to the stage two win, leading 38 of the first 185 laps in the

Penske Ford, clinching his seventh stage victory of the 2026 campaign. Berry was second at the green-checked flag. Wallace placed third, Ryan Preece was fourth and Larson rounded out the top five at the end of the second stage.

The most significant yellow flag slowed the pace early in the stage, when Carson Hocevar's collision with Connor Zilisch sent Hocevar's Chevrolet spinning on the frontstretch on

lap 84. Joey Logano and Austin Dillon also spun in the wake of the incident, but all four cars continued.

Later in the stage, Hocevar raced Zilisch hard, banging fenders with the rookie's Chevy before rooting him out of the groove in turn one. Zilisch finished Stage 2 in 21st place, with Hocevar 31st.

Visiting the Olympics, relatively close to home

As anyone who has read these pages over the years probably knows, I am a big Olympics guy. I've had the honor of covering six Olympic Games over the last 12 years, four Winter Games and two Summer Games. Even before I got those credentials for the 2014 Sochi Olympics, I loved watching them on television.

All those things considered, it's pretty surprising that I had never been to the Olympic venues that are physically closest to where I live. My recent trip to Los Angeles allowed me to see some of the venues being used in two years (and some that were used in 1984) and I've also seen places in Atlanta that hosted the Games in 1996.

But until last Monday, I had never been to Lake Placid, the two-time Winter Olympics host in upstate New York. I had an unusual Monday off from the bakery so Sunday night I pointed the car west and made my way across Vermont, over Lake Champlain and on to Lake Placid. Before I left I made the decision to purchase the Lake Placid Legacy Sites Passport, which got me free admission to different venues, discounts at merchandise and concession stands and discounts on certain attractions.

I started Monday by heading just outside Lake Placid to Whiteface, the host of alpine skiing during the 1980 Olympics. It was dreary and cloudy, so I was pretty sure I was not going

to have much of a view from the summit of Whiteface. However, the gondola ride was included on the passport, so I got on the earliest ride to the top at 8:30 a.m. and made my way up into the clouds. I could see the surrounding area for most of the trip up, but the summit was socked in pretty good so it wasn't a terribly long stay on the summit.

From there, I made my way back into town for a 10 a.m. tour at the US Olympic and Paralympic Training Center. After a quick trip around the facilities where many Olympic athletes train I headed downtown to the Olympic Center in the middle of town. That facility included the outdoor speedskating rink (right in front of the high school), the original 1932 ice rink and the infamous rink where the Miracle on Ice occurred during the 1980 Olympics. It also included the Olympic Museum, which had the admission covered on the passport.

From there, I headed to the other side of town and the Olympic Ski Jumping Center. The passport granted me a ride up the gondola to the base of the jump and then there was an elevator ride up the ski jump to the top. I have been to the top of the ski jumps in Albany and Plymouth and I've been to a few different Olympic ski jumps, but this was the first time I had stood at the top of an Olympic jump. It was pretty cool, if I do say myself.

My final stop of the day was at Mount Van Hoevenberg, which hosted the slid-

ing sports along with biathlon and cross-country skiing at the 1980 Olympics. The passport got me a discount on a ride on the Cliffside Coaster, which brought me up the mountain and then back down along part of the former bobsled course, which has since been redone and moved up to modern standards. Luckily the rain held off (for the most part) and I was able to finish out my day without getting soaked.

As I headed home, I started counting and realized that I had seen almost as many Olympic venues in my one day in Lake Placid as I did over the course of two-plus weeks in Italy for the Milan-Cortina Olympics. I also came away impressed that such a small community could host a big event like the Olympics. Yes, I know the Olympics were a bit smaller back then, but I've seen what is needed to host the Olympics and being able to do it in a relatively small community is pretty impressive. Would I love to see the Olympics return to Lake Placid? Sure, but I don't know if it is completely reasonable.

And now, it's on to fall sports.

Plenty of Saturday action at New Hampshire Motor Speedway

LOUDON — Layne Riggs put the finishing touches on a stellar NASCAR Craftsman Truck Series regular season Saturday at New Hampshire Motor Speedway (NHMS), winning the Team EJP 175 and securing the regular season championship before the series heads into The Chase.

The victory was the 11th of Riggs' NCTS career and his sixth of the 2026 season. It was also his first victory at NHMS in just his second start at "The Magic Mile" and his 11th top-10 finish of the season.

Riggs emerged from a double-overtime finish at "The Magic Mile" to take the checkered flag, capping a day that saw the championship picture change all throughout the afternoon. His victory completed a one-two finish for Front Row Motorsports, with teammate Chandler Smith following him across the Granite Stripe start/finish line.

"This is awesome," Riggs said after the victory. "Thank you to all the fans. They got a lot of people in the stands today, so thank you guys so much. Love coming up here. I'm ready for some lobster."

Connor Zilisch controlled the opening portion of the Team EJP 175, winning both stage one and stage two. When the final stage began, Riggs officially clinched the NCTS regular season championship and the number one seed for The Chase, but his afternoon was far from over.

Riggs battled a tight truck as the race went on, with Zilisch and Smith both getting by him before his Front Row Motorsports team made adjustments to help put him back in position to contend for the victory.

"I thought I was off a little bit. I thought I was in trouble," Riggs continued. "Zilisch got by me, Chandler got by me. I was just really, really tight, couldn't get it where I needed it, but my crew chief, Dylan Cappello, engineer Jonathan Coates, they made some excellent, excellent adjustments there at the end. Thank you to my teammate, Chandler, for racing me clean there at the end."

While Riggs battled for the win, the fight for the final position in The Chase produced plenty of drama deeper in the field. With three drivers separated by just one point entering the closing laps, a crash involving Gavan Boschele with six laps remaining sent the race to overtime and left Stewart Friesen, Tyler Ankrum and Jake Garcia tied around the final transfer position.

When the dust settled from a thrilling double-overtime finish, Ankrum emerged with the 10th and final spot in The Chase, despite battling rear-brake problems throughout the race.

"Extremely," Ankrum said when asked how difficult the afternoon had been. "It's very rare you get to come to a place as fast as this, and you have no rear brakes, and we can't fix the problems."

After falling as far back as 27th, Ankrum said the points situation reminded him of racing for a Championship 4 berth at Martinsville Speedway last season. Although relieved to advance, he made it clear afterward that simply making The Chase did not erase his frustration with the team's performance.

"Definitely did not want to come to New Hampshire and perform like that," Ankrum said. "Got lucky, did not perform like we belong in The Chase, so we got lucky."

At the front of the field,

Riggs made the most of the late restart and closed out the regular season with a victory, a championship and plenty of momentum heading into the seven-race Chase. Smith's runner-up finish was his 12th top-10 of the season and his second in two starts at NHMS.

"I love this place. I love this type of racetrack," Riggs said. "Let's bring on The Chase. We only got seven left. Just no mercy."

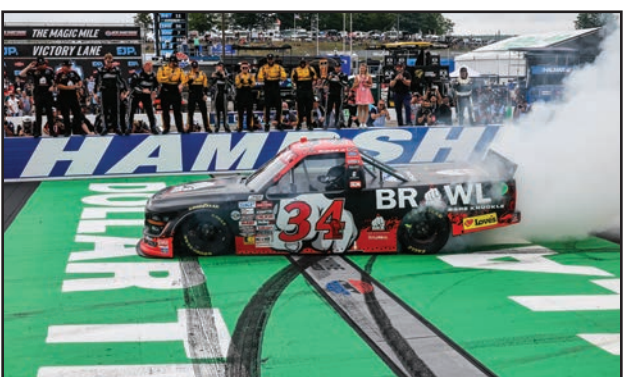

Jonathan McKennedy saved his best move – and just enough fuel – for the final lap Saturday at New Hampshire Motor Speedway (NHMS), taking the lead from Tommy Catalano and holding on to win the Mohegan Sun 100 NASCAR Whelen Modified Tour (NWMT) race at "The Magic Mile."

McKennedy was in the middle of a thrilling battle for the lead throughout the closing laps of the 100-lap race, trading the top spot with Catalano while NASCAR Cup Series (NCS) veteran Ryan Preece lurked close behind. After Catalano led the field to the white flag, McKennedy dove to the inside entering turn one and emerged with the lead.

McKennedy held the top spot through the final two corners and raced back to the checkered flag to earn the Mohegan Sun 100 victory, but his car was already beginning to run out of fuel as he approached the finish line. Catalano crossed the Granite Stripe just 0.215 seconds behind McKennedy, while Preece finished third, only 0.308 second behind the winner.

"I actually ran out. It started to stumble before taking

the checker," McKennedy said. "And when I crossed the checker, it was done, stalled, so it was a huge gamble."

The dramatic finish capped an eventful afternoon at "The Magic Mile," where drafting and changing track conditions kept the running order in constant motion.

Austin Beers and Justin Bonsignore established themselves as two of the cars to beat early, swapping the lead several times before a caution with 63 laps remaining sent the leaders to pit road. Chase Dowling inherited the lead before Beers and Bonsignore began working their way back through the field.

Rain brought out another caution with 28 laps remaining and temporarily halted the action as track-drying efforts began. Once racing resumed, the intensity picked up quickly. Beers battled McKennedy for the lead before McKennedy regained the top spot with 14 laps remaining, setting the table for a frantic run to the victory.

Catalano challenged McKennedy for the lead with 10 laps remaining as Preece joined the fight from behind. A late caution bunched the field once again and gave the

leaders one final opportunity to settle the race.

Catalano and McKennedy raced side-by-side and made contact after the restart before Preece helped push McKennedy stayed within striking distance, however, and made his move as the field took the white flag, completing the final-lap pass that delivered one of the biggest victories of his career.

"This is probably the big-

gest event in the Northeast," McKennedy said. "This is our Super Bowl, so to win here in New Hampshire was just huge. Tons of people here. The whole NASCAR group's here this weekend. A ton of eyes on this race. Everyone talks about this race. Everyone comes to watch this race."

Defending Mohegan Sun 100 winner Tyler Rypkema finished fourth, with Trevor Catalano rounding out the top-five. Michael Christopher Jr. finished sixth, followed by Dowling, David Sapienza, Teddy Hodgdon and Andrew Molleur.

The victory also gave McKennedy a boost in the NWMT championship standings after a pair of difficult races had dropped him from near the top of the standings.

"Anything's possible," McKennedy said. "I've been doing this a long time,

and you just gotta keep on digging until the last race. It was just a few races ago I was only, I think, 10 points out of the lead. We had two bad races, just nothing but bad luck. Here we are today, just like that, within striking distance again. Anything can happen."

The Mohegan Sun 100 once again delivered the close-quarters racing that has made the NHMT a fan-favorite at NHMS. The Tour's unique combination of drafting and high-speed, open-wheel racing has produced some of the most memorable finishes in the history of "The Magic Mile," and Saturday's last-lap battle added another chapter to that tradition.

The Mohegan Sun 100 completed the on-track portion of Doubleheader Saturday at NHMS following the Team EJP 175 NCTS race earlier in the afternoon, won by Layne Riggs.
