Gilford's Amanda Joy tops female field in Granite Man Triathlon

Alton's Josh Flanagan finishes third overall

WOLFEBORO — The 43rd annual Granite Man Triathlon featured a pair of new winners with plenty of familiar faces in the mix as well.

The annual Wolfeboro tradition was started as a fundraiser for the Albert Dow III Memorial Scholarship and is run in memory of the former Tuftonboro resident who died during a search and rescue mission in the White Mountains in the

early 1980s. The triathlon is run by the Wolfeboro Parks and Recreation Department.

The swimming portion takes place at Carry Beach on Forest Road, with athletes swimming out and back into the bay then they hop onto the bikes and head out Forest Road to Route 109 toward Tuftonboro. The bikes turn at Union Wharf Road in Tuftonboro and then on to Route 109A to head back toward Wolfeboro. After a sharp turn onto Waumbek Road, riders return to Route 109 and Forest Road, where

Barnstead-based logger convicted of multiple felonies; ordered to pay more than \$100,000

BARNSTEAD — The N.H. Forest Protection Bureau has announced that Clay Dow, president of CMD Logging of Barnstead, has been convicted of seven deceptive forestry practice violations across two counties resulting in fines and restitution totaling \$107,002.33. He also faces up to 15 years in prison.

Dow was convicted of five felony counts in Belknap County Superior Court, stemming from crimes committed against five separate landowners residing in Barnstead, Gilmanton and Alton. He was also convicted of two felony counts in Strafford County Superior Court stemming from crimes committed against two separate landowners residing in Strafford and Lee. All seven crimes took place in 2022.

The investigation into Dow's actions began when New Hampshire Department of Revenue Administration Timber Appraiser Rick Evans raised concerns about a potential timber tax violation reported to him by a landowner in 2023.

Evans shared his research with the N.H. Forest Protection Bureau, which is responsible for the enforcement of New Hampshire's timber harvesting laws.

As a result of a 20-month investigation, N.H. Forest Rangers uncovered repeated instances in which CMD Logging did not pay landowners for multiple truckloads of timber removed from their properties.

"The success of these investigations was made possible due to assistance provided by the New Hampshire Department

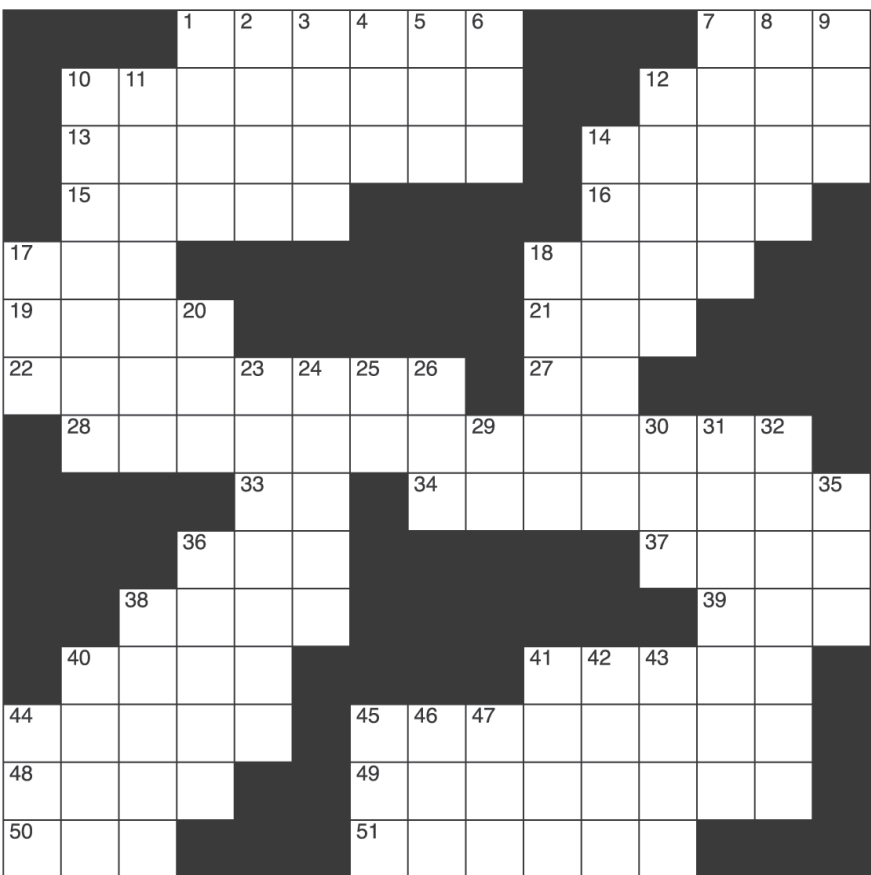

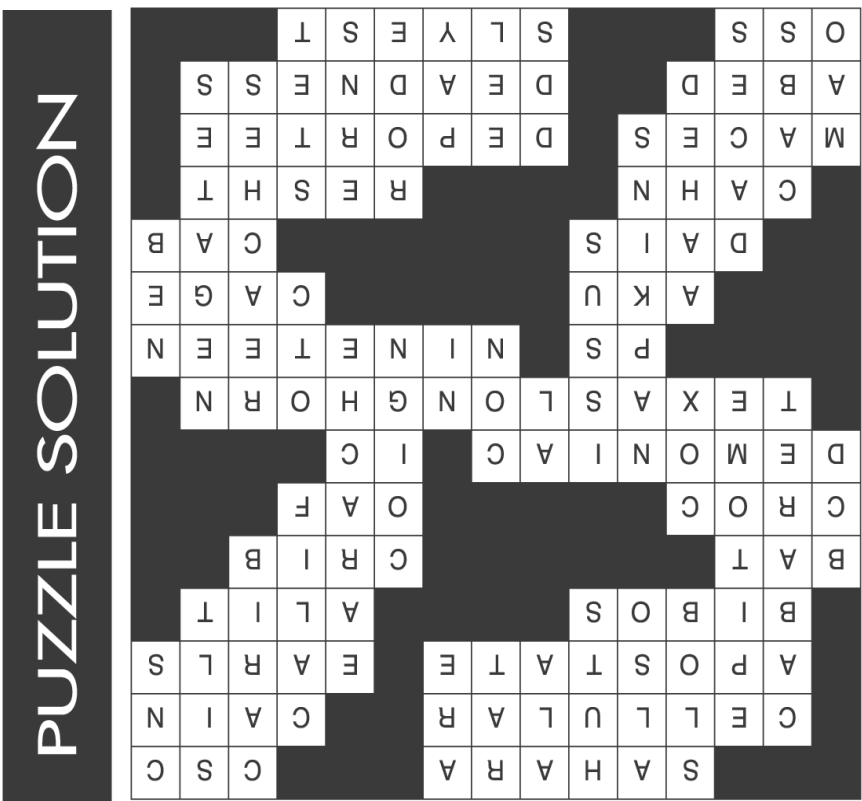

Alton Board of Selectmen Updates

ALTON BOARD OF SELECTMEN

The Alton Board of Selectmen's meeting on Aug. 11 covered several issues, briefly reviewed as follows:

A public hearing was held to approve acceptance of a premium refund for \$10,500 from our health insurance co-operative. There was no public input and all voted in favor. This money will be returned to the general fund.

A representative from the New Hampshire Department of Environmental Services presented the most recent plan relating to Alton Power Dam. The plan has been revised to conduct a compete draw-down of the dam over a two-week period commencing on Sept. 2. The water level would then be restored to a depth two and a half feet below the current level. The Board expressed a great deal of concern for several reasons, including downstream silting and pollution, habitat damage, impact on both private and public wells, loss of property values and loss of fire protection water sources. The Board pressed for further study and a delay in the proposed drawdown schedule. More than 30 citizens were present, and their comments made it quite clear that there is a great deal of opposition to the proposed plan. Executive Councilor Joe Kenney addressed the

Board and committed to protect the town's interest to the extent possible.

The Board reviewed an updated proposal for several computers and related accessories. These would replace existing equipment which has an average age approaching seven years. The original low bid was for almost \$60,000. IT director Josh Monaco was successful at reducing the cost by approximately \$10,000 through negotiation and additional quoting. The Board voted to spend up to \$50,000 for the equipment, with funds drawn from the IT capital reserve account.

-Town Administrator Ryan Heath Reported a request from the firm seeking to establish a seaplane base in Alton Bay to apply to the state for a docking permit in the Bay. The Board agreed that such step was very premature and should await a public hearing and likely a warrant article vote before any application would be entertained.

The board voted to enter executive session. Upon completion, the Board returned to public meeting status.

A motion was made, seconded and unanimously approved, instructing the Town Administrator to direct Town Council to seek an injunction prohibiting the state from any further action regarding the Alton Power Dam for at least one year. It was recognized that legal

action against the state can be difficult and costly, but that the town had reasonable grounds for such an action, and a good chance of prevailing.

The Town Administrator reported that our new Building Inspector and Town Planner were making significant progress clearing permit and inspection backlogs and advancing needed work on zoning amendments, Capital Improvement Plan work, file and record organization and revisions on various systems. It was proposed to transfer the Zone Enforcement function to the Planner. Given the evident progress in these departments, the planned hiring of a part-time assistant is no longer required, saving a budgeted \$28,000 annual expense. The Board voted to approve the changes and included a wage adjustment for the Planner and Assistant Planner.

-The regular meeting scheduled for Tuesday, Aug. 25 has been cancelled. The Sept. 8 meeting has been rescheduled to Wednesday, Sept. 9 due to the primary election set for Sept. 8.

Gilman Public Library adds 103 children's books through Friends fundraiser, Pilcrow Foundation grant

ALTON — The Gilman Public Library has expanded its children's collection with the addition of 103 new books through a partnership between the Friends of the Gilman Library and the Pilcrow Foundation. The Friends of the Gilman Library raised \$400 to support the purchase of new children's books. Through the Pilcrow Foundation's Children's Book Project, that donation was matched 2:1 with an additional \$800, providing a total of \$1,200 to strengthen the library's collection for young readers.

The funding allowed the library to purchase 103 new children's books, including several bonus titles provided by Pilcrow Foundation donors. Each book purchased

through the grant program includes a commemorative bookplate recognizing the Pilcrow Foundation and its supporters.

"This project demonstrates the impact that community support can have on our library," said Eileen Gilbert, Director of the Gilman Public Library. "We're grateful to the Friends of the Gilman Library for their fundraising efforts and to the Pilcrow Foundation and its donors for making it possible to bring so many wonderful new books to the children and families we serve."

The Pilcrow Foundation is a national nonprofit organization dedicated to providing new, high-quality children's books to public libraries

across the United States through its Children's Book Project. By partnering with local libraries and community donors, the foundation helps expand access to reading materials for young people.

Library staff members say the project has been especially rewarding because it brought together community volunteers, donors, and a national nonprofit with a shared goal of encouraging a lifelong love of reading.

Visitors are invited to stop by the Gilman Public Library to browse the new additions to the children's collection. Look for the special Pilcrow Foundation bookplates inside each of the grant-funded books.

Small acts of stewardship keep special places healthy

Some of the most valuable conservation work does not require a massive construction project, a large grant or a complicated government program. Sometimes it requires a pair of work gloves, a few free hours and people willing to pull weeds.

That will be the case at Gunstock this week, where volunteers are being invited to help care for the Wetlands Walk on Thursday, Aug. 20, and Saturday, Aug. 22, from 9 a.m. to noon.

The work might seem modest. Volunteers will remove invasive plants, clean the boardwalk and identification plates, perform minor carpentry and help maintain features that make the trail accessible. At the Belknap County Conservation District's pollinator garden, there is crabgrass to pull before it produces seed.

Yet these small jobs add up to something much larger.

The Wetlands Walk gives visitors an opportunity to see a natural environment that can easily be overlooked. Wetlands perform important ecological functions, but their value becomes much easier to understand when people can walk through one, see what is growing there and observe the birds, insects and other wildlife that depend upon it.

At this time of year, the rewards are particularly visible. Joe Pye weed, blue vervain, spirea, boneset and goldenrod are among the native plants providing summer color. Sumac offers food for birds. Those plants are also competing against invasive species including purple loosestrife, glossy buckthorn and oriental bittersweet.

Managing invasive plants is rarely a one-day proposition. Pulling a buckthorn plant or removing loosestrife before it goes to seed will not eliminate invasive species from the Lakes Region. It does, however, keep them from gaining additional ground. Repeated year after year, that kind of patient maintenance can make an important difference.

There is also something worthwhile about conservation work that allows ordinary residents to participate directly.

Environmental stewardship can sometimes feel distant from everyday life. Discussions about water quality, habitat protection and invasive species can involve scientific reports, regulations and policy decisions. Those things matter, but so does putting hands in the soil and learning to recognize which plants belong there and which ones threaten the native ecosystem.

A volunteer who spends Saturday morning pulling buckthorn may leave knowing considerably more about the woods than when he or she arrived. A young person earning community service hours might discover an interest in conservation. Someone who has walked the boardwalk many times might gain a new appreciation for the work required to maintain it.

The effort also demonstrates why public spaces depend upon more than the organizations responsible for managing them. Trails, conservation lands, gardens and parks remain inviting because people continue caring for them long after they are created.

There will always be another board that needs cleaning, another invasive plant emerging along the edge of the woods and another repair that cannot wait forever.

That is not a failure of conservation. It is the nature of stewardship.

Gilford and the surrounding Lakes Region are fortunate to have abundant natural places that residents and visitors can explore. Protecting them does not always require doing something dramatic.

Sometimes, it means showing up for a few hours, pulling some weeds and leaving a special place a little better than it was that morning.

I've been finally getting around to doing some house maintenance work lately. It feels good to be somewhat productive. I've been tending to scraping and painting my windows and trim, something that was long in need of attention. To be honest, I was expecting to find more rot than the minor amount I found. That was pretty easy to deal with.

Working around the house, four ladders at a time, I'm now working around the back corner. Along the way, I'm tending to the cellar windows as I go. When I came around to the back

side, there was a whole mess of plant matter growing up in front of the windows, so I needed to facilitate their extraction.

Going over to the woodshed, I reached up to get a sickle. Wouldn't you know that it was all rusty, sending me to the cellar to find the sharpener. It wasn't there. The nail where it should be hanging only held a paint can opener. That's dangerous. It could be anywhere. It wasn't on the work bench which is the only other place it should be in the cellar.

Finally, an impression of it sitting in the truck toolbox came to

me. And there it was. It had become another one of those little things that gets slipped into that already overloaded toolbox. Thank you, Lord. At least I located it. I got to doing a good sharpening job on the sickle.

Down on my knees, I'm extracting all this growing wildness, holding the weeds with my left hand while slicing them off with my right. The right tool always comes in handy.

All of a sudden, my attention is drawn to my left hand. There was a yellow jacket sitting there stinging and stinging me over and over again. This was an interesting thing to watch, but it wasn't a highly desirable situation, so I took the sickle and just kind of nudged the little bugger and it flew away. There were a whole bunch of others flying around, defending the nest, so I figured that I'd leave that window to some other time.

As I was getting on with the rest of the work I had in progress, I looked down to notice that my left hand was all bloody. Good Lord, I was really gentle with that little wasp. I guess I did a good sharpening job. Giving it a look over, I decided to let it be, it wasn't much of a cut and God makes the best band-aids.

After finishing up, there was still time to do something, and my eye caught my bike, so I squeezed the tires and they were OK, so I hopped on and went for a cruise around the neighborhood. When I got back, I wandered out back and checked to see how the berries were

doing. There were still a fair amount of my favorite dark ones left. I sampled a quick handful. Then I did a handful of the whitish ones. No contest. I went and got my picking can and went around the bush picking enough for one last breakfast with berries.

Being unable to totally put my work aside, I checked out the last cellar window as I left the house, there were some wasps building a hive there. It was still small, so I kicked it off with my toe. In checking it out a little later, there were a couple more small hives starting to be build. My toe was ineffective on these little ones so I grabbed an old ski and sort of sliced them all off. Another one of those proper tool things.

If I wasn't going to be painting it soon, I'd spray some oil up under there because they will be back quickly to rebuild. They don't like to build, or can't attach their nests to an oily surface. I sprayed the inside ceiling of my tractor cab with some wire dry number forty and the wasps seem to no longer be interested in that location.

Sitting on the sauna bench, I watched Mother Bluebird land on the arbor. Then one of the little ones landed next to her. I could tell they were keeping an eye on me. Then Dad landed on a garden post and they all zoomed into the blueberry bush before heading off to the woods to meet with the rest of the family.

The things we keep meaning to fix

There is a loose doorknob in our house that has been loose long enough to qualify as a member of the family.

I know how to fix it. This is important.

I am not being defeated by some complicated piece of machinery involving electronics, hydraulics or an instruction manual translated from another language. It is a doorknob. There are screws involved. I own screwdrivers. And yet, the doorknob remains loose.

Every few days, I grab it, feel the familiar wiggle and think, "I really need to fix that." Then I continue on my way.

Most houses, I suspect, have something like this. Maybe it is a kitchen drawer that sticks. Perhaps there is a cabinet door that doesn't quite close, a screen with a tiny hole in it or a floorboard that squeaks so reliably that everyone knows exactly where to step if they're trying to move quietly.

None of these things rises to the level of an emergency. That is precisely why they survive.

If a pipe bursts, we respond. If the refrigerator stops working, action is

immediate. If water begins coming through the ceiling, nobody says, "I'll get to that one of these weekends."

The little problems are different. They settle in.

A while back, I mentioned our loose doorknob to my wife.

"I know," she said.

There was something about the way she said it that suggested she also knew exactly how long I had been planning to repair it.

"I'll tighten it," I said.

She nodded.

Long marriages contain conversations like this. Both parties understand that no actual timetable has been established.

The strange thing is that the repair itself would probably take five minutes. Finding the screwdriver might take another 15, depending upon whether I returned it to its proper location the last time I used it. I probably did not.

The screwdriver is likely

sitting next to some other unfinished project, thereby creating a small museum devoted to good intentions. I don't think this tendency is limited to home repairs. We all accumulate little things we intend to get around to.

There is the friend we have been meaning to call. The photograph we planned to put in a frame. The book sitting on the nightstand with a bookmark that hasn't moved since April.

There are recipes clipped out and never tried, roads we keep saying we ought to explore and local places we have driven past hundreds of times without ever stopping.

None of these things is urgent. Urgency is very good at getting our attention. The ordinary things have to wait their turn. Unfortunately, their turn doesn't always come.

The older I get, the more suspicious I become of the phrase "someday." Some-

day is a wonderfully convenient place. You can put almost anything there. I'll organize those old photographs someday. I'll take that scenic drive someday. I'll stop at that little museum someday. Someday apparently has unlimited storage capacity.

The trouble is that our calendars do not contain a day by that name. This doesn't mean I am about to embark upon a grand campaign of personal efficiency. I know myself better than that.

There will always be unfinished jobs around our house. I suspect that is true of most homes that are actually lived in. A perfectly maintained house sounds impressive, but also slightly suspicious. I would be afraid to touch anything.

Still, perhaps there is something worthwhile about occasionally choosing one small thing that has been waiting patiently and finally doing it. Make the call. Frame the picture. Take the drive. Tighten the doorknob.

In fact, after writing this, I think I'll go find that screwdriver. Assuming I can remember where I left it.

of Revenue Administration, the many hours of investigation by the New Hampshire Forest Protection Bureau's forest rangers, and the incredible support provided by both the Strafford County and Belknap County Attorneys' offices," said Chief Michael Matson of the NH Forest Protection Bureau.

"Furthermore, the Forest Protection Bureau wishes to thank the many sawmills that cooperated with the State of New Hampshire's requests to provide critical evidence necessary to prove the State's case," he continued. "The landowners victimized by CMD Logging in these cases could not have been made whole without their assistance."

Belknap County Superior Court has ordered the following relief, based on

the five felony convictions in that county:

- Dow will pay \$72,410.37 restitution to the Belknap County victims
 - Dow will pay \$10,000 in fines to the State of New Hampshire
 - Dow will pay \$2,400 Penalty assessment to Belknap County Superior Court
 - Dow will serve one-and-a-half to three years in prison for each felony conviction, with the prison sentence suspended for five years good behavior.
- Strafford County Superior Court has ordered the following relief, based on the two convictions in that county:
- Dow will pay \$17,231.96 restitution to the Strafford County victims
 - Dow will pay \$4,000 in fines to the State of New Hampshire
 - Dow will pay \$960

Penalty assessment to Strafford County Superior Court

- Dow will serve one-and-a-half to three years in prison for each felony conviction, with the prison sentence suspended for five years good behavior.

In addition to the Belknap and Strafford County convictions, felony indictments against Dow are awaiting trial in Hillsborough and Merrimack counties.

Removing invasive weeds such as purple loosestrife, glossy buckthorn and oriental bittersweet are helping to manage them. There are only a few loosestrife plants to dig out, buckthorn is pulled along damp woods edges and bittersweet vines are tucked into the sumac. The red flowering sumac helps feed the birds healthy food. Keeping the invasive plants from producing seed is part of the goal. From May to October there are native wildflowers blooming at the Wetlands Walk, currently Joe Pye weed (tall pink), blue vervain (purple), spirea (pink or white), boneset (white), golden rod (yellow) and others brighten

Other volunteer tasks include cleaning the boardwalk surface and the name plates, minor carpentry for leveling and new posts, sanding and priming/painting the bumper for the visually impaired.

Belknap County Conservation District has a pollinator garden that will need some crabgrass (non-native variety) pulled before it goes to seed. Snacks, water and beverages provided.

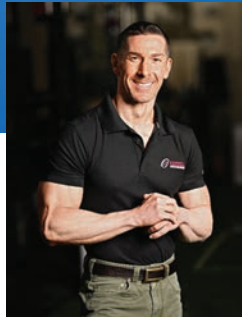

The Mt. Washington

Auto Road was opened in August 1861, a little more than 100 years before the first official Mt. Washington Auto Road Bicycle Hillclimb race starting cannon was fired. Built by hand, the road climbs over 4,000 feet of elevation in 7.6 miles from the base. Since 1973, cyclists have challenged themselves by riding up the road in a race against their peers or sometimes, just the clock.

In the early 1990s, Tin Mountain Conservation Center was approached by the Mt. Washington Auto Road to organize the Bicy-

cle Hillclimb race. The Auto Road gives visitors from around the globe the opportunity to experience being above tree line and educates them about the natural and cultural history and traditions of the mountain.

Tin Mountain Conservation Center promotes an appreciation of the natural environment to children, adults and families and demonstrates responsible stewardship of natural resources. TMCC works closely with the Auto Road to give cyclists the opportunity to experience all that is Mt. Washington on the only day that the road is open exclusively to bicycles.

The route is 7.6 miles in length, has an average grade of 12 percent with extended sections of 18 percent and the last 50 yards is an amazing 22 percent.
