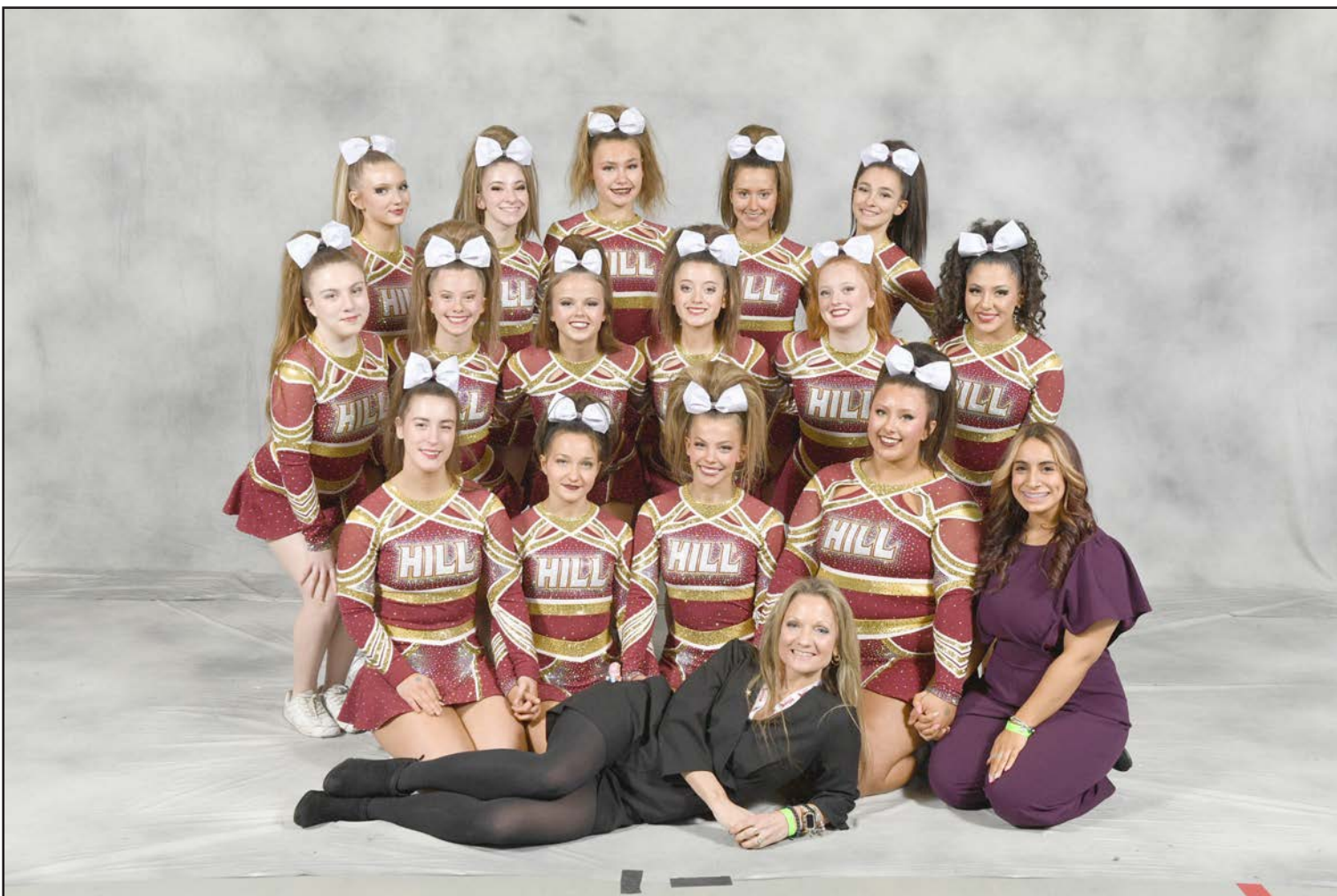

Franciscan missionary shares work in Uganda during visit to Saint Joseph School

WEBSTER — Students at Saint Joseph School recently welcomed Fr. Piotr Dąbek, OFM Conv., a Franciscan friar who has spent the past nine years serving as a missionary in Uganda, for a presentation on his work and life in East Africa.

Fr. Piotr, who currently lives in the capital city of Kampala and oversees a community of Franciscan friars, spoke to students about the culture, faith, and daily realities of life in Uganda. He described the country as both diverse and vibrant, noting that it

is home to nearly 50 tribes and languages, with English often serving as a unifying language.

Drawing from his experiences, Fr. Piotr highlighted the welcoming nature of the Ugandan people, recalling how warmly he was received upon his arrival. He also shared insights into local customs and traditions, including the importance of family and respect for ancestors.

Students were especially engaged by his descriptions of Uganda's landscape and wildlife. He spoke about

A season to celebrate at Shepherd Hill

There are many ways a community measures success in its schools. Test scores matter. Graduation rates matter. College acceptance rates matter. But there is another kind of achievement that is sometimes harder to quantify and just as important to recognize: the kind that grows from teamwork, discipline, and shared purpose.

The Shepherd Hill Varsity Cheerleading Team gave our area a powerful reminder of what that kind of success looks like this season.

Winning the Mid-Wach League Championship with the highest score in the competition would be an accomplishment in its own right. Following that performance with another top score at the Central Massachusetts Regional Championship showed something more than momentum. It showed consistency, preparation, and confidence. Then, to finish third in the Massachusetts State Cheerleading Championship among the best Division 2 teams in the state confirmed what many already knew. This was a team competing at the highest level.

Behind those results are hours that most people never see.

Competitive cheerleading demands strength, precision, timing, and trust. Athletes lift one another, quite literally, and rely on teammates to do the same. A routine succeeds only when every participant performs their role exactly as planned. There is no shortcut to that level of coordination. It comes from repetition, resilience, and a willingness to support one another through mistakes as well as victories.

That kind of effort deserves attention.

In towns like Dudley and Oxford, school teams often serve as a shared point of pride. They bring families together in gymnasiums on winter evenings and create common memories that last long after the season ends. When a local team advances through league, regional, and state competition, it becomes something the entire community can celebrate.

It also sends a message to younger students watching from the stands.

They see what commitment can achieve. They see older students representing their school with confidence and determination. They begin to imagine themselves in those roles one day. That sense of possibility is one of the quiet strengths of school athletics and activities of every kind.

The Shepherd Hill cheerleaders also demonstrated something else worth noting. Their success did not come from a single standout moment. It came from steady progress across an entire season. Championship performances at multiple levels do not happen by accident. They reflect coaching, planning, and a team culture built on accountability and encouragement.

Those qualities extend beyond competition.

Students who learn how to work together under pressure, set goals, and support teammates carry those lessons into classrooms, workplaces, and communities. They become the neighbors and volunteers who help keep small towns strong.

That is why achievements like this matter.

The Shepherd Hill Varsity Cheerleading Team has given our community a season to remember and a performance record that stands among the best in the state. Their accomplishments reflect not only talent, but dedication and teamwork of the highest order.

They have represented their school, and all of us, with pride.

As time goes on: A fish and clock story

Just inside the door of the main museum room is a 43-inch-high clock with a sign that says: "1930 Original Time Clock. This time clock was made in Gardner Massachusetts and used in the Fish Nursery that was located at 39 School St. Auburn Massachusetts."

This lovely wooden encased clock kept track of the comings and goings of the workers as they punched in to work each day. Blank timecards are on top and in the ready waiting to be used.

It was Edward G. Watkins who invented and patented this kind of clock in 1894. He was working for Heywood Brothers & Wakefield Company in Gardner, MA and in charge of the engineering department. They were the makers of chairs and school furniture. Watkins eventually left the company to start the Simplex Time Recorder Company which made the clocks he had invented. For over 86 years Simplex was the trusted time-recording device on the market. His system was a topic of meetings at the Washburn Mechanical Engineering Society where papers were presented and discussed on "Modern methods of time-keeping in manufacturing" in 1894. When grandson, Edward G. III, took over the company he diversified to fire alarms and security systems. He also was a philanthropist giving to hospitals and sitting on the boards of several different charities. So, how does a clock relate to Fish?

Fish Nursery, the original owner of the time recorder clock, was started by Charles Robinson Fish Sr. about 1900 in Worcester on Hadwen Road near June St. An advertisement showed that the Charles R. Fish & Co. sold a variety of fruit, ornamental and evergreen trees and shrubs, Hardy roses, peonies and phlox, and much more all at producer's prices and planting at cost.

The 1927 tax records of Auburn had Charles listed as a non-resident paying taxes of \$13.92 on property at 39 School St. The 1930 record showed that Chester B. Fish had 36 acres, house, barn, shed and two horses on the property. By 1945, Fish Nursery owned not only the 36 acres at 39 School Street, but also 22 acres off Washington Street. Through the years, Fish

Nursery would be mentioned in articles like the Westboro Woman's Club annual event of 1934 at their town hall that referred to "the exhibit of C.R. Fish nursery and landscape gardener of Worcester." In 1942 the nursery donated a truck to the USO to help them with their fundraising efforts to collect scrap metal to sell to continue their programs. Chester, Charles's son who took over the business, died in 1967 and his obituary said he had lived in Auburn for 43 years. He was a member of the First Congregational Church, a member of the Joel Prouty Lodge of Masons, and a member of the National, New England and Massachusetts Nurserymen's Association.

In 1963, about four acres of the nursery was sold to the Western Massachusetts Episcopal Diocese to build St. Thomas Episcopal Church and vicarage. At this time there were only 23 acres left of the original acreage. Chester's brother, H. Judson Fish, sold the Washington St. property to M. Grossman Lumber Co. of Quincy which they wanted to turn into an Auburn Branch of the company. Grossman donated 11 mountain ash trees and 11 cedar trees to the Auburn Tree Planting Committee for the west side of Memorial Field and a maple tree for Auburn in June of 1962. The 1968 tax record book, which is the last one the Auburn Historical Society & Museum has, shows Ada E. Fish, the remaining person living at 39 School St. with only four acres.

The museum is happy to be able to be the steward of this time recorder clock that was used at the Fish Nursery, which was not far from where the Auburn Historical Society & Museum is located and may have been part of the nursery. The public is invited to come and see this exhibit and several other vintage clocks that are throughout the museum and are waiting to be seen.

The old road map in the glove compartment

The other afternoon, I went looking for my car registration and found something I had not touched in years.

It was an old paper road map. Folded the wrong way, of course.

I do not even remember when I put it there. The edges were soft from being opened too many times, and there were little pen marks along Route 20 and Route 9 from trips I must have taken when my children were younger and every ride somewhere counted as an adventure.

These days, most of us travel with a calm voice coming from the dashboard telling us exactly when to turn left and exactly when to turn right. It is efficient. It is helpful. It is also a little lonely compared to the way we used to get around.

Paper maps required cooperation.

Someone had to hold the map. Someone had to read it. Someone had to admit when the map was upside down. And someone had to say, "I think we missed that turn about two miles ago."

Usually that last person was me.

There was a time when every glove compartment in Massachusetts seemed to hold at least one folded map of the state, sometimes two if you counted the one that covered the Berkshires and the one that covered the eastern half where the roads never seem to go quite the way you expect them to.

You could tell how old a map was by which highways were missing.

Route numbers changed. Interchanges appeared where nothing had been before. Whole bypasses arrived that made you feel as if the world itself had shifted slightly while you were not paying attention.

Still, we trusted those maps.

They helped us find county fairs we had never visited before. They helped us get to Little League games in towns we could not pronounce. They helped us discover ice cream stands that were never advertised anywhere except by the number of cars already parked outside.

A map did not simply tell you where to go. It invited you to notice where you were.

I remember sitting in the passenger seat while my wife drove through towns neither of us knew very well, tracing the road ahead with one finger and announcing each turn like it was part of an expedition. The children in the back seat always seemed to believe we were traveling somewhere important, even if it was only the next town over for a school concert or a Saturday errand.

There was a sense that we were figuring things out together.

Today, when the dashboard voice tells me to turn, I turn. When it says I have arrived, I believe it. There is nothing wrong with that. It gets me where I am going every time.

Still, finding that old map reminded me how much of small-town life used to depend on learning the roads slowly.

You learned where the river crossed under the highway. You learned which towns had the best shortcut when traffic backed up near the rotary. You learned which back roads felt longer in winter and shorter in June.

Most of all, you learned how close everything really was. Massachusetts is full of places that seem far away until you discover they are only twenty minutes down a road you had never taken before. A folded map used to make that clear in a way a glowing screen never quite does.

I put the map back in the glove compartment when I finished looking at it. I do not expect I will need it again. The car already knows how to get me where I am going.

But I am glad it is still there.

It reminds me that for a long time, getting somewhere was not only about arriving. It was about paying attention to the turns along the way, and sometimes even missing one or two and finding something better because of it.

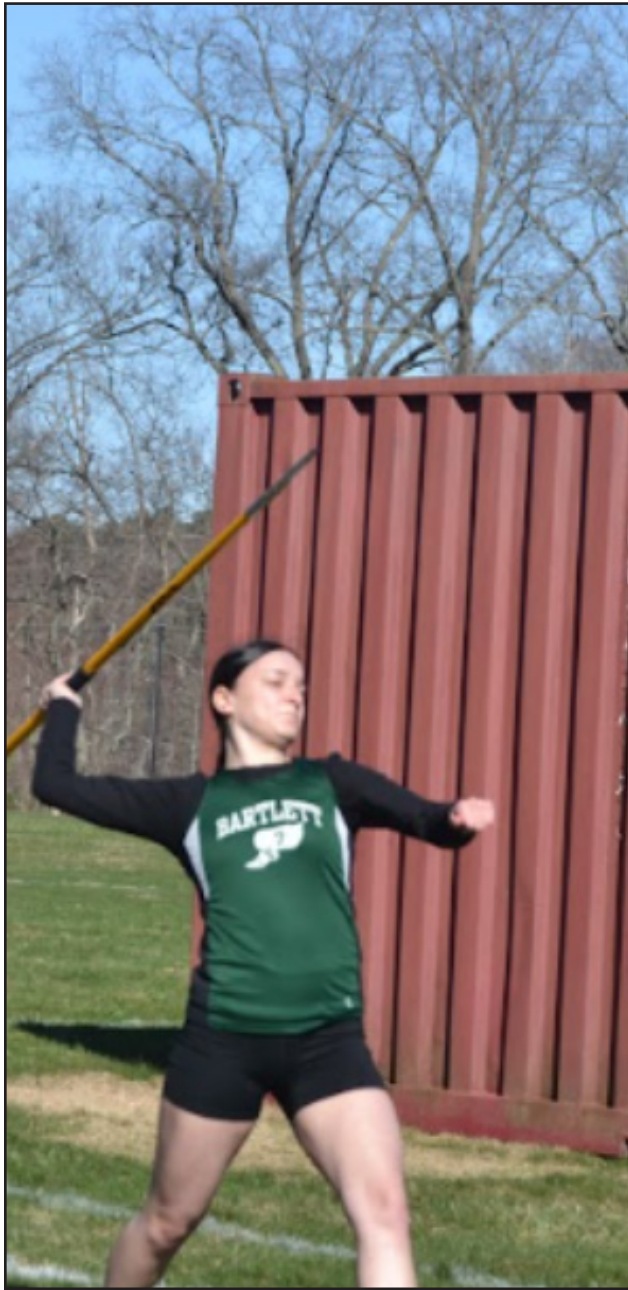

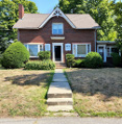
Overall, both teams competed hard, with Quaboag earning the win by a final score of 78-60.

Administrators (NASBLA) it will also cover the requirements to operate a vessel in most other states & many countries where boating safety education is mandatory including RI and CT.

The Hanson-Milone Boater Safety Act, signed into Mass. Law, will now requires ALL Mass. motorboat operators to complete an approved Safe Boating Certificate course before April 1, 2026, for anyone born after 1/1/1998, and by April 1, 2028, for boaters born before 1/1/1998. Enforcement of the new law will begin on September 1, 2026. This course meets the new Mass. requirement. Most boating insurance companies offer a discount on premiums for successful completion of this course. Participants 16 years old and under must be accom-

the country's national parks, which are home to lions, giraffes, and gorillas, as well as the Nile River—one of the longest rivers in the world—which begins in Uganda and supports a wide range of wildlife, including crocodiles and hippos.

Fr. Piotr outlined the work of the Franciscan mission, which serves communities in several regions, including Kakooge and Matugga. The mission's efforts extend beyond parish ministry to include educational initiatives, medical outreach, youth programs, and sponsorship opportunities for

children.

He also discussed ongoing development projects, including the construction of a Divine Mercy Chapel dedicated to perpetual adoration and plans to expand the Franciscan presence into additional areas of the country.

Throughout the presentation, Fr. Piotr emphasized both the challenges faced by many communities, including poverty and limited access to resources, and the resilience and strong faith of the people he serves.

He encouraged students to consider how they might make a difference in the world, reminding them that even small acts of generosity and faith can have a

meaningful impact.

In support of his mission, Saint Joseph School's Eagles Chapter of the National Junior Honor Society presented Fr. Piotr with a \$500 donation to assist with his work in Uganda.

School principal Beth Boudreau said the visit provided students with a valuable opportunity to learn about global service and the universal nature of the Catholic Church.

"Fr. Piotr's visit helped our students see how faith is lived out in different parts of the world," Boudreau said. "It was a powerful reminder that we are all called to serve others."


