Strategic Master Plan Committee seeks public's input

WEBSTER — The Webster Strategic Master Plan Committee (SMPC) wants to hear from Webster residents.

In June, the Board of Selectmen appointed the committee to develop a Strategic Plan that will guide Webster over the next decade. The Committee is in the information gathering phase of the project. It is reaching out via the town's NotifyMe system to ask residents to answer some questions about Webster. The answers will provide a better understanding of the community's thoughts about a future Webster. It will help lay a basis for the development of strategic goals and objectives.

The SMPC is not starting from scratch. Webster is fortunate to have a wealth of information available to assist the Committee in developing the strategic plan. Key is the prior Master Plan which will be updated in this effort. More recent plans cover demographics, economic development, land use, hazard mitigation, community development, and town services. These plans have been generated to allow the town to apply for resources in specific areas. They will be very useful in building a strategic plan. One

Two men arrested after melee at Dog Park

WEBSTER — On Thursday, Aug. 6 at approximately 7:37 p.m., Officer Nicholas Trinque of the Webster Police Department was patrolling Main Street when he observed a fight at the Black Bull Meat Market. Officer Trinque radioed for other Officers to assist as both men had injuries.

As additional officers arrived, they learned this altercation stemmed from a previous fight at the dog park on High Street. Officer

Aaron Suss proceeded to that location and observed two men, one of which was lying face up on the ground with blood all over him. The man was breathing but was unconscious. Webster EMS was requested to respond.

Officers continued their investigation and learned that multiple men were at the dog park sitting at one of the tables drinking alcoholic beverages. At one point, one of the men, Mr. Derick Brock, started arguing with another man

(who is 63 years of age) and began punching him, causing serious injuries. This resulted the group of men all fighting each other in a melee. Another one of the individuals involved, Mr. Robbie Hryzan, kicked another in the face with a shoe on, resulting in injuries. It was also reported that Mr. Brock was armed with a knife during the fight.

As a result of the incident, Mr. Brock and Mr. Hryzan were arrested without incident.

Derick Brock, 41, of Brandon Road, Dudley, was arrested for A&B on a Person Over 60 Causing Injury and Disorderly Conduct. Robbie Hryzan, 56, of Main Street, Worcester, was arrest for A&B with a Dangerous Weapon and Disorderly Conduct. All suspects are presumed innocent until proven guilty in a court of law.

Dudley-Charlton Regional School District sets public information meeting regarding Sept. 29 special election

DUDLEY — The Dudley-Charlton Regional School Committee has called a district-wide special election in both Dudley and Charlton seeking voter authorization to borrow \$11,183,735 for capital improvements.

School District officials have set a public information meeting for 6:30 p.m. Sept. 2 at Shepherd Hill Regional High School, 68 Dudley-Oxford Road. Dudley residents are invited to learn more about the district's plan for capital improvements and ask questions.

Dudley's share of the borrowing is \$5 million, with Charlton voters considering the remaining share in a concurrent district-wide election. A simple majority of the combined ballots cast in both Dudley and Charlton will decide the question.

The Special Election polls will be open at the Dudley Municipal Complex from noon to 8 p.m. on Sept. 29.

EDITORIAL

A plan for Webster should belong to Webster

Long-range planning can sound like the sort of work best left to consultants, committees and municipal officials. There are statistics to compile, land-use maps to study, economic trends to consider and reports stretching back years to review.

But the most important ingredient in Webster’s new Strategic Master Plan cannot be found in any report. It is the people who live here.

The Webster Strategic Master Plan Committee is now asking residents to help shape a plan intended to guide the town for the next decade. That request deserves a strong response from the community.

Webster is not beginning this process with a blank sheet of paper. The town already has substantial planning work available covering demographics, economic development, land use, hazard mitigation, community development and municipal services. The Community Wide Preservation Plan completed last year adds another valuable piece by examining both Webster’s history and opportunities for revitalization.

Those documents provide data and professional analysis. What they cannot provide on their own is the everyday experience of living in Webster in 2026.

Residents know which intersections cause headaches. They know which neighborhoods have changed, where development has helped and where concerns remain. Business owners understand the challenges of operating here. Parents see the needs of young families. Senior citizens can identify obstacles that may not be obvious to younger residents. People who have lived in Webster for generations bring one perspective, while newer residents can bring another. All of those voices have value.

There is also something encouraging about the committee’s approach. Residents are being surveyed, but that is not the only source of information. The committee also plans focus groups involving business, community and government representatives, interviews and updated statistical research. Taken together, those efforts should provide a much fuller picture of Webster than any single method could accomplish. The greater challenge will come after the plan is written.

Municipal shelves everywhere contain impressive planning documents that were carefully researched, professionally presented and gradually forgotten. Webster officials appear to recognize that danger. The stated intention of creating a “living plan,” potentially accompanied by annual action plans and progress reviews by the Board of Selectmen, may ultimately be as important as anything contained in the final document.

A strategic goal without responsibility, deadlines or follow-through is little more than a wish.

That is why the eventual plan should identify realistic priorities and establish ways for residents to see whether progress is being made. Not every objective can be accomplished immediately, and circumstances will inevitably change over a decade. A useful strategic plan should be flexible enough to respond to those changes without losing sight of the larger direction residents have chosen.

Webster also has an opportunity to recognize that planning for the future and preserving the past are not competing goals. The town’s mill history, its connection to Samuel Slater and the neighborhoods and institutions that developed over generations are part of Webster’s identity. Thoughtful revitalization can build upon that history rather than erase it.

The committee expects to begin drafting long-term goals and objectives in October, with completion of the plan scheduled for February 2027. That makes the current information-gathering period especially important.

Residents who have complained about something in town, praised something that works particularly well or thought, “Webster really ought to...” now have an opportunity to turn that observation into useful input.

Ten years from now, people will still be living with decisions Webster makes today. The best way to make those decisions reflect the community is for the community to participate.

Manchaug Pond vs. Webster Lake

To the Editor:

If you Google “Webster Lake Association,” you will see the heading “Preserving Webster Lake.” If you Google “Are weeds good for New England lakes?” you will read a resounding: Yes. The predominant weed in Webster Lake is Coontail (nickname given to it because it looks like a racoon’s tail). The Google description: “...a native perennial plant that provides good ecological benefits by housing fish and FILTERING WATER.” It goes on: “Provides crucial hiding spots for small fish (which largemouth and smallmouth bass need to grow and flourish) and macroinvertebrates.”

I am a fisherman, and have been fishing in Webster Lake since 1978. It was one of my favorite bodies of water to spend a day. It always (and the unexaggerated word is “always”) gave up 6 and 7 pound giant largemouth and consistent three-and-a-half-to-four-pound smallmouth. You would also catch a trout or two. Those days have, over the past four or five years, completely disappeared.

As a tournament bass fisherman, I am penalized if a fish dies. Therefore, all bass boats are equipped with aerated livewells to keep the fish alive until the 3 p.m. weigh-in. What’s important for readers to know is that these tournaments end with all the fishermen talking about their day and the lake we just spent 8 hours. The conversations will always talk about the quality and the number of fish caught. The picture painted is disturbing.

Comparing Manchaug Pond in Sutton to Webster Lake is quite telling. As the

“crow flies” the lakes are about two and a half miles apart. Almost every tournament in Manchaug produces several six- and seven-pound bass. The lake is magnificent, as Webster Lake was several years ago. The question has to be asked and asked by the organization that claims it is “Preserving Webster Lake,” What has happened to Webster Lake?

The answer is that chemicals that kill the all important Coontail, is killing the lake. The hired killers are doing a great job. The weed, which replenishes itself every summer, is killed off usually by July. In shallow water, where skiers and swimmers don’t go, Coontail can mat over, but this unused water isn’t bothering anyone. I have witnessed weed kill in small bays and even in Stump Pond to the left of Memorial Beach. That area is 3’ deep and full of rock and huge stumps. Nobody is going to ski or swim there – and that is just one example of the killing.

What do the people on Manchaug or Sutton do to keep their lake so pristine? They have harvesters (my word) chop and collect the weed. They look like paddle boats in reverse. They chop and collect and sell the grass as fertilizer. No chemicals, no poison — Webster Lake will be healthy again. And don’t say you don’t know how. Someone that cares about the life of Webster Lake - call someone in Sutton. Someone there knows how to do it right.

Build confidence in your 401(k) decisions

In its simplest form, saving can mean putting money into a jar, adding to it and letting it grow slowly. A 401(k), or other workplace retirement plan, is a step beyond that. It’s more like a garden than a jar. Once you understand the basics of your 401(k), it becomes easier to feel confident in your decisions.

In a jar, your money only grows when you add more. In a garden, what you plant can begin to grow on its own. Your investments can earn returns, and those returns may in turn earn additional returns. That’s called compounding, and it can have a meaningful impact over time. Like a garden, however, growth is not guaranteed. Markets can rise and fall, and investments can lose value.

Most workplace retirement plan contributions are made with pre-tax dollars, which lowers today’s taxable income; you’ll pay taxes when you withdraw it in retirement. Some plans also offer a Roth option: you contribute after-tax dollars and withdrawals in retirement can be tax free. Your plan administrator can provide more information.

Many 401(k) plans include an employer match, either up to a set dollar amount, perhaps \$500, or a percentage of your salary, typically 3–5 percent. Contributions you make, as well as those from your employer, can grow over time. Try to contribute at least enough to capture the full match; anything less means you’re leaving money on the table.

Now the question is how to invest your contributions inside your 401(k). The menu of investment options may seem complicated, but most fall into a few common categories.

Stock or equity funds focus on stocks, which represent ownership in companies. Because they’re tied to company performance, they have the potential for higher growth over time, but their value can go up and down in the short term. When you’re decades from retirement, that short-term volatility matters less; you have time to ride out the swings.

Bond funds invest in loans made to governments or corporations. These tend to be more stable than stock funds but typically grow more slowly. They can help balance the ups and downs.

Balanced or blended funds hold a mix of stocks and bonds in a single investment. Target-date funds combine different types of investments in one fund. As you move toward a specified retirement year, the fund gradually adjusts to focus more on stability and less on growth.

The earlier you start planting, the more time your money has to grow. Even small contributions early in your career can end up as large amounts later, simply because they had more time to compound.

If you change jobs, keep in mind that your employer’s contributions may not be fully yours immediately. It depends on your plan’s vesting schedule, so it’s worth checking before you go.

The most important steps in a retirement plan are getting started, contributing consistently and taking advantage of what your plan offers. With a little knowledge, you can feel more confident moving forward. The garden is yours. Start planting.

Burnap family: The Revolutionary War connection

The Burnap family can be traced back eight generations to Hertfordshire, England in the late 1400s, during the reign of King Henry VII. It was Thomas Burnap, Sr. (1625-1691), who made the trip over to Reading MA sometime before 1689 when Thomas Jr., Ebenezer’s great grandfather, was born. Ebenezer was born on Oct. 13, 1757, in Sutton. He married Thankful Singletary, (born 30 Oct 1762, at Sutton, daughter of Amos and Mary [Curtis] Singletary), about 1796. They had a daughter, Sabrinia. Thankful died in 1808. Ebenezer then married Ruth Tucker in 1809 in Charlton and had daughter Mary, and sons Erasmus and Ebenezer. He was a blacksmith by trade, and lived in Ward [Auburn] until 1803, when he moved to Oxford and bought an estate near Town’s Pond, but returned to Ward in 1810. According to the history of Oxford, the Pratt house in Oxford was conveyed 13 May 1803, by Sylvanus Town to Ebenezer Burnap, and by him in 1815 to Elias Pratt, Jr.

Ebenezer Burnap was a major landowner on Pakachoag Hill in the late 18th and early 19th centuries. According to the “Historic Houses of Auburn,” the house at 340 Pakachoag St. was built by Ebenezer Burnap circa 1795. His land may have extended down to 406 Pakachoag Street with a house that was built about 1840 on land that was originally owned by James Nichols, Gershom Rice Jr., and William Bancroft between 1772 – 1781. The farm that was created was bought by Joseph Dorr in 1785. Joseph sold the house and land to Ebenezer Burnap in 1795, but after Ebenezer’s death in 1820 the heirs divided the estate and sold part of it to Tyler Putnam in 1843. The house was known as the Tyler Putnam house or the Rufus W. Putnam house. Rufus was related to General Israel Putnam, Revolutionary War hero from Connecticut. Ebenezer’s father-in-law, Captain Jonathan Tucker, also served in the Revolutionary War.

Ebenezer served as a private in the Revolutionary War in Captain James Greenwood’s company in Colonel Ebenezer Learned’s regiment out of Oxford which marched on April 20, 1775, in response to the alarm of April 19, 1775 in Lexington, then to Roxbury and served two days. He was also listed with Captain Isaac Bolster’s company in Colonel Learned’s regiment according to the muster roll dated August 1, 1775. He enlisted May 1, 1775, and served three months and 8 days. The company returned from Roxbury, Oct. 7, 1775, according to the “Massachusetts Soldiers and Sailors Who Served in the Revolutionary War.” His brother, Timothy, also served in Captain Samuel Sibley’s company and Captain Arthur Dagget’s company in the Colonel Learned’s regiment at this time. Timothy went on to serve in Captain Jonathab Carriel’s company in Colonel Josiah Whitney’s regiment at Point Shirley 1776 and served until November 1776. He was involved with the march from Sutton to Providence RI on the alarm of December 10, 1776. He was with Captain Jonathan Woodbury’s company in Colonel Jacob Davis’s regiment on the march July 30, 1780. He was discharged Aug. 8, 1780, after serving 13 and a half days at Rhode Island.

Early town records show that Ebenezer was a tax bondsman for Benjamin Carter Jr. in 1785, who didn’t pay his taxes that year. Ebenezer guaranteed that Benjamin would pay all he owed to the town as a tax bondsman. He was also the moderator for a town meeting held on May 5, 1786.

Burnap family apparently left a lasting impression on the town of Auburn by having a street and a lane named after the family In the Pakachoag area. Burnap Street and Lane can be found between Southbridge Street and Pakachoag Street with Burnap Lane running parallel to Southbridge Street.

After Ebenezer’s death, the family seemed to have moved to the Cabot Vermont area. Several of the children are buried there with other family members. His son, Ebenezer Tucker Burnap, was also well thought of in the town as stated in his obituary of November 1900, “Mr. Burnap has always been a much respected and prominent townsman, managing his own affairs with shrewdness and carefulness yet always being lenient and kind to his debtors”.

There are certain objects in a house that apparently do not belong to anyone. Scissors are one of them.

My wife and I have purchased enough pairs of scissors during our marriage that, mathematically speaking, we should be able to open a small barber shop. Yet when I actually need a pair, there are none to be found.

This happened again recently when I needed to cut the tag off something. Simple job. Thirty seconds, maximum.

I opened the kitchen drawer where the scissors are supposed to live. No scissors.

I checked the other kitchen drawer, even though scissors have never lived there. No scissors.

Then came the junk drawer, which is less a drawer than an archaeological site. I found three expired coupons, several batteries of uncertain strength, a key that nobody can identify, two rolls of tape and a tiny screwdriver apparently designed to repair eyeglasses. But no scissors.

At this point, I asked my wife the question every married person eventually asks. “Have you seen the scissors?” This is different from asking, “Where are the scissors?”

The second question suggests that the other person has some responsibility for their disappearance. After three decades of marriage, you learn these distinctions.

She had not seen them. Or, more accurately, she had not seen “the good scissors.”

That was when I remembered that our house has categories of scissors. There are the good scissors. There are the old scissors. There are the little scissors.

There are scissors that came with some kind of sewing kit and are apparently forbidden for ordinary use.

And somewhere, allegedly, there is a pair of scissors in the garage. I went to investigate.

Anyone who has ever entered a garage looking for one specific item knows how this goes.

You begin with scissors. Ten minutes later, you are holding an extension cord, wondering why you own four nearly empty cans of spray paint and trying to remember when you bought a snow shovel with a cracked handle.

I did find a pair of pruning shears, but even I

understood that using those to remove a clothing tag would represent an unnecessary escalation.

So I returned to the house. By now, the original task had become irrelevant. This was no longer about cutting a tag. This was about solving a mystery.

I checked the desk. I checked a basket in the living room. I looked in the drawer where we keep pens, even though the pens themselves rarely seem to be there. Then I spotted them.

The scissors were sitting on a table approximately six feet from where I had begun my search. I picked them up triumphantly.

My wife looked over.

“Those aren’t the good scissors,” she said.

Apparently, victory has many definitions. I cut the tag anyway.

Later that day, I started thinking about all the other household objects that seem to operate under the same rules. Tape measures vanish immediately after being used. Pens migrate from room to room. Flashlights are plentiful until the power goes out. The one screwdriver you need is always missing from the otherwise complete set.

And socks? I am not even going to discuss socks. Some mysteries are beyond the reach of science.

What fascinates me is that these things never seem to disappear permanently. They merely go somewhere else for a while.

A missing tape measure eventually appears on a workbench. The flashlight turns up in the car. A pen emerges from underneath a pile of mail.

And the scissors will inevitably return to the kitchen drawer.

That is, until the next time I need them.

I suppose every home has its own small ecosystem, with objects circulating mysteriously among rooms and family members. Maybe that is why, after all these years, I have stopped asking who moved something.

There is rarely a satisfactory answer. Besides, I have learned the safest approach.

When you finally find the scissors, use them quickly. Then put them back exactly where they belong.

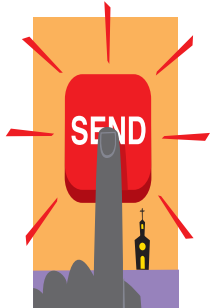
That way, when they disappear again, you can be absolutely certain it was somebody else.

example is the Community Wide Preservation Plan issued last year. It summarizes Webster’s history as a mill town and explains its unique relationship to Samuel Slater—Father of the American Industrial Revolution. But it also provides solid approaches to revitalize key areas of Webster, while preserving and learning from its history. In addition to the call to the community for their ideas, the SMPC is updating

statistics; conducting focus groups for business, community, and government; and doing interviews.

The SMPC recognizes that a plan is only useful if it is used. One key task is to lay out an approach for turning the plan from goals to actions. While it is too soon to say what this process will be, it could include such things as town annual action plans and progress reviews by the Board of Selectmen. It is the intention of the Webster Board of Selectmen to make this a living plan.

Once the information gathering phase is done and the Committee has evaluated all the information, it will begin to draft long term strategic goals and objectives. The drafting phase will begin in October. A completed plan is scheduled for February 2027. 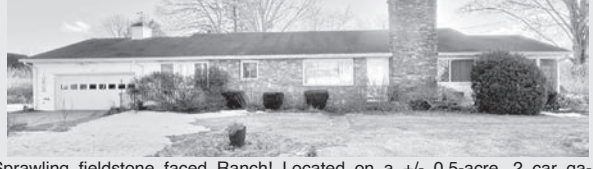
