Dudley energy programs announce new rates

DUDLEY — The town of Dudley has signed a 13-month contract with its current aggregate supplier, First Point Power.

Beginning with the October 2026 meter reads, the Dudley Community Choice Power Supply Program, designed to meet the specific needs of the town’s electricity ratepayers, will continue to offer the same options but at new rates:

- The standard product which meets the Massachusetts Renewable Energy Requirement of 69.1 percent at a rate of \$0.16345 per kWh.
- An optional product that is 100 percent renewable - meets the MA Req plus an additional 31% National Wind Renewable Energy Certificates - at a rate of \$0.16423 per kWh.
- A second optional product which meets the MA Req plus an additional 5% Massachusetts Class I RECs at a rate of \$0.16545 per kWh.

For Dudley residents and businesses who are enrolled in the town’s standard product, the current rate of \$0.12826 per kWh will expire and the new rate of \$0.16345 per kWh will take effect with the October 2026 meter reads. This represents an increase of \$21 per month on the supply side of the bill given average usage of 600 kWh. However, this new rate is 5 percent lower than National Grid’s Residential Basic Service rate of \$0.17185 per kWh. Residents can expect to see an average savings of \$5 per month for the months of October 2026 through January 2027.

Dudley launched its electricity program in April 2025 in an effort to develop an option for residents that would be stable, affordable and incorporate renewable energy.

Booklovers’ Gourmet plans full slate of September arts, music and literary events

WEBSTER — Art, music, literature and an evening exploring the paranormal are among the offerings coming to Booklovers’ Gourmet during September.

The independent bookstore and cafe at 72 East Main St. will begin the month with “Green Rapture,” an exhibit featuring the work of Debra Horan, owner of Booklovers’ Gourmet.

Horan’s work focuses on connections with nature and the experiences that can come from walking through the woods, spending time in a garden or observing the natural world. The exhibit explores how time outdoors can provide opportunities to slow down, reduce the distractions of everyday life and reconnect with one’s surroundings.

A meet-and-greet with Horan will be held Saturday, Sept. 12, from 2 to 4 p.m. Light refreshments will be served. The exhibit will remain on display in the cafe gallery throughout September.

The month’s programming continues Wednesday, Sept. 16, with “Whispers from Spirit,” featuring psychic medium Leo McCarthy from 6:30 to 8 p.m.

McCarthy will lead an evening centered on spiritual connections and messages, followed by time for questions and answers. Organizers note that because of the nature of the program, there is no guarantee that every attendee will receive an individual connection.

Tickets are \$45 per person, and attendance is limited to 12 people. Reservations may be made at the store or through Eventbrite, where

additional ticket fees apply.

Music takes center stage Saturday, Sept. 19, when longtime friends and collaborators Eddie Barnett and Bob Jordan present a concert from 6 to 8 p.m.

The pair will perform rock, folk, country and other musical styles, with the evening including short solo sets from each musician on vocals and guitar before they join forces for the bulk of the performance.

Barnett and Jordan’s musical connection stretches back decades. Barnett was 11 when he moved to Shrewsbury and began visiting Mac Duff’s Music, located next to the former Spag’s store, where Jordan worked. They have since performed together in numerous live and studio sessions, but the Booklovers’ Gourmet appearance will mark their first concert featuring only the two musicians.

Jordan, a Winchendon resident, performs at farmers markets, elder care facilities and occasional concerts, including an annual appearance at the Webster Senior Center.

Barnett has lived in Webster for 20 years and performs an annual summer concert in town. A guitarist and drummer, he has performed with several bands, including Bees Knees and Cosby Sweaters.

Admission to the Sept. 19 concert is \$20 per person or \$30 per couple.

The month’s schedule concludes Saturday, Sept. 26, with a program for young readers and families featuring local author and illustrator J. Roach-Evans from 1 to 3 p.m.

Roach-Evans will read from her latest children’s book, “Beach Rocks: Treasures from the Northeast Coast,” and lead participants in a craft activity in which they can paint their own beach rock creature.

The book introduces young readers to common rocks and pebbles found along the Northeast coast, ranging from Maine’s “wishing stones” to New Jersey’s Cape May “diamonds.” It also includes information to help readers identify minerals and rocks including quartz, feldspar, basalt, granite, jasper, gneiss, slate and quartzite.

Roach-Evans grew up in Auburn and studied art, English and graphic design at the School of the Worcester Art Museum, Worcester State University and Quinsigamond Community College. She also earned a master’s degree in education from Worcester State.

She is the author and illustrator of six children’s beginner guidebooks exploring seashore life and the natural world. Her previous titles include “Seashells: Treasures from the Northeast Coast,” “Seaweed: Marine Algae from the Northeast Coast,” “Marine Animals from the Northeast Coast,” “Marine Birds from the Northeast Coast,” “Little Piping Plover” and “Wildflowers from the Northeast Coast.”

OXFORD — What should Oxford look like 10, 20, or even 30 years from now? That question is at the heart of the Town of Oxford’s Master Plan process—and residents are being asked to help provide the answer.

The town is encouraging residents, business owners, property owners, and anyone who has a connection to Oxford to participate in the Master Plan survey. The survey provides an opportunity for the community to share its thoughts about the future of the town, particularly how Oxford should approach land use and development.

A Master Plan is more than a planning document. It establishes a long-term vision for the community and provides a framework to help guide future decisions about growth, development, infrastructure, housing, open space, transportation, and other issues that affect the character and quality of life in Oxford.

One of the most important components of developing a successful Master Plan is understanding what residents value about their community—and what they would like to see change.

Oxford has experienced significant growth and change over the years, and additional changes are likely in the future. Decisions about where and how development occurs can have lasting impacts on neighborhoods, businesses, natural resources, municipal services, and the overall character of the community.

The Master Plan will ultimately serve as a roadmap for Oxford’s future. It can help the Town identify priorities, establish policies, and make informed decisions about how land is used and how future development should occur.

Your participation matters. Whether you have lived in Oxford for decades or recently made the community your home, you have a perspective that can contribute to the conversation.

Strategic Master Plan Committee seeks public’s input

WEBSTER — The Webster Strategic Master Plan Committee (SMPC) wants to hear from Webster residents.

In June, the Board of Selectmen appointed the committee to develop a Strategic Plan that will guide Webster over the next decade. The Committee is in the information gathering phase of the project. It is reaching out via the town’s NotifyMe system to ask residents to answer some questions about Webster. The answers will provide a better understanding of the community’s thoughts about a future Webster. It will help lay a basis for the development of strategic goals and objectives.

The SMPC is not starting from scratch. Webster is fortunate to have a wealth of information available to assist the Committee in developing the strategic plan. Key is the prior Master Plan which will be updated in this effort. More recent plans cover demographics, economic development, land use, hazard mitigation, community development, and town services. These plans have been generated to allow the town to apply for resources in specific areas. They will be very useful in building a strategic plan. One example is the Community Wide Preservation Plan issued last year. It summarizes Webster’s history as a mill town and explains its unique relationship to Samuel Slater—Father of the American Industrial Revolution. But it also provides solid approaches to revitalize key areas of Webster, while preserving and learning from its history. In addition to the call to the community for their ideas, the SMPC is updating statistics; conducting focus groups for business, community, and government; and doing interviews.

The SMPC recognizes that a plan is only useful if it is used. One key task is to lay out an approach for turning the plan from goals to actions. While it is too soon to say what this process will be, it could include such things as town annual action plans and progress reviews by the Board of Selectmen. It is the intention of the Webster Board of Selectmen to make this a living plan.

Once the information gathering phase is done and the Committee has evaluated all the information, it will begin to draft long term strategic goals and objectives. The drafting phase will begin in October. A completed plan is scheduled for February 2027. 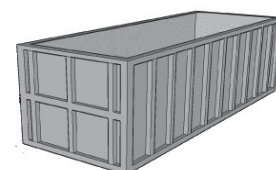

A small investment in books can pay dividends for years

There are few gifts simpler than a book. There are also few that can continue giving long after the wrapping paper is gone.

For 351 young children in Webster, a new book arriving in the mail has become a regular part of growing up. Through the Friends of the Gladys E. Kelly Public Library’s partnership with Dolly Parton’s Imagination Library, children from birth to age five can receive age-appropriate books at home at no cost to their families.

That is the kind of program whose value can be easy to underestimate.

A book delivered to a toddler is not merely another object for the bookshelf. It can become part of a bedtime routine. It can introduce a new word, spark a question or inspire an imaginative game the next morning. It can give a parent and child 15 quiet minutes together at the end of a busy day.

Most importantly, it helps establish the idea that books belong in a child’s everyday life.

Dolly Parton launched the Imagination Library in 1995 with a remarkably straightforward goal: Encourage children to develop a lifelong love of reading. Since then, the program has distributed more than 300 million books and now mails more than three million books each month to children in several countries.

Those numbers are impressive, but the numbers that matter most locally are much smaller.

There are 351 Webster children currently participating, and another 141 have already “graduated” after reaching age five.

That means hundreds of Webster families have already experienced a program that did not exist locally until the Friends of the Gladys E. Kelly Public Library became a program partner in 2024.

It is also important to recognize that the books are free to families, but they are not free to provide. Local partners are responsible for enrolling eligible children and contributing an average of \$2.60 per child each month toward the wholesale cost of books and mailing.

That is a modest amount for one child. Multiply it across hundreds of children and an entire year, however, and it represents a meaningful community commitment.

It is a commitment worth making.

Communities spend considerable time discussing education after children enter the classroom. School budgets, curriculum, test scores and facilities naturally receive attention because they are important. Yet learning begins years before a child walks through a Kindergarten classroom door.

Reading aloud introduces children to language. Turning pages teaches them how books work. Talking about pictures encourages observation. Hearing the same favorite story for what may seem like the hundredth time helps build familiarity with words and ideas.

The Imagination Library also has an important quality that makes it particularly well suited to a community program: It is available without regard to a family’s income. A child does not have to demonstrate financial need to deserve books. The goal is simply to put books into the homes of young children and encourage reading.

Webster should be proud that its library community has embraced that mission.

Public libraries have always been places where people can encounter ideas regardless of the size of their bank account. Helping a child build a home library before reaching school age is a natural extension of that principle.

The best measure of the program’s success may eventually be found not in statistics but in memories.

Years from now, some Webster children may remember waiting for an envelope containing their next book. They may remember a particular story their parents read again and again. Some may eventually read those same books to younger siblings or even their own children.

For now, there are still more Webster children who can become part of that story.

Families with eligible children should learn about the program, and the broader community should recognize the work required to keep it going.

At roughly the price of a cup of coffee each month, helping put a book into the hands of a child seems like a remarkably good investment in Webster’s future.

Sept. 29: The choice before Dudley

To the Editor:

I understand why some residents are frustrated that another Proposition 2½ override is on the ballot. Dudley voters rejected an override in June, and less than four months later they are being asked again. It is fair to ask whether the Town heard the first vote.

We did.

The June request was \$1,985,187. The September request is \$717,630 — approximately \$1.27 million less. Most of the June proposal is gone. What remains is limited to maintaining two police officers, two firefighter/paramedics and Highway staffing and operations that support road maintenance, snow removal, tree work and other basic services.

These are not new programs or an expansion of the Town government. They are existing employees and services. A majority of the Board of Selectmen believes they should be maintained. I agree.

The June vote mattered. The September request is nearly two-thirds smaller because of it. Rather than simply make the remaining reductions, the Board substantially narrowed the request and decided residents should make the final decision about whether these services are worth maintaining.

Some will say we have heard warnings about public-safety reductions before and they never happened. The history is important. Dudley went to the voters three times during the 2023 budget crisis. The first two override attempts failed. In August 2023, voters were presented with five separate questions and approved three — public safety, the library and the increased school assessment. The public-safety positions at risk were maintained because voters ultimately provided the revenue to maintain them.

Something else has changed since 2023. Three of our five Selectmen have changed, and we have a different Town Accountant. Different elected officials and a different financial professional have reviewed the numbers and asked their own questions. Yet a majority of today’s Board has reached essentially the same conclusion: eventually further reductions stop being efficiencies and begin reducing basic services.

That doesn’t mean residents have to agree, but I think it matters. This isn’t simply the same group of people repeating the same recommendation three years later. Different people, with responsibility for balancing the budget today, have looked at the numbers and arrived at much the same place.

There is no popularity to be gained by asking residents to increase their own taxes. There is no joy in doing it. Under Proposition 2½, we cannot make that decision for you. Only the voters can. Our responsibility is to tell you when we believe the revenue is necessary and what happens if it isn’t available.

The override itself is estimated to add approximately 39 cents per \$1,000 of

assessed value to whatever the FY2027 tax rate would otherwise be. Using the FY2026 average single-family assessment of \$449,928, that is about \$175 per year, or \$14.62 per month. That is real money, particularly when families are dealing with many of the same rising costs affecting the Town, and I don’t minimize it.

There is another issue on Sept. 29 that is equally important. Dudley and Charlton voters will decide whether to authorize \$11.18 million in school capital borrowing, while Dudley voters will separately decide whether our approximately \$5 million share should be paid through a debt exclusion.

The distinction matters because rejecting the debt exclusion does not necessarily reject the debt.

If the district borrowing passes, Dudley owes its share. Without the debt exclusion, those payments would come from the Town’s existing operating budget — the same budget that funds Police, Fire, Highway and every other municipal department. The current financing projection shows Dudley’s annual payment reaching approximately \$739,000 at its peak, roughly the size of the entire public-safety and Highway override.

That isn’t a scare tactic or an argument for or against the school projects. It is how the financing works. A vote against borrowing and a vote against the proposed way of paying for borrowing that has already been authorized can have very different consequences. Residents should understand that distinction before voting.

On Sept. 14 at 6:30 p.m. at the Dudley Municipal Complex, the board will hold a public information session. Our Town Accountant, Principal Assessor, Treasurer/Collector and I will be there. If you think there are other places to cut, ask us. If you question the tax calculation, ask us to show you. If the debt exclusion is confusing, we will walk through it.

You don’t have to agree with our recommendation, but you should expect us to explain it, defend the numbers and answer the difficult questions.

The June vote was clear, and the board responded. What remains is what a majority of a substantially different Board believes is necessary to maintain Police, Fire/EMS and Highway services. I believe it is necessary too.

We will make our case, show our work and answer the questions. Then the decision is yours.

On Sept. 29, that is exactly where it belongs.

There is a particular day every September when I realize the windows are open. Nobody announces it.

There is no family meeting where we agree that summer humidity has officially ended and authorize the reopening of the house. One day, the air conditioner is humming away, doing its best to keep the living room from feeling like the inside of a baked potato, and a few days later there is a breeze coming through the kitchen window. That first open-window day is one of my favorite days of the year.

I noticed it the other morning when I came downstairs. The house was quiet, and somewhere outside I could hear a truck backing up. Farther away, somebody was running a lawn mower. There were birds making whatever announcements birds feel compelled to make at 6:30 in the morning. And I could hear all of it because the windows were open.

Summer tends to seal us inside. When it gets hot enough, we close the windows, turn on the air conditioning and create our own little climate-controlled worlds. The houses along the street might be only 30 feet apart, but everybody is tucked inside behind closed windows.

September changes that. Suddenly, the neighborhood comes back. You hear someone calling the dog. You hear a screen door slam. You hear a kid bouncing a basketball in a driveway.

Somebody is doing something involving a power tool that apparently needs to begin before breakfast. You smell somebody’s coffee in the morning and somebody else’s dinner at night. And every once in a while, you hear a conversation you weren’t supposed to hear.

That is when you quietly move away from the window and remind yourself that good neighbors occasionally need to pretend they are deaf.

Open windows were simply part of life when I was growing up. We didn’t think of fresh air as an amenity. It was the cooling system.

You opened every window you could, and if the house was still hot, you found a fan. The fan was usually about 40 years old, weighed as much as a lawn mower and had metal blades capable of propelling a small aircraft.

Safety standards were apparently more of a suggestion back then.

At night, an open bedroom window brought in all the sounds of the neighborhood. Cars passing. Crickets. A dog barking three streets over. Sometimes, you could hear a radio playing somewhere. Eventually, those sounds faded into the background and you fell asleep. I hadn’t thought much about that until recently.

Modern life has become remarkably good at separating us from our surroundings. Cars have climate control. Houses have climate control. Offices have climate control. We put earbuds in when we walk. We can travel from our garage to a parking lot to a building and barely experience the outdoors at all.

Then September arrives in Massachusetts and gives us a brief stretch when the best temperature-control system is a wooden frame, a screen and a little cooperation from Mother Nature. It doesn’t last long.

Soon enough, one of those chilly mornings will arrive when somebody says, “Why is it freezing in here?” The windows will come down. Then the heat will go on.

And before long we’ll be standing beside the thermostat having the annual household debate over what temperature constitutes “perfectly comfortable” and what temperature constitutes “Do you think we’re made of money?”

For now, though, the windows are open. The curtains move a little when the breeze comes through. The house smells different. The neighborhood sounds closer. It is a small thing, certainly. But the older I get, the more convinced I become that the calendar doesn’t really tell us when the seasons change.

The little things do. The first morning, you need a sweatshirt. The first leaf you notice in the driveway. The first time you see apples stacked outside a farm stand.

And that September morning when you walk into the kitchen, hear the neighborhood outside and realize somebody has opened the windows again.

That is when you know fall is on its way.

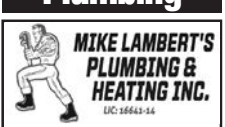
