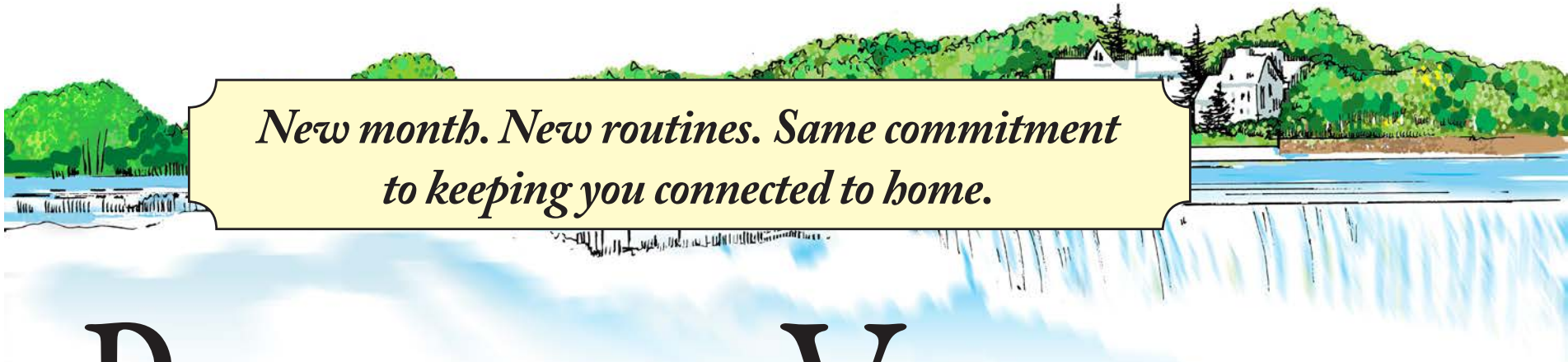

Killingly BOE hires new Superintendent

KILLINGLY — The Killingly Board of Education has announced that Dr. Paul Haughey has been selected as the new Superintendent of Killingly Public Schools.

Haughey brings with him more than two decades of experience in educational leadership. He most recently served as Superintendent of the Spencer-East Brookfield School District for the last eight years.

His move to Killingly was confirmed during an Aug. 25 School Committee meeting and subsequent official announcement via press release by the school board.

Haughey succeeds Dr. Sue Nash who departed Killingly earlier this year to lead Ellington Public Schools. Ken DiPietro, former Superintendent of the Plainfield School District, was appointed as interim superintendent prior to Haughey's hiring.

"This was an incredibly important decision for our Board and

For his part, Haughey said he was looking forward to leading Killingly into the future.

"I am incredible honored and excited to begin my tenure as Superintendent of Killingly Public Schools. I look forward to building upon the district's proud tradition and strong commitment to putting students at the center of everything we do," Haughey said. "I am eager to partner with our dedicated staff, families, and community to ensure every student has a safe, supportive, environment where they can discover their talents, grow as critical thinkers, and reach their highest potential. Together, we will continue building a culture of excellence, collaboration, and opportunity for all students."

Haughey will hit the ground running immediately as Killingly and other schools begin their new school years.

Fire destroys Duma Decorating Center in Thompson

THOMPSON — A structure fire in Thompson on Aug. 17 resulted in the total loss of the Duma Decorating Center on Riverside Drive.

Multiple departments responded to the multi-alarm incident at 470 Riverside Dr., where fire personnel found a commercial building consisting of a garage, main building, and attached apartment heavily engulfed in flames.

According to a post by West Thompson Fire Department Chief Mathew Whipple, all occupants were confirmed to be out of the building as firefighters began their attack. Two cats were known to have been in the building as well, and both were eventually found alive and transported for veterinary care.

"Crews immediately went to work and confirmed that all occupants had safely evacuated the building. A deck gun was deployed from the first-arriving apparatus while crews established a water supply from the closest hydrant. Due to the size and complexity of the building, a secondary water supply was also established. The incident was upgraded to a second alarm and subsequently a third alarm to bring additional resources to the scene. Firefighters were able to contain the fire to the office and garage areas of the building. No injuries were reported among firefighters or civilians," wrote Whipple.

Firefighters from West Thompson, Thompson Hill, Community Fire Company, Quinebaug Fire Department, East Thompson, Putnam, East Putnam, Woodstock, the Bungay Fire Brigade, Muddy Brook, Southbridge, Webster, East Killingly, Dayville, Williamsville, Pomfret, and Attawaugan assisted in the response.

Due to the damage from the fire the building, including the apartment and business structures, were a total loss and have since been torn down. The business has served as a well-known flooring and decorating business for decades. The cause of the fire was said to be under investigation with no updates released as of this writing.

The cats that resided in the home also created a lot of concern after only one of the animals, named Willow, was found during the initial fire. Another cat was believed to have been in the basement, and demolition crews took special care to try and locate the animal prior to knocking own the building. The second cat, named Jade, later returned to the scene unharmed.

Thompson Animal Control and PAWS Cat Shelter in Putnam assisted with getting the animals to the Quinebaug Valley Veterinary Hospital for treatment and they have since been reunited.

Another unique result of this fire is a video posted by the Thompson Fire Engine Company and credited to the Thompson Hill Fire Department. It showed a first-person response to the incident, giving viewers a special look into the intensity and complexity of the job that most of

Pig roast raises \$18,000 for homes in Guatemala

WOODSTOCK — A farm home overlooking a buccolic valley, perfect 80-degree weather, music by "That Dollar's Gone" and an old fashioned pig roast on July 25 at the Morse family farm in Woodstock — all came together for a lovely evening supporting a cause to build a home in Guatemala.

The roast was the 42nd pig roast done by hosts David Morse and Pam Moore. Entertainment was provided by That Dollar's Gone, a guitarist duo, playing covers from the '60's through the '80's. The group is made up of Peter Blair and Jo-Ann Pierpoint who have been delighting crowds for many years.

The fundraiser benefits Partners in Development (PID), a 501c3 charity working with the "poorest of the poor" in Haiti, Guatemala, Peru and the Mississippi Delta. Local volunteers have been serving in Guatemala yearly since 2015 and provide medical care, install cooking stoves and assist with construction projects during their yearly service trips. During 2025-26, the volunteers raised money to build a house in Guatemala and then did some of the construction during the Feb 2026 service



trip. This year's pig roast fundraiser brought in nearly \$18,000 — enough to build 1.7 houses!

Partners in Development has been supporting development of two villages in Guatemala for 20 years. The development process

starts with child sponsorship. The family identifies the child to be sponsored and a generous donor from the US gives \$40/month to help that child and their family. The child's school progress is closely tracked and supported with

free tutoring. The entire family receives free medical and dental care and a monthly bag of food staples. In Guatemala, children commonly stop school by fourth grade to help with family needs at home. With support through PID, children may complete high school and even go on to college. Teams that travel to Guatemala support the year-round project work done by the Guatemalan staff.

Families that are selected to have a house built for them have a sponsored child. The family must have title to the land. The mortgage for the house is held by PID and paid for over a 20-30 year period. The very basic 400-square-foot house is a two-room concrete structure with a tin roof. Money raised through our fundraiser will supplies the materials for the house. PID service teams help build the foundation and walls and paint the structure, while local builders handle carpentry and plumbing.

The next service trip is scheduled for Feb. 20-28, 2027. Costs run about \$2000/pp. Contact Mitzi Davis, trip leader at connect9295@gmail.com re trips, child sponsorship, other questions or donations. An anonymous donor will still match your donation to the housing program.

Paddle 4 Hope to support Neighbors Against Cancer

BROOKLYN — Paddlers will take to the water at Riverside Park this month for Paddle 4 Hope, a community fundraiser benefiting Neighbors Against Cancer and its efforts to assist local residents facing financial challenges following a cancer diagnosis.

Paddle 4 Hope will be held Sunday, Sept. 13, at Riverside Park, 26 Greenway Dr. in Brooklyn. Registration will open at 8:30 a.m., with participants launching at 10 a.m.

There is no registration fee, although participants are encouraged to make a tax-deductible donation to Neighbors Against Cancer, a 501(c)(3) nonprofit organization.

The event is open only to nonmotorized watercraft, and a personal flotation device, or life jacket, is required for all participants. Organizers are asking paddlers to arrive early enough to unload their watercraft, register and be ready for the 10 a.m. launch.

Participants can determine how far and how long they would like to paddle. Options range from an approximately eight-mile round trip to shorter excursions upstream, allowing paddlers of varying experience levels to participate.

Proceeds will support Neighbors Against Cancer's work assisting individuals and families dealing with the financial impact of a cancer diagnosis. The organization has provided assistance with expenses including mortgages, rent, car payments, food and gasoline.

"Paddle 4 Hope is your opportunity to help us help our neighbors," organizers said in announcing the event.

Neighbors Against Cancer focuses on providing direct financial assistance to people in the community during a time when medical challenges can also create significant household expenses and financial strain.

The organization sums up its mission with the phrase, "We have a NAC for helping people."

Donald Cimochoowski named Thompson’s Veteran of the Month

THOMPSON — United States Army Specialist E-5 Donald (Donny) Cimochoowski of Marcy Lane in North Grosvenordale has been selected by the nominating committee to be recognized and honored as the September 2026 Veteran of the Month for the Town of Thompson.

Cimochoowski is a disabled Vietnam War Veteran who was awarded the medal of commendation for saving mul-

iple American lives in Bo Duc, Vietnam.

Donald was born on May 2, 1947, to parents Edward and Clara Cimochowski, and has lived his entire life in North Grosvenordale. As a young boy, he attended the former St. Joseph Grammar School graduating in the class of 1961. He then matriculated to the Ellis Technical School and learned his lifelong trade in the Machine Shop as a Maintenance Machinist. He remembers with fond appreciation, his machine instructor Pondo Gity, also a long time well know and respected North Grosvenordale resident and athlete. In 1986 Donny earned his associate degree from the Quinebaug Valley Community College completing day and evening classes.

Donny was drafted in 1966. He chose instead to enlist on his own terms for a four-year commitment in the United States Army. He immediately was assigned to Fort Jackson, S.C. for his Basic Training, and remained there for approximately 4 months. At the conclusion of basic training he was assigned to the Danvers, Ma. Nike Missile Battery Facility for his advanced training (A.I.T.). As part of his advanced training he was sent to White Sands New Mexico to be instructed in training exercises for shooting missiles at reported enemy aircraft. At the conclusion of Specialist Cimochoowski’s advanced training, he was deployed to the 23rd infantry division in Munich, Germany. While in Munich he was trained to become a fire director and after a two-month deployment in Germany, he was sent to Fort Riley, Kansas, the home of the 23rd Infantry for a full year to train to become a lead instructor in Vietnam, training the local Vietnamese villagers to take over the American fighting effort. Sergeant Cimochoowski also was trained in the customs and the Vietnamese language so he could properly articulate to the villagers and gain their trust.

On June 23, 1969, Donny was deployed to Vietnam. Specialist Cimochoowski was part of the very first school in Vietnam, under the direction of General Abrams, to actually work with, and educate the local young Vietnamese children to prepare them to use fire missions, and how to fire artillery so that eventually the Americans could begin to pull out of Vietnam. He completed an eight-week teaching assignment, and after the Vietnamese students graduated, he would accompany them to their respective villages on the Cambodian border to oversee their work and their fire missions. On the Ho Chi Ming Trail, also known as Thunder Road, the Americans were constantly subjected to enemy incoming fire, artillery, hidden mines, grenades and living with the constant fear of agent orange contamination.

Donny was diagnosed with agent orange disease in 2004. Specialist Cimochoowski flew numerous missions in military helicopters as a forward observer to find, detect and eliminate enemy targets. Sergeant Cimochoowski’s last tour of duty in Vietnam was in Bo Duc at the LZ Jerry Fire Base with the 101st airborne. His recollection of LZ Jerry Fire Base was that clearly this was the most dangerous “hot spot” he had been in, with an extremely high rate of American war casualties. Without much detail,

Sgt. Cimochoowski related to me that this was the location where he was awarded the Medal of Commendation for his heroic actions that saved many American lives in a very active and dangerous battleground. Sergeant Donald Cimochoowski was also presented his Commendation of Service citation by Major Le-Tat-Bien. It read, in part, “Sergeant Cimochoowski has performed his assigned duties in an outstanding manner. His vast knowledge in the Artillery field, and skilled as an instructor, has contributed a great deal to the exemplary success obtained by CIDG trainees and his experience of Artillery.” Major Le-Tat-Bien, the Commanding Officer of Detachment B-16 of the Vietnamese Special Forces (Airborne) “greatly appreciate Sergeant Cimochoowski for his achievements throughout his tour of duty as Artillery Instructor at the Trung Training Center.” Interestingly enough, this is also the location where Donny’s Mom Clara, swears that she spotted her son Donny, on the NBC National news one evening, running between a bunker and diving into another bunker for cover.....Sergeant Cimochoowski was returned from Vietnam to the United States Army personnel center in Oakland, California and was eventually separated from his overseas duty and received his honorable discharge from the United States Army on June 23, 1970.

For his service to his country, Specialist E-5 Donald Cimochoowski received the National Defense Service Medal, the Vietnam Service Medal, the Vietnam Campaign Medal, the Good Conduct Medal, the Army Commendation Medal twice, and the Gallantry Cross with Palm, in addition to his previously mentioned Commendation of Service citation.

After returning from his tour of duty in the Army, Donny worked as a machinist for a number of years at the John M. Dean plant in Putnam. While at John Dean, he worked his way up from a maintenance machinist, to Assistant Plant Manager, and then as Plant Manager. He also worked for Spirol Corporation in Dayville, and then for Parker and Harper in Worcester, Mass.

Donny has enjoyed a lifetime passion for music since he was a teenager. He was, and he continues to be very well-known musician and entertainer having played with numerous bands for more than 65 years. He began his musical career as a base guitarist and singer with the newly formed band called “Felix and the Cats” in 1964. If you grew up in that decade, you certainly danced to their music. The original members of that well know and well-traveled group included friends Chippy Hoffman, drummer Armand Lafleur, lead guitarist Roger Laporte, John Roux and Ernie Plante. Unfortunately, Donny remains as the only living member of his original band. This group “Felix and the Cats” played every School dance, most weddings, stag and showers, and events at all the local clubs and venues within a 75-mile radius of Northeastern Connecticut. They opened for, and played with the “Cowsills” at the old “Dance Land” venue in Quadic, played at the Albee Theatre in Providence with Peter and Gordon, with Jerry and the Pacemakers, and with Terry Knight and the Pack who later went on to become “The Grand Funk Railroad.”

It goes without saying that “Felix and the Cats” and all its original members became a household name and a beloved group with all teenagers and young music and dance enthusiasts following their every appearance. In the mid to late 70’s the group “Plum Road” was formed with Donny and members Charlie Zamagni, Ernie Plante, and Chippy Hoffman. This group became the “House Band” for the very popular and well-known “Treasure Island Restaurant and Dance Club” in Webster. Treasurer Island was the go to place, to see, and to be seen for many, many years. In the late ‘70’s, “Friendship” was formed with Donny, Greg and Fred Para, Eddie Morgan and Jerry Cullen. Donny and his musical friends remained together for decades playing their music every weekend all over the Tri-State area. Not willing to end his musical career just yet, Donny recently re-connected, with members Steve Lapointe, Barry Ayer, Chuck Thorstenson, Tuzzy Navarro and Anna to form another new group “Now and Then”. The stories and experiences that Donny could tell from his passion of music and playing with his bands for most of his life could easily be written into a best-selling novel. Needless to say, those of us who have had the pleasure over the years to see and hear Donny’s music are quite fortunate, and we have been treated to great music and dance for over 6 decades. The beat plays on...

Donny is a member of the VFW post 10088 of Quinebaug. He is also a member of the American Legion Post 0067 of Grosvenordale and a Lifetime member of the Valley Springs Sportsman Club in North Grosvenordale. He was a 21-year Bar Tender at the VSSC and loved by all. For many special events, the organizers would often request the Donny be the bartender of their event. He was just that kind of a wonderful and loved by all individual.

Donny has two Brothers Richard and Thomas and a Sister Dolores. He has two adult Sons Kyle and Eric and twin Granddaughters Ashlyn and Aubrey. Donny’s long-time partner, Ginny Menzigian who he had originally met while playing with his band at Treasure Island in the ‘70’s, rekindled their relationship some 10 years ago on a chance meeting at Indian Ranch. They remained together until sadly, Ginny passed on May 19. Ginny, a Pediatric Nurse, had recently had been under Hospice Care. Donny was her full-time caretaker during her last few difficult months. She will be greatly missed by Donny and her Family and Friends.

United States Army Vietnam War Veteran Donald (Donny) Cimochoowski will be presented with a commemorative plaque by the Selectmen and the Veterans Officer at the Sept. 1 Board of Selectman meeting.

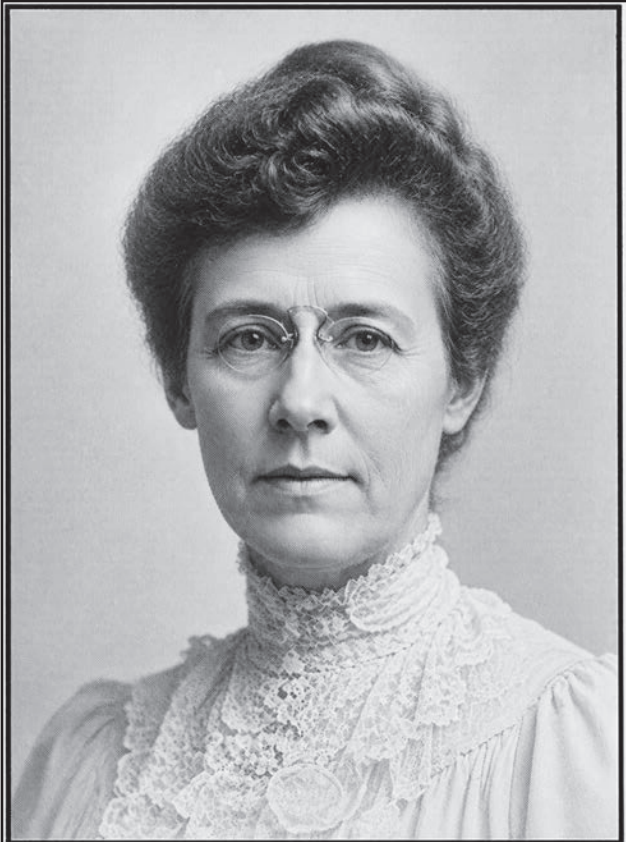

Hometown Heroes: Mary Bishop—guardian of the Revolutionary generation

PUTNAM — Long after the soldiers of the American Revolution had passed from living memory, Mary Hope (Bugbee) Bishop devoted much of her life to ensuring that their names, service records and final resting places would not be forgotten. Through painstaking genealogical research, cemetery surveys and historic-preservation efforts, she helped preserve the stories of hundreds of Revolutionary War veterans from Putnam and the surrounding towns of northeastern Connecticut.

Mary Hope Bugbee was born in Woodstock on May 23, 1858, the third child of Edwin Sumner Bugbee and Frances Agatha Thurber Bugbee. She attended the district school in the neighborhood where the Bugbee family lived and later completed her education at Woodstock Academy.

Her interest in early American history was deeply personal. Mary descended from Edward Bugbee, who settled in Roxbury, Mass., and from his son Joseph Bugbee, one of Woodstock’s early settlers. Her Revolutionary War ancestor, Ensign Hezekiah Bugbee, served during the struggle for American independence.

Mary was also descended from Mayflower passengers John Howland and Elizabeth Tilley. In 1911, she became a member of the Society of Mayflower Descendants. She was later made a life member of the New England Historic Genealogical Society and joined the Daughters of Founders and Patriots of America.

She married first Benjamin Franklin Medbury (1835-1923) of Providence, Rhode Island. In October 1917, at the age of 59, she married Ebenezer Bishop (1841-1919) of Woodstock, a respected Civil War veteran and successful Boston real-estate dealer.

Their marriage was brief. Ebenezer died from pneumonia in a Boston hospital on January 3, 1919. He was buried in the family plot at North Woodstock Cemetery. Mary’s greatest historical legacy, however, began years before her marriage to Ebenezer Bishop.

She conceived the idea of organizing a Putnam chapter of the Daughters of the American Revolution. On May 14, 1897, the Elizabeth Porter Putnam Chapter was formally

established, with Mary serving as its organizing regent. She played a major role in obtaining the genealogical documentation necessary to prove the ancestry of its approximately fifty charter members.

Under her leadership, the chapter immediately began identifying and marking the graves of local Revolutionary War veterans. It was a formidable undertaking. Many of the veterans had died early in the nineteenth century, and their graves were scattered among old town cemeteries, isolated family burial grounds and abandoned plots hidden in woods and fields.

Some markers had become weathered and difficult to read. Others were broken, displaced or overgrown. Establishing a soldier’s identity often required more than locating a stone. Researchers had to compare inscriptions with military rolls, pension applications, family records, church registers, town documents and published genealogies.

Mary Bishop and charter member Helen Mansfield prepared individual filing cards containing the genealogical and military records of each soldier they identified. By 1929, the Elizabeth Porter Putnam Chapter reported that it had located and marked an extraordinary 414 Revolutionary War graves in Putnam and the surrounding communities.

These cards represented far more than a list of names. They connected each veteran’s military service with an identifiable burial place and family history. In an era long before computers, digital photography or searchable databases, Mary and her associates created a carefully organized body of information that could be preserved and consulted by future generations.

The chapter also established the tradition of placing American flags on the veterans’ graves each Memorial Day. Members were assisted by children from the Quinebaug Children of the American Revolution Society. This annual observance transformed Mary’s historical research into an act of public remembrance. The soldiers were not simply entries in a record book; they remained honored members of the community.

Her concern extended beyond the graves that had already been found. As Connecticut State Consulting Registrar and chairman of the State Genealogical Committee, Mary promoted an ambitious effort to copy the inscriptions in old cemeteries throughout Connecticut. She understood that gravestones were fragile historical records. Once an inscription eroded or a stone disappeared, information found nowhere else might be lost forever.

This work was especially important in northeastern Connecticut, where numerous small family cemeteries had already become neglected or nearly forgotten. Mary’s efforts anticipated the statewide cemetery-recording project later undertaken under Charles R. Hale during the 1930s.

Her surviving work remains particularly relevant to the search for lost burial grounds such as Putnam’s old Wheelock Cemetery, also known as the Pigeon Hill Cemetery or Old Wheelock Yard. Historical accounts identify Revolutionary War veterans Nathaniel Arnold, John Phipps, Jonathan Sabin and Silas Sabin as having been buried there. The cemetery has since disappeared from the visible landscape. Records created by early researchers such as Mary Bishop may now provide some of the best evidence that those veterans were buried there and were once formally honored.

Mary was also instrumental in preserving one of northeastern Connecticut’s most famous historic landmarks: the Wolf Den in Pomfret, traditionally associated with Israel Putnam’s legendary encounter with a wolf in 1743.

During the first year of the Elizabeth Porter Putnam Chapter’s existence, its members learned that the magnificent trees surrounding the site were in danger of being cut for timber. The chapter arranged to purchase the 97-acre property so that its woods and historic character could be preserved. Mary was made permanent chairman of the Wolf

Den Committee.

The chapter cared for the property for twenty-seven years. In 1925, after disease damaged many of its chestnut trees, it transferred the land to the Connecticut State Park and Forest Commission. The property consequently became part of the state’s protected forest reservations, ensuring its preservation for future generations.

Mary served the DAR in nearly every important capacity, including regent, historian, librarian, registrar and treasurer. On the chapter’s twenty-fifth anniversary, she was again elected regent and served for another two years. At the state level, she served twice as councilor and became State Consulting Registrar. She was also a member of the DAR’s National Committee on Genealogical Research.

Gov. Everett J. Lake appointed her to represent Windham County at the tercentenary celebration at Plymouth, Massachusetts. She also represented Windham County in helping furnish the historic Oliver Ellsworth Homestead.

Mary Hope Bugbee Bishop died in Meriden on April 15, 1941, at the age of 82. By then, she had spent more than four decades preserving the history of the families, soldiers, cemeteries and landmarks of northeastern Connecticut.

Her work demonstrates that preserving history does not always occur on a battlefield or in a government office. Sometimes it is accomplished quietly, one cemetery, one weathered inscription and one carefully documented soldier at a time.

Because of Mary Bishop’s tireless efforts, hundreds of men who fought for American independence were not reduced to forgotten names on crumbling stones. Their identities, military service and burial places were recorded, marked and honored.

Mary Bishop was not herself a military veteran. Nevertheless, she performed an invaluable service for generations of veterans who could no longer speak for themselves. In preserving their memories, she became one of northeastern Connecticut’s own hometown heroes.

New leadership, and a new chapter for Killingly schools

The beginning of a school year always carries a sense of renewal. New classrooms, new teachers, new routines and new opportunities arrive together as students return from summer vacation.

This year, Killingly Public Schools will add something considerably more significant to that list: a new superintendent.

Dr. Paul Haughey arrives in Killingly with more than two decades of experience in educational leadership, including eight years as superintendent of the Spencer-East Brookfield Regional School District in Massachusetts. He succeeds Dr. Sue Nash, who left Killingly earlier this year to become superintendent of Ellington Public Schools.

Leadership transitions at the top of a school district deserve attention because a superintendent’s influence reaches virtually every corner of the system. Budgets, staffing, curriculum, facilities, student services, communication and long-term planning all eventually reach the superintendent’s office.

But effective leadership does not mean arriving with a long list of immediate changes.

One particularly encouraging element of the Killingly Board of Education’s announcement was Chair Susan Lannon’s description of the qualities the board sought during its search. The board wanted an experienced leader who would “listen first,” recognize the work already being done within the district and bring people together around students.

That is a sensible approach.

Every incoming superintendent inherits both challenges and strengths. The temptation for any new administrator can be to demonstrate leadership by quickly putting a personal stamp on an organization. Sometimes changes are necessary, but understanding a district should come before attempting to reshape it.

Haughey appears to recognize that. In accepting the position, he spoke about partnering with staff, families and the community while building upon Killingly’s existing traditions. Those relationships will be important.

Schools work best when teachers believe administrators understand what happens inside their classrooms, parents know their concerns will be heard and taxpayers understand how decisions are being made. Students, meanwhile, need consistency and an environment where the adults responsible for their education are working toward common goals.

Building that trust takes time.

Haughey’s experience should help. Eight years leading one district means he has already navigated the realities of public education beyond theories and strategic plans. Superintendents must balance educational ambitions with budgets, staffing limitations, state requirements and community expectations. They must also make difficult decisions knowing that almost every significant decision will affect children, employees and taxpayers.

There will inevitably be disagreements. No superintendent can satisfy every parent, employee, board member or resident on every issue. The better measure of leadership is whether disagreements are handled openly, respectfully and with a clear explanation of why decisions are being made.

Killingly also deserves credit for maintaining continuity during the transition. Former Plainfield Superintendent Ken DiPietro stepped into the interim role following Nash’s departure, giving the Board of Education time to conduct its search rather than treating an important appointment as something that simply needed to be completed quickly.

Now the search is over, and Haughey arrives as another school year begins. His first months should be spent listening to the people who know Killingly’s schools best: students, teachers, support staff, administrators, parents and community members. From there will come the opportunity to identify priorities and determine where the district should go next.

A new superintendent brings the possibility of new ideas. The greater opportunity, however, is to combine those ideas with the knowledge and experience already present throughout Killingly Public Schools.

That is how a leadership transition becomes something more valuable than a change of names on an office door. It becomes the beginning of the district’s next chapter.

The Thompson Republican Town Committee needs to recover its integrity

To the Editor:
[Recently], John B. Lenky, former Chairman of the Thompson Republican Town Committee and a former candidate for District 51 House of Representatives, released a statement about recent events concerning two current members of the Thompson Republican Town Committee.

Specifically, John is calling for removal of said two members from the RTC for their apparent violation of personal confidence in truthfulness. This violation has served to significantly undermine their professional trustworthiness, rendering them unworthy to serve any longer on the committee.

Why it matters: Voters must be able to trust those they elect to represent their interests. When Republican voters discern that self-interest has taken precedent over dutifully serving the voters’ interests, their confidence is eroded. When Republican voters observe certain actions that raise serious doubts regarding ongoing distractions related to non-Thompson politics, it becomes the duty of their representatives on the RTC to change course.

Key facts:
Mr. Steve Nickerson, in the role of temporary Convention Chairman, and Ms. Susanne Witkowski in the role of temporary Convention Secretary, were key players while conducting the Republican Convention on May 15. The purpose of the Convention held at the Thompson Library was to endorse candidates for District 51 House of Representatives. The final Convention voting resulted in five votes for incumbent Chris Stewart and four votes for Mr. Ryan Courmoyer, who had earlier announced his candidacy for the seat.

At our local Convention, the acting chair, Nickerson, voted against Ryan. Following the vote, efforts were made for Ryan Courmoyer to not run. Later the same day, they were joined by other political operatives from Putnam, one of whom approached Ryan Courmoyer in a demonstrably close-encounter manner.

The day following the Convention, Nickerson prepared and submitted the required documentation containing the voting results to the Secretary of State. Ryan was not given an opportunity to review the required submission form. Nor did he have reason to think an error would be made in a simple, basic document. Although Nickerson voted against him, Mr. Ryan trusted that the form would be completed correctly.

On or about the 18th of June, Candidate Ryan called the Secretary of State’s office and asked if they received the ‘Nomination Party Form’ from Mr. Nickerson. Then Ryan Courmoyer drove directly to the Secretary of State’s Office to request a party nomination form. An employee from the SOTS office stated to Mr. Ryan that the deadline for submission had passed, therefore his request was not relevant. The “error” occurred with the second “unknown” Secretary of State document that required Ryan’s signature due to not receiving the email from the Secretary of State since Steve Nickerson provided the wrong email address after notifying Candidate Ryan it was submitted. This “email error” violation was the major responsibility and duty of Chairman

Nickerson.

As a first-time candidate, and trusting Nickerson to enter his information correctly, Ryan did not call the Secretary of State to ask about the status of his registration. In addition, since Ryan received an email on May 22 from Nickerson stating that he had filed the required forms, Ryan took for granted that Nickerson had fulfilled his duty responsibly and reliably. The result was the exclusion of Ryan Courmoyer with no opportunity for constituents of District 51 to make their choices via a Republican Primary.

Mr. Courmoyer had good reason to trust Mr. Nickerson, given that he and Mr. Nickerson regularly communicated using the same email address for Town matters. In addition, Mr. Nickerson’s professional career is with Information Technology, where accurately entering data is a critical component to his job.

In response to the error and the ultimate exclusion of Ryan Courmoyer in the Republican Primary for District 51 on the 11th of August, Nickerson and Witkowski quickly deflected the issue, claiming that the error was unintentional. They also stated it was Mr. Ryan’s responsibility to call the Secretary of State to verify his status. Thereafter, Mr. Nickerson and Ms. Witkowski participated with other political operatives from Putnam in an ongoing effort to pressure Candidate Ryan to disassociate with his supporters and drop out of the race. This included orchestrated social media campaigns, text message trolling and other tactics. Their defensive and evasive response, and their subsequent actions appear to indicate a clear intent.

Thompson Republican considerations:
We Republicans may disagree on some or even all issues. We may not like each other.

But what binds us together as Republicans is our commitment to our Republic’s values and principles as outlined in our nation’s Constitution upon which our country was founded and has flourished. The anchor of these values and principles is the foundational underpinning of trust.

We Republicans take trust seriously. We trust that elected officials and those who are elected to perform a leadership role will do so in a trustworthy and responsible fashion. This duty is not optional.

The actions of Steve Nickerson, supported and encouraged by Susanne Witkowski, clearly indicate that both individuals have violated Ryan’s trust. Labor Day weekend, and what could be more fitting than to write about the

Woodstock Fair? Perhaps some of you attended the 1963 Woodstock Fair. The Thursday, Sept. 5, 1963 issue of the Windham County Observer and Putnam Patriot’s headline read: “Woodstock Fair’s Attendance Tops All Previous Records. Nearly 50,000 Present for 1963 Event. The 103rd Woodstock Fair, a yearly event for the Labor Day weekend... surpassed records of previous years not only in attendance but in entries and participants. Gov. John Dempsey was among the visitors. He spent several hours watching the races and chatting with fairgoers Saturday. State Agricultural Commissioner Joseph Gill and U. S. Representative William St. Onge also roamed the fairgrounds...Ballooning Barbara Keith, the Fair’s ‘flying grandmother,’ launched her free flight hot air sport balloon Saturday and Sunday as a special jet age attraction. (Hot air balloons went out of vogue about a century ago). The launching(s) were successful, to the delight of hundreds of onlookers, but landing the thing was not so easy. Plans for the Saturday trip called for Grandma Keith to land at the nearby Putnam Country Club, but wind conditions were not right and she was carried some 13 miles south, landing in East Killingly. She bravely took off again Sunday afternoon, but this time she came down in a tree in Foster, RI. Grandma called off her Monday take-off because of a fractured ankle received in the landing. She was admitted to Day Kimball Hospital and released the next day.” (p.2 of 28).

An Internet search revealed that the first Woodstock Fair was held in 1859 in the vestry of the Baptist Church on Woodstock Hill. I tried to find early articles but found none for that year. The earliest was a short announcement in the September 19, 1861 Windham County Transcript. “The Woodstock Fair. The Woodstock Agricultural Society will hold their annual Fair on Wednesday of next week. An address will be delivered by Gilbert W. Phillips, Esq. of Putnam. It is safe to predict a good exhibition as the citizens of Woodstock never do anything by the halves.” (p.2).

The next I found was from the Windham County Transcript of Thursday, Oct. 1, 1863. “A fog, concealing the heavens and the earth, appeared on the early morn of Wednesday, causing doubt

Earth — A warning from a warming Himalaya

To the Editor:

Known as the cryosphere, about 10 percent of the Earth is permanently frozen. Beyond Earth's polar regions, the Himalayan Mountains contain the largest amount of ice in the world. Himalayan glaciers, the source of two of the world's five largest rivers, also provide drinking water for a quarter of the world's population. Glaciers in the Himalayas, Alps, Andes, and Rocky Mountains are central to the Earth's hydrologic cycle, wherein snowfall eventually forms glaciers, which undergo partial melting in the summer and thus feed streams and rivers essential to the world's agricultural production. Without these mountain glaciers, global human food production literally dries up!

But mountain glaciers across the world are warming rapidly and melting. Since the turn of the 20th century, the observed glacier loss has been a steady, accelerating retreat, leaving empty valleys or lakes where massive glaciers formerly and continuously crawled down the mountains at "glacial pace." Here in the U.S., Glacier National Park was the place where, years ago, we could see more than 100 active glaciers feeding the Earth's hydrologic cycle. But today, the park contains only 26 active glaciers, and scientists predict it could have none in as little as four years. We may change its name to "The Park Formerly Known as Glacier," but what will we do about losing a huge natural watershed and all the biodiversity and downstream uses it supports?

On Aug. 26, a massive Himalayan glacier collapsed and released a surge of water and mud into the Lhende Khola River, near the border of Nepal and Tibet. The monstrous flash flood that resulted traveled at 120 miles per hour, leaving a trail of death and destruction across mountain communities. Early reports have only begun to count the dead and forever missing.

If you haven't seen video footage of the event, look it up. It's hard to believe your eyes. At first, I couldn't believe mine and thought what I was seeing had to be computer-generated, like some Hollywood disaster film. But it wasn't. In an instant, entire communities were wiped away. Large buildings, roads, and bridges—entire villages full of people—were washed away. Dozens of buses were hurled around like chunks of fruit in a blender. Others, spared the initial blast, were overwhelmed and lost before they could escape as water rose 30 feet in 30 minutes.

This disaster immediately reminded me of the 2025 Los Angeles fires in its scale. But as this event was so instantaneous and absolute, the ancient volcanic eruption at Pompeii and the 2004 Indonesian tsunami

that killed 230,000 seemed like better analogies. The collapse of ice, rock, mud, and water was so massive that, according to the U.S. Geological Survey, it generated a seismic signal—an earthquake—measuring 5.3 on the Richter scale.

Like the steady retreat of mountain glaciers around the world, the event in the Himalayas may signify another "new normal" created by climate change. This raises important questions: What does climate change have to do with the disaster? And what lies ahead?

While it's too early to attribute this event solely to climate change, there can be little doubt that it played a profound role. Climate change is making the Himalayan and other mountain regions increasingly unstable as they warm, lose ice mass, and destabilize slopes. As the cryosphere and other elements of Earth's life-support systems destabilize, such as the Atlantic's Gulf Stream currents, we are seeing an accelerating rate and intensity of fires, droughts, storms, and floods. And now, like the icicles that fall from house gutters in the sun, catastrophic ice collapse may be added to the list of regular disasters as Earth is subjected to rapid climate change. According to the United Nations, Nepal's mountains lost close to one-third of their ice over roughly three decades, and the rate of glacier loss accelerated significantly in the 2010s. It all makes sense.

The people of Nepal now need help—big help. But have we even finished helping the tens of thousands of L.A. residents displaced by the colossal fires in 2025? That event inflicted a quarter-trillion dollars in losses! And what about 2024's Hurricane Helene in Florida? I read that, well over a year later, local streets were still buried in storm debris that went on for blocks. What about Paradise? That beautiful mountain community never recovered. What about the 2023 fires in Lahaina, Hawaii? That historic town will never be the same.

The property insurance industry has repeatedly warned that these "climate-fueled natural disasters" are destabilizing the industry, resulting in soaring reinsurance costs, market withdrawals, and the potential for systemic collapse of the industry itself. Of all this, legendary venture capital investor John Doerr says, "People are coming to the realization that it is now cheaper to save the Earth than to destroy it." Or, as Ben Franklin put it, "An ounce of prevention is worth a pound of cure." Both are right—if we do what we need to do right now, we can avert catastrophe and, in the process, save money. And, of course, we'll save lives and reduce human suffering. So what lies ahead? The choice is ours.

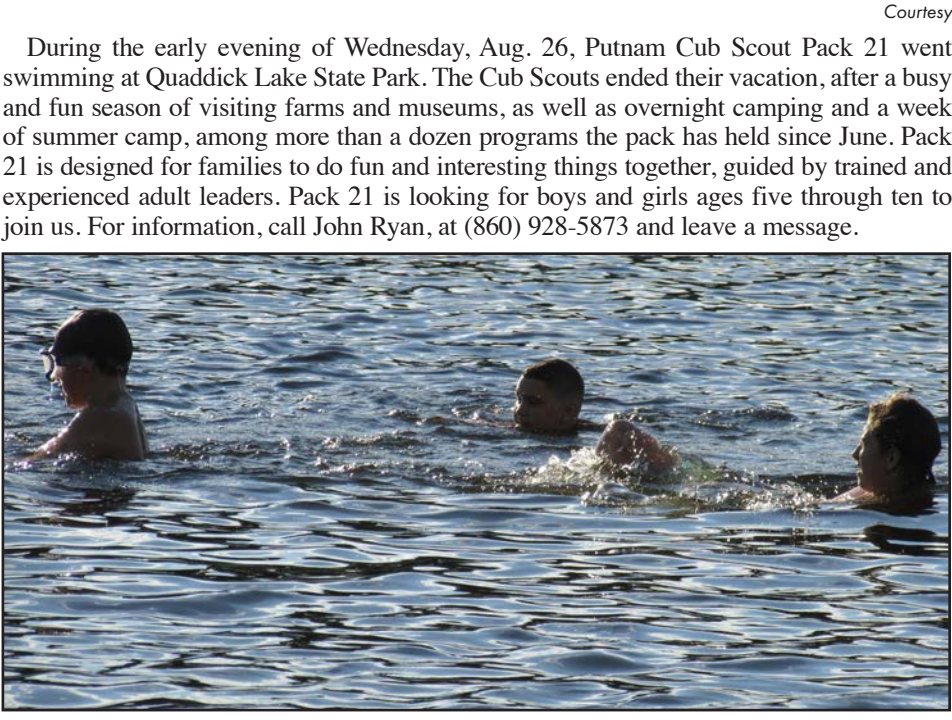

Alex (Kallgren) Revane

WILLIMANTIC, Conn. — One of only three four-time All-Little East Conference selections in Eastern Connecticut State University field hockey history, Alexandra (Kallgren) Revane has been chosen for induction into the Eastern Athletics Alumni Hall of Fame, it has been announced by chair Scott Smith.

Kallgren ’18 becomes the second field hockey selection in the 29-year history of the field hockey program and the first to gain induction based exclusively upon her field hockey exploits (Mo Deegan, a field hockey-lacrosse standout between 2001 and 2005, was a 2014 inductee).

Kallgren is the final-announced member of the five-person Class of 2026, following the announced induction of former four-year All-Little East Conference volleyball player Adrianna Mihalek ’17, who maintains the program standard for career kills; Max Fantl ’10, a former four-year All-LEC forward and two-time LEC Offensive Player-of-the-Year in soccer and an all-conference lacrosse midfielder and four-year member of the program; Christian D’Ambrosio, the former 22-year head women’s soccer coach who won a record 240 matches and 13 LEC regular-season and playoff titles from 2000 through 2021; and two-time baseball All-America and current home run and RBI leader Melvin Castillo ’11.

Dudley’s Alex (Kallgren) Revane named to Eastern Alumni Hall of Fame

The 32nd induction ceremony is scheduled for Oct. 17 at 5 p.m. at the campus’s Fine Arts Instructional Center’s Concert Hall and Lobby, with a social to follow. For ticket information, contact Scott Smith at 860-465-4326 or at smithsc@easternct.edu.

A four-year starter at midfield and forward between 2014 and 2017, the Dudley, MA native was ranked either first or second on the team each season in goals, assists and points with one exception, when she ranked third in assists as a sophomore in 2015. Nine years after playing her final match, Kallgren remains the all-time leader in points (93) and game-winning goals (9), shares the all-time lead in goals (37) and is second in assists (19) (Kallgren had stood alone atop the all-time goals list until her record was tied by All-Region forward Emma Sanson in the fall of 2025).

Three times chosen to the LEC second team and once to the third team, Kallgren is one of only three players in program history named to the National Field Hockey Coaches Association (NFHCA) national Senior Team, when she played in the last NFHCA North-South Senior All-Star Game conducted, in 2017 (the game was discontinued after 2017, although a national Senior Team is still selected by the NFHCA).

Through a commitment to strength and conditioning, Kallgren “was able to build, basically, what we call, a ‘bullet-proof body.’”, says former Eastern strength and conditioning coach Mike Jones. “She was very durable and able to go out there, game-after-game, and perform. She always had a great work ethic, and she can certainly thank her parents (Duane and De) for that. She already had that work ethic from home, and she applied the work ethic to [the strength and conditioning room].”

Kallgren led the team in points and goals in each of her first two seasons (in 2014 and ’15), with her career-highs of 29 points (equalling the season record at that point) and 12 goals (second-most in a season at that point) in 2015 helping launch the most successful season to that point in program history. With the program managing only one winning record in its first 17 years, the 2015 club set or tied 12 current team season records in winning 13 of 20 matches

In that 2015 season, the Warriors set season records to that point for overall wins, winning percentage (.650),

consecutive wins (six) and LEC wins (8-3 record). Placing fourth in the 12-team conference (its highest finished to that point), the Warriors won twice in the playoffs at home (their first home LEC playoff games in the 18-year history of the championship) over Westfield State University (3-0) and Fitchburg State University (2-1) to stretch their winning streak to six and reach the LEC title game for the first time, where they lost a one-goal road decision.

In that year’s LEC playoffs against Fitchburg, Kallgren set up the tying goal with 20 minutes left when Brianna Passero sent home the rebound of a shot by Kallgren that was saved, and Kallgren’s 12th goal of the year four minutes later proved as the game-winner.

Today, Kallgren stands as one of only four players in program history with as many as two matches of three or more goals. Her first hat trick came against Westfield State in the LEC opener at home in her fourth career game in mid-September – a 6-1 victory that snapped a nine-game losing streak against the Owls; her second hat trick proved to be the final goals of her career and sparked a 5-4 road win over four-time defending LEC playoff champion Keene State in mid-October of her senior year – the team’s first victory over Keene in 15 years that guaranteed the Warriors of a fourth straight LEC playoff berth (Kallgren assisted on a fourth goal in that match that gave her a career-high seven points, which remain tied for the third-most in a match in program history).

After joining the program as freshmen in the fall of 2014, Kallgren, Katie Jankura and Maddie LaRusso became the first players in program history to qualify for the LEC playoffs in each of their four seasons, with Kallgren and Jankura serving as senior captains in 2017.

In her career, Kallgren appeared in all 72 possible matches (starting all but three) and contributed at least one point in more than half of those matches. Through 2025, Kallgren is the only player in program history with two of the Top 10 scoring seasons and is one of only two players with two of the Top 10 marks for goals in a season.

Kallgren graduated with a B.S. Degree in Sport Management and currently serves as a health fitness professional. She resides in her hometown with husband Michael and infant daughter Lillian.

for a while whether the day was to be foul or fair, but before nine o'clock it was so dissipated that one's eye could clearly discern the end of his nose, and soon a bluer sky and a clearer sun, or purer air never exhilarated the life-blood, or made 'out-doors' more attractive. And the most attractive spot in the region, seemed to be under and near the beautiful elms in South Woodstock. Scarcely a more beautiful spot can be found in that beautiful town, and rarely has there ever been a larger gathering in it, or for a more excellent purpose. The first exhibition was a trial of oxen and horses with the plough. Much interest was excited by this by the large number present, and we doubt whether George Goddard, Esq., or any other man, ever had a piece of ground ploughed quicker or better. It was easier to decide which was done the quickest than to say which was the best. Edwin Bugbee's horse team did the work in twenty minutes, and his ox team in twenty-five minutes and others but a few minutes more. The ploughs used, with a single exception, were 'The Cylinder,' manufactured by James Allen of Putnam... "There were displays swine, sheep, of fruits and vegetables, "fancy articles," etc. "The late frosts prevented a large display of flowers, but a few beautiful bouquets appeared. There were some fine paintings and crayon drawings" (p.3).

I knew that Putnam had once had a fairgrounds, but I initially was having difficulty pinpointing when it came into existence. (The Aspinock Historical Society was closed when I began my research). The first mention I found in assorted newspapers was in the August 15, 1906 Windham County Observer (p.2; genealogybank.com). The article simply mentioned someone living near the fairgrounds. My late grandmother Margaret Lyter always said, "Patience and perseverance" so I did call Putnam's Municipal Historian Bill Pearsall for help. Luck was with me for the Aspinock Historical Society files contained the February 2020 issue of the Pomfret Times which had an article on the fairgrounds by James Platt. "The Fair, was located on the land between The Quinebaug River and Park Street on what is now known as Lower Kennedy Drive. The current farmers market is on part of the site as is the Ford Dealer and the interchange with I-395. The fairgrounds included a half mile race track which was considered to be fastest race track in the state at that time. The track was used mainly for trotting horse races, but bicycle racing was also a big attraction." The first fair of the Putnam Park and Fair Corporation, J. B. Tatem, president, was held August 30, 1898, ran for three days and drew an attendance of 7,000. "The fair was last opened in 1910 with an attendance of only 2,500 people." In November of that year the directors and stockholders voted to sell the property. (Windham County Observer, November. 30, 1910, p. 6; genealogybank.com). Pictures of the Putnam Fairgrounds can be seen at the Aspinock Historical Society in Putnam's Municipal Complex.

Nevertheless, after the sale the property continued to be utilized and referred to as the Putnam Fairgrounds as the next articles show. The Friday, Sept. 1, 1916 Worcester Telegram and sounded like it would have been quite a fun to attend this event at the former fairgrounds. "Bloomer Girls to Play Putnam (men's) Team Tomorrow. Putnam, Aug. 31. The Putnam baseball team, Thomas McDermott manager, will play the New York Bloomer Girls Saturday afternoon at the Putnam Fairgrounds. The Bloomer girls claim to be the champion female team of the world and Mr. McDermott, who has seen them play, says Putnam will have to put the best possible team into the field to defeat them... Manager McDermott said this afternoon the regular Putnam team will line up against the girls. Sunday afternoon the Putnam team will play Marlboro on the Putnam fairgrounds." (p.16; genealogybank.com). The Monday, Sept. 4, Worcester Telegram carried an article about Putnam's 7-0 win over Marlboro, who had had a 16-game winning streak snapped. I was able to get at least some idea of the Putnam's players of that time. Nanning, 3 b; Barnicle, c; Gilmore, rf; Johnston, 1b; Labelle, lf; Hogan, 2b; Pearce, ss; McNamnee, c; Hanley, p. Attendance was listed at 1000. (p.11; genealogybank.com). The Aspinock Historical Society has a photo of the team.

Your business has a healthy profit: Should you refinance, reinvest, or hold cash?

Picture a company coming off a strong year. After payroll, taxes, and normal operating costs, there is \$500,000 sitting in the operating account that the business does not need next month. The owner has three broad choices: restructure debt, put the money back into the business, or hold it.

Nearly every business owner reaches this point eventually; it's a question that our team here at WHZ fields frequently from our clients who own a business. The honest answer is that all three can be right, and which one wins usually depends on facts that have nothing to do with the money itself. The best way to determine which is right for you is to walk through them in order.

Before anything else, determine the cost of your capital

Before choosing anything, put two numbers on paper: what your existing debt costs after tax, and what a dollar reinvested in the business has actually returned over the past several years. If your debt costs 8 percent and your incremental return on invested capital is 15 percent, reinvesting usually wins. If those figures are reversed, they are telling you something.

Interest rates have settled into a steadier range after several volatile years, which means this comparison holds long enough to plan around instead of needing to be rerun every quarter.

Option One: Refinance or restructure debt

Refinancing is a cash flow decision more than a rate decision. Consolidating variable-rate balances, extending a term to lower monthly obligations, or replacing a line of credit that has become a permanent fixture can all free working capital without spending a dollar of profit.

The tax side of this equation has improved recently as well. The One Big Beautiful Bill Act (OBBBA) returned

the business interest limitation to an EBITDA-based calculation, which restored deduction capacity for capital-intensive businesses that had lost it under the narrower rule. So, debt is somewhat cheaper after tax than it was two years ago, making refinancing a potentially winning choice. Just be sure to check prepayment penalties, personal guarantees, and any covenant that tightens as leverage changes before signing on the dotted line.

Option Two: Reinvest in your business

This is where the law moved most. OBBBA permanently restored 100 percent bonus depreciation for qualifying property acquired and placed in service after Jan. 19, 2025, and reinstated immediate expensing of domestic research and experimentation costs rather than spreading them over five years. Section 179 expensing allows up to \$2,560,000 in 2026, phasing out once purchases exceed \$4,090,000.

In practice, a qualifying equipment purchase can reduce this year's taxable income roughly dollar for dollar. That is a real advantage, and it is also where owners get into trouble. A deduction is not a reason to buy something the business does not need. Fully expensing a poor purchase still leaves you with a poor purchase.

Remember that reinvestment also means people. A key hire, a retention package, or training that reduces turnover rarely shows up on a depreciation schedule, but it often produces the higher long-term return.

Option Three: Hold cash deliberately

Cash should be a position, not a leftover. Yields have shifted enough that reserves earn something meaningful again, though inflation still works against purchasing power over time.

Holding makes sense when the pipeline is uncertain, when a known outlay is coming within the next 12 to 18 months, when you are preparing for a sale or ownership transition, or when your reserve sits below three to six months of operating expenses. Past that point, idle cash tends to sit on the balance sheet earning less than the business itself does, and an acquirer may not pay you much for it.

The Fourth Option most owners overlook

Profit can also move out of the business and into your own retirement plan, and this is frequently the most efficient use of a strong year.

For 2026, an owner can defer up to \$24,500 as an employee, plus an \$8,000 catch-up at age 50 or older, or \$11,250 for those age 60 through 63. Employer profit-sharing contributions stack on top, with total annual additions capped at \$72,000 per participant and compensation counted only up to \$350,000. The contribution is deductible to the business, funded from the same profit you were deciding about, and it moves money from a balance sheet exposed to business risk onto one that is not.

For owners with a small or older employee group, adding a cash balance plan alongside the 401(k) can allow considerably more. One change to note for 2026: if your prior-year FICA wages exceeded \$150,000, catch-up contributions must now go in as Roth, which shifts the deduction math slightly.

Remember that this is a wealth decision, not only a

business one

Pomfret program to explore medicine on the Revolutionary War battlefield

POMFRET — The Pomfret Historical Society will turn back the clock to

the Revolutionary War this weekend with an interactive look at the difficult, danger-

ous and sometimes unsettling work of an 18th-century military field surgeon.



“Doctoring the Soldier: The Life of a Military Field Surgeon During the Revolutionary War” will be presented Saturday, Sept. 5, at 3 p.m. at the Old Town House, 11 Town House Drive, Pomfret Center.

Historical researcher and reenactor Daniel Newman will lead the program, drawing on more than 40 years of study of 18th-century medicine and surgery. Newman portrays a British surgeon attached to the 54th Regiment of Foot and will discuss the medical practices, surgical techniques, remedies and cures available during the colonial era.

Among the treatments visitors will learn about are practices known as “bleeding, blistering and purging,” which were commonly employed by physicians at a time when modern anesthesia, antibiotics and an understanding of infection were still far in the future.

The program will also place those medical practices within the experience of soldiers who fought during the opening months of the Revolutionary War.

One such soldier was Elihu Sabin, who left his family in April 1775 after joining Capt. Zebadiah Ingalls and the 11th Regiment in answering the call following the battles at

Lexington and Concord.

According to an account preserved in the Seth Chase family papers and provided by Eliza Kimball of the Abington Social Library, Sabin’s daughter, Lavina, remembered her father saying goodbye before departing with his gun over his shoulder.

After the Battle of Bunker Hill, fought largely on Breed’s Hill on June 17, 1775, Sabin eventually returned home wounded. According to the family account, Sabin was unable to dismount from his horse without assistance and knocked on the family’s door using his crutch.

Although he recovered sufficiently to live for more than another 50 years, the wound continued to trouble him periodically throughout the remainder of his life.

Sabin would have been among the many wounded soldiers treated by military surgeons serving with the forces gathered in and around Boston during the early months of the Revolution.

Battlefield medicine was crude by modern standards, and military surgeons faced a daunting combination of gunshot wounds, infections, disease and limited medical knowledge. Soldiers with less serious injuries could

have their wounds dressed and return to service, while others recuperated in makeshift hospitals and encampments. Injuries that might be routinely treated today could become life-threatening, sometimes leading to amputation or death.

The experience was shared by soldiers on both sides of the conflict. Field surgeons treated everything from relatively minor injuries to catastrophic wounds while working without the medical technology later generations would take for granted.

Newman’s presentation will give visitors an opportunity to examine that world through a hands-on program exploring the tools, theories and treatments available to military doctors during the Revolutionary era.

The presentation is free, and is funded through an America 250 grant from The Last Green Valley. Donations will be accepted to support continued renovations and maintenance of Pomfret’s Old Town House, which was built in 1841.

Attendees are encouraged to arrive early for parking and refreshments.

Help Wanted

Seven signs your child may be struggling with bullying

Remember the words to this old song?

“School days, school days,
Dear old golden rule days.

Readin’ and ‘ritin’
and ‘rith-me-tic

Taught to the tune
of a hick’ry stick.”

For parents, the return to school this fall signals the big shift from summer to the back-to-school season. My suggestion to you this fall: Don’t wait for your child to use the word bullying. Sometimes the behavior changes before the words do. As I write this monthly article, I recognize these signs in my younger self after being bullied and beaten up. It’s amazing how after 50 years, I can still vividly remember having these feelings of despair and sadness along with these symptoms. When I was a kid, my Grandmother would tease me. She would say, “You are so shy that if someone were standing on your foot, you would not say a thing.” These tips are warning signs of more serious mental health issues to watch out for.

Your child suddenly doesn’t want to go to school. Frequent complaints of feeling sick, requests to stay home, or unusually anxious behavior about Monday mornings can be a warning sign. I desperately wanted to skip school after being beat up. Walking the halls at school with a black eye was one of the most humil-

iating experiences of my life. Comments like “loser” followed me for days. It’s not that they want to skip; it’s just that it’s hard to learn when you are scared.

Their friendships suddenly change. A child who normally talks about friends may stop mentioning them, lose a friendship unexpectedly, or seem increasingly isolated. After being beaten up by the alpha teen in my neighborhood group, I lost my circle of friends. My parents were great about pushing me to keep in contact with other friends in town because we all need a support system and a sense of belonging. Even with kids around, your child can feel alienated and lonely.

Your child has mood or behavior changes. Increased irritability, sadness, anger, withdrawal, or emotional outbursts can signal that something is happening at school. On the outside, your child may look the same, but inside, their emotions are in a whirlpool of despair, helplessness, and sadness. They are trying their best but may not have the tools to cope. Long talks and hugs go a long way in helping.

They start avoiding certain places or activities. Pay attention if your child suddenly doesn’t want to ride the bus, go to the cafeteria, attend recess, participate in

activities, or go to a particular class. Going to these places is difficult because your child knows the bullies lie in wait and the bullying will begin again. As much as you might tell them to “tough it out,” it’s not that easy. After being beaten up and bullied, my Mom drove me to school every day so I didn’t have to take the bus. I am not sure this helped. I wished and hoped that I had confidence and self-defense skills, but at that time I had none.

Their school performance changes. Difficulty concentrating, missing assignments, declining grades, or losing interest in school can sometimes accompany social problems. It’s difficult and nearly impossible to learn when you live in a state of terror. Bullying has many debilitating effects on kids and will result in a lack of concentration and, as a result, poor academic performance and grades.

Your child becomes unusually quiet about their day. If “How was school?” used to generate stories and now gets a quick “fine,” gently ask more specific questions rather than assuming everything is okay. Withdrawal from family and friends is another warning sign.

Your child loses confidence or begins blaming themselves. Statements like “Nobody likes me,” “I’m stupid,” or “It’s probably my fault” deserve attention. Children experiencing repeated negative treatment may begin to internalize it. A child who is bullied may

feel like it was their fault that this is happening to them.

An important point for parents: None of these signs automatically means your child is being bullied, but these are signals to slow down, listen, and start a conversation. Sometimes it’s easier for your child to speak to a trusted uncle or aunt because it feels safer. Let’s do whatever it takes to get your child talking about their feelings, and communication is key. If you think this situation warrants seeing a counselor or therapist, please take action. If you live in northeast Connecticut, I have the perfect person to recommend.

It’s a long road back from being bullied. I have two proven suggestions. One: find your kids a bodyguard, not like a Secret Service escort or a person with aviator sunglasses, but a confident and respected student in their class who will stick up for them. Bystanders need to become upstanders.

Secondly, build your kids from the inside out. Confident kids don’t get bullied. Your child needs a skill that will build their confidence. When a child excels in any given field, their confidence will grow (in time). I wish I had the confidence I have today back then. I was shy and quiet, but being a martial arts black belt has given me great confidence and saved my life.

“These days, my motto is simple: there are two kinds of people in the world — people who know me, and

people who want to know me.”

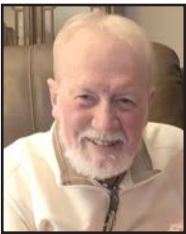

these responders perform on a volunteer basis.

"Most people never get to see what it's actually like inside a structure fire. You may see the trucks, lights, and firefighters from the outside, but this quick helmet-cam video gives you

a glimpse of what your Thompson volunteer firefighters experience on the inside. It's what they spend countless hours training for," wrote the Thompson Fire Engine Company. "Television rarely gets it right. Inside a real structure fire, there aren't always clear rooms and perfect visibility. Smoke can bank

down to the floor, visibility can be near zero, and firefighters often have to work by feel more than sight. This is a quick glimpse of what we see—and, more importantly, what we often can't see."
