### Dudley sends \$4.8 million override to ballot vote

DUDLEY — The town of Dudley is officially sending a Proposition 2 1/2 override request to the voters as a ballot question on April 25. The question will determine if Dudley proceeds with a \$4.8 million spending plan to offset projected shortfalls in both the municipal and education budgets for the next fiscal year and beyond.

The budget situation in Dudley has been one of the biggest talking points in public forums throughout the first two months of the year, but on March 9 numbers became more official as the Board of Selectmen unanimously approved recommending a \$4,846,597 budget with \$3.17 million to fund the Dudley-Charlton Regional School District and \$1.67 million to fund Dudley's operational expenses on the town side beginning in Fiscal Year 2024. These numbers require the voters to approve a Proposition 2 ½ override in an election-style ballot vote. If the vote fails, Dudley town and school officials have warned that significant cuts will need to be made to both budgets.

### **Oxford Town** Manager warns of energy bill scam

OXFORD — At the last selectmen's meeting March 7, Town Manager Jen Callahan warned citizens to be warv of a new scam.

The police "are issuing a local alert because several residents have been scammed out of actual money by individuals falsely posing as National Grid employees," she said. The people claim "their power is going to be shut off if their payment is not received immediately."


"Especially with people's overall inflationary costs, it's awful when people become victims," she added.

According to National Grid's website, this scam has been hitting residential and business customers. It noted that immediate shutoff threats are "not our procedure" and the firm does not accept payments through wire transfers or prepaid debit cards, as the scammers have been requesting. Specifically, the site states people should seek the caller's identity and reject calls when "The caller can't provide the last five digits of your National Grid account number when asked. A National Grid representative will know it."

"National Grid may ask for a payment over the phone, but will leave the method of payment to the customer," the page's drop-down FAQ section adds. "National Grid will not contact customers demanding immediate payment by wire transfer, Green Dot Money-Pak or any other pre-paid card service. Never under any circumstances – offer personal or financial information to someone who you cannot identify.'

The page states people who have been scammed should contact the police and/or Attorney General's office, and those with account questions can contact National Grid at these numbers: electric 1-800-322-3223 and gas 1-800-233-5325.

Callahan said she's recently received the state's 'cherry sheet" governor's budget figures, which give Oxford about 2 percent, or \$374,000, more in general aid than last year. 



### Teaching workshop at Nichols College hosts Michael Roberto, D.B.A., top case study author

the Nichols College campus yesterday to conduct a teaching workshop open to Nichols faculty and organized by the Nichols College Faculty Development Committee.

Roberto is the Trustee Professor of Management at Bryant University leadership, managerial decision making and business strategy. He joined the tenured faculty at Bryant after serving for six years on the faculty at Harvard Business School.

The workshop focused on teaching and learning using active learning techniques such as the case method to spark curiosity and learning, as well as tactics for keeping students engaged and energized. "Active" learning is a method of teaching where student learn by participating in hands-on exercises; "passive" learning is where students receive and memorize the information that is provided to them.

'At Nichols College, we aim to foster an active and vibrant educational environment; we understand the powerful impact that faculty can have on student learning and outcomes," said Nichols College President Glenn M. Sulmasy, JD, LL.M.



## DA's office receives funding for drug diversion programs

REGION — Worcester County District Attorney Joseph Early, Jr., recently announced that his office has received significant grant funding to expand drug diversion programs.

The \$1.6 million federal grant was awarded by the Department of Justice to help build a network of supports for children exposed to drug overdoses within their families or their home environments. The funding will assist kids across Worcester County.

"As we continue our work to fight against the opioid epidemic, we want to make sure those suffering from substance use disorder get the treatment they need," Early said. "We also know substance use disorder is a disease that affects the entire family, with children often being the forgotten victims who are traumatized when a family member is caught in addiction. Our aim is to provide a soft touch and a helping hand to eliminate long-term trauma to these

The grant funding will allow for the continuation of court-based drug diversion programs in several area district courts, as well as the expansion of the diversion program to courts in Dudley, East Brookfield, Uxbridge, and Westborough.

Clinicians from AdCare Hospital, a partner on the recently awarded grant, will provide on-site assessment services to individuals referred to the diversion program in the ten courts across Worcester County. This program will allow low-level offenders to enter a treatment program.

"AdCare Hospital is grateful to be working with the Worcester DA Diversion Program," said Andrea Dayotas, the executive director of inpatient services at AdCare. "This year, we are expanding our bandwidth of services to court systems throughout central Massachusetts. We are committed to fighting the disease of addiction in our communities."

The National Alliance for Drug Endangered Children (National DEC) will assist in the advancement of a Worcester County program to connect community partners and resources from across the county. The National DEC will perform a community needs assessment and provide training and technical assistance to strengthen the local alliance, officials said.

'The National Alliance for Drug Endangered Children is excited to be a collaborative partner in this grant," said Stacee Read, the organization's director of network development. "Our staff has worked with DA Early and his office over the past several years by providing training and technical assistance to assist in starting drug endangered children efforts. DA Early and his office are filled with great knowledge and experience, but most importantly the passion for this work that will in turn help to change the trajectory of children and families' lives in Worcester County. We are honored to be walking this journey with DA Early and the Worcester County DA's Office to collaboratively help children and families impacted by parental or caregiver substance use."

Comprehensive Stimulant, and Substance Use Site-Based Program grant was awarded in late 2022, with work set to begin this

"I'd like to thank our partners and all those who helped us secure this grant, especially Congressman James McGovern," Early said. "These funds will help us save lives and prevent future crime by getting help to those who need it and by protecting children from trauma.'

For legislators at all levels, combating the opioid crisis has been a point of emphasis for well over a decade.

"The opioid epidemic has claimed the lives of thousands in communities across America," Congressman McGovern said. "These initiatives will provide a hand to those struggling with substance use and their families, helping them create a future of hope and possibilities."

request. These presentations proposed harsh realities for the town, but in the weeks following the presentations Town Administrator Jonathan Ruda reassessed the cuts with input from the Board of Selectmen and proposed changes to accommodate certain needs, both long- and short-term, even if the override fails. In a statement, Ruda explained that even with these changes his "failed override budget" will still come with heavy losses to almost every department in town.

My recommendations with a 'failed override budget' will result in the reduction of six months of highway materials and to reappropriate the limited funds to the Fire Department. The lay-off of one Highway Truck Driver no later than six months into FY24, as well as an administrative assistant from the Treasurer/ Collectors Office, the Assessor's Office, Animal Control, and the administrative assistant from the Police Department within the same time frame will be made to preserve two police positions. Additional recommendations focus on maintaining food inspections through the Board of Health, and additional use of stabilization to maintain minimum amounts for energy, fuel and regulatory and compliance. There is no room for error in either the police or fire budgets, and free cash will be required to maintain both departments, and compliance and regulatory mandates, and public health services," said Ruda. "Generally, we have a few hundred thousand in available free cash at the October Town Meeting. That falls far short of addressing the \$1.6 million required to maintain current service levels. Absent an adjustment in revenue, we will be planning for FY25 with cuts to public safety that will be insurmountable.

A failed override would also result in significant cuts on the education side which have also been heavily discussed by the Dudley-Charlton Regional School Committee in public forums throughout the past few months.

During the March 9 meeting, selectmen took to the microphone to comment on the state of Dudley's budget. The town's highest elected board acknowledged that this will not be an easy process and that the voters and town officials have tough decisions ahead.

"I know a lot of time and resources have gone into this report, and it's a grim one, but it is reality and those are the facts based on the real numbers that we're working with or not working with," Selectman Mark Landry said. "This is a factual statement. We don't want it to happen. We want everything to go nice and we want to keep everybody where they are, doing the best Live music and refreshments! they can, and not cut anything if at all possible."

Selectman Steve Sullivan presented a warning to the voters to trust the process and the department heads in charge of putting together the budget. His fear is that misinformation or disinformation on social media coul voters.

"Don't find your information on Facebook. Don't find it from someone who doesn't know what they're talking about, spit balling against the wall. The people that speak tonight, the department heads from the last meeting, those are the people who are empowered in their position. Those are the people we trust to run our day to day . . . watch (meetings) and come to meetings to get your information - not social media,' said Sullivan.

The Board of Selectmen unanimously approved sending an assessment of an additional \$4.8 million in real estate and personal property taxes to the ballot on April 25 "for the purposes of operational expenses for the Dudley-Charlton Regional School District in the amount of \$3,172,083 and operational expenses for the Town of Dudley in the amount of \$1,674,514.00 for the fiscal year beginning July 1, 2023." According to the Town Assessor's Office, this would result in an average increase to the average tax bill of \$1,205.55 per year. It should be noted that no members of the public chose to comment during the meeting when given the opportunity.

When asked if the proposed spending plan presents a realistic long-term solution for Dudley, Town Administrator Ruda said the override is the only feasible way that Dudley can maintain the services it currently has at this time.

'The only realistic, long-term plan for Dudley is to adjust revenue amounts to levels that accurately reflect the cost of running municipal services, and funding education - With inflation numbers reaching as high as 9 percent last year and fluctuating to date between five and nine percent, the simple math limiting revenue increases to 2 1/2 simply doesn't work," said Ruda. "The answer is clear, and it is very simple - we need sufficient funding to provide sufficient municipal services and education. Our tax rate doesn't support that, nor is our tax rate capable of adjusting and overcoming the challenges that we face as a community; only voters are capable of stepping up to that challenge.'

Dudley's ballot vote will take place on April 25 with voter information made available on the town Web site. Recordings of Board of Selectmen and Dudley-Charlton Regional School Committee meetings detailing the numbers behind the budget have been made available for public viewing on the Town of Dudley YouTube channel as well.

been included in the fiscal 2024 budget. He noted the board set aside \$70,000 to implement such changes, and has spent about half that during this fiscal year.

Similarly, he noted Feb 28 was the deadline for budget requests, and the capital plan has all its submissions but needs prioritization. Part of that will include an analysis of key building needs, based on a "scaled-down" version of their architect's proposal; he noted "what they have available is more than we need." LaFond said he's not pursuing a facilities director now, opting to finish that analysis and let the new school superintendent get settled in place first.

LaFond credited Accountant Tim Bell and HR Director Courtney Friedland's "institutional memory and knowledge" for making the process go "so well." He also noted the governor's budget "should be more beneficial to Webster than it has [been] the last few years."

Beyond budgeting, LaFond said he's seeking assistance from CMRPC's Local Technical Assistance Program to study issues related to a proposed Business Improvement District, "something we haven't had a chance to deal with too much."

He also referred to the foundation of a regional Housing Alliance, which met first in Southbridge and is gathering March 17 in Webster. He said he attended and found it helped him "understand some things I hadn't really given a lot of thought to over the years." Among them, he noted

that there's some overlap with the opioid task force's effort, and most of its current members are social service agencies. Tom Klebart said this has become "a major concern over at the library.'

The evening's final issue was a brief look at how to fill committee vacancies, with Moderator Ted Avlas saying he's concerned about "how they're handled, addressed and posted." While most are selectmen's appointments, some are his, and he noted lists on the town's website are sometimes out of date and missing seats. "If I'm confused, I think our residents are as well."

The board briefly discussed whether it would craft a formal policy regarding who's responsible for keeping a board's page updated.

of teachers and programs to sacrificing an opportunity for funding through the Massachusetts School Building Authority (MSBA) to assess the future needs of Shepherd Hill Regional High School. The budget pushed forward during the School Committee's March 8 meeting represents a perfect scenario where Charlton is able to accept a \$2.2 million increase in assessments and Dudley approves a multi-year override to fund both school and town needs. School Committee members were realistic in stating that the proposed budget will likely change significantly in the coming months, but they felt it was proper to propose a level-funded budget to at least begin larger scale discussions.

"One of the things I've learned is that you have to have a starting point and I feel that we owe it to our students and our staff to at least start at a level service budget," said School Committee Chair Cathleen Carmignani. "If we start any less, I think that's a disservice to our students, our staff, and our public and future residents of our towns.

The proposed plan calls for a Proposition 2 1/2 override in Dudley which will go before voters in a ballot vote in April that includes \$3.17 million in added assessments for education. The initial plan being put before Charlton calls for a \$2.2 million increase, however the town has made it clear \$2.2 million would be unattainable.

The agenda noted the following committees need people: Two full members each for Bylaw and Disabilities; two alternates each for Zoning and Conservation; one full member each for Finance, Personnel, Water/Sewer, Economic Development and Historical; and a whole complement for the Recreation Committee. They also discussed the fact there's a vacancy on the Board of Health, where an elected member resigned, but LaFond said he's not aware of anyone who has either sought to be appointed until the election or taken out papers to run for the seat.

Superintendent Lamarche presented \$600,000 in possible cuts to get Charlton's assessment to \$1.9 million, which still doesn't meet the \$1.3 million limit that the Board of Selectmen set during a meeting in February as their maximum starting point for conversation. Lamarche said Charlton's numbers are far from finalized.

"I completely understand where the town of Charlton is coming from with their timeline, but that assessment is really contingent on a successful override (in Dudley) that doesn't occur until April 25. There is some room in there for continued dialogue with the leaders of the Town of Charlton to really try to hammer that out and what that looks like," said Lamarche.

Throughout the meeting

Lamarche and the School Committee stressed these numbers are all just conversation starters and that this budget presents two different situations that both need to be resolved to finalize the final spending plan. In order for any of the numbers to work, Dudley must approve the override request set for a vote on April 25. If that vote is successful, the district must also come to an agreement on assessment increases with the town of Charlton before both towns bring their budgets to town meetings this spring. There's still plenty more to work out, but for now both towns and the school committee have a solidified starting point to begin larger conversations about the future of the district.



### Let's end Daylight **Savings Time once** and for all

Last year, United States Senators voted unanimously to nix daylight savings. The plan is to make daylight savings time permanent. If the bill passes, it will go into effect in November of 2023 to avoid a scheduling nightmare with the travel industry.

The bill is called the Sunshine Protection Act. Florida Senator Marco Rubio noted that most people despise the changes, and he questioned why the practice of turning our clocks back or forward one hour at the onset of winter and spring is still, as the younger generations say, a 'thing.' The time change first became known to Americans in 1918.

Island Democrat Sheldon Whitehouse noted that the change places New England in complete darkness during afternoon hours, affecting youth sports and leads to depression. A sunset of 4:15 p.m. is not conducive to daily life. Some experts relayed that year-round daylight savings will make people happier and more produc-

We are all always happier when it's lighter longer. Most of us. If the bill passes, the rest of the country will join the likes of Arizona, Australia and Hawaii who opt not to spring forward and fall back. Daylight savings time is used in roughly 70 countries across the globe. Here we compiled a list of pro's and con's so you can determine your own thoughts.

The idea of DST is to utilize activity during daylight hours. Some benefits include decreased electricity consumption, a decrease in the number of traffic accidents and crime. DST also increases recreational time, hence boosting the economy.

According to studies the changes cost \$60 billion. Interesting is the fact that the barbecue industry and small convenience stores increase sales by \$135 billion.

As for energy consumption a study in 1997 revealed that no significant effects occurred when DST was observed all year. In all, energy demands were reduced by just 2.6

Another pro is the decrease in traffic When more people drive during daylight the risk of accidents decreases due to the simple fact that driving in the dark is typically more dangerous.

Pedestrian accidents would also significantly drop.

A reduction in crime has also landed on the pro list. When folks finish work, and run errands while it's still light out, the exposure to crime becomes less since more crimes take place at night.

The increase in recreational time is a no brainer. The longer it's lighter out, the more time there is to have fun outdoors. As stated above this is also an economy booster. When more people are out and about, they spend more money. The exposure to more vitamin D that the sun provides also proves as a health benefit.

On the flip side of the coin, the change may disrupt sleep schedules. The transition can be rough especially for those who don't get more than five hours per night as it is. However, after the initial adjustments no long-term adverse effects on circadian rhythms were noted.

The longer the day, the more fuel consumption takes place in the atmosphere. The increase in evening traffic emits more pollution in the air.

It's clear the pros outweigh the cons. In our opinion, the natural cadence of the sun should not be altered. If we stick with longer days and leave it at that, we think a much more positive population would ensue.

### Christ the healer



### Late winter tent caterpillar management

Start this year's tree pest management with a stroll through the landscape. As you enjoy the scenery, be sure to look for any unwelcome pests that may be overwintering on the twigs of trees.

Look for and remove egg masses of tent caterpillars now through spring. These clusters of eggs look like shiny blobs of mud surrounding the twigs. Each egg mass contains hundreds and in some cases thousands of eggs.

The forest tent caterpillar is the most widely distributed tent caterpillar. It attacks a variety of trees that vary with the region. Check any sugar maples, aspen, cherries, apples, oaks, birch, ash, alder, elm, basswood, or water tupelo trees growing in your landscape.

Trees may suffer damage when large populations of these caterpillars devour the majority of the tree's leaves for several years in a row. This can result in reduced tree growth, top dieback, and tree mortality. There are several natural predators of this insect pest so working with nature is a great way to help reduce damage. Remove the egg masses found on small twigs that are more easily reached on

To the Editor:



### Acid rain continues to impact local fishermen

I knew if I took my boat out of mothballs, we would get some snow, but I did not expect a Northeaster. By the time you read this column, it will already be melting, so I guess we are over winter. Come on, springtime! Prior to the snow this week, the birds were singing in my backyard, and I even put on my summer shorts and stretched out on a lawn chair in the

Mass. Fish & Wildlife has started to stock trout in numerous lakes and ponds last week, and it brought out a lot of anglers to catch some for the dinner table. Powerbait is the number one choice of bottom fishermen, and it was literally flying off the shelves at local bait shops and big box stores. Shiners are also popular with some anglers, but they are a bit pricey. What the heck happened to the old worm for fishing?

The latest news on chemically infected fish is not new, and is a problem with all water bodies in

Mass. and surrounding states. The major polluters are the western utilities that continue to pollute the atmosphere, and it is carried into the clouds, and travels thousands of miles, and then deposited in our waters as acid rain. It not only pollutes local waterways, but is responsible for polluting our gardens and farmers' crops. At one time 35 years ago, the western utilities had set aside a million dollars or more, and a company called Living lakes was formed. They were responsible for treating ponds, lakes and reservoirs with lime to bring back the Ph balance that was disrupted because of the acid rain.

This writer sent in an application on behalf of Mass. Fish & Wildlife and we received a communication from Living Lakes, that Wallum lake was chosen to be treated with tons of lime to correct the problem. Approximately 10 huge tankers of lime arrived at Wallum Lake with a slurry of lime that was spread by a large boat, using digital machines that spread an even amount of the lime on the entire lake. It brought the lakes PH back to a level that would sustain rainbow trout, as Mass. Fish & Wildlife had stopped stocking rainbow trout that they claimed would die if they were stocked. Still. 35 years later, Wallum Lake receives rainbow trout and they do very well.

Bottom feeding fish like hornpout, perch, have the most levels of heavy metals that are dangers for humans to eat, but bass, pickerel and other freshwater fish also have seen an increase in the heavy metals. As a longtime fishing angler in local freshwater ponds I always caught a lot of yellow perch, and brought them home for a good feed. The last 10 to 15 or so years, I stopped eating the fish when I observed black spots on the skin of the fish, and when I removed the skin they had worms crawling out of the flesh. I knew we had a problem, and wrote numerous articles on my findings for many years. Not much was made of it. Saltwater fish like cod and Haddock also are showing signs of worms in their flesh for a number of years now. It sure wants to make



She grew up in Webster, spending

her summers at the local lake, Lake Ch argoggagoggmanchauggagoggchaubunagungamaugg. Marie loved that lake and her childhood in and on its waters. She became an avid water skier. Her children would later marvel and ask about how she earned all those skiing trophies on the bookshelf. Later in life, on trips back home with her own family, she always found a neighbor or old friend to take her sons out on the lake to ski for a few hours. She wanted them to share a piece of her childhood and memories from that wonderful place. Marie always pointed out the ski ramp and explained that she never jumped – a promise she made and kept to her dad. The joy she felt from those summer waters was palpable, and she made sure to share those memories of her idyllic home with her children. Dick's return let her continue the journey she and they always wanted – a long life and family together. They had three sons, Jeffrey, Matthew, and Eric, whom she poured her life into. She definitely

was not a helicopter parent, but she was always there – from morning wake ups, packing school lunches, nightly dinners, homework help, games, field days, and parties. Every birthday was celebrated with amazing homemade cakes – that would have been great viewing on today's reality cooking shows – edible 3D sculptures, always an amazing surprise at the reveal.

Frugality and Marie were dear friends. She attributed this skill to starting her married life on a second lieutenant's salary. A favorite life lesson she often retold was rooted in a night of cards where Dick and Marie gambled away all their coins – their laundry money literally gone for the week. Even as their fortunes changed, Marie's eye for saving money never did. Every dollar and coin counted, and every coupon clipped.
