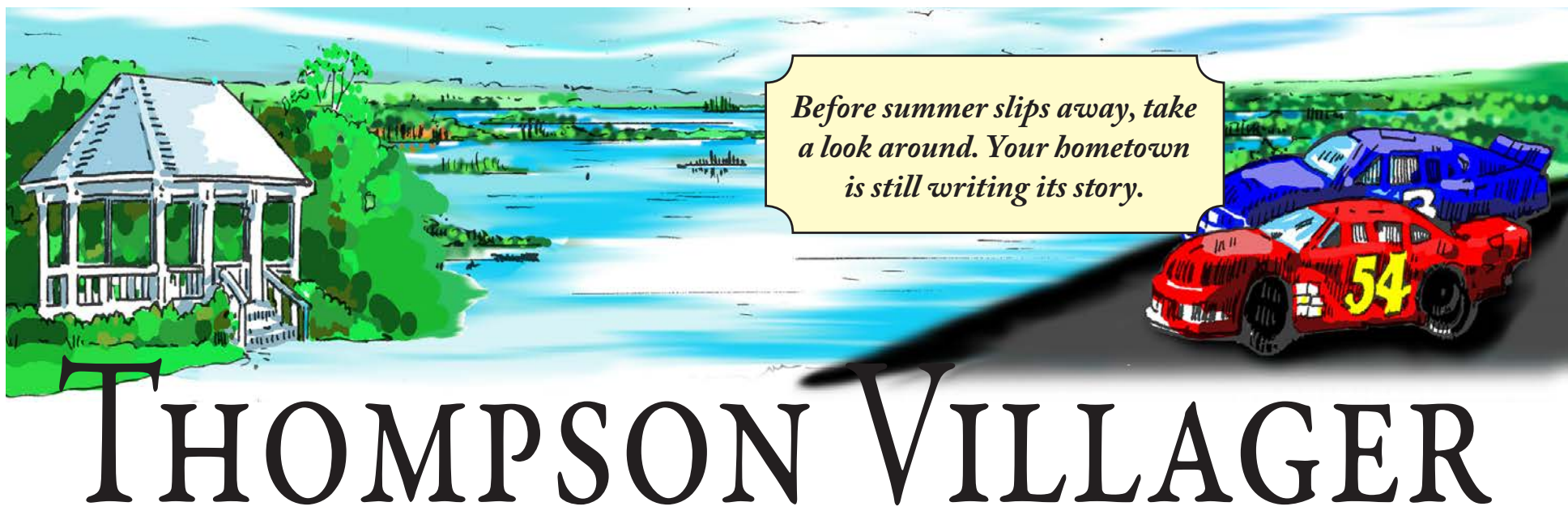

Thompson Recreation renews focus on Bull Hill Recreation Area

THOMPSON — Talks around resolving drainage issues at the Bull Hill recreation area have resurfaced in Thompson thanks in part to urgency from a local soccer club.

The Thompson Recreation Commission received a letter from the NECONN Soccer Club based in Putnam urging the town to prioritize resolutions to ongoing issues that have halted use of the Bull Hill recreation area which once played host to local soccer leagues prior to the pandemic. Issues with drainage surfaced in the late 2010s and only a few years later the property stopped hosting sports entirely.

Alexandra Robin, the NECONN Soccer Club's Fundraising Chair, submitted a letter to Thompson Recreation Commission that sought an update on the situation at Bull Hill, noting that the last assessment of the property that was made public occurred in 2017 courtesy of UConn Department of Civil Engineering. NECONN expressed their continued stake in supporting local soccer programs and urged Thompson Recreation to provide an update regarding any further testing, a capital improvement timeline, and collaboration opportunities between the club and the town to prioritize the fields.

American Legion Post 67 needs you

HISTORIC POST
FACES POSSIBLE
LOSS OF
CHARTER
UNLESS LOCAL

THOMPSON — For more than a century, American Legion Post 67 has represented the military veterans of Thompson. Now, after 106 years, that tradition is in danger of disappearing.

Post 67 was chartered in 1920, in the aftermath of the First World War, when communities across America were welcoming home a generation of young men who had served their country overseas. During the decades that followed, the Post became a familiar part of community life in Thompson.

Today, however, Post 67 faces a crisis that money

Putnam Cub Scouts walk among the patriots at historic Aspinwall Cemetery



PUTNAM — On Wednesday, Aug. 5, members of Putnam, Connecticut's Cub Scout Pack 21 took a walk through more than three centuries of local history when they visited historic Aspinwall Cemetery, one of the oldest burial grounds in northeastern Connecticut.

Led by Scoutmaster John Ryan, the Cub Scouts toured the cemetery and visited the graves of more than 40 local veterans of the American Revolution. Their guide for the evening was Putnam resident, local author and historian Michael Rocchetti, Commander of the Mayotte-Viens Post #13, American Legion, in Putnam.

As the Scouts moved among the weathered slate and stone markers, Rocchetti told them about the men from Killingly, Pomfret, Woodstock and the surrounding communities who answered the call to arms during America's War of Independence from 1775 to 1783. "This cemetery is hallowed ground," Rocchetti told the Scouts, "because it is the final resting place of the local men and women who sacrificed so much for our freedom."

A cemetery older than the United States

Aspinwall Cemetery dates to the early years

of European settlement in what is now Putnam. Lieutenant Peter Aspinwall, one of the area's earliest settlers, donated land for use as a community burial ground in the early 1700s. At the time, the area was part of the much larger town of Killingly. Putnam itself would not be incorporated until 1855.

The cemetery contains the graves of generations of the region's earliest families, along with town leaders, ministers, soldiers and community figures. Some of its surviving slate grave-stones date from the first half of the 18th century.

Many of the Revolutionary War veterans buried at Aspinwall Cemetery first entered military service following the fighting at Lexington and Concord on April 19, 1775. When news of the fighting reached Connecticut, militia companies throughout the colony mobilized and began marching toward Massachusetts. Men from Killingly, Pomfret, Woodstock and neighboring towns were among them.

A remarkable number of the men now buried at Aspinwall Cemetery appear on the surviving rolls of northeastern Connecticut militia companies responding to what became known as the Lexington Alarm.

Some served only a matter of days during the original alarm. Others soon enlisted for longer periods and went on to fight throughout the Revolution.

For the Cub Scouts walking among their graves more than 250 years later, these were no longer simply names printed in a history book. They had been farmers, tradesmen, fathers, sons and neighbors who once lived along the same roads and in the same communities the Scouts know today. Each grave represents a different piece of the larger struggle for American independence.

A family tradition of service

One striking aspect of Aspinwall Cemetery is the number of families represented by more than one Revolutionary War veteran. In an era when communities were small and extended families often lived close together, military service became a shared family experience. Fathers marched beside sons. Brothers served together. Neighbors found themselves standing in the same militia formations. For a community such as Killingly, the Revolution was not a distant event taking place somewhere else. It reached directly into local

Danielson Martial Arts leader receives prestigious G.O.A.T. Honors Award



DANIELSON — Master Daryl Laperle of Danielson has been selected as a recipient of the prestigious 2026 G.O.A.T. Honors (Greatest of All Time) Martial Arts Award, recognizing his exceptional lifetime of leadership, teaching, and service to the martial arts community.

The G.O.A.T. Honors Awards, founded by Grand Master Lawrence Arthur, recognize distinguished martial artists from around the world whose lifelong commitment to excellence, leadership, instruction, and service has made a lasting impact on generations of students and instructors. The 2026 awards ceremony was held on July 25, 2026, in Lynchburg, Va.

Master Laperle began his martial arts training at the Danielson Martial Arts Academy in 1986 and earned his Black Belt in 1990. At just 18 years old, he became Chief Instructor of the academy in 1994 and has since dedicated more than three decades to teaching and mentoring students. A 7th Dan black belt in the Cheezic Tang Soo Do Federation, he set multiple federation records as its youngest 4th, 5th, 6th, and 7th Dan master, reflecting his lifelong commitment to technical excellence and leadership.

Throughout his distinguished career, Master Laperle has competed nationally and internationally as a member of Team USA, earning victo-

ries throughout the United States, Bermuda, Australia, the former Soviet Union, and most recently a Silver Medal at the 2025 World Martial Arts Games in Oslo, Norway. His many honors include multiple inductions into the Action Martial Arts Hall of Fame, the USA Martial Arts Hall of Fame, as well as the Golden Gate Hall of Fame, and numerous federation awards recognizing his outstanding service and dedication to Tang Soo Do. As of 2026, he has promoted more than 110 black belts and numerous master belts, leaving an enduring legacy through his students.

"Master Daryl Laperle exemplifies everything the G.O.A.T. Honors were established to recognize," said Grand Master Lawrence Arthur, Founder of the G.O.A.T. Honors. "His lifelong dedication to teaching, competition, leadership, and the development of future generations of martial artists has made an extraordinary impact. Roger A. Dumas: A Prisoner of War unaccounted for

Connecticut’s Quiet Corner during the Korean War is that of Cpl. Roger Armand Dumas of Plainfield.

During the summer and early autumn of 1950, the division fought a series of desperate defensive actions before participating in the dramatic United Nations breakout from the Pusan Perimeter. Following the successful amphibious landing at Inchon and the liberation of Seoul, United Nations forces rapidly advanced northward, pursuing the retreating North Korean People’s Army. By late October, American forces had crossed the Chongchon River and were advancing deep into North Korea under the belief that the war was nearing a successful conclusion.

Unknown to United Nations commanders, however, hundreds of thousands of soldiers from the Chinese Communist Forces (CCF) had secretly crossed the Yalu River and were preparing a massive counteroffensive.

On Nov. 4, 1950, Company C, 1st Battalion, 19th Infantry Regiment occupied defensive positions on the high ground north of the Chongchon River, near the city of Anju, North Korea. The battalion suddenly came under attack by overwhelming Chinese forces. As wave after wave of enemy soldiers assaulted the American positions, another Chinese force maneuvered around the battalion’s southwestern flank, threatening to surround the entire unit.

Realizing that encirclement was imminent, the battalion was ordered to fight its way back to friendly lines. The breakout succeeded, but it came at a terrible cost. Many soldiers were killed, wounded, or captured during the confused fighting that unfolded across the rugged hills north of Anju. Among those who did not return was Corporal Roger Armand Dumas.

Captured by Chinese Communist forces during the battle, Dumas entered the harsh world of North Korean prisoner-of-war camps. Fellow prisoners who later returned home reported seeing him alive at several different holding locations before he was eventually transferred to Camp No. 5 at Pyoktong, one of the largest and most notorious prisoner-of-war camps in North Korea. Conditions there were exceptionally harsh. Prisoners endured severe cold, chronic malnutrition, inadequate medical care, exhausting forced marches, and political indoctrination. Disease and starvation claimed hundreds of American prisoners during the winter of 1950–1951. Despite these hardships, Roger survived.

When the Korean Armistice Agreement was signed on July 27, 1953, surviving prisoners from both sides were assembled for Operation Big Switch, the exchange of prisoners at Panmunjom. According to reliable accounts provided by fellow American prisoners after their release, Roger Dumas had reached the repatriation point and was expected to return home. Instead, they reported that he was unexpectedly taken away before his scheduled release. What happened afterward remains one of the enduring mysteries of the Korean War. Roger never returned.

The Army continued to list him as miss-

ing while investigating conflicting reports concerning his fate. Finally, on February 26, 1954, after exhaustive efforts to determine what had become of him, the United States officially declared him presumed dead. His remains have never been recovered.

Today, the Defense POW/MIA Accounting Agency (DPAA) continues to classify Roger Dumas as unaccounted for, and his case remains open. Advances in archival research, witness interviews, and forensic science continue to offer hope that one day his fate may finally be determined.

Cpl. Dumas was posthumously awarded the Purple Heart, Prisoner of War Medal, Combat Infantryman Badge, Army Good Conduct Medal, Army Presidential Unit Citation, Republic of Korea Presidential Unit Citation, Korean Service Medal, United Nations Service Medal, National Defense Service Medal, Republic of Korea War Service Medal, and the Marksmanship Badge. These decorations recognize both his valor in combat and the suffering he endured as an American prisoner of war.

Because his remains were never recovered, Corporal Dumas has no grave in Connecticut. Instead, he is memorialized on the Courts of the Missing at the National Memorial Cemetery of the Pacific in Honolulu, Hawaii, where the names of thousands of Americans still missing from overseas conflicts are engraved in stone. His name also appears on the Wall of Remembrance at the Korean War Veterans Memorial in Washington, D.C., added during the memorial’s expansion in 2022 to honor every American who died during the Korean War.

Dumas’ disappearance profoundly affected his family, especially his younger brother, Robert (“Bob”) Dumas, who spent decades searching for answers about Roger’s fate. His determined efforts to uncover the truth became the subject of the award-winning documentary “Missing, Presumed Dead: The Search for America’s POWs,” which examines evidence suggesting that some American prisoners may have remained in North Korea involuntarily after the 1953 armistice. Regardless of the ongoing debate surrounding those claims, Bob Dumas’ lifelong dedication ensured that his brother’s sacrifice would never be forgotten and brought renewed public attention to the unresolved fate of America’s missing Korean War servicemen.

The story of Corporal Roger Armand Dumas reminds us that the casualties of war are measured not only by those who are killed in battle, but also by those who disappear without explanation and by the families left waiting for answers that may never come. His courage during combat, endurance in captivity, and the uncertainty surrounding his final days continue to symbolize the sacrifices made by thousands of American prisoners of war during the Korean conflict.

More than seven decades after his capture north of the Chongchon River, Roger Armand Dumas remains one of the Quiet Corner’s most poignant hometown heroes. Though no known grave marks his final resting place, his memory lives on in the hearts of his family, the people of Plainfield, and a grateful nation that continues to honor those who never came home.

The story of Roger Dumas will be included in a new book that will be published soon: “Hometown Heroes of the Quiet Corner – The Korean War Edition, 2026 Volume 7.” The author of the Hometown Heroes book series is Michael Rocchetti, a retired USAF Colonel, Iraq War Veteran, and Commander of the Mayotte-Viens Post #13 American Legion, Putnam. One more call to service

For more than a century, generations of Thompson veterans have made certain that those who served before them were remembered. Now, American Legion Post 67 needs another generation to step forward.

The situation facing the Post is serious. Chartered in 1920, Post 67 has survived for 106 years, through enormous changes in Thompson and in the nation itself. Yet its future is threatened by a problem familiar to veterans organizations throughout New England: declining membership and, more importantly, a shortage of members willing and able to take on leadership responsibilities.

There is something particularly unfortunate about the possibility that Post 67 could disappear. This is not an organization without history, property or potential. It has all three.

Its Thompson Hill Road property includes a substantial building of approximately 9,000 square feet, with meeting and recreation areas, a bar, a large upstairs function room and a commercial-style kitchen. Outside are ample parking, picnic tables and a covered barbecue area.

In other words, Thompson does not need to build a veterans center from scratch. Generations before us already did the difficult part. What is needed now are people willing to keep it alive.

That distinction matters because it would be easy to look at declining membership and conclude that the era of organizations such as the American Legion has simply passed. Perhaps Americans do not join civic organizations as readily as they once did. Perhaps younger veterans have different interests and different demands on their time. But organizations can change without abandoning their purpose.

Post 67 does not need to recreate 1950 or 1975. It needs to determine what a veterans organization should look like in Thompson in 2026 and beyond.

Its building alone offers possibilities. Functions, community dinners, veterans breakfasts, fundraisers, reunions and other events could help transform the property into an active community gathering place while generating revenue to support its operation. More important, the Post can continue serving as a connection between generations.

The veterans of World War I who established Post 67 eventually gave way to those who served in World War II. They were followed by veterans of Korea and Vietnam and, later, the Persian Gulf, Iraq and Afghanistan. That succession did not happen automatically. At some point, someone had to accept the responsibility. That moment has arrived again.

The request being made of Thompson's veterans is not that hundreds suddenly become active Legion members. The immediate need is far more achievable. Post 67 needs a relatively small group of responsible veterans willing to provide leadership, examine the organization's finances and property, work with American Legion officials and develop a sustainable plan.

Military service teaches many things, among them responsibility, teamwork and the understanding that sometimes a job belongs to whoever is willing to step forward and do it. Those qualities are needed here.

There is also something larger at stake than ownership of a building. Veterans organizations have long helped communities understand why Memorial Day and Veterans Day matter. They have maintained traditions, supported young people, participated in ceremonies and ensured that the names and sacrifices of earlier generations were not forgotten.

Once an institution carrying 106 years of that history disappears, recreating it is extraordinarily difficult. That is why the time to act is before the doors close, not afterward.

Post 67 has survived the Great Depression, World War II, Korea, Vietnam, the Cold War, the attacks of Sept. 11 and two decades of war that followed.

Its greatest challenge should not be finding a handful of people willing to carry it into its second century.

The veterans who founded Post 67 in 1920 could not know who would come after them. They built something anyway, trusting that future generations would find value in preserving it. For more than a century, that trust was honored.

Thompson's veterans now have an opportunity to honor it once again. Post 67 needs a few people willing to answer one more call to service. This time, the place they are being asked to serve is home.

Earth — The Matrix has you!

To the Editor:

Who among us isn't concerned about artificial intelligence (AI) and the monstrous data centers that feed it? Beyond predictions that AI will eventually take our jobs, rendering us humans useless, the physical footprint of AI is becoming impossible to ignore. The U.S. currently has about 5,000 data centers, with some approaching a square mile in size. Beyond the vast tracts of land they consume, they also devour enormous amounts of water and electricity—even in regions already suffering severe shortages, such as the American Southwest.

Nothing is more fundamental to a community—or a nation—than reliable, affordable energy. Oil, first commercially drilled in Pennsylvania in 1859, transformed human civilization. But more than a century and a half later, we're realizing its enormous hidden costs: petro-states, endless conflicts, economic dependence, pollution, and, above all, climate change.

With fossil fuels, humanity has entangled itself in a system so vast, destructive, and undemocratic that it increasingly seems beyond our control. From the air conditioner to the gas pump, and now the AI data center, our insatiable appetite for energy has shaped foreign policy, driven military interventions, empowered petro-states, and turned strategic waterways such as the Strait of Hormuz into geopolitical choke points. President Trump would like us to believe America controls the fossil fuel industry, but increasingly we see the industry with a choke hold on America.

Our fossil fuel energy system has become eerily similar to the machine world in the 1999 science fiction classic "The Matrix"—everywhere, all-powerful, and nearly invisible because we have grown so accustomed to it. Like the characters in the film, we are trapped inside a system that dictates the rules, kills off any attempts at change, and destroys the world around us.

The Fossil Fuel Matrix has had a remarkable run. But every dominant system eventually faces a better alternative. As AI accelerates the demand for electricity and the Matrix begins to overheat, another path has emerged, and just in time. Breaking through the thick black cloud of fossil fuels, renewable energy offers humanity a cleaner, more democratic future—one capable of liberating us from the Matrix and perhaps even preserving the world we leave to future generations.

No country understands this better than China who has wagered its future on clean energy, and the payoff has been extraordinary. It now dominates the global manufacturing of solar panels, batteries, electric vehicles, and other green technologies—many of which were originally pioneered in the United States. As a result, China's economic influence has only grown while its dependence on oil-producing nations such as Russia, Saudi Arabia, and Iran has declined.

Meanwhile, under President Trump, the United States has chosen not to compete for this defining industry of the twenty-first century. Instead, he

has folded our cards and let China take all the chips.

Rather than embracing a cleaner, cheaper, and ultimately safer energy system, President Trump has pushed America backward toward an aging fossil fuel economy. That direction traces back to a promise he made during a 2024 meeting at Mar-a-Lago with executives from major U.S. oil companies—asking them for \$1 billion and pledging in return to reverse President Biden's clean energy initiatives and environmental protections. In the end, they gave him half a billion, and for that, he the richest industry in history everything they ever dreamed of and more.

In one example that should outrage us all, Trump has paid \$2.6 billion to wind energy companies not to build facilities that had already been fully vetted and permitted. Those wind farms would have added desperately needed electric capacity to the grid while lowering power costs for millions of households. Yes, the Fossil Fuel Matrix recognizes the threat it faces from clean energy and has entered full self-preservation mode—with American households footing the bill.

The risk that comes with fossil fuels are profound. When I began this article, smoke from 1,000 Canadian wildfires was drifting across one third of the U.S., in and out of Connecticut's Quiet Corner. Europe was into it's second month of record-breaking heat, which has killed more than 20,000 people, and Oregon was living through it's worst fire season in history. Climate-driven disasters are producing losses so severe today that they threaten the collapse of one of the world's largest and oldest industries—insurance.

And the warnings do not end there.

Scientists are increasingly concerned about the Atlantic Meridional Overturning Circulation (AMOC), the vast system of ocean currents that regulate climate, rainfall, and the distribution of nutrients throughout the Atlantic Ocean. Evidence suggests the AMOC is weakening and potentially leading to a major disruption that would profoundly alter global weather, agriculture, ecosystems, and economies. It would rank among the gravest climate risks humanity has ever faced.

Either President Trump is inexcusably ignorant of these well publicized catastrophic risks to our world, or he has decided the Fossil Fuel Matrix that funds him is worth the price. Either way, the facts remain unchanged; renewable energy is now the cheapest source of new electricity on Earth, its is the fastest to deploy, and it's our best opportunity to meet the soaring energy demands of the AI age.

The choice before us is becoming impossible to ignore. We can remain trapped inside the Fossil Fuel Matrix and hope the worst risks of climate change don't materialize, or we can build the energy system that finally sets us free and leads us to a safer and cleaner future. As for the risks of AI taking over, that's another story altogether.

From Revolutionary songs to Danielson's whip socket past

On Aug. 8, I had the great pleasure of listening to a rousing program of Revolutionary era music by Richard Franklin Donahue, Cromwell's town historian. Dressed as a Minuteman and accompanying himself on a harpsichord, Richard sang a number of songs which would have been popular in New England taverns of the era. He explained that newspapers such as the (Hartford) Courant published lengthy poems which were to be sung to well-known tunes of the day. Often, but not always, the songs themselves were mentioned. In some cases, both pro-Patriot and pro-Tory verses were composed to the same melodies. He provided the members of the audience with handouts of the words which made it very nice to follow along. He visits towns all over the region. If you have an opportunity to hear What A glorious Crash They Made, do try to attend.

While I was in Pennsylvania, I received several emails about the fire on Hawkins Street in Danielson. One individual had heard that the home had been a funeral home at one time, and wondered if I had any information about that. Now, that was a new one to me. I checked and none of the regular Killingly Historical Center volunteers had heard that either. The Center does have a number of sources that contain funeral home references, so Society president Bernie Mitchell and I started checking. Bernie looked through our directories, which go back to the late 1800's and are basically the forerunner of the telephone books. There was no mention of a funeral home on Hawkins Street, although there were several on Academy Street. I decided to check the Historic House Surveys which were done in the 1980's and 1990's. Hawkins Street was surveyed by Bruce Clouette and Mathew Roth of Historic Resources Consultants, Inc. in 1981 (See Book 7). Again, I came up empty. However, I did learn of a business which I had not known about and which intrigued me—a whip socket factory. (Remember the late 1800's are still before the age of automobiles!). Whip sockets were a necessity and were used to secure the whip when the carriage, buggy, or other vehicle was not in motion.

In 1885, Erastus W. Scott of Wauregan purchased land from Charles Hawkins at the corner of Broad and Hawkins Street "for the purpose of erecting a residence and a building to accommodate his whipssocket manufactory... his whipsockets now find their way not only to all parts of America, but also in foreign countries. He will employ at first 20 hands. (Natalie L. Coolidge-Killingly Business Encyclopedia-reference Windham County Transcript March 18, 1885). The June 30, 1886 Transcript reported that "it will be ready for occu-

Vote like your “White” House depends on it

To the Editor:

Washington, D.C. is supposed to be a shining example of our nation’s values, patriotism, and storied history. Since Trump took office, the city has become a battlefield of bulldozers and cement. According to the Atlantic’s Matt Viser, the South Lawn and the Ellipse — the 52-acre park between the White House and the Washington Monument — are completely torn up. Last month, the once-green grass became a temporary arena for a bloody UFC fight. Now, the park is a brown dirty mess. Viser describes the White House as an active construction site, cement trucks rolling through the same gates typically reserved for the president’s armored limousine, with a gaping hole where half of the building once stood.

That hole is where the East Wing used to be. Trump demolished it last October to make way for a new ballroom — a project whose price tag has climbed steadily. Trump’s own estimates rose from \$200 million when announced, to \$250 million, to \$300 million, and now to \$400 million. It was pitched as costing taxpayers nothing. But a Washington Post investigation found the project’s true cost could reach \$600 million, with roughly half of that borne by taxpayers.

Congress said no to funding it directly. This spring, Senate Republicans tried to tuck \$1 billion in Secret Service funding tied to the ballroom into a GOP reconciliation bill, only to have the Senate parliamentarian strip the provision out before it ever reached a floor vote. So, the administration found another way. In June, the White House’s own budget office quietly apportioned \$352 million from Trump’s tax cuts law for “White House Security Measures,” even though that law specifies the money can only be used for “United States Secret Service resources, including personnel, training facilities, programming, and technology.” A source familiar with the matter told the Post the funds will support construction of the new East Wing, including the 90,000-square-foot ballroom. Republican Senator Susan Collins said with frustration: “I’ve said repeatedly that the President has promised only private donations would be used for the ballroom, and I believe he should keep that promise.”

Change must start at the top

Then, on Aug. 7, a federal appeals court weighed in on the ballroom itself, ruling 2-1 that the White House lacks authority to build it without Congress’s approval. The D.C. Circuit said: “Each President is a temporary tenant, not the owner, of the White House and its Executive Residence. The President has no—and claims no—constitutionally assigned authority over that property, which is designed and maintained for the use of all Presidents, current and future, and for the American people.”

The court went further, writing that it was “aware of no instance in American history in which a President unilaterally and using privately collected funds demolished substantial portions of the White House that Congress authorized to be built and American taxpayers paid for. Until now.” The panel stayed its ruling for two weeks to let the administration appeal to the Supreme Court, which Trump has said he will do.

Trump tore down part of a building that belongs to the American people, got rebuffed by his own party on direct funding, and then redirected money Congress had earmarked for something else entirely — all for a project a federal court now says he never had the authority to build in the first place.

Meanwhile, families are dealing with high gas, grocery and housing costs, and polling consistently shows Americans want leaders focused on affordability — not ego-driven construction projects, tax breaks for billionaires, and endless wars.

Now that the primary election is over, voters will choose representatives in November who will decide how taxpayer dollars are spent in Connecticut and Washington. I urge everyone to register to vote, review where Democratic midterm candidates stand on affordability issues — including housing costs and availability, property taxes, everyday expenses, and energy costs in Connecticut — and make a plan to vote.

Eastford’s Old Colony Road Bridge set for replacement

EASTFORD — Plans are in full swing to replace an aging bridge along Old Colony Road in Eastford at no cost to the town. The Connecticut Department of Transportation held a public hearing on July 28, which revealed the finer details of the replacement of the 93-year-old bridge over Bungee Brook. The \$5.2 million project, designated as Bridge No. 04642 by the DOT, is funded 80 percent by federal funds and 20 percent state funds at no cost to the town. Deborah Richards, First Selectman of Eastford, kicked off the hearing expressing she gratitude for the project. “The Town of Eastford is once again partnering with the Connecticut Department of Transportation and CHA Consulting on this important bridge replacement project. They have consistently demonstrated their expertise, professionalism, and commitment to collab-

oration, and I’m grateful for their guidance as we work together on our second bridge replacement project,” Richards said. Much of the project detail was provided by Stephany Dubina, a Senior Engineering Designer at CHA Consulting, Inc who also happens to be an Eastford resident. She explained that the bridge was constructed in 1933 and rehabbed in 1970. The 45-foot structure sees an average daily count of 949 vehicles per day. Wear and tear, age, and structural concerns all led to the bridge being a priority for CTDOT and its partners. “This bridge has a spread footing sounded on soil which is identified to be scour critical. There’s the potential that if there’s a large storm event the soil around the footings could be washed away and ultimately this is one of the primary reasons this project was taken on,” Dubina said. Also among the larger overall concerns are its inventory load rating which is below the 1.0 standard

following inspections in 2024, the scour conditions in several parts of the structure, the hydraulic performance of the bridge, and its overall age all necessitating a brand-new structure as opposed to repairs. The proposed replacement would be a single-span prestressed concrete deck unit bridge. It would be 57 feet by 6 inches with a 75-year service life and a 26-foot roadway. The foundations would be better built for scour and improve the hydraulic conditions with no weight restrictions. The current bridge has been deemed safe for travel until the construction begins. The bridge will be closed during construction with a detour planned through Old Colony Road, Schoolhouse Road, Route 244, and Route 198. The eight-month-long replacement process is expected to take place in spring 2028.

Five things to check in your executive compensation package in 2026

If you take a step back and look at executive compensation right now, the headline is actually good news: the tax brackets we’ve been working with are now permanent. The OBBBA, signed into law in July 2025, made the lower TCJA rates (topping out at 37 percent instead of jumping to 39.6 percent) a permanent fixture. For anyone managing a complex compensation package, that certainty is a gift. It means you can finally plan multi-year strategies without guessing where rates are headed.

But here’s the catch: the same law quietly reduced the after-tax value of certain benefits high earners have leaned on for years. So let’s walk through this as a checklist — the moves worth thinking through, and why each one matters for the money you actually keep.

Item One: Rethink deferred comp now that rates are locked in

Nonqualified deferred compensation (NQDC) lets you push a chunk of today’s salary or bonus (and the tax on it) into a future year, ideally one where you expect to be in a lower bracket. The whole strategy rests on a bet: that your rate later will be lower than your rate now. Permanent rates change how you make that bet. You’re no longer guessing whether Congress will let rates spike; the brackets are set. That makes NQDC a cleaner, more predictable planning tool: if you’re deferring from peak earning years into retirement

years when your income drops, the math is more reliable than it’s been in a long time. What’s really beneficial is that you can now model a deferral schedule — staggered payouts across several retirement years — with real confidence about the rates on the other side.

The one big thing to weigh: NQDC isn’t protected like a 401(k). Your deferred dollars are an unsecured promise from your employer, exposed to company credit risk, and you can’t roll them into an IRA later. So the discipline here is the same one we stress often at WHZ: don’t over-concentrate. Defer enough to smooth your tax picture, but only after you’ve maxed your protected, qualified accounts first.

Item Two: Time your stock option exercises around the new deduction cap

Here’s a rule that took effect in 2026 that every option-holding executive needs to know: for taxpayers in the top 37 percent bracket, OBBBA caps the value of itemized deductions at roughly 35 cents on the dollar instead of 37 (the so-called “2/37 rule”). In plain terms: once you’re in that top bracket, your deductions are worth a little less than they used to be.

Why does that matter for stock options? Because exercising nonqualified stock options (NQSOs) creates ordinary income on the spread, and a big exercise

can rocket your income into that top bracket, where your deductions get devalued.

The critical aspect here is timing. If a large exercise would push you over the 37% threshold, consider straddling it across two tax years, exercising just up to the threshold in each, so more of your income (and your deductions) stays in the friendlier zone.

This is classic “don’t panic, plan ahead” territory. Small timing choices on a vesting or exercise calendar can meaningfully change your after-tax outcome. Map your exercises against your projected income before you click the button, not after.

Item Three: Watch the SALT phase-out at \$500,000 — especially in Connecticut

This one stings in high-tax New England. OBBBA raised the state and local tax (SALT) deduction cap to \$40,000. That’s a real win, but for higher earners it phases back out fast. Once your modified adjusted gross income (MAGI) crosses \$505,000, the deduction shrinks by 30% of every dollar above that line, and by the time you hit \$600,000 you’re back down to the old \$10,000 cap.

Connecticut’s top income tax rate is 6.99 percent, kicking in above \$500,000 of income, and the state stacks property taxes among the highest in the nation on top. So a Connecticut executive earning well into the

\$500,000–\$600,000 range pays steep state and local taxes and loses most of the federal deduction that used to soften the blow.

The planning takeaway: if your income lands in that phase-out window, the value of accelerating or bunching deductible expenses is reduced. So coordinate the timing of income events (like that option exercise) with an eye on where your MAGI lands.

Item Four: A bonus you’ve probably already earned — the Social Security cap

In 2026, Social Security tax only applies to the first \$184,500 of wages. If you’re a high-earning executive, you almost certainly blew past that cap earlier in the year, which means your later paychecks, year-end bonus, or option income come in without the 6.2 percent Social Security bite.

Why care? Because it’s a small but real tailwind for year-end planning. That late-year compensation is slightly “cheaper” from a payroll-tax standpoint, which can make the fourth quarter a sensible window for things like an extra deferral election or a bonus deferral — you’ve already cleared the cap, so you’re optimizing around income that’s taxed a touch more lightly. It’s a nice example of how knowing the rules lets you make confident, informed decisions.

Item Five: Revisit agreements you set up under the old rules

Last item, and an important one. Many executive

comp agreements — deferral elections, exercise plans, charitable-giving strategies — were designed when the rules looked different and rates were set to rise. With the brackets now permanent and the deduction landscape reshaped, an arrangement that made perfect sense three years ago may no longer be optimal.

This doesn’t mean tearing everything up. It means a disciplined review: does your deferral schedule still line up with your expected retirement income? Are your charitable gifts timed to clear the new 0.5 percent AGI floor and the deduction cap? Does your exercise calendar account for the 2/37 rule? These are exactly the questions worth bringing to your advisor.

Boiling it down to best practices

If I had to boil it down to a quick recap: First, treat permanent rates as an opportunity to plan deferred comp with real confidence, but don’t over-concentrate in an unprotected plan. Second, time big option exercises around the 37 percent threshold and the 2/37 deduction cap. Third, know exactly where your MAGI lands relative to the \$505,000 SALT phase-out, especially here in Connecticut. Fourth, take advantage of the Social Security wage cap when timing late-year compensation. And fifth, revisit older agreements to make sure they still fit the new rules. None of this is about chasing a single tactic; it’s about disciplined, intention-

al planning that helps you keep more of what you’ve worked hard to earn.

Pomfret Historical Society hosts program on music of Connecticut’s Revolution



POMFRET — The Pomfret Historical Society (PHS) will host a concert by tenor and harpsichordist Richard Donahue on Aug. 23 at 3 p.m. in the Pomfret Old Town House (OTH), 11 Town House Dr., Pomfret Center.

The concert is the last in the Summer Concert Series, “Music of the Revolution,” sponsored by the Pomfret 250 Commission. The well-attended concerts at

the OTH have explored multiple genres of music listened to and performed by America’s Revolutionary heroes and ordinary people from the late 1700’s to the mid 1800’s.

What a Glorious Crash They Made: Musick of Connecticut’s Revolution features a collection of “New Songs” and Hymns published in Connecticut during the American Revolution. From the time

of the Stamp Act through the British surrender at Yorktown, Connecticut’s seditious colonists used these works to foment rebellion, commemorate victory, and give thanks for preservation. Music Historian Richard Franklin Donohue, will share his original research and explore this fiery repertoire that in the words of John Adams “cultivated the sensations of Freedom.” The program spans the Revolutionary war years with selections like John Dickinson’s “Liberty Song,” William Billings’ Chester, Andrew Law’s “Middletown,” and several popular British tunes with “new” texts reflecting the cause of freedom.

Richard Franklin Donohue is a singer, private music instructor, and historian. A life-long performer, Richard specializes in historic music ranging from Middle English Carols to 19th century romantic music. He studied music at the University of Connecticut and has been teaching Piano, Voice, and Music Theory since 1992. He is the Town Historian in his hometown of Cromwell, Connecticut and has been the President and Program Director of the Cromwell Historical Society for twenty years. He is the author

of “Rosetown Review,” a monthly history article published in the Cromwell Life newspaper and presents historical lectures throughout New England on a wide range of topics.

be quality craft vendors, textile demonstrations, a food court, church supper, music, and military demonstrations by the reenactors.

alone cannot solve.

Its membership has declined dramatically, and the Post no longer has enough qualified members who are willing and able to assume the leadership positions necessary to keep the organization functioning. Officials from the American Legion Department of Connecticut and the Legion’s 4th District, which serves Northeastern Connecticut, are working to preserve Post 67. But unless qualified veterans from Thompson step forward to assume responsibility for the Post, its charter may ultimately have to be revoked. If that happens, Thompson could lose something that can never truly be replaced.

More than a Legion Post

The military history of Thompson did not begin with the American Legion.

Men from this community have answered their country’s call for generations. Thompson’s tradition of military service reaches back to the earliest settlements of the region and continued through the colonial wars, the American Revolution, War of 1812, Civil War, Spanish-American War, two World Wars, Korea, Vietnam, the Persian Gulf, Iraq, Afghanistan and the conflicts of the modern era.

“Our club is deeply invested in the proposed soccer field space at Bull Hill. However, the severe and persistent water drainage issues at the site continue to significantly limit its usability, particularly during critical windows of our spring playing season,” Robin wrote in a letter to the town which was a major focus of the Recreation Commission’s July 23 meeting. Thompson Recreation Director Brian Lievense explained that the town has not conducted an assessment of the property since 2017 but has recently consulted with UConn about a follow-up in the near future. While he acknowledged the value of the property in hosting local sports, he pointed out that realistically it’s not something that could be funded through the town’s budget. Thompson has faced budget constraints year after year in the 2020s and back in 2017 the estimated cost

Post 67 became one of the institutions through which that tradition was remembered and passed from one generation to another.

The veterans who founded the Post in 1920 could not have known what the next century would bring. They could not have imagined Pearl Harbor, Normandy, Iwo Jima, the frozen mountains of Korea, the jungles of Vietnam or the deserts of Iraq. But they understood something important. They knew that military service creates an obligation not only to remember those who served, but also to preserve their memory for generations that follow. That remains one of the most important purposes of the American Legion. Legion posts help communities remember the meaning behind traditions Americans sometimes take for granted. Memorial Day is more than a three-day weekend. Veterans Day is more than another date on the calendar. They exist because generations of Americans put on a uniform and served.

Some never came home. Local veterans’ organizations have traditionally been among the people making certain their communities remember them.

Post 67 has also supported community activities, including involvement with the Tri-Town American Legion Baseball Team, continuing another longstanding American Legion tradition of supporting young

for upgrades to resolve the drainage problems came in at roughly \$800,000, which has likely only increased under the current economic climate. But that doesn’t mean all hope is lost. Lievense said they’d just need to get creative, which will likely include pursuing STEAP grants and other similar fund sources and pursuing fundraising opportunities. “There’s a need for it, so I actually think it would be a pretty big candidate to win a STEAP grant or another type of grant, but it’s a long process and I think the first step is we need to have the assessment updated,” Lievense said. The reality remains that the fields are unusable for the foreseeable future. Any updates are likely years away as the town seeks next steps. But the requests from NECONN and the town’s interest in working with UConn confirm that stakeholders see continued value in the property bringing hope that the fields may once again see sports activity in the future.

A building worth saving

There is another reason for urgency.

Post 67 possesses something increasingly uncommon among small veterans’ organizations: its own substantial building and property, located at 17 Thompson Hill Rd, Thompson, CT 06277

The building contains approximately 9,000 square feet between its two levels and has tremendous potential. The ground floor includes an attractive bar area and large recreation rooms with pool tables and games. Upstairs is a spacious dining and function room capable of accommodating 100 or more people, together with a large, fully equipped commercial-style kitchen.

Men’s and women’s restrooms are located on both floors.

Outside is a very large paved parking area, approximately a dozen picnic tables and a covered barbecue pit.

The wood-frame, vinyl-sided building has an asphalt-shingle roof that appears to be in good condition. Heat is supplied by an oil-fired boiler and hot-water baseboard system. Three air-handling units for air conditioning are present, although they are presently not operational.

This is not simply an old meeting hall.

It is a community asset with real possibilities.

With responsible management, the facility could potentially host weddings, anniversary parties, birthday celebrations, reunions, banquets, fundraisers, club meetings, veterans’ events, a quinceañera, community dinners, youth activities and other private and public functions.

The building has the potential to generate revenue rather than simply consume it.

But first, there must be an organization—and people—willing to manage it.

What happens If Post 67 closes?

The consequences of losing the Post’s charter could extend far beyond removing the number “67” from the American Legion’s rolls.

If the charter is revoked and the Post ceases to exist, control of its assets would be handled according to applicable American Legion rules and legal requirements. The building could ultimately pass under the control of the American Legion Department of Connecticut and potentially be sold, with proceeds applied as required to outstanding liens, debts and other obligations.

Once the property is sold, the opportunity may be gone forever.

A building that Thompson veterans spent generations establishing and maintaining could pass out of veterans’ hands. And Thompson would lose its American Legion Post. That outcome is not inevitable.

It doesn’t take hundreds of veterans Saving Post 67 does not necessarily require hundreds of new members. What is desperately needed is something much simpler:

A small group of qualified, responsible and civic-minded veterans willing to become actively involved

The immediate need is for veterans capable of accepting leadership responsibilities, restoring effective management and developing a realistic plan for the future of the Post and its property. There may also be opportunities for financial or organizational assistance if a credible group of veterans steps forward with the willingness and ability to rebuild the Post.

The building itself provides an enormous head start. Imagine Post 67 once again busy with veterans’ meetings. Imagine a Saturday evening wedding reception upstairs, a community dinner, a veterans’ breakfast, a fundraiser for a Thompson family, an American Legion Baseball event or a Memorial Day gathering.

Imagine younger veterans from Iraq and Afghanistan sitting at the same tables once occupied by veterans of Vietnam, Korea and World War II.

That is possible. But buildings cannot preserve organizations.

People do. Thompson still has veterans

There are still hundreds of military veterans living in Thompson.

They served in different branches, different places and different generations. Some spent careers in uniform. Others served one enlistment and returned home. Some served during wartime; others served during periods of peace.

They share something relatively few Americans experience: they raised their right hand and accepted an obligation to serve their country.

Post 67 now needs some of them to serve once again—this time at home.

The commitment does not require carrying a rifle, deploying overseas or leaving one’s family.

It requires attending meetings, accepting responsibility, managing an organization, maintaining accountability and working with fellow veterans and the community.

It requires leadership. Those qualities should sound familiar to anyone who has worn the uniform.

What will Thompson veterans leave behind?

There is a larger question facing Thompson’s veterans.

When the last World War I veterans were gone, the veterans of World War II carried the Legion forward.

As that generation aged, Korean War and Vietnam veterans increasingly assumed responsibility. Today, those generations are disappearing.

The question is whether younger veterans will pick up what they left behind.

A charter issued in 1920 has survived the Great Depression, another World War, Korea, Vietnam, the Cold War, the Persian Gulf War, September 11, Iraq and Afghanistan.

It would be a terrible irony if Post 67 survived all of that only to disappear because no one was willing to take responsibility for it.

Future generations of Thompson residents may someday ask what happened to their American Legion Post.

The answer has not yet been written.

A few good men and women

There is still time.

Post 67 does not need someone to rescue it single-handedly. It needs a team.

It needs a few good men and women—military veterans who are responsible, energetic and civic-minded—to sit down together, examine the finances, evaluate the property, work with American Legion leadership and determine what can be done.

Perhaps the Post can be reconstituted and revitalized.

Perhaps its building can once again become a busy gathering place.

Perhaps new members can be recruited.

Perhaps Post 67 can begin its second century with a renewed purpose.

But none of those things can happen unless someone steps forward.

More than a hundred years ago, Thompson’s World War I veterans came home and established American Legion Post 67 for themselves, their fellow veterans and the generations that would follow them.

They did their part.

Now it is our turn.

If you are an eligible military veteran living in Thompson—or a veteran with ties to the community—this is the time to become involved.

Don’t wait until the doors are locked, the charter is gone and a “For Sale” sign appears in front of the building.

By then, it may be too late.

Thompson American Legion Post 67 has stood since 1920. Whether it will stand for another generation may now depend upon a handful of veterans willing to answer one more call to service.

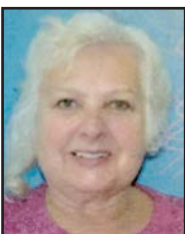

pancy early in July.” An April 13, 1887 Transcript ad indicated that Erastus also was selling carriages, Cornings, extension tops, and carts. By 1888 he was installing a windmill on the property to provide power for the factory (WCT Sept. 12, 1888). He apparently decided to devote his factory to whipsockets and placed an ad to sell out his carriage stock in the April 3, 1889 Transcript. The 1894 Danielson Directory described Scott as a Whip Socket manufacturer. By the end of the century, he was said to be the largest whip socket manufacturer in the world. The factory is now a residence located at 49 Hawkins Street. Erastus Scott’s Queen Anne style home was located at the corner of Broad and Hawkins Street. (Historic Survey). He died in Danielson September 29,

1908, age 77 (WCT Oct. 1, 1908) and was interred in Old Westfield Cemetery. Scott’s will revealed a little more about the property which went to his sons Winfield E. Scott and Frank E. Scott. It also included an oil house and a Japan works in addition to the “manufactory” and windmill. (Ancestry.com; Ct. U.S. Wills & Probate 1609-1999).

I was curious about the Japan works and was quite challenged while doing a Google search. At first, I could not find an answer. (No, I did not want workers in Japan). Finally, I saw the word lacquer and tried that with success. “Traditional horse-drawn carriages and buggies frequently feature wood and lacquerware whip sockets mounted on the dashboard or side panels to secure driving whips. Traditional wood whip sockets are turned from hardwood and finished with multiple pro-

ductive coats of high-gloss black lacquer to withstand outdoor weather elements and match the polished finish of a high-end carriage. (ICV Carriage). I do not have enough information about Scott’s whipsockets to know if they were wood or not.

Have you ever taken a buggy ride? During the late 1800’s there were a number of styles available to suit many purposes. “A Corning (often called a Corning buggy or Corning wagon), advertised by Erastus Scott, (was) a specific style of light, Victorian, horse-drawn buggy featuring a cut-down front, deep sides, and molded panels. First built in 1875 by Brewster & Company of New York, it got its name because the very first one was sold to prominent businessman and politician Erastus Corning of Albany, N.Y. It belongs to the ‘coal-box’ or square-box family of buggy bodies, meaning the side panels forward of the driver’s seat are cleanly cut away. While popular as a light sporting or general-use open buggy, adding a closed top easily converted it into a convenient ‘physician’s phaeton’ used by doctors making house calls.” (geriwalton.com).

While I was searching the Hawkins Street area, I decided to see if I could find out for whom it was named. Charles S. Hawkins had a house and barn in that location and was listed as a farmer in the 1870 U. S. Census. The Killingly Business Encyclopedia listed him as a milkman on August 11 of that year. The Feb. 3, 1876 Transcript entry in the Killingly Business Encyclopedia noted that Hawkins had run a milk cart in this village for “a quarter-of-a century, or very near it.” Hawkins died in 1899 and was buried in Old Westfield Cemetery.

I found his will and was amazed at the number of carriages and wagons in his inventory- --a two seated carriage, a covered phaeton, an open buggy, a market wagon, and a lumber wagon (Ancestry.com; Killingly Probate Vo. 14-16, 1895-6).

I love the information that can be teased from old maps so checked the Danielsonville panel of Grey’s Atlas of Tolland and Windham Counties (1869). In that year Hawkins Street did not exist. Academy Street ended at what is now Broad Street. Reynolds Street (by Davis Park) did go over Broad, and the main road to South Killingly was Stearns Street (north of Killingly Memorial School). The area east of Broad Street was farm land although some of it may have already been designated for future house lots. The Borough was very much different than it is now. (Keep in mind that the Civil War did not end until 1865). If you like old maps, reprints of the above map and that of the town of Killingly in 1869 are available for purchase at the Killingly Historical Center. These maps give names of individuals who owned the houses at the time.

“Many times, memories become vague or changed as they are transmitted from generation to generation. I’m hoping that those Putnam and area citizens who witnessed ‘The Flood’ will share their stories. I also recommend they jot them down for posterity,” concluded Coderre.

“We’re fortunate that Putnam has an individual who was interested enough to put his memories in print for the future of our community. As the anniversary of ‘The Flood’ approaches, this program once more demonstrates that our citizens recognize important historic events,” said Putnam Historian Bill Pearsall.

Connecting a new generation with the past

That connection between ordinary people and extraordinary events was one of the lessons Rocchetti hoped to share with the Cub Scouts. For the members of Cub Scout Pack 21, the August cemetery tour brought that history out of books and records and placed it directly beneath their feet. The Scouts could stand beside the graves of men who had heard the news from Lexington in 1775, marched toward Boston, fought in New York, endured defeat and retreat, defended the Hudson, survived Valley Forge, fought at Saratoga and eventually helped create the United States.

More than two centuries later, a new gener-

ation came to remember them. Aspinwall Cemetery may appear at first glance to be a quiet collection of weathered stones beneath old trees. But behind those stones are the stories of the people who built the community and, in many cases, helped build the nation. For the Cub Scouts of Pack 21, their visit on August 5 was therefore much more than a cemetery tour. It was an opportunity to stand among the hometown patriots of the American Revolution and to learn that the history of the United States can be found not only at famous battlefields such as Lexington, Saratoga, Valley Forge and Yorktown, but also in an old cemetery in Putnam, Connecticut.

And as long as new generations continue to visit their graves, learn their names and tell their stories, the service and sacrifices of those veterans will not be forgotten.
