Shepherd Hill graduate carves his own path in Music City

NASHVILLE, Tenn. — Since moving to Nashville, Tenn. in January 2022, Liam Coleman has been carving his own path in Music City. Coleman, a 2021 graduate of Shepherd Hill Regional High School, has been busy in 2026 performing and writing original music and has a new song titled, “Oh Man” that released on Aug. 28 with co-writer and fel-

low musician Mac Hankins from East Texas. “Oh Man” had a strong debut week-end, with more than 12,000 Spotify streams alone. Coleman has been touring the south and Midwest this year with his band playing original music. They have played ten states and some of the biggest colleges in the U.S. such as Ole Miss, University of Oklahoma,



Auburn Alabama and the University of Michigan as well as club shows in Texas and Florida. In August 2025, Coleman sold out his first headlining show of all original music at Off The Rails in Worcester. With more than 300 tickets sold, Coleman put on an electrifying performance that showed of his mix of alternative rock with a 1990’s-style of alternative grunge and a hint of 2000’s pop-punk. The music features heavy guitar riffs and draws inspiration from some of his favorite red-dirt rooted bands like Whiskey Myers, Treaty Oak Revival and Dexter and The Moonrocks. Coleman is solidifying himself in the resurgence of rock music with many people taking note. Boat America Safe Boating Certificate course offered at Bay Path Oct. 13 & 15

CHARLTON — The United States Coast Guard Auxiliary Tri-State Flotilla, Massachusetts will be instructing the Boat America course that meets current state mandated educational requirements offered in a two-night format developed to provide the skills and confidence needed to explore the coast and inland waters by boat. Basic knowledge and skills are needed to have safe and enjoyable boating experiences. This course is perfect for families that have just purchased any type of boat or are planning to in the future, and for the boater keeping up with changes to boating regulations and laws. The Hanson-Milone Boater Safety Act, signed into Mass. Law, now requires all Mass. motorboat operators over 12 years of age to complete an approved Safe Boating Certificate course before April 1, 2026 for anyone born after Jan. 1, 1998, and by April 1, 2028 for boaters born before Jan. 1, 1998. Enforcement of the new law began on Sept. 1. Personal Watercraft / Jet Ski operators are required to be at least 16 years of age also included. A certificate, required to be carried onboard, will be issued by the state to resident motorboaters. Successful completion of this BA course offered meets this requirement and inclusion into the Mass. Environmental Police Boating Safety Database, Approved by National Association of State Boating Law Administrators (NASBLA) it will also cover the requirements to operate a vessel in most other states & many countries where boating safety education is mandatory including NH, RI and CT. You will receive the additional USCG Auxiliary certification and a possible discount on premiums for most boating insurance companies for successful completion of this course. Some basic marlinespike seamanship (knots etc.) will also be included as part of the course. Participants 16 years old and under must be accompanied, in person, by a registered parent/guardian. 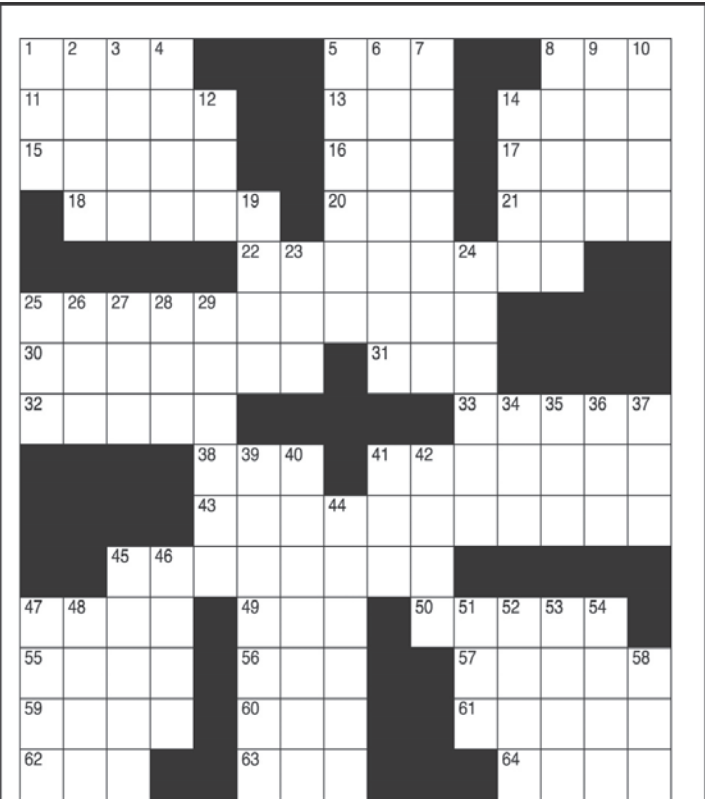

CHARLTON — The Town of Charlton is accepting applications for funding through the Town's Opioid Settlement Funds Grant Program.

The purpose of this pro- gram is to support initiatives that prevent opioid mis- use, expand access to treat- ment and recovery services, reduce the harms associated with substance use disor- ders, and improve the health and well-being of Charlton residents. Funding is made available through the Town's allocation of national opioid settlement funds and must be used for eligible purpos- es consistent with applicable settlement agreements and guidance. Funding may be requested to a maximum of \$2,500 per applicant. Final awards will be distributed based on available funding as well as demonstrated need and community impact.

Eligible applicants may include:

- o Nonprofit organizations
- o Educational institutions
- o Healthcare providers
- o Community-based orga- nizations
- o Other organizations serv-

ing Charlton residents

Projects may include, but are not limited to:

- o Prevention and educa- tion programs
- o Treatment and recovery support services

- o First responder or public safety initiatives related to opioid response
- o Behavioral health and mental health services
- o Community outreach and support programs
- o Data collection, eval- uation, and other evi- dence-based strategies that address opioid use disorder

Applications will be eval- uated based on demonst- rated community need, align- ment with eligible opioid settlement uses, measurable outcomes, organizational capacity, and the anticipat- ed impact on Charlton resi- dents.

Completed applications and all required supporting documentation for the first round of this grant program must be submitted by Aug. 31. Late or incomplete appli- cations may not be consid- ered.

CHARLTON — The Charlton Police Department will give residents an opportunity to meet local first responders and learn more about several specialized police units during its upcoming Barks, Badges & Boots community event.

The free, family-oriented event will be held Saturday, Sept. 12, from 11 a.m. to 2 p.m. at St. Joseph’s Church, 10 H Putnam Rd. in Charlton.

Members of several Charlton Police Department units will be on hand to meet residents and provide a closer look at the equipment and services they use while serving the community.

Among those scheduled to participate are members of the department’s K9 unit, drone team, detective unit, motorcycle unit and 911 communications team.

The event is designed to give children and adults an informal opportunity to meet local first responders while learning more about the different responsibilities within the Police Department.

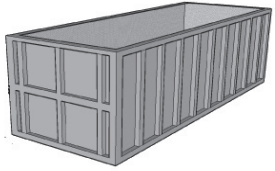

Local roots can travel a long way

Success rarely arrives all at once. More often, it is built quietly, one opportunity at a time, through long hours of work that most people never see. A song is written. A show is booked. A small audience becomes a larger one. Another town gets added to the tour schedule. Eventually, what once looked like an ambition begins to resemble a career.

That makes the progress of Shepherd Hill Regional High School graduate Liam Coleman worth watching.

Coleman graduated from Shepherd Hill in 2021 and moved to Nashville, Tenn., in January 2022. Since then, he has been doing what generations of young musicians have done before him: trying to find a distinctive sound and build an audience in one of the most competitive music cities in America.

There are no guarantees in that business. Talent matters, certainly, but so do persistence, professionalism and the willingness to perform wherever an opportunity presents itself.

Coleman appears to be putting in that work. During 2026, he and his band have traveled through 10 states, performing original music at colleges and clubs across the South and Midwest. His new song, “Oh Man,” co-written with musician Mac Hankins, drew more than 12,000 Spotify streams during its debut weekend following its Aug. 28 release.

Those numbers do not guarantee what comes next. The music business is far too unpredictable for that. They do, however, demonstrate something important. An artist who grew up and attended school in this area is finding listeners well beyond his hometown.

There is something particularly satisfying about seeing a local graduate pursue an unconventional career and make measurable progress.

Communities spend considerable time talking about preparing young people for the future, and understandably so. Usually that conversation centers on college, the trades, public service, health care, business or other established career paths.

The arts belong in that conversation, too. Music, theater, writing and the visual arts can be extraordinarily difficult ways to make a living. Young people who pursue them often encounter uncertainty that comes with no clear ladder to climb. Success depends upon developing a craft while simultaneously learning how to promote it, make professional connections, manage the business side and keep going through inevitable disappointments. That is why milestones matter.

Coleman's sold-out headlining appearance at Off The Rails in Worcester last year put more than 300 people in the room for a performance built around original music. On Sept. 24, he will return to the Worcester venue as an opening act for Texas musician Cole Barhill. There is a lesson in that progression that extends well beyond music.

Young people from towns such as Charlton and Dudley do not have to begin their lives in New York, Los Angeles, Nashville or another major city to eventually find themselves on bigger stages. They can grow up here, learn here and carry those beginnings with them wherever their ambitions lead.

Some will eventually return. Some will build lives elsewhere. Either way, their accomplishments remain points of connection to the communities that helped shape them.

And occasionally, after traveling hundreds or thousands of miles pursuing an ambition, they get to come home and show everyone how far they have come.

For Coleman, the Sept. 24 Worcester performance is another stop on what remains a developing career. Where that road ultimately leads is impossible to know. But there is something worth celebrating about a young person being willing to take it.

The windows are open again

There is a particular day every September when I realize the windows are open. Nobody announces it. There is no family meeting where we agree that summer humidity has officially ended and authorize the reopening of the house. One day, the air conditioner is humming away, doing its best to keep the living room from feeling like the inside of a baked potato, and a few days later there is a breeze coming through the kitchen window. That first open-window day is one of my favorite days of the year.

I noticed it the other morning when I came downstairs. The house was quiet, and somewhere outside I could hear a truck backing up. Farther away, somebody was running a lawn mower. There were birds making whatever announcements birds feel compelled to make at 6:30 in the morning. And I could hear all of it because the windows were open.

Summer tends to seal us inside. When it gets hot enough, we close the windows, turn on the air conditioning and create our own little climate-controlled worlds. The houses along the street might be only 30 feet apart, but everybody is tucked inside behind closed windows.

September changes that. Suddenly, the neighborhood comes back. You hear someone calling the dog. You hear a screen door slam. You hear a kid bouncing a basketball in a driveway.

Somebody is doing something involving a power tool that apparently needs to begin before breakfast. You smell somebody's coffee in the morning and somebody else's dinner at night. And every once in a while, you hear a conversation you weren't supposed to hear.

That is when you quietly move away from the window and remind yourself that good neighbors occasionally need to pretend they are deaf.

Open windows were simply part of life when I was growing up. We didn't think of fresh air as an amenity. It was the cooling system.

You opened every window you could, and if the house was still hot, you found a fan. The fan was usually about

40 years old, weighed as much as a lawn mower and had metal blades capable of propelling a small aircraft.

Safety standards were apparently more of a suggestion back then.

At night, an open bedroom window brought in all the sounds of the neighborhood. Cars passing. Crickets. A dog barking three streets over. Sometimes, you could hear a radio playing somewhere. Eventually, those sounds faded into the background and you fell asleep. I hadn't thought much about that until recently.

Modern life has become remarkably good at separating us from our surroundings. Cars have climate control. Houses have climate control. Offices have climate control. We put earbuds in when we walk. We can travel from our garage to a parking lot to a building and barely experience the outdoors at all.

Then September arrives in Massachusetts and gives us a brief stretch when the best temperature-control system is a wooden frame, a screen and a little cooperation from Mother Nature. It doesn't last long.

Soon enough, one of those chilly mornings will arrive when somebody says, "Why is it freezing in here?" The windows will come down. Then the heat will go on.

And before long we'll be standing beside the thermostat having the annual household debate over what temperature constitutes "perfectly comfortable" and what temperature constitutes "Do you think we're made of money?"

For now, though, the windows are open. The curtains move a little when the breeze comes through. The house smells different. The neighborhood sounds closer. It is a small thing, certainly. But the older I get, the more convinced I become that the calendar doesn't really tell us when the seasons change.

The little things do. The first morning, you need a sweatshirt. The first leaf you notice in the driveway. The first time you see apples stacked outside a farm stand.

And that September morning when you walk into the kitchen, hear the neighborhood outside and realize somebody has opened the windows again.

That is when you know fall is on its way.

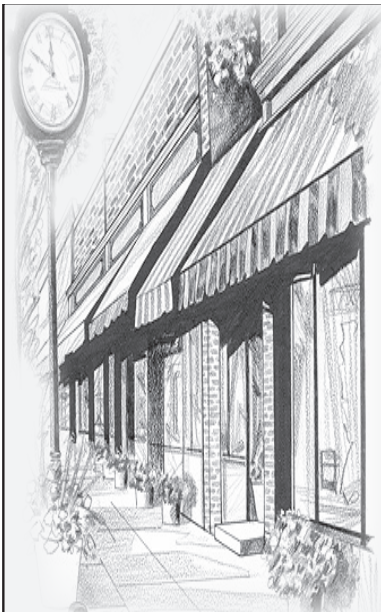

Sheriff’s Office Safekeep Program delivers public safety support, significant cost savings

REGION — After decades of requests from local law enforcement agencies to house individuals arrested by municipal and state police departments, the Worcester County Sheriff’s Office officially opened the first cells dedicated to its Safekeep Program in 2021. The Worcester County Sheriff’s Office (WCSO) Safekeep Program has since delivered measurable public safety improvements and meaningful cost savings to communities across Worcester County and throughout the Commonwealth of Massachusetts.

The program operates from the Sheriff’s Office Intake and Medical Unit in West Boylston, a modern, purpose-built facility designed to centralize intake, medical

number of successful safekeeps include:

- Shrewsbury (202), Westborough (180), Milford (104), Auburn (99), Rutland (94), Barre (85), Lunenburg (83), Leominster (75), Fitchburg (58), and Blackstone (52)
- The Massachusetts State Police represents the largest single user of the program

These figures highlight both the strong demand for the safekeep Program and the Sheriff’s Office’s commitment to maintaining careful screening and responsible custody decisions.

Chief Ryan Malatos of the Leominster Police Department explained that the Worcester County Sheriff’s Office Safekeep Program has been an invaluable resource for his department, particularly when a detainee is unlikely to make bail or when call volume and community needs require him to reassign officers quickly.

Malatos went on to explain that, “by providing a secure option for continued detention, the program allows us to return a uniformed officer back to the road rather than requiring that officer to assist with a detainee. This helps us maintain patrol coverage and respond more effectively to calls for service.”

Maintaining safety and professional standards

All detainees must meet established medical, mental health, and classification standards before being accepted into the program, in accordance with formal agreements between the Sheriff’s Office and participating agencies. These requirements ensure the safety of staff and detainees while upholding professional standards of care, custody, and oversight

The Worcester County Sheriff’s Office Safekeep Program demonstrates how regional collaboration and modern infrastructure can enhance public safety, improve operational efficiency, and provide meaningful cost savings to the taxpayers of the Commonwealth.

WORCESTER — “Esta Isla” (This Island), the award-winning feature film by Puerto Rican filmmakers Lorraine Jones Molina and Cristian Carretero, will screen in Worcester on Sept. 26, bringing the acclaimed Puerto Rican film to audiences across Central Massachusetts.

BoriCorridor, in collaboration with Experimento Lúdico and Vejigantes Restaurant, presents the screening as part of the BoriCorridor Screening Tour, an initiative that brings Puerto Rican artists and cultural productions to communities across the United States.

“Esta Isla” premiered at the 2025 Tribeca Film Festival, where it won Best New Director and Best Cinematography and received a Special Jury Mention for Best U.S. Narrative Feature. In 2026, the film received the John Cassavetes Award at the Film Independent Spirit Awards, further establishing “Esta Isla” as one of the most recognized Puerto Rican films in recent years.

Set against the backdrop of Puerto Rico’s coastlines and mountains, the film follows Bebo, a teenager trying to survive amid economic hardship. After a violent incident alters his life, he flees with Lola, a young woman determined to escape her circumstances.



Their journey explores identity, belonging, and redemption in a Puerto Rico that is as beautiful as it is complex.

More than a chase thriller, “Esta Isla” offers a deeply human and contemporary portrait of Puerto Rican life, exploring inequality, resilience, and the island’s historical legacy.

“This film was born in Puerto Rico—from its landscapes, its contradictions, and its people. Being able to share it now with Puerto Rican communities across the United States is a very special opportunity for us,” said Lorraine Jones Molina, who, along with Cristian Carretero, directed and produced the film. The screening in Worcester will include a post-screening discussion, giving audiences an opportunity to engage directly with the filmmakers and explore the film’s themes and creative process.

“‘Esta Isla’ represents the kind of stories that BoriCorridor seeks to

bring to our communities: deeply Puerto Rican, honest, and contemporary narratives that invite us to reflect on who we are and how we relate to our country, our history, and our diaspora,” said Elsa Mosquera, founder of BoriCorridor.

The Worcester screening is part of a broader nine-city BoriCorridor Screening Tour that will bring “Esta Isla” to communities in Massachusetts, Connecticut, Colorado, and Texas, as well as New York City.

The tour marks the first time BoriCorridor has incorporated film into its programming, expanding the range of Puerto Rican artistic and cultural productions it brings to the diaspora. Supported by the Mellon Foundation, the BoriCorridor Tour has spent the past three years connecting Puerto Rican artists and cultural productions with communities throughout the United States.

screening, and short-term housing for individuals in custody. The facility operates 24 hours a day, seven days a week, and provides a secure environment for pre-arraignment detainees transferred from municipal police departments and the Massachusetts State Police.

“The Worcester County Sheriff’s Office specializes in the care, custody, and control of detainees,” commented Worcester County Sheriff Lew Evangelidis. “I’m grateful that the Baker-Polito administration believed in this project and the potential it had to benefit the hardworking police departments of Massachusetts.”

Estimated \$1 million in taxpayer savings

The Safekeep Program is estimated to have saved approximately \$1 million in personnel and operational costs for Worcester County municipal police departments and the Massachusetts State Police. These savings are achieved through:

- Reduced overtime expenses
- Fewer officers

assigned to extended detainee watch

- Decreased need for local holding capacity

- Consolidated and efficient court transport procedures

- Cost-cutting through avoiding providing meals, medical resources, etc.

By centralizing short-term custody operations at the Intake and Medical Unit, the Sheriff’s Office helps law enforcement agencies operate more efficiently while reducing the financial burden on Massachusetts taxpayers.

Webster Police Chief Michael Shaw stated that the Safekeep program takes the burden off the officers and dispatchers. It allows these individuals to focus on more relevant tasks as opposed to monitoring, feeding, and ensuring the overall safety of arrestees.

Shaw stated that, “Having this program in place is a huge relief to our agency, which, like many others, is facing staffing difficulties. We are grateful for our partnership with the Worcester County Sheriff’s Office, not just for its Safekeep program, but the commitment to helping police departments across Worcester County.”

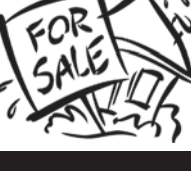

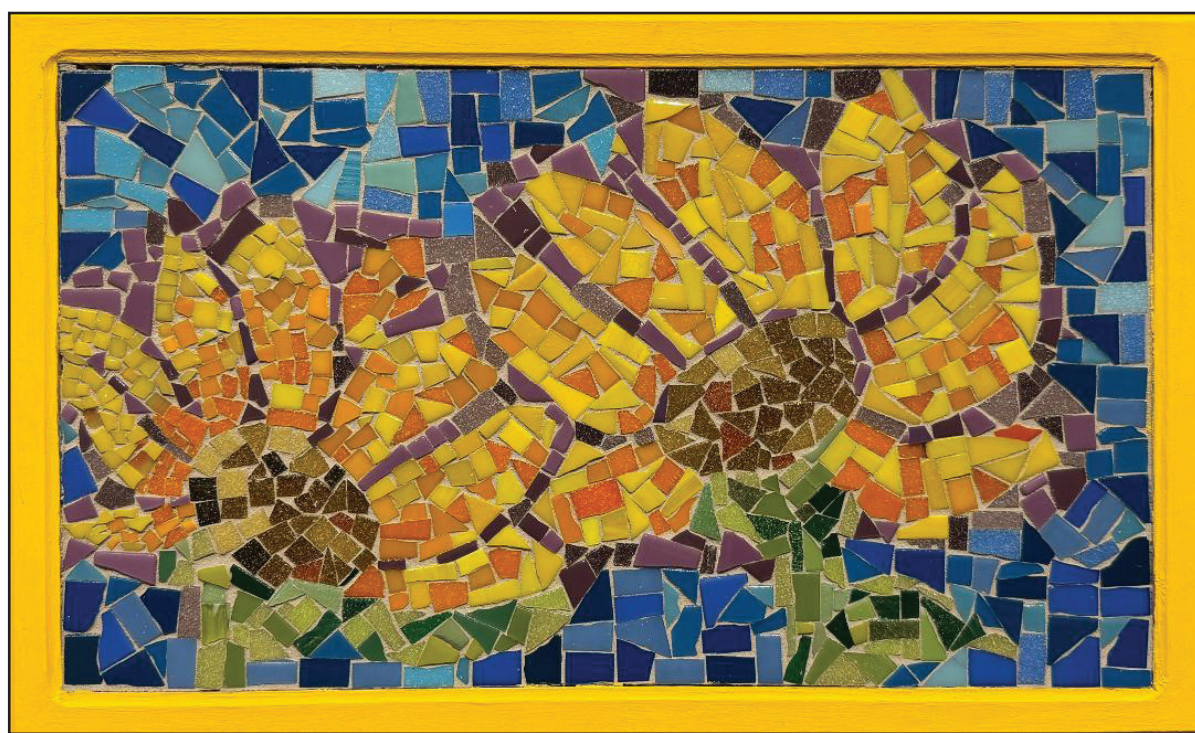

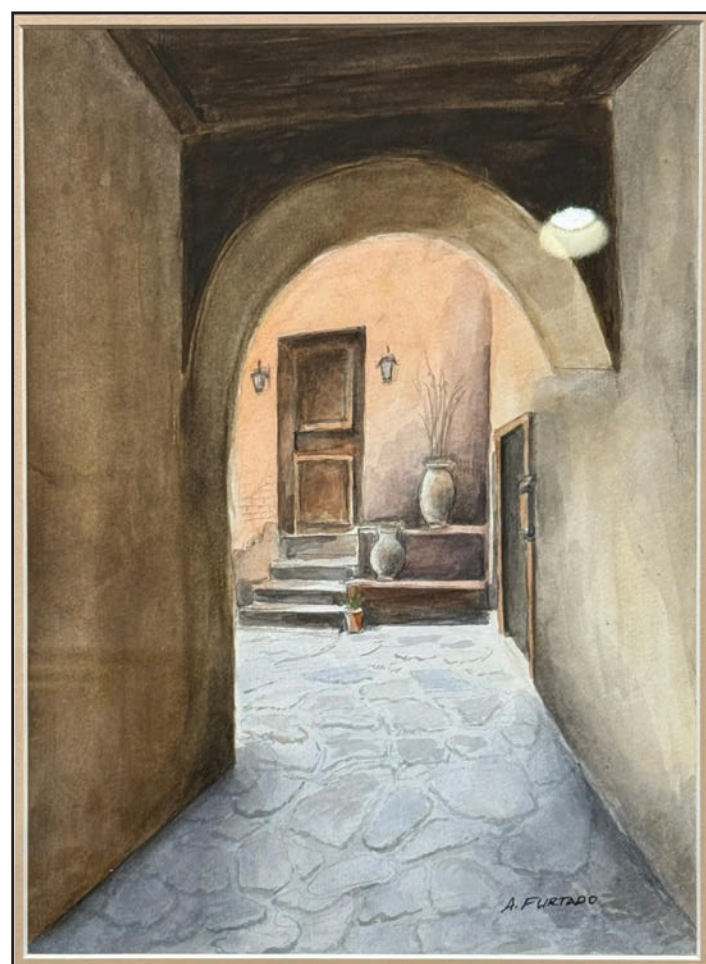
