Run for Ryan hosts Eighth Annual race at Owen Bell

DAYVILLE — The annual Run for Ryan event returned for its eighth year on July 18 honoring its namesake Ryan French, a Thompson native who passed away in 2017 while attending Killingly High School.

The run preserves his life and legacy in many ways. Not only is it a cross-country race on the track at Owen Bell Park he once ran as a member and eventual captain of Killingly's cross-country team, but it also raises money for a scholarship program through a foundation founded by Ryan's parents,

Joselyn and Jeffrey French, to support Killingly High School Regional Agricultural Education students, a program Ryan himself was enrolled in while at KHS.

The 2026 race was one of the biggest years to date according to Ryan's parents, and it also resulted in major milestones for the winners including a course record. An estimated 232 people signed up for the run and walk portions of the event, 148 participating in the run alone. While the final financial take from the race was not available for this story, the couple estimated the foundation has provided \$34,100 in scholarships to date benefitting 59 seniors from Killingly High Schools Agricultural Education program.

Ryan's mother, Joselyn French, said the annual support they receive for the cause has made Run for Ryan an uplifting experience for all involved.

"It's actually the greatest gift we could really receive is keeping his memory alive and having people continue to talk about him and remember him," Joselyn French said. "We're still finding out things about him that we didn't even know that he did behind the scenes at the school, and it always warms our hearts when we hear that. We feel so fortunate to be part of this corner of Connecticut. The fact that people choose to come to our event, to support us, to be part of this and remember him, it's all very special."

Ryan's father Jeffrey spoke about how he thinks his son would feel seeing how his mem-

ory has helped create such a great cause for everyone to get behind.

"I think he would be pleased that we're doing this and that the event is helping to turn tragedy into something positive by helping out Ag-Ed seniors," he said. "We found out after he passed away some things about Ryan like that he helped kids who were being bullied. He was the kind of kid where if there was a younger classmate who was sitting alone at lunch, he would come over and invite them to join him and his friends. Because he was a giving kid, he would be pleased that we're doing something positive to help other students."

The winners of the cross-country run were Seth Varin as the first male and overall winner, and Katie Stevens as the first female across the line. The victories were milestones for both in this event. Varin has placed second or third three times prior but finally broke through for the overall win with a time of 16 minutes and 50.96 seconds. Stevens, who was friends with Ryan in school, set a new record for a female besting the previous record which was held by another of Ryan's friends, Angie Rafter, until this year. Stevens crossed the line with a time of 18 minutes and 36.99 seconds just barely beating the previous record of 18 minutes and 37 seconds by the smallest margin.

The family has already announced that Run for Ryan will return in 2027 with the ninth iteration set to take place on July 17 next year.

Livestrong's 343-mile First Responder Ride for Resilience to pass through area

THOMPSON — Ahead of the 25th anniversary of Sept. 11, Livestrong, a nonprofit dedicated to improving the daily lives of cancer survivors, is hosting a landmark First Responder Ride for Resilience, a five-day, 343-mile cycling journey from Boston to the 9/11 Memorial in New York City honoring the 343 firefighters lost on September 11, 2001. Riders will move through northeastern Connecticut on Monday, Sept. 7. Local residents are invited to cheer on riders, volunteer at a water stop, or donate to show their support.

According to research from the National Institute for Occupational Safety and Health, firefighters are nine percent more likely to be diagnosed with cancer and 14 percent more likely to die from it than the general public. The ride brings together first responders, cancer survivors, and community members to raise funds benefiting Friends of Firefighters, the Boston Fire Cancer Foundation, and Livestrong, expanding access to cancer survivorship and mental health programs for first responders and their families.

"This ride wouldn't be possible

Keeping Killingly's history alive

KILLINGLY — History is more than a record of the past—it is the story of the people, places, events, and ideas that have shaped who we are today. Our families, neighborhoods, communities, and natural environment all contribute to our shared heritage. Preserving those stories for future generations is the mission of the Killingly Historical and Genealogical Society.

Founded in 1972, the Society is dedicated to promoting knowledge, interest, and research in the history of Killingly and Windham County. Whether you are researching your family tree, a historic home or business, the town's role in the Revolutionary War, or simply want to learn more about our community, our volunteers are eager to help or connect you with valu-

able resources.

The Society continues to bring local history to life through educational programs and public presentations. Most recently, the Society hosted a program at the Killingly Public Library featuring "Up and Down the River," a documentary produced by the Mohegan Tribe. The presentation was led by Mohegan educator and storyteller Ms. Hutchins, who shared the history of the Mohegan people leading up to the American Revolution.

The documentary explored how the Thames River connected Indigenous communities and early settlers, highlighting their shared experiences during the Revolutionary War 250 years ago. The video and talk by storyteller Madeleine Hutchins presented the differing viewpoints among tribal members regarding participation in the conflict and examined how life changed for the Mohegan people after the war. The primary river associated with the Mohegan Tribe in Connecticut is the Thames River. Historically known in Mohegan as Massapequotuck (Great Water).

The Killingly Historical and Genealogical Society also recently held its Annual Meeting at the Killingly Public Library. As a registered nonprofit organization, the Society is operated entirely by dedicated volunteers who generously donate their time to preserve and share the history of our community.

During the meeting, officers and board members were elected to three-year terms. The officers are President Bernard Mitchell, Vice President Frank Aleman, Secretary Lynn LaBerge, and Treasurer Teresa Barton. Newly elected board members are Margaret Weaver, Sue Gosselin, and

Danielson tackles Hawkins Street fire

DANIELSON — A fire on Hawkins Street in Danielson brought multiple departments to town with fears of entrapment inside the building creating a dire situation for first responders.

According to a report published on social media by the Danielson Fire Department, a first-alarm fire was struck at 6:44 a.m. the morning of July 27 with reports of people trapped inside the burning building at 32 Hawkins St. in the Danielson Borough of Killingly.

Killingly-Brooklyn Ambulance was the first on scene only minutes later, arriving at a fully engulfed building. Fire crews soon arrived on scene sparking a second alarm. It was confirmed that all occupants had safely escaped the building, with one civilian sustaining burns and smoke inhalation injuries and transported to a hospital. Occupants of neighboring buildings were also evacuated due to the home's proximity to nearby structures.

While the human occupants survived, the report from the Danielson Fire Department confirmed that



numerous cats perished in the fire, although one was rescued.

"A KB medic, assisted by firefighters on scene, successfully revived the cat before a good samaritan transported it to a local veterinary hospital for further care. Tragically, despite the efforts of firefighters, approximately 30 cats perished in the fire," the Danielson Fire Department report stated.

One firefighter also sustained injuries after being struck by falling debris. They were treated on scene but then transported to a hospital for further evaluation.

The fire came in the midst of a difficult time for the Danielson Fire Department. The department has endured several changes since more than half of its membership resigned in May during a

Why are more trees failing in Northeastern Connecticut?

REGION — If it seems like more trees have been coming down in recent years, you’re not imagining it.

Across northeastern Connecticut, homeowners in communities like Putnam, Pomfret, Woodstock, Thompson, Killingly, Brooklyn, and surrounding towns have experienced stronger storms, heavier rainfall, and damaging wind events that have taken a toll on our trees. Combined with the lingering effects of the spongy moth outbreak, these conditions have contributed to an increase in hazardous trees and property damage throughout the region.

At Stately Tree Service, we’ve seen a noticeable increase in calls from homeowners dealing with fallen limbs, uprooted trees, and trees that appeared healthy from the outside but were actually weakened from within.

One of the biggest misconceptions is that a tree must look dead before it becomes dangerous. In reality, many hazardous trees still have green leaves and appear healthy while suffering from internal decay, structural damage, or weakened root systems.

Many homeowners may also

remember the widespread gypsy moth infestation that affected our region several years ago. While many trees survived the initial outbreak, repeated defoliation left thousands of oaks under significant stress. Today, we’re still seeing the effects, as many of those weakened trees continue to decline and become more vulnerable to failure during storms.

Weather has only added to the problem. Prolonged periods of heavy rain can saturate the soil, reducing the stability of a tree’s root system. When strong winds follow, even trees that have stood for decades may suddenly uproot or lose large limbs.

Homeowners should periodically inspect the trees on their property, especially after severe weather. Warning signs may include dead or hanging branches, cracks in the trunk, mushrooms or fungal growth near the base, thinning canopies, exposed roots, or a tree that has recently begun leaning. While these signs don’t always mean a tree needs to be removed, they shouldn’t be ignored.

Our region is known for its

beautiful, mature trees, which add character, shade, and value to our homes and communities. Taking a proactive approach to tree safety can help reduce the risk of property damage and improve safety for homeowners, neighbors, and anyone enjoying the outdoors.

As weather patterns continue to change and the long-term effects of the gypsy moth outbreak remain evident across northeastern Connecticut, regular tree inspections and early action can make all the difference in preventing avoidable damage.

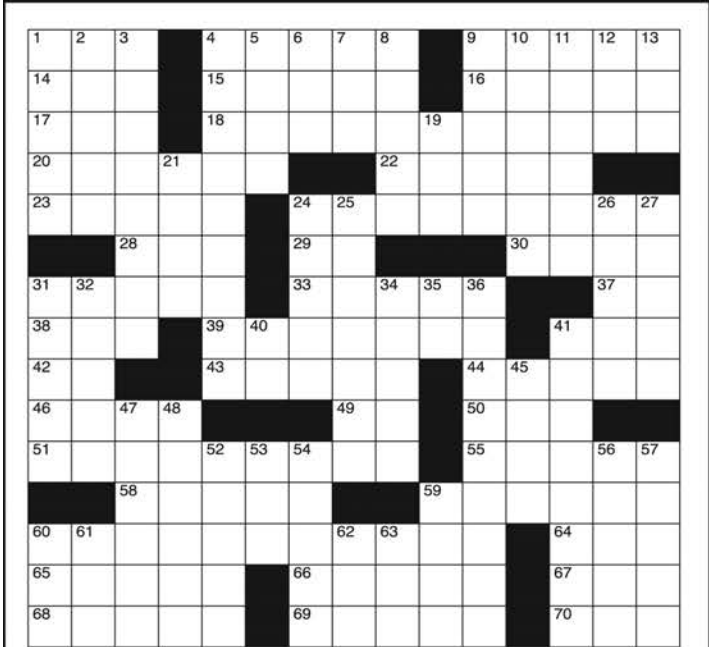

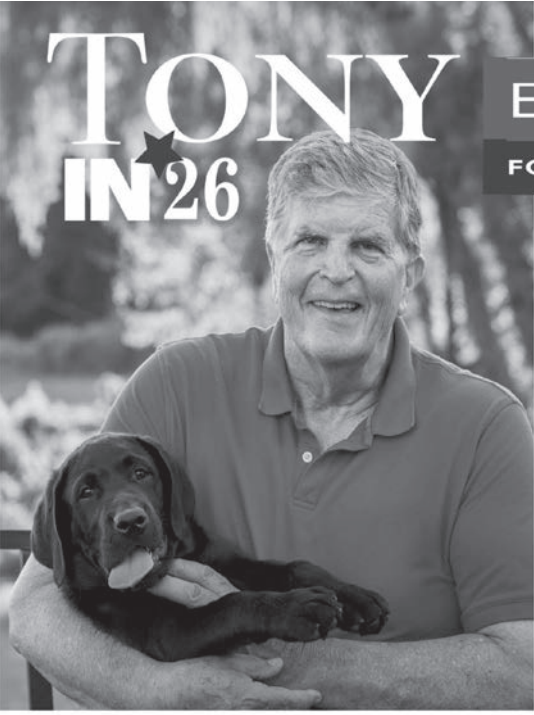

Turning memory into momentum

Every community hopes to leave something meaningful to the next generation. Sometimes that legacy comes through new buildings or public projects. Sometimes it comes through a scholarship fund. And sometimes it begins with a single family deciding that even in the face of unimaginable loss, they will choose purpose over despair.

That is what the Run for Ryan has become. Eight years after the inaugural event, what started as a tribute to Thompson’s Ryan French has grown into one of the Quiet Corner’s most inspiring traditions. Hundreds of participants now gather each July at Owen Bell Park, not only to run or walk, but to celebrate a life that continues to make a difference.

The numbers tell an impressive story. More than 230 people registered this year. Nearly \$35,000 in scholarships has been awarded to 59 graduates of Killingly High School’s Agricultural Education program. A course record fell. Familiar faces returned, and new participants joined for the first time.

But those statistics are only part of the story.

The true measure of the event lies in the conversations that happen along the course and afterward. Friends share memories. Former classmates reconnect. Students who never had the opportunity to know Ryan learn about the kind of young man he was. His parents continue to discover stories of quiet acts of kindness that never sought recognition. Those accounts of inviting lonely classmates to lunch or standing beside students who were being bullied reveal a legacy far greater than athletic accomplishments alone.

In an era when headlines often focus on division, the Run for Ryan reminds us that kindness has staying power. It creates ripples that extend far beyond the moment in which they occur.

There is also something fitting about the event taking place on the same course where Ryan once competed as a member and captain of the Killingly High School cross-country team. Running has always been a sport built on perseverance. Every mile requires determination. Every finish line represents countless unseen hours of preparation. The annual race reflects those same qualities, with a community steadily building something meaningful year after year.

Equally important is where the proceeds go. Supporting students in Killingly’s Agricultural Education program honors Ryan’s own interests while investing in young people preparing for careers in agriculture, environmental science, mechanics, animal care, and other skilled professions. The scholarships recognize not only academic achievement but also the values of hard work, service, and commitment that Ryan’s family believes he embodied.

The event’s competitive side deserves celebration as well. Congratulations are certainly due to Seth Varin for earning his first overall victory after several near misses and to Katie Stevens, whose new women’s course record came by the narrowest possible margin. Their accomplishments add another chapter to the event’s history, but even they unfolded within a larger purpose. On this day, personal victories become part of a shared community achievement.

Perhaps the greatest lesson from the Run for Ryan is that remembrance does not have to be passive. It can be active. It can inspire generosity, encourage healthy living, support education, and strengthen community bonds all at once.

Many towns search for traditions that bring people together. Dayville, Thompson, and the surrounding communities already have one. It is built on compassion, sustained by volunteers, supported by neighbors, and fueled by the determination of one family that chose to transform heartbreak into hope.

As plans are already underway for next year’s ninth Run for Ryan, the event continues to prove that while a life may end too soon, its influence does not have to. Some legacies are measured not by years lived, but by the good they continue to inspire long afterward. Ryan French’s legacy is clearly still running strong.

Earth — close to the edge!

ity now lights billions of fossil fuel fires every single day. Each of these fires thickens up the carbon dioxide blanket in the atmosphere, making our planet hotter.

Prior to that first well, all oil was sequestered within the Earth’s geologic formations. But today, much of it is now part of the atmosphere. And with that, the 58-degree temperature of the Holocene has climbed to about 60 degrees. Spread across the entire Earth, this rapid warming is wreaking havoc on the natural planetary systems that support life and civilization. Scientists now argue these changes have pushed the Earth beyond of the Holocene and into a new geologic epoch: the Anthropocene. The precise moment of this change is debated, but many regard the first nuclear bomb test in 1945 as a compelling start date.

The Anthropocene—literally “the age of humans”—is marked by our growing influence over the atmosphere, oceans, biosphere, freshwater systems, and climate itself. Human activity now determines not only the composition of the atmosphere but also the abundance and distribution of countless other species. We have become a planetary force.

Among the most concerning examples of this influence is our effect on the Atlantic Meridional Overturning Circulation, or AMOC—a vast network of ocean currents often described as Earth’s circulatory system. Scientists warn that this critical current is weakening and may be approaching a tipping point. A significant slowdown, or even a collapse, would dramatically alter weather patterns across the planet.

This is big stuff - very big, and it tells us humanity has entered unfamiliar territory where we are now steering the planetary systems foundational to civilization, without fully understanding how to control them.

That realization can feel overwhelming. Some respond with optimism, believing technology will solve every problem. Others retreat into denial because the implications seem too daunting to confront, or worse, because of politics. But beneath those different reactions lies a growing sense that something fundamental has changed.

Deep down, many of us feel it.

Preserving a healthy livable planet for our kids and generations to follow should be humanity’s highest priority. Elon Musk’s pipe dream of colonizing Mars only distracts us from this. With all his brilliance, he fails to recognize the simple fact that this miraculous and beautiful place called Earth is and will remain our only home. If we fail to preserve it, it may end up looking like his dream home—Mars. But last I checked, nobody lives there.

Recently, I traveled to Pennsylvania for my sister’s memorial service. While with my daughter in Lancaster, I decided to have a “busman’s holiday” and visited Wheatland, the home of our 15th President, James Buchanan, Jr. (1791-1868), the only president from Pennsylvania and the only bachelor. Buchanan served as president from 1857 -1861 and was in office at the beginning of the Civil War. “Historians often rank him poorly because his weak response to rising tensions over slavery failed to prevent the American Civil War.” “Presiding over a rapidly dividing Nation, Buchanan grasped inadequately the political realities of the time. Relying on constitutional doctrines to close the widening rift over slavery, he failed to understand that the North would not accept constitutional arguments which favored the South. Nor could he realize how sectionalism had realigned political parties: the Democrats split; the Whigs were destroyed, giving rise to the Republicans.” Prior to becoming president, Buchanan served in the house of Representatives five times, was a minister to Russia and later Great Britain and also Secretary of State.” “President James Buchanan was personally and morally opposed to slavery, but politically he acted as a ‘doughface’—a Northern politician who consistently appeased and protected Southern pro-slavery interests.” (history.com, national archives, https://trumpwhitehouse.archives.gov/about-the-white-house/presidents/james-buchanan/).President Buchanan never married but became the guardian of an orphaned niece and nephew, thus living in a family situation. His niece Harriet Lane (Johnston) served as his hostess while he was president. “She is considered the ‘first First Lady,’ as she was the

Get out and vote in Connecticut’s Primary

To the Editor:

People don’t think their vote counts for much in a Primary. The truth is that Primaries are where the real choice happens and how candidates are chosen on the ballot in November. If you want a say in who’s on your ballot this fall, now’s the time.

Here are the dates and rules you need to know.

The important Primary deadlines and voter registration details to cast a vote in Connecticut’s Primary election are as follows:

July 21 - First day absentee ballots are issued.

July 24 - Last day to register to vote by mail.

Aug. 3 - First day of early voting.

Aug. 9 - Last day of early voting.

Aug. 10 - Last day to request an absentee ballot and register to vote in person.

In Connecticut, only voters registered with a political party may vote in that party’s Primary, making it a closed Primary state:

Democratic Primary – Only registered Democrats can vote.

Republican Primary – Only registered Republicans can vote.

The deadline for voters to change parties was May 11.

Unaffiliated Voters – Voters who are not registered with any political party cannot participate in the Primaries unless they register with a party by the deadline, which is before noon on Monday, August 10, the last business day before the Primary on August 11.

A new voter who wants to register to vote in Connecticut’s Primaries must be a U.S. citizen, a resident of Connecticut, and at least 17 years old (turning 18 by Election Day). New voters must register in person before noon the business day before voting during Early Voting. New voters who want to vote on Primary Day must register to vote in person by Noon on Aug. 10.

Check your registration, figure out how you’re going to vote in the Primary — absentee, early, or on the 11th — and go do it. Make your voice heard. Vote.

Ballots, bullets & anti-Blackness

To the Editor:

Growing up in the Quiet Corner, I was taught that my country’s founders were brave men seeking to escape the religious persecution and unchecked greed of the English crown. As I grew older, I came to understand that the U.S.’s promise of freedom, enshrined in the Constitution and the Bill of Rights, only granted voting rights to property-owning white men. Even more disturbingly, the Constitution’s Three-Fifths Compromise, Slave Trade Clause, and later, Congress’ Fugitive Slave Act defined Black people as property, who, like all women at the time of the country’s inception, were legally denied the right to vote, and thus excluded from U.S. citizenship (The Counter-Revolution of 1776; Horne 2014).

It would not be until 1870, when Congress ratified the Fifteenth Amendment, that Black men—in theory—were given the right to vote, though poll taxes, literacy tests, grandfather clauses, and gun-backed voter intimidation prevented most from safely or legally casting their ballots (Jim Crow North: The Struggle for Equal Rights in Antebellum New England; Archer 2017). Even after the CT state legislature passed the Gradual Emancipation Act in 1784 (which mandated that all those born into slavery after March 1, 1784 be freed at the age of 25), it took our state another half century to totally prohibit chattel slavery (“No Taxation without Representation: Black Voting in Connecticut”; Harris 2016). In 1920, the nation further expanded the right to vote to white women by ratifying the 19th Amendment. Women of color, however, had to continue fighting for—and well past—Congress’ passage of the Indian Citizenship Act of 1924 and the Voting Rights Act of 1965 to be granted the same.

To this day, legacies of Jim Crow, racialized violence, and class inequity place barriers between everyday Americans and the voting booth, all whilst Republicans attempt to gerrymander away the power of Black and Brown votes (The Counter-Revolution of 1776; Horne 2014). Under the Trump administration, these multi-state efforts haven’t stalled. If anything, they’ve only gained steam, fueled by Republicans lawmakers’ proposed SAVE Act, a policy that would require voters to present documentary proof of U.S. citizenship, such as a passport, a birth certificate, or a naturalization certificate to register to vote, despite more than 21 million voting-age Americans lacking access to such documents (“21.3 Million American Citizens of Voting Age Don’t Have Ready Access to Citizenship Documents”; Brennan Center for Justice 2024).

If our elected officials believe so strongly that proof of identity and citizenship are essential to the integrity of American elections, why don’t they apply the same rigor and scrutiny to Americans’ ability to purchase firearms? Even when looking only at Connecticut, between 2019-2023, firearms were the third leading cause of death among young people, and between 2014-2023, gun violence across the state increased by 24 percent («225 Gun Deaths in Connecticut»; Johns Hopkins Bloomberg School of Public Health 2023). While Connecticut’s rising rates of gun violence might lead you to believe that the federal government has consistently failed to restrict Americans’ access to firearms, in 1967, the National Rifle Association (NRA) worked with the state of California to pass the Mulford Act amidst one of the largest open carry crackdowns in U.S. history. The targets of these brutal, violent and cross-state crackdowns? The Black Panther Party (“When an irresistible prejudice meets immovable politics”; Higginbotham et al 2023).

At one time, I would have thought of the right to vote and the right to bear arms as two disparate issues, with “liberals” and “conservatives” sitting neatly on either side. Our national history, however, paints a far more nuanced picture, one of a country whose policies are steeped in the anti-Blackness of its founding fathers (and this state is not immune). Just as local, state and federal governments have punished Black people for arming themselves against repeated racial violence, the state of Connecticut has long denied its Black residents access to the right to vote, serving as the first ever state in the country to implement voter literacy tests (“Connecticut needs its own Voting Rights Act”; Zaccagnino 2023).

If state and federal lawmakers are willing to burden millions of voters (disproportionately young people, women, transgender folks, and people of color) in the name of “voter fraud,” a problem so rare that election officials struggle to document more than a handful of cases (“Prosecutors struggle to turn voter fraud claims into criminal charges”; Stein and Arnsdorf, 2026), shouldn’t they be half as willing to require background checks for firearm purchases, given that gun violence kills over forty thousand Americans a year (“What the data says about gun deaths in the U.S.”; Gramlich 2024)?

So, as you prepare to head to the voting booth this fall, it’s worth asking why so many of the very lawmakers who champion the SAVE Act as a «common-sense» integrity measure decry gun safety policies like background check expansions, red flag laws, or safe storage requirements as government overreach. It’s worth asking who stands to profit from increased documentation for voter registration. And it’s worth asking which of our friends, family, and neighbors will be first affected if we fail to stop the SAVE Act.

Don’t forget to vote on November 3rd!

Give him a chance?

To the Editor:

They keep saying to “give him a chance.” Let’s look at the public record-not rumors, social media posts, or partisan talking points. Just documented events.

The record:

- At least seven flights on Jeffrey Epstein’s plane.
- Invoked the Fifth Amendment more than 400 times during a single deposition involving his business practices.
- Convicted on 34 felony counts in the New York hush-money case, becoming the first former U.S. president to be criminally convicted. He also faced 91 criminal charges across four separate indictments.
- Accused of sexual misconduct or assault by at least 26 women.
- Six corporate bankruptcies involving businesses that bore his name.
- Five draft deferments during the Vietnam War era.
- Twice impeached by the U.S. House of Representatives, making him the first president in American history to be impeached twice.
- Two Trump Organization companies were convicted on 17 criminal tax fraud counts in 2022 and fined \$1.6 million.
- Trump University settled fraud claims for \$25 million, and the Trump Foundation was dissolved after he agreed to pay \$2 million for misusing charitable assets.
- Found liable for sexually abusing and defaming E. Jean Carroll. A jury awarded \$5 million in damages, followed by an additional \$83.3 million in a separate defamation case. The \$5 million judgment was later upheld on appeal.

- Found liable for business fraud in New York for inflating the value of his assets. Although the monetary penalty was later reduced on appeal, the fraud finding remained in place.

- Granted pardons or commutations to roughly 1,600 people convicted in connection with January 6, including leaders of the Oath Keepers and Proud Boys who had been convicted of seditious conspiracy. Some recipients have since been arrested or charged with additional crimes.

- The national debt exceeded \$39 trillion, increasing by roughly \$11 trillion since his first inauguration.

- Presided over multiple government shutdowns, including the longest shutdown in U.S. history during his first term. In 2026, the federal government shut down twice, with the second lasting from mid-February through the end of April.

- Tariffs are estimated to increase costs for American households. According to the Yale Budget Lab, the average annual impact is estimated at approximately \$1,700 to \$2,400 per household.

None of these events are secret. They are matters of public record.

When someone says, “Give him a chance,” it’s reasonable to ask another question: How much weight should voters give this record when deciding whether he deserves another chance?

Every voter will answer that question differently. Make sure your answer is based on the documented record, then vote accordingly.

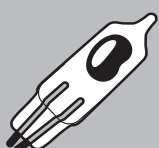

Don't panic — do this!

Safety tips to teach your children if lost

One holiday season, while at the Auburn Mall, when my son was six years old, we were shopping with friends. While I was busy chatting, my son stopped to look in a store window while we continued. When I glanced down, I saw he was not with us, and I began to panic. After a look around our immediate area, I retraced my steps, checking the sales desk at each store. I was able to find him quickly because he knew to go to the register and ask for help. Crisis averted.

Parents, don't be afraid to talk about it, and even role-play; it can make a difference. I always like to highlight this in my strategy: "Perfect planning prevents

poor performance".

Stop moving- I taught my son to stay put. I retraced my steps, kept scanning, and was able to find him in minutes. Then I managed to bring my jacked anxiety back to normal.

Identify and Approach Safe Adults. First, stay calm- both the parent and the child should take three long, very slow breaths.

Teach your children how to identify safe adults they can approach for help. These choices should include police officers, store employees, security personnel, or women with children. Instruct them to avoid speaking to strangers who don't fit these categories.

Give them a simple script to use (and please practice), such as, "I'm lost. Can you help me find my parents?" Reassure them that most adults are kind and willing to help, but they should still be cautious.

Your child must know that leaving a park or building with a man is a no-go proposition.

Additionally, show them how to recognize uniforms and name tags that indicate someone's official role.

Memorize names - Kids need to know their full proper names. Not just their nickname or shortened kid name, but full first and last name.

Your children should know your real first and last name, not just Mommy or Daddy.

When kids realize that you're not in their line of sight, they should practice

shouting your first and last name (like -John Smith!), not just Mommy or Daddy.

Memorize your phone number- Ensure they have memorized your phone number. To practice this, you can make a game or a song out of your number (think the alphabet song).

Establish a meeting spot- When visiting crowded places like parks, malls, or events, establish a clear meeting spot (this is my recommendation for older children) in case you get separated. Choose a location that is easy to find and recognizable, such as the main entrance, a specific landmark, or the sales desk in a store. Show your children the spot when you arrive and explain that if

they get lost, they should go there and wait for you. If they can't find the meeting spot and you have already indicated it, they should seek help from a safe adult to guide them there. The very best choice for assistance is always a woman with children. A pre-planned spot serves as a reliable point of reference, giving you and your child a known location to reunite.

For you, the parent- Take a photo right when you go to an amusement park so you can show someone what your child was wearing. Staff can't recognize similar-looking children but can grab a color combination much more easily.

Dress them in bright colors so they stick out in a crowd (picture the cop directing traffic). You can always use a digital tracker like an AirTag. You do this for your luggage; why not your kids?

One parent can stay in the

spot where you first noticed your child was missing while the other parent/adult retraces your steps.

Please assure your kids that you are not angry, only scared for their safety. Everyone's emotions will run high in these situations, and I will remind you that in times of stress, long, slow breathing will help you manage your stress. By teaching your children these essential tips, you equip them with the knowledge and confidence to handle situations where they may become separated from you, ensuring their safety and your peace of mind during summer outings. Like anything else, role-playing and regular practice make these habits stick.

Roth Conversion or not?

How to decide in the new tax landscape

For years, the big question hanging over Roth conversions was a guessing game: would tax rates jump when the 2017 tax cuts expired? That uncertainty is gone.

With the One Big Beautiful Bill Act (OBBA) signed into law in July 2025, the lower tax brackets we’ve grown used to are now permanent — including the top rate, which held at 37 percent instead of climbing to 39.6 percent in 2026 (Tax Foundation, 2026). For high earners who are still in their building years, that changes the calculation in a few meaningful ways.

So let’s walk through how to think about it.

First, a quick refresher

A Roth conversion is exactly what it sounds like: you move money from a traditional IRA or 401(k) — where you’ll owe ordinary income tax on every dollar you eventually withdraw — into a Roth account, where the money grows and comes out tax-free in retirement. Think of it like paying tax on the seed instead of the harvest. You pay tax today on the amount you convert, and in exchange, all the future growth escapes taxation entirely.

One thing a lot of high earners don’t realize is that while you may earn too much to contribute directly to a Roth, there’s no income limit on converting to one (SDO CPA, 2026). That’s exactly why conversions are such a useful tool for higher-income households. The catch, of course, is that you’re voluntarily creating

a tax bill right now, and for a high earner, that bill can be steep. So the real question is always: will I pay a lower rate now, or later?

Why the new landscape tilts the scale

Here’s where permanence matters. In the old world, you might have rushed to convert before rates went up. Now, with brackets locked in, the decision is less about beating a deadline and more about your own trajectory — and that’s where it gets interesting.

If we think about three things, the picture comes into focus.

First, your own future tax rate may be higher than you assume. Many high earners picture retirement as a lower-tax chapter. But if you’re a strong saver, your traditional accounts can balloon and required minimum distributions, stacked on top of Social Security and other income, can push you right back into a high bracket later. Paying 32 percent now might genuinely beat paying 35 or 37 percent on a much larger balance decades from now.

Second, OBBA quietly trimmed the value of itemized deductions for top earners. Starting in 2026, taxpayers in the 37 percent

bracket face a new limitation that reduces the benefit of their itemized deductions (IRS, 2025). The one thing to consider there is that the deductions you’d normally lean on to soften a high-income year are a little less powerful now, which can make the clean, predictable cost of a Roth conversion comparatively appealing.

Third, estate goals are clearer than ever. A Roth IRA passes to your heirs income-tax-free, and there’s no required distribution during your lifetime. If part of your plan is leaving a tax-free gift to the next generation, conversions are one of the most elegant ways to do it.

A real-life example

Let’s make this concrete. Say you’re 48, married, with taxable income around \$250,000 — comfortably in the 24 percent bracket, which for 2026 runs up to \$256,225 for joint filers (IRS, 2025). You’ve got \$600,000 in a traditional IRA you don’t plan to touch for decades. You’re disciplined, so that account could realistically grow well past \$2 million by the time RMDs begin.

This is where a “fill-the-bracket” approach shines. Rather than converting a giant lump sum, you convert just enough each year to reach the top of your current bracket without spilling into the next one (College Investor, 2026). In years when your income dips, that headroom grows. Pay tax at today’s known rate on a smaller balance now,

and everything that grows afterward comes out tax-free later.

J.P. Morgan’s Guide to Retirement illustrates this relationship well: the lower your tax rate today relative to your expected rate in retirement, the more a conversion works in your favor, and the wider that gap, the bigger the lifetime payoff.

The trade-offs (because there always are some)

I’d never present this as a slam-dunk, because it isn’t one for everyone, especially during peak earning years. When wages, bonuses, and other income are already stacking up, piling a large conversion on top can mean paying tax at your highest marginal rate, which is the opposite of smart planning (Defiant Capital, 2026).

Here are a few things to consider: Always pay the conversion tax from outside the retirement account — ideally a taxable brokerage account. If you have to dip into the IRA to cover the tax, you lose much of the benefit. A conversion also raises your taxable income for the year, which can ripple into things like Medicare premium surcharges (IRMAA) down the road or the 3.8% net investment income tax. And remember, once you convert, it’s permanent — recharacterizations were eliminated back in 2018 — so accurate income projections really matter.

This is genuinely a “show me the numbers for my situation” decision. There’s no rule of thumb that replaces modeling it against your actual income, balances, and timeline.

Your next step

If you’re a high earner with sizable traditional retirement balances, this is worth mapping out, ideally before year-end, when conversion timing matters most. Action is the best remedy to anxiety: you don’t need every answer first, you just need to start the conversation.

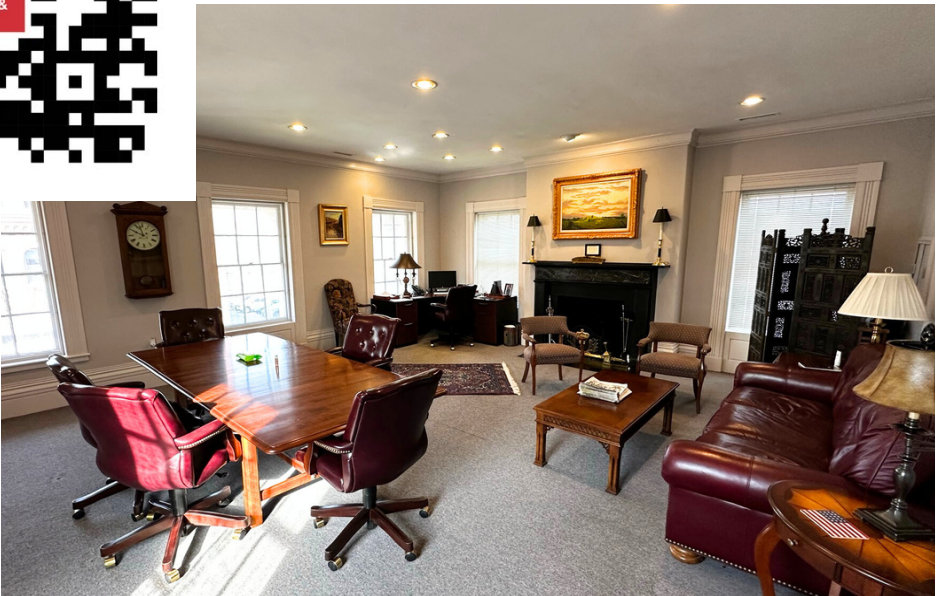

dispute over the hiring process for a new chief and the perceived lack of support from the town. Kevin McNeill was eventually appointed chief.

Despite the recent controversies, the department was able to respond and manage the scene effectively. The department’s official release did not shy away from addressing the controversy stating that, despite everything, the department remains focused on protecting the community.

“The Danielson Fire Department extends its sincere appreciation to all of our mutual aid partners for their rapid response, professionalism, and teamwork. Since early May, the department has been focused on rebuilding and strengthening relationships with neighboring agencies through collaboration, joint training, and a shared commitment to providing the highest level of service to our communities. Today’s incident serves as a powerful example of those efforts and demonstrates what can be accomplished when agencies train together and respond as one unified team,” the department wrote.

The cause of the Hawkins Street fire remains under investigation by the Killingly Fire Marshal’s Office and the Connecticut Office of the State Fire Marshal.

first person to be given the title of “First Lady” by the American press. (lancaster-history.org...)

Wheatland (no s) was built in 1828 in a Federal style and was acquired by Buchanan in 1848 while he was Secretary of State under President Polk. There are aspects of the interior which remind me of Bowen’s Roseland Cottage in Woodstock (the Pink House). The guided tour we took spent quite a while in the dining room where the table was already set. The guide said that it was common to have dinners served by courses as it was easier to keep the food warm that way. It had to come from the kitchen in the basement, by way of steep stairs, to the butler’s pantry adjacent to the dining room where there was a small stove which could keep food warm. I was intrigued by a large oval, glass bowl-about 4 inches deep, at each place setting, since I’d never seen one. It was for rinsing out your wine glass between courses. I was unable to climb the stairs to the second floor but was given a very informative “virtual” tour on an ipad. A costumed docent explained the

clothing of the day, which included very wide hoop skirts for women (think Mrs. Lincoln). A woman had to put on what looked like a cage, then a number of petticoats, then her dress to achieve the desired fullness. I don’t know how she would have been able to sit down! I’m very glad that I didn’t have to wear that. I was very glad that I had taken the time to visit the house. If you’re in the Lancaster area, you might also enjoy it. (Visit lancaster-history.org for photos and more).

I thought I would see what the headlines were in early August 1966, a year many of you might well remember. The Aug. 4 Windham County Transcript front page carried the headline, “Ground Breaking today for Building to expand Rogers Headquarters Here.” The plans were for a 10,000 square foot addition. Another headline read, “Airplane For Missionaries Set to Arrive Here Sunday. This coming Sunday, August 7, is the day when a Piper Cub airplane, purchased for the use of the LaSalette Fathers on the island of Madagascar, is scheduled to arrive at the Danielson Airport at 3 p.m. The Rev. Armand Nadeau, M.S., pastor of St. James Parish, previously announced that the plane

had been bought and that the transaction had been made with trading stamps, mostly 3,000,000 of the well-known S & H Green Stamps.” Imagine, buying a plane with green stamps! “Reopening of Soap Street Termed ‘Not Reasonable by Highway Commissioner Ives ...Soap Street was closed to permit the construction of a bridge over Route 52 (now 395) which is in a twenty-foot cut at that location...The possibility of temporarily reopening Town Farm Road has also been considered. It has been found, however, that it crosses Route 52 where there is a twenty-foot fill.” Did any of you ever use Town Farm Road? If you’re new to the area or a younger resident, think of Owen Bell Park in Dayville and the location of the Killingly Town Highway Garage on Route 12. Town Farm Road cut from 101 to 12in that area.

“Marshall C. Dowe Dies at 44 from Accident Injuries...Marshall C. Dowe, popular owner of Dowe’s Inc., a century-old Danielson Main Street business, died last Friday of injuries sustained on July 17 after the motorcycle he was driving struck a dog on Cucumber Hill Road in Foster, R.I...The business was founded by his grandfather Marshall P. Dowe in 1860.”

The movie of the week at the Orpheum in Danielson was “The Russians are Coming, The Russians are Coming.” The Parkway on Route 12 had Elvis Presley in Paradise Hawaiian Style scheduled during the coming week. Sundown Beach at Alexander’s Lake was advertising docks, floats, and a waterwheel. Roller Skating Every Wednesday and Sunday evenings. (p.2). Perhaps you have fond memories of some of these entertainments. Please feel free to share them.

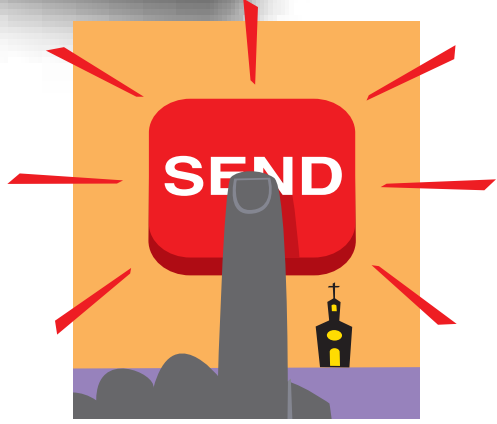
