Volunteers brave the heat to transform Antos Farm Sanctuary ahead of centennial celebration

DUDLEY — Local volunteers braved high temperatures this past weekend at the first-ever stewardship day for Dudley Conservation Land Trust’s newest sanctuary, Antos Farm. A passionate team of 20 energetic volunteers gathered on Marsh Road, Dudley, to clear trails, dispose of legacy homestead items, and rescue the property’s farmhouse from overgrowth, kicking off preparations for the farm’s upcoming 100th anniversary celebration on October 3.

The productive workday resulted in a completely filled 15-yard dumpster of trash and debris removed from the property. Armed with hand tools and bolstered by some powerful equipment, the crew tackled prickles, invasive plants, and overgrown bushes that had swallowed the historic farmhouse.

“The energy today was incredible,” said Liza Moran, President of the Dudley Conservation Land Trust. “At DCLT, we believe that stewarding our land is a sacred duty and one of the most important parts of our



mission. Restoring the area around the historic farmhouse and clearing existing trails is a wonderful way to celebrate one of our newest sanctuaries, Antos Farm, as

we approach its centennial milestone this October.”

The October event is not just a commemoration of 100 years but also a celebration of the land trust’s ded-

icated efforts in acquiring and conserving this hard-won property. Thanks to the team’s hard work, preexisting trails on the sanctuary are now significantly more

accessible for future public use. Volunteers cleared low-hanging branches, removed tripping hazards, and mapped out key paths for future visitors.

“We had a massive amount of work to do today, but our stewardship volunteers jumped right in to tackle it,” said Vice President Heather Radcliffe, who organized the event and its extensive to-do list. “From the youngest participants, eager to help, to seasoned volunteers who shared their expertise, it was truly a collective effort.”

As the celebration approaches, the Dudley Conservation Land Trust is looking forward to showcasing the beauty and significance of Antos Farm in this local wildlife corridor, offering a space where people can connect with nature and appreciate the legacy of conservation.

This stewardship day marks the beginning of a long-term effort to restore the sanctuary’s natural habitats and historic features. The community is invited to visit the land trust’s website to RSVP for the Oct. 3 celebration, which will kick off with a short, pre-celebration hike along the newly cleared trails.

Dudley sets Sept. 29 special election on public safety funding, school capital improvements

DUDLEY — Dudley voters will head to the polls on Tuesday, September 29 to decide three ballot questions that will determine the future of the town’s public safety services and school capital improvements.

Two separate special elections will be held concurrently that day from 11 a.m. to 7 p.m. at the Dudley Municipal Complex, 71 West Main St., with Dudley voters receiving two separate ballots.

The Dudley-Charlton Regional School Committee has called a district-wide special election in both Dudley and Charlton seeking voter authorization for a borrowing associated with proposed capital improvements.

Separately, the Dudley Board of Selectmen has called a special town election for the same date,

time, and polling location. The Town ballot will seek voter approval for funding to support Police, Fire, and Highway services and will also ask voters whether to approve a Proposition 2½ Debt Exclusion to fund Dudley’s share of the borrowing sought through the district-wide special election.

Together, the two ballots will present Dudley voters with three questions:

- The Dudley-Charlton Regional School Committee seeks approval to borrow \$11,183,735 for capital improvements. Dudley’s obligation would be \$5,018,583.

- The Dudley Board of Selectmen seeks voter approval to override the limits of Proposition 2 ½ to assess an additional \$717,630 in taxes to fund public safety for the current

fiscal year.

- Selectmen also seek approval for a Proposition 2½ Debt Exclusion to fund Dudley’s \$5 million share of the school district’s capital borrowing, if it’s approved by voters.

Both Proposition 2½ questions would raise taxes in Dudley: the debt exclusion would be temporary for the life of the school borrowing; the override would be permanent.

Town Administrator Jonathan Ruda said the two local ballot questions serve different purposes but are closely connected.

“The two local questions are legally separate, but they should also be considered together,” he said. “It is important that voters understand how the

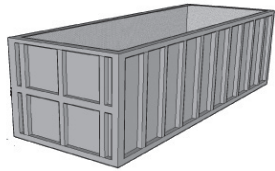

Caring for the land that outlasts us

There is something fitting about beginning the next chapter of a century-old Dudley farm with work gloves, hand tools and a dumpster.

At Antos Farm on Marsh Road, 20 volunteers recently spent a hot summer day doing the decidedly unglamorous work that conservation requires. They cleared trails, cut back invasive plants and overgrown brush, removed debris and began reclaiming the historic farmhouse from vegetation. By the end of the day, they had filled a 15-yard dumpster.

It would be easy to look at such a workday simply as cleanup. What happened at Antos Farm, however, represents something considerably larger.

The property is one of the newest sanctuaries of the Dudley Conservation Land Trust, and this first stewardship day offered a reminder that preserving land does not end when a deed changes hands or conservation protections are secured. In many ways, that is when the responsibility begins.

Protected land needs people willing to care for it.

That means maintaining trails, addressing invasive species, protecting wildlife habitat and making thoughtful decisions about public access. At a property such as Antos Farm, it also means respecting the human history that exists alongside its natural history.

Those responsibilities can extend for generations.

That is what makes the timing especially appropriate. Antos Farm will mark its 100th anniversary with a community celebration Oct. 3, beginning with a hike along the trails volunteers have been working to reopen.

A centennial naturally encourages people to look backward, but the more important question may be what happens during the farm’s second century.

Dudley is fortunate to have landscapes that still tell something of the town’s story. Farms, forests, stone walls, wetlands and old homesteads provide connections to earlier generations while also serving very modern purposes. Conserved properties can protect wildlife corridors and habitat, preserve open space and give residents places to walk, explore and experience the natural world close to home.

Once those places disappear to development, they are extraordinarily difficult, and often impossible, to recover.

That does not mean every undeveloped acre must remain untouched. Communities need homes, businesses and economic growth. The challenge is ensuring that growth occurs without sacrificing every piece of the landscape that gave a town its character in the first place.

Local conservation organizations play an important role in maintaining that balance.

The volunteers at Antos Farm demonstrated another important part of conservation: Community ownership does not necessarily mean municipal ownership. A community can take responsibility for a place simply because residents decide it is worth protecting and are willing to contribute their time toward that goal.

There was something particularly encouraging about seeing volunteers of different ages working together. Experienced hands brought knowledge, while younger participants brought energy and the possibility that stewardship will continue long after today’s volunteers have put away their tools.

A hundred years from now, nobody is likely to remember who hauled which branch, cleared which section of trail or helped fill that dumpster.

They may, however, still have Antos Farm.

That is the value of stewardship. Much of the work is temporary. The responsibility is not.

A carousel, a doll and a peacock: Auburn ice cream shops, Part 2

When you think of a carousel, wooden horses bouncing up and down may come to mind. In Auburn’s history Carousel also means ice cream and good food. The Carousel Dairy Bar was a popular place in town to get some good ice cream. It was located at 750 Oxford St., at the corner of Washington Street. It was originally owned by Michael Deliso and his wife, Frances, who bought land in Auburn in 1949. They originally had a house and garage, but by 1951, a store was listed on the property.

In 1956, there was a restaurant located on Washington Street next to their house, but no garage was listed on the property tax. Michael and Frances Deliso lived in a house next door to the Carousel Dairy Bar until they sold the house and it was moved to Goulding Drive. In 1957, a boat store appeared along with the restaurant, so you could buy a boat then celebrate with and ice cream cone. The 1961 tax records show that the Deliso’s bought a house on Bryn Mawr Ave and still owned the restaurant but no store. The restaurant finally disappeared in 1966 when Interstate 290 was being built in Auburn. The location is where the ramps are off Route 20. The Carousel touted the best in ice cream, fountain service of ice cream sodas, jumbo frankfurters and hamburgers, sandwiches, fried clams and French fries. A longtime resident remembers it was also a school bus stop. Some Auburnites who worked at the Carousel Dairy Bar included George Lamb, Betty Gaines, and George & Louise Jewell Sr. in the early 1950s. In the mid-’50s, he said it was run by a very large man called “Tiny.”

There was another unique place to get ice cream that eventually wound up in a museum. According to a 1999 article, it was manufactured by the Worcester Lunch Car Company about 1940 and was in operation in Medford for ten years. It was then moved to Worcester and was found at the corner of Commercial and Foster Streets. When the Centrum was being constructed the diner was moved to a salvage yard. That’s where John P. Tighe bought the Sherwood’s Diner in the 1970s for a whopping \$500. He renamed it the Dairy Doll and it was placed between Colony Package Store and Cantwell Hardware Store. John said he bought it because he was a bricklayer and ate many meals in diners so owning one brought back many memories. The diner also served hamburgers and other food fare. The Dairy Doll was donated to The American Diner Museum of Providence in 1999 by John Tighe. It cost more to move it than it did to buy it.

The 1948 Auburn High School yearbook had an ad that said Harlow’s Dairy Bar at Drury Square was the place to sit down with books and French fries. A person could get a 5-cent vanilla coke to go with the ice cream and fries. This place was owned and run by Leslie Harlow and his wife, Clarice. Leslie spent most of his early life working with candy and snacks. The 1900 census has him as a wrapper in a popcorn factory at the age of 18. His World War I draft card stated he was employed at the Harlow Quality Kiss Company, 269 Main St. in Worcester and so it was stated also in the 1920-1950 census. He married Clarise Farwell in 1906 and she was by his side helping at Harlow’s and carried on after he died in 1963. There were many name changes through the years with the last one being the Peacock Club. It was eventually owned by Mark Sarkisian and provided many years of entertainment on Fridays and Saturdays, so say the many ads. This aspect of the Peacock Club will be explored at a later date.

Building your child’s education fund, one brick at a time

Every solid house starts with a good blueprint and a strong foundation. Saving for a child’s education is very similar.

College costs can seem daunting. In addition to tuition, you’ll need to account for housing and food, books and supplies, transportation and other expenses. The average annual budget at an in-state public university runs around \$30,990 today, and a private school is \$65,470 according to the College Board. While most families won’t pay a college’s list price, you’ll still want to start saving as early as possible to be ready when your child is.

Lay the foundation early. You don’t have to wait until you have the perfect set of plans to start building. There are specific accounts designed to save for education and some do not require a minimum opening deposit. Setting up automatic recurring contributions, even modest ones, lets you build steadily over time without requiring constant attention.

As your child ages, look for ways to redirect expenses you no longer have towards the build. For example, daycare costs, which can exceed \$1,000 a month, can be shifted into a college savings account once your child enters school. Tax refunds and annual bonuses make excellent additional contributions. And others can pitch in – instead of birthday or holiday toys, ask grandparents or relatives to contribute directly to a college savings account.

Know the size of the house you’re building. Families saving for community college followed by two years at a public university might target around \$65,000. Those aiming for four years at a public school are looking at roughly \$100,000. Whatever the goal, plan for education inflation of about 4% annually, which can roughly double costs over 18 years.

You don’t have to source all the building materials yourself. Scholarships, grants, student loans and income from part-time work are all legitimate ways to help finish the structure.

Don’t let one project consume the whole budget. One risk for parents is pouring so much into the college fund that the retirement fund goes neglected. Remember, loans and grants exist for college, but not for retirement. A common expression for difficult topics learned over a period of time is “the learning curve.” It’s hard work sometimes, and certainly can be tumultuous. We the people who make up the electorate in America have been involved in a 10-year duration learning curve with regard to how our democracy was designed to work vs. how it is actually working.

A good example of a very public learning curve has been demonstrated by the people of Hungary. Hungary was a mature democracy, that fell prey to a slow creeping authoritarian regime over a long period of 16 years. Taking note of the good people of Hungary’s playbook, the time has come to reclaim our sanity beginning in November, when our duty to vote is most warranted. The long healing period of restoring our democracy will begin when our elected representatives are once again empowered to represent us all in defiance of any authoritarian influence.

When everything started beeping

I miss appliances that knew their place. The toaster toasted. The washing machine washed. The refrigerator kept things cold. None of them had anything to say about it. Somewhere along the way, however, the appliances in our lives discovered communication. Now everything beeps.

Our washing machine beeps when it finishes. It beeps wrong button. Sometimes things that remain between the machine and its maker. There may be the worst offender. The microwave finished its job, it rang a bell. One ding.

The modern microwave apparently believes that unless I retrieve my coffee immediately, civilization may collapse. Beep. A little while later, another beep. Then another. Yes, microwave. I know. I put the coffee in there.

There is something mildly irritating about being nagged by an appliance you purchased. It isn't only the noise. Everything now has settings. Our old washing machine had a knob. You turned it. The machine started. That was essentially the entire relationship.

Today's machines have buttons for temperature, soil level, spin speed and enough specialized cycles to make me wonder whether I've been washing clothes incorrectly for 50 years. Normal. Heavy duty. Delicate. Quick wash. Bedding. Towels. Whites. Apparently, towels have needs.

I recently stood in front of the washing machine holding a perfectly ordinary pile of clothes and realized I was being asked to make more decisions than I wanted to make before breakfast.

I selected "normal." I select "normal" for almost everything. Normal has gotten me this far.

Our television is another matter entirely. There was a time when televisions had an on-off switch and a channel knob. If the picture wasn't good, you adjusted the antenna. If that didn't work, somebody stood beside the television holding the antenna.

This was our first wireless technology. Now the television has several remotes, numerous menus and an occasional habit of announcing that it cannot find something called an "input." Neither can I.

I have learned that when the television stops working, the safest strategy is to avoid touching anything. The temptation is to start pushing buttons. This is how a minor television problem becomes an evening project.

One wrong selection and suddenly the screen is displaying a menu last seen by the engineer who designed the television. My wife will eventually ask what I did. "Nothing." This is rarely true.

Technology has improved our homes in countless ways, of course. Modern appliances are more efficient, more capable and often safer than what we grew up with. But I sometimes wonder whether every object really needs to be quite so clever.

I don't need my refrigerator to connect to the Internet. I don't need an app for my light bulbs. I certainly don't need my dishwasher sending notifications. There are already enough people and organizations trying to contact me. I don't need to hear from the dishwasher.

Maybe this is simply what getting older looks like. Every generation eventually encounters technology that makes it wonder why the old way wasn't good enough. My grandparents probably said the same thing about automatic transmissions. Still, I think there should be a market for appliances designed specifically for people like me. One button. It would be large. The instructions would read: "Push this."

And when the appliance finished doing whatever it was supposed to do, it wouldn't send a notification, connect to Wi-Fi or play a cheerful little melody. It would simply stop. If I wanted to know whether it was finished, I could walk over and look. I still remember how to do that.

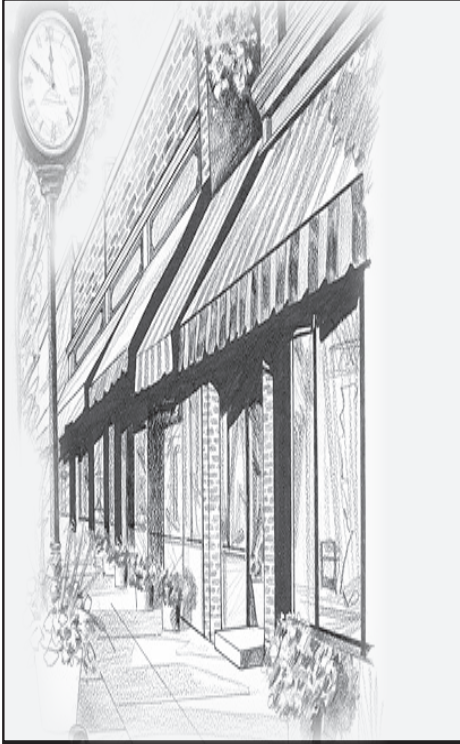

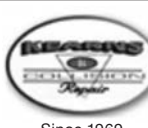

outcome of one question affects the financial impact of the other.”

The \$717,630 override, he said, provides the recurring revenue necessary to maintain current Police and Fire service levels, and restore cuts to the Highway Department, thereby helping to avoid future layoffs, position reductions, and corresponding cuts in public safety and essential services as operating costs continue to rise.

The debt exclusion, he said, provides separate funding for Dudley’s share of the school district’s capital borrowing. If the school district’s ballot question is approved but the debt exclusion is not, the Town would be legally obligated to pay the \$5 million from its municipal operating

budget. Those payments would compete with funding for every town department including police, fire, and highway, even if the \$717,630 public safety override were approved.

“Absorbing the school debt into the operating budget would eliminate the benefit of that additional override revenue and could require further budget reductions to maintain a balanced budget,” Ruda said.

The proposed \$717,630 override

The new proposal is significantly less than the \$1.9 million override rejected by voters in June.

Board of Selectmen Chairman Christopher Starczewski said there’s a fine balance in bringing back an override after voters rejected one in June. That balance, he said, is to respect the vote in June

while giving residents a say in determining the final budget cuts.

“The Town of Dudley is rich in identity and experience; without the support for the override, Dudley will be faced with a shift in that identity with a certain reduction of services,” he said.

Ruda noted the town is not attempting to revisit the June vote but is instead presenting a more limited request focused on preserving frontline Police, Fire/EMS, and Highway services.

Ruda said the proposed override would fund:

- Two firefighter/paramedic positions and associated benefits (\$252,487.46)
- Two police officer positions and associated salary and benefits (\$311,533.54)
- Highway Department operations, including two driver/laborers, overtime, road maintenance, tree

removal, traffic painting, snow removal, equipment, and tires (\$153,609.16)

Ruda said the proposal is intentionally limited and would not:

- Restore stabilization funds used to balance the FY2027 budget.
- Reinstate other departmental requests or eliminated positions.
- Fully fund departmental accounts that remain below requested levels.
- Resolve the Town’s broader structural financial challenges.

“The Police and Fire amounts cover the full cost of retaining these positions—not just salaries, but required health insurance, retirement and other employment costs. Those costs have been major budget drivers and including them gives voters an honest picture of what it takes

to preserve the positions,” Ruda said.

School District capital improvement borrowing The Dudley-Charlton Regional School Committee is seeking voter approval to borrow \$11.18 million for capital improvements across all seven district schools.

Projects include drainage and water filtration improvements, replacement of an aging phone system, information technology upgrades, re-keying building locks, window and door improvements, carpet replacement, paving and walkway improvements, and a backup generator purchase and installation.

Dudley’s share of the borrowing is \$5 million, with Charlton voters considering the remaining share in a concurrent district-wide election.

A simple majority of the

combined ballots cast in both Dudley and Charlton will decide the question.

Proposed \$5 million debt exclusion

If the school district’s request to borrow \$11.18 million is approved by voters on September 29, the debt exclusion would temporarily raise taxes to pay Dudley’s share of the debt until it is retired.

This year, Deb Horan, owner of Booklovers’ Gourmet, has chosen a poem, The Red Wheelbarrow by William Carlos Williams. She says, “I was inspired by this simple, descriptive poem of everyday objects and setting that asks us to just stop and observe our surroundings.” We can’t wait to see how she will translate this into a visual form through flowers.
