Charlton Lions Club & Overlook Tree Advisory Committee join forces

CHARLTON — The Charlton Lions Club and The Overlook Independent Living Tree Advisory Committee will join forces in April to improve their town. The two groups will host a booth at Charlton’s Earth Fest, 11 a.m. to 2 p.m., on Saturday, April 25 on the Charlton Town Common where they’ll give away 100 sweetgum trees. As they do each

year, the Lions will also participate in the town’s roadside cleanup effort, which starts at 8 a.m. and the trees will be available at that time. Each small sweetgum tree will come with instructions for planting and caring for it as it grows. Sweetgums (Liquidambar styraciflua) are large, decorative deciduous trees native to eastern North America.

Their star-shaped leaves turn red and gold in the fall. The baby trees will be given to the first 100 Charlton residents who commit to planting and caring for the trees on their property. The trees will be donated by Bartlett Tree Experts. The Overlook Tree Advisory Committee

is comprised of residents and staff of the Independent Living community as well as representatives of Bartlett Tree Experts and Babe’s Landscape & Construction. The Committee’s mission is to advise on ways to protect and maintain the trees on The Overlook

Campus and to educate the community about trees and the importance of trees to our environment and well-being. Through the work of the Committee, The Overlook was recently named a Tree Healthcare Campus by the Arbor Day Foundation. One focus of Lions

Clubs International is protecting the environment to create healthier communities and a more sustainable world. The worldwide service organization encourages planting and caring for trees to contribute to cleaner air as part of their mission.

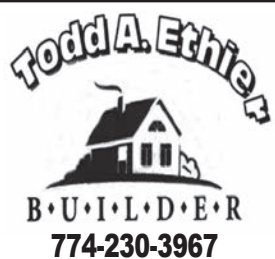

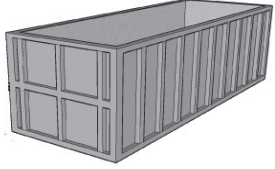

Planting
something that lasts

On a spring Saturday morning in Charlton, residents will have a chance to carry home something small that promises to grow into something lasting.

The Charlton Lions Club and The Overlook Independent Living Tree Advisory Committee plan to give away 100 young sweetgum trees during Earth Fest on April 25 at the Town Common. The effort will take place alongside the annual roadside cleanup, another familiar sign that winter has loosened its grip and the season of renewal has begun.

It is easy to think of tree giveaways as modest gestures. A sapling fits easily in the trunk of a car. It can be planted in an afternoon. Yet the value of planting a tree stretches well beyond the moment when the shovel first breaks the soil.

A tree planted this spring may shade a front yard for decades. It may soften the edge of a busy road, cool a neighborhood during the heat of summer, or provide a splash of color each fall. It may become part of a child’s memory of home. In time, it becomes part of the town’s landscape itself.

Efforts like this one show how local organizations quietly shape the character of a community. The Lions Club has long been associated with hands-on service, whether through roadside cleanup, public events, or support for residents in need. The Overlook Tree Advisory Committee brings another perspective, combining environmental stewardship with education and the experience of residents who understand the long view of community life.

There is something especially fitting about that partnership.

Older residents helping guide the planting of trees that will mature long after today’s volunteers have stepped back from public roles is a reminder of how towns endure. Communities grow stronger when generations work together on projects that benefit people they may never meet.

The choice of sweetgum trees adds another thoughtful touch. Native to eastern North America and known for their distinctive star-shaped leaves and brilliant fall color, they offer both beauty and ecological value. They also reflect a broader understanding that environmental stewardship is not only about protecting distant forests or faraway coastlines. It begins at home, one yard at a time.

Charlton’s recognition of Earth Fest as a moment for action rather than simply observation deserves notice as well. Pairing a tree giveaway with roadside cleanup turns a symbolic day into a practical one. Residents are not only talking about the environment. They are improving it.

Perhaps most important, the trees come with a simple expectation. They will be given to residents who commit to planting and caring for them.

That small promise carries weight. A tree survives only if someone waters it, protects it, and gives it the chance to grow. In that way, the effort reflects something true about community life itself. The places people value do not stay healthy on their own. They thrive because someone chooses to care for them.

A hundred trees will not change Charlton overnight. But they will change it gradually, quietly, and permanently. Years from now, when those leaves turn red and gold each autumn, they will stand as living reminders of neighbors who chose to invest in the town’s future one planting at a time.

Ask these two questions before buying a home

The bulletin board by the door

Just inside the entrance of our town library, there’s a bulletin board that most people walk past without really noticing.

I try not to be one of them. It’s not much to look at. A sheet of cork. A scattering of pushpins. A collection of flyers printed on everything from bright neon paper to the back side of what used to be someone’s grocery list. But if you stand there long enough and read what’s posted, you begin to understand something about the place you live that you might otherwise miss.

I stopped in last week to return a book and found myself lingering there longer than expected.

There was a notice for a spaghetti supper. A handwritten card offering piano lessons. A flyer for a church rummage sale with the date circled three different times in blue marker, as if to make sure nobody overlooked it. Someone had pinned up a careful request for help finding a lost cat. Another note announced a fundraiser for a neighbor going through a difficult stretch.

None of these things would make big headlines. But together they told a story.

It struck me that the bulletin board might be the most honest page in town.

Nobody is trying to impress anyone there. The paper curls at the corners. The tape never sticks quite right. Some notices are printed neatly at home, others written in block letters with a felt-tip marker. Every one of them represents somebody who decided to reach out instead of keeping quiet.

That still means something.

Years ago, before everything moved onto screens, those bulletin boards were how people found out what was happening. If you wanted to know when the pancake breakfast was scheduled, or who was collecting coats for winter, or whether someone was offering snow shoveling for a few dollars after school, that’s where you looked.

I suppose today most of that information can be found online. But I’ve noticed that the bulletin board still fills up anyway.

I don’t think that’s an accident. There’s something reassuring about seeing those little pieces of paper pinned up in a real place where real people walk past them. It reminds you that the town is still paying attention to itself. It reminds you that neighbors are still asking for help and still offering it.

One flyer announced a community clean-up day along a stretch of roadside I drive past all the time. I had no idea it was happening. Another advertised a local concert I might otherwise have missed entirely. A third simply said “Volunteers Needed,” followed by a phone number and a hopeful-looking smiley face drawn in pen.

Someone clearly believed someone else would call.

What I admire most about that board is how ordinary it is. Nobody gets paid to maintain it. Nobody organizes the colors or straightens the corners. It grows and changes week by week, quietly reflecting whatever the town happens to need at the moment.

In a way, it feels like a conversation that never quite ends. Sometimes I think those boards are small acts of trust. A person puts something up there believing that someone else will read it and care. That’s not a grand gesture. It’s not dramatic. But it says a lot about the kind of place we live.

We still expect each other to notice.

On my way out of the library, I stepped back and looked at the board again before heading through the door. I didn’t take down any phone numbers. I didn’t sign up for anything that day. But I left with the quiet feeling that the town was doing what it has always done best, which is keeping track of its people in simple, steady ways that don’t require much explanation.

Prayers were offered in multiple languages, including Swahili by Michael Kamangu (Grade 5), Polish by Amadeusz Gacek (Grade 6), Gaelge by Mia Reed (Grade 5), Arabic by Ariel Corbin (Grade 5), Spanish by Hayley Benes (Grade 8), Greek by Giorgios Sgouritsas (Grade 6), and English by Cecilia Coan (Grade 5). Hymns including “Save Your People, O Lord,” “Your Only Son,” “One Bread, One Body,” “Bread for the World,” and “From a King to a King” resonated throughout the basilica and added to the reverent and joyful atmosphere.

The Mass concluded with a special presentation to Bishop McManus by Student Council President Mychael Jones and Vice President Tenleigh Dowd, a heartfelt moment that reflected the gratitude and leadership of the students.

Following the Mass, students gathered with the bishop for a commemorative photo, capturing the joy and spirit of this meaningful occasion.

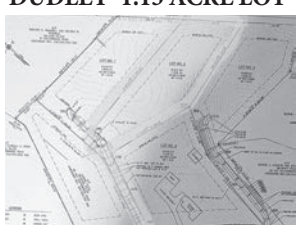
