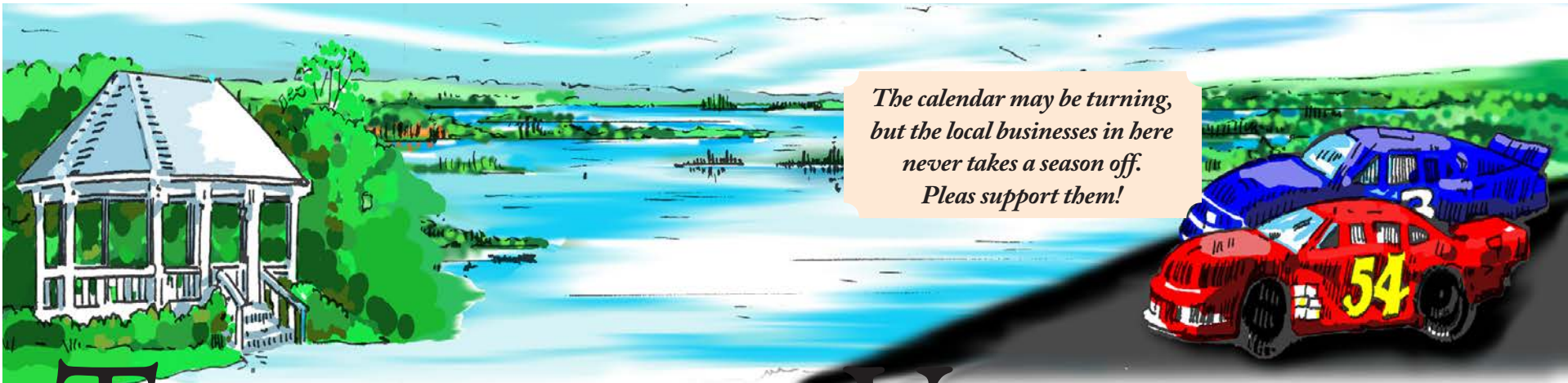

## Community rallies behind Congregational Church of Putnam after ceiling collapse

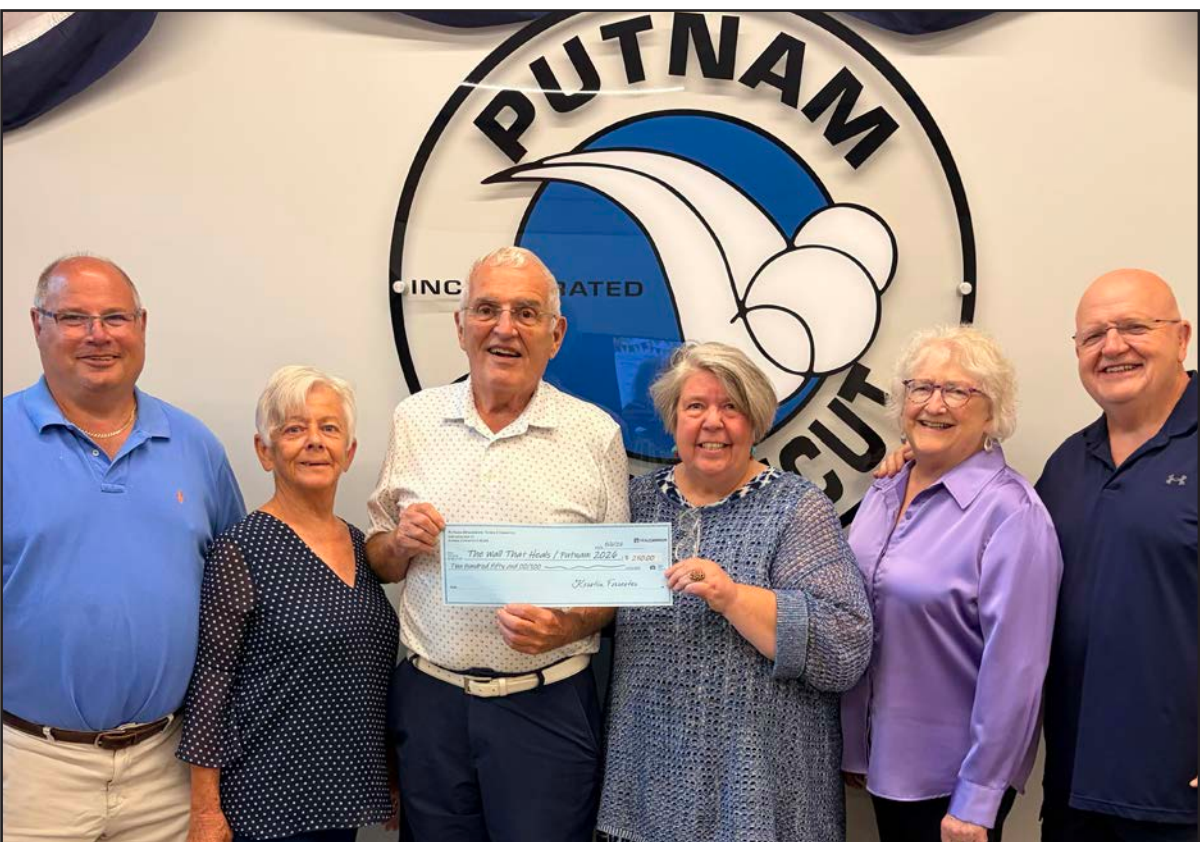

PUTNAM — “The building is not the church” has become a defining phrase of resilience for a local congregation after their church’s ceiling fell in, damaging one of Putnam’s most iconic downtown landmarks.

On the outside, the Congregational Church of Putnam looks normal as ever - a shining beacon of hope and strength where many have come and gone to embrace their faith, and many more have visited to enjoy meals, fundraisers, and craft fairs in downtown Putnam.

Inside, however, are the remains of an unfortunate

## Local schools receive first wave of High-Quality Special Ed Incentive grant funding

REGION — The Northeastern CT Chamber of Commerce is pleased to announce that Kelly Bellavance has been selected as the organization’s next Executive Director. Bellavance brings more than 20 years of experience in higher education, leadership, relationship building, small business ownership, and community involvement to the role.

Bellavance was selected following a comprehensive search and interview process led by the Chamber’s hiring committee and Board of

REGION — Three local school districts have been named as recipients of funding through the first round of the High-Quality Special Education Incentive Grant Program.

Brooklyn, Putnam, and Thompson will each receive money to help support their special education programs through the competitive grant. Brooklyn will receive \$146,159, while Putnam and Thompson will receive \$315,000 and \$156,422, respectively.

The High-Quality Special Education Incentive Grant Program, administered by the Connecticut State

Department of Education, was created through an act of the Connecticut General Assembly to help local and regional education boards build in-district and regional special education services according to a release from Gov. Ned Lamont’s office.

In the press release announcing the recipients, Lamont focused on the value and importance of investing in these programs to help districts accommodate all students regardless of their specific educational needs.

“It is important that school districts have the resources to support special education programming that allows more students to

learn alongside their peers in their own communities,” Lamont said.

“Over the last several years, special education services have been one of the largest cost drivers for school districts due to the increase in the number of students eligible for special education services and the rapid increase in the cost of those services, particularly for students outplaced in approved special education programs,” he continued. “This increased investment supports our municipalities and our students with special needs.”

The first round of the new grant committed \$10.6

# Back-to-school spending: Does consumer sentiment make the grade?

Back-to-school shopping lists are more than a seasonal ritual; they’re also a real-time read on how households are weighing two competing forces this year: the squeeze of inflation and the lift of a strong market.

While estimates for back-to-school shopping are wide-ranging, at WHZ we’re optimistic that spending will increase again this year. Most consumers are employed, and stocks have been in a bull market for almost four years. School goods aren’t immune from inflation, which will make this year’s purchases more expensive, but sales should attract buyers. Judged by Amazon’s Prime Day, consumers are ready to spend, especially when there’s a bargain to be had. Prime Day sales, which ran from June 23 to June 26, rose 9.3 percent, according to data from Adobe.

A National Retail Federation (NRF) survey found that consumers plan to spend a record \$43.3 billion on back-to-school goods for those in grade school, a 9.9 percent increase from last year and surpassing the prior high of \$41.5 billion in 2023. Spending is expected to increase on shoes,

Back to school means shopping

Now that the dog days of summer are in the rearview mirror and kids are returning to school, it’s time to go shopping for sneakers that fit and crayons that are sharpened. In recent years, back-to-school shopping has been spread over more weeks as families take advantage of sales.

Early birds tap into Amazon’s

Prime Day shopping specials in June, and procrastinators race to the stores in late August or early September. Estimates for back-to-school shopping run the gamut—from down 17 percent to up 10 percent. We’re optimistic that spending will be relatively strong because unemployment is low and Amazon’s Prime Day sales were strong in June.

Let’s take a look at what may influence this year’s back-to-school shopping season.

Survey says: More spending this year

A National Retail Federation (NRF) survey found that consumers plan to spend a record \$43.3 billion on back-to-school

goods for those in grade school, a 9.9 percent increase from last year and surpassing the prior high of \$41.5 billion in 2023. Spending is expected to increase on shoes, school supplies, and electronics. Spending on college students is expected to be even stronger, rising 16.6 percent to a record \$103.5 billion, with strong spending on electronics, dorm décor, and clothing.

Not everyone is optimistic. A NerdWallet back-to-school survey found that shoppers plan to spend 17.5 percent less this year vs last year. A quarter of respondents said they plan to pull back because higher costs of living have squeezed budgets, and 62 percent plan to seek out sales, up from 52 percent last year. A Deloitte survey found consumers plan to spend the same amount this year as they did in 2025.

The divergent results may be due to the survey respondents’ income levels. JLL’s survey found that back-to-school budgets rose by an average of 11.7 percent this year, but those earning less than \$50,000 plan to increase spending by only 3.8 percent, while those earning between \$50,000 and \$150,000 plan to boost spending by 20.7 percent, and those with even higher incomes expect to spend 14.4 percent more this year.

Reason to stay optimistic

We expect back-to-school spending to be robust because sales rose 9.3 percent during Amazon Prime Day, which ran from June 23 to June 26, according to data from Adobe. Amazon has successfully turned its annual sale into a major event, with \$26.4 billion spent over the four days. That rivals the \$32.5 billion spent from Black Friday through Cyber Monday last year. Amazon’s impressive Prime Day results are even more impressive now that Walmart and Target have launched their own competing sales events.

We’re hopeful consumers will continue shopping because the job market remains healthy. With the July unemployment rate at only 4.1 percent, the vast majority of consumers are pulling in a paycheck. Meanwhile, consumers who invested in the stock market are sitting on multiple years of strong gains.

We’re certainly mindful of the impact of inflation, which continues to run north of 3 percent. With prices rising broadly, it’s tough for some families to stretch their incomes. Looking for sales will no doubt be part of the back-to-school shopping equation.

This year artificial intelligence (AI) may play a role in helping families stay within their budgets. Seventy-three percent of parents surveyed by PwC said they plan to use AI to help research, compare, budget, or find deals. We’ll be watching to see how this new tech tool helps parents track down all the items on their kids’ wish lists.

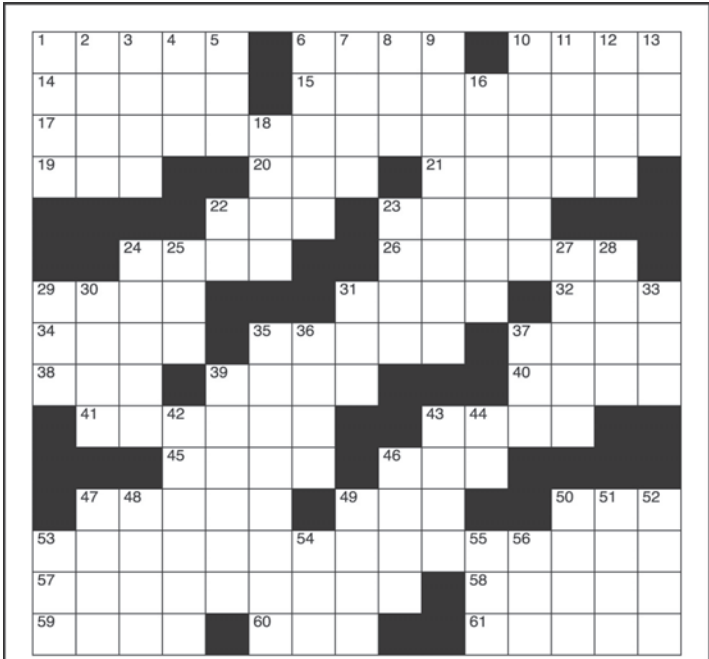

# A church is more than its walls

There are certain buildings that become inseparable from the identity of a community.

The Congregational Church of Putnam is one of them. Its familiar presence downtown represents generations of worship, weddings, funerals, community meals, craft fairs, fundraisers and gatherings. Even those who have never attended a Sunday service likely recognize the church and understand that it occupies an important place in Putnam.

That is why the Aug. 7 collapse of the ceiling into the sanctuary was more than a maintenance problem. The photographs of wood, dust and debris scattered across a room normally associated with worship and celebration were difficult to see.

Fortunately, nobody was injured. Buildings can eventually be repaired. That fact alone is something worth remembering as the congregation confronts what could be a lengthy and complicated recovery.

Yet perhaps the most important lesson to emerge from the collapse was expressed by the Rev. Pamela Briddle herself: “The building is not the church. We are.”

Those words could apply to many of the institutions that hold small communities together.

Buildings matter. They give organizations a home and communities landmarks around which memories accumulate. A church sanctuary where generations have celebrated Christmas, mourned loved ones and watched children grow up cannot simply be replaced by another room with four walls and a roof.

But an institution ultimately survives because of its people. That became evident remarkably quickly following the collapse. Only days later, members of the Putnam congregation gathered at Fort Hill Farms with the Thompson Congregational Church. The joint service had been planned before the Aug. 7 incident, but circumstances gave it considerably greater meaning.

Members of the Thompson church understand something about suddenly losing access to a cherished spiritual home. Their own congregation endured a devastating fire in 2016. There was something fitting about these two congregations worshipping together as Putnam began facing its own period of uncertainty.

There was also a broader lesson in the response. When something goes wrong in a small community, people frequently discover connections they did not realize existed until they need them. Offers of assistance arrive. Organizations share space. Neighbors ask what they can do. People who might ordinarily encounter one another only in passing suddenly find themselves working toward the same goal.

Putnam Town Hall and Community Center has now become part of that response, with the congregation announcing plans to hold services in its large meeting room for at least four weeks beginning Aug. 23.

It will not look like the sanctuary. It does not have to. What matters during these next several weeks and months is that the congregation continues gathering while those responsible for the building determine what must be done to make it safe again.

There are still significant questions ahead. There is no announced timeline for reopening. Repairs to a historic and prominent building can be complicated, and the extent of the work required will determine what comes next.

There is little value in pretending that those challenges will be easy. There is considerable value, however, in recognizing what has already survived.

The congregation remains together. Its neighbors have responded. Another church has stood beside it. The town has provided a temporary place to gather. Most importantly, no lives were lost when the ceiling came down.

Briddle told her congregation that the future does not have to be figured out all at once. That is sensible advice far beyond the walls of a church.

Large problems are rarely solved in a single moment. Communities address them one inspection, one decision, one contribution and one act of generosity at a time.

Someday, the hope is that people will again walk through the doors of the Congregational Church of Putnam and gather beneath a restored and safe ceiling. When that day comes, the building will undoubtedly mean even more to those who return.

Until then, the congregation has already demonstrated something important.

A ceiling can fall. A sanctuary can close. The church can carry on.

### Human dignity in a time of tyranny

To the Editor:

Any political system that treats human beings as expendable must be rejected, and instead, we must rededicate ourselves to a society that protects human well-being and human dignity everywhere. No political leader should be permitted to reduce others to a lesser status in which they are deemed unworthy of food, water, safety, or kindness.

Our survival depends upon empathy and compassion because these qualities are the foundation of civilization itself. It is no coincidence that allies of the current administration disparage empathy and call it a “weakness.” By discrediting empathy, those in power hope to prepare people to accept the gross mistreatment and even annihilation of those deemed troublesome or expendable.

We have seen this process before, and we appear to be seeing it again. Today, however, the consequences extend beyond a country, continent, or community. Tyranny renders human lives expendable even as it assumes no responsibility for future generations or the environment upon which all life depends. Our escalating global climate crisis is the ultimate test of our current political values, and we are failing that test badly.

George Orwell understood the political machinery of power. In “1984,” he writes that those in power seek only one thing: more power. They surveil and control the population, corrupt lan-

guage, dominate the media, and compel people to deny the evidence before their eyes. Deprivation, humiliation, and disinformation make people fearful and angry. Into this mix, tyranny presents itself as a solution in the name of order and safety.

Today, those in power commit crimes against vulnerable people, especially children, that are almost impossible to imagine except for the pictures, eyewitnesses, and other records that make these crimes undeniable. Such crimes are the ultimate expression of heartless power over others.

What can be done? The possibilities are complex, but the problem is simple. Some people may prefer authoritarian certainty, political, religious, or both, to the difficult work of responsible democracy. But if we still hope to form a more perfect union, we can rededicate ourselves to a few basic ideas.

First, we must improve our critical-thinking skills so that we can recognize manipulation rather than repeat it. Second, we must confront the local expressions of global crisis by protecting our water, air, land, and other resources. Third, we must defend human dignity and reject every effort to dehumanize others. If it can happen to them, it can happen to you. At the heart of this is compassion, empathy, and the Golden Rule: do unto others as you would have them do unto you.

### Application for Plainfield trash plant must be opposed

To the Editor:

We strongly oppose the proposed solid waste recycling facility (“trash plant”) that Smart Technology Systems, LLC is seeking to develop on land between Norwich Road and Black Hill Road in Plainfield, CT. As lifelong residents of this community, we want to make everyone aware of the application that Smart Technologies has submitted to the CT Siting Council asking for a declaratory ruling. This declaratory ruling means Smart Technologies wants to bypass the full application/certification and public process, including an in person public hearing in Plainfield.

We urge everyone to oppose this application, and to oppose the declaratory ruling.

We also ask all state senators and representatives to support a change to state law so the Siting Council cannot put these projects in residential areas, and certainly not more than one per town! Plainfield already has the wood burning plant on Route 12. We believe it is unfair to the people of Plainfield to be forced to have another burn plant in our town.

The town of Plainfield did hold a vote on if the townspeople wanted the trash plant or not, and the results were an overwhelming 1,148 to 125 against the trash plant. Although this was a non-binding vote, the townspeople have definitely spoken!

This land is currently zoned residential for important reasons that should be respected and preserved. The proposed trash plant could have severe negative impacts on our community. Some of our concerns are below.

Health and environmental concerns:

Waste processing facilities are known to release particulate matter and potentially toxic chemicals that can harm respiratory health.

The proximity to residential areas puts families and the aquifer at direct risk of exposure to these pollutants

The proposed site is very close to Sugar Brook State Forest, threatening this protected natural area

Property value impacts:

Similar facilities have been documented to decrease surrounding property values for residents

Many residents, we included, have invested their life savings in their homes with the understanding that this area would remain residential

This financial harm would be imposed on homeowners who chose this location specifically for its

residential character

Quality of life degradation:

The facility would introduce constant industrial noise and odor to our peaceful neighborhood

Increased truck traffic would create safety hazards, especially for children and the elderly

Light pollution would disrupt the natural day/night cycles for both residents and wildlife

The possibility of mice and rat infestations is high around huge amounts of trash

Experimental technology concerns:

This facility would be the first of its kind in the United States, making our community unwilling test subjects

Without established operational history in our country, there is no reliable data on the long-term health and environmental impacts

Residents should not bear the burden of being the “guinea pigs” for an unproven waste processing technology

Environmental justice:

The land serves as a natural buffer between existing residential homes

Industrial development would permanently destroy this environmental asset

The zoning laws were established precisely to prevent these kinds of incompatible land uses from harming established residential communities. The current zoning designation as residential should be maintained to protect the character of our neighborhood, our property values, our health, and our environment.

We strongly urge everyone who is concerned about this project to contact your State Representatives and give them your feedback. Also, please contact the Siting Council by Sept. 6 at siting.council@ct.gov or 860-827-2935 to inform them of your opposition to Smart Technologies application and request for a declaratory ruling.

Hopefully we can collectively ensure this land in Plainfield remains zoned residential, protecting it from this industrial development. Please stand with us and the many residents of Plainfield who chose to live here because of its residential character and natural beauty.

PowerPoint presentation on Revolutionary Families of Northeastern Connecticut by Killingly Municipal Historian Margaret M. Weaver. Sponsored by the Putnam Public Library & the Aspinock Historical Society of Putnam. Margaret will talk about how the Revolution was affecting families here in the Quiet Corner. Have you heard about the House the Women Built? All are welcome.

Although I am busy researching my own Revolutionary program, I’ve been trying to attend many of the ones that are being presented here in Northeastern Connecticut in conjunction with America’s 250th anniversary. On Aug. 21, I had the pleasure of seeing a Revolutionary presentation by Danbury storyteller Mike Allen, former host of the podcast Amazing Tales About History. Given for LIR-QV, Mike spoke about significant Connecticut figures and Connecticut Battle Sites during the Revolution. Of course, he included Pomfret’s and Brooklyn’s own Israel Putnam. I loved the slide of Putnam riding his horse down steps in Danbury during the British attack on that community. Did you know that Putnam Memorial State Park in Redding, where Putnam had a winter encampment similar to Valley Forge in the winter of 1778-9, was the first such Connecticut park? The more venturesome among you might want to do a daytrip to the western part of the state to visit it.

Other significant Connecticut individuals whom Allen highlighted were Roger Sherman, who signed four Revolutionary era documents: the Continental Association of 1774, the Declaration of Independence, the Articles of Confederation, and the U. S. Constitution. Eastern Connecticut’s Samuel Huntington was born in what is now the town of Scotland. He lived in Norwich, was a signer of the Declaration of Independence, served as the first president of the United States under the Articles of Confederation, and later became the State’s governor. Noah Webster, considered the Father of American Scholarship and Education, published a simple textbook called the Blue-Backed Speller in 1783. “Originally titled ‘A Grammatical Institute of the English Language,’ this simple textbook sold tens of millions of copies and replaced British books in early American classrooms. He changed British spellings to simpler American forms, altering words like centre to center and colour to color.” (Noah Webster House). Jonathan Trumbull, of Lebanon, Connecticut, was the governor of Connecticut during the Revolution. Important meetings with Washington, Rochambeau, and other officers took place at his War Office which is now a museum. Nathan Hale of Coventry, Benedict Arnold of Norwich and New Haven, Major General David Wooster,

Don't be a bystander

To the Editor:

It's been a while since I've written, mostly because I'm remembering the words of American author Ambrose Bierce: "Speak when you are angry, and you'll make the best speech you'll ever regret." What to do with anger and frustration with some of my fellow citizens? So here is an effort to communicate something useful to someone who may read this letter.

How important is it to vote? Let's remember that earlier in our history—and who knows, maybe in future elections—our own people were beaten and sometimes killed for attempting to register to vote. If you did not hear of those historically documented tragedies in history or civics classes, you can still look it up now.

One of the most famous of these patriots was Georgia Congressman John Lewis, born into a family of impoverished sharecroppers. Sharecroppers farmed land owned by others and paid rent with a portion of the crops grown and harvested by their own labor, and could keep a small amount of the money when those crops were sold. The landowner took most of the proceeds, making it very difficult for sharecropping families to save enough to buy their own land or to afford food and basic supplies for themselves. So they borrowed from those landowners and often remained in debt.

John Lewis, inspired by the words and actions of Rev. Dr. Martin Luther King, Jr., managed to be educated and to graduate from the American Baptist Theological Seminary in Nashville, paying for his education by working campus jobs in exchange for tuition, room and board. His first job there was in the cafeteria cleaning large industrial-size cooking pots, later mopping and waxing administration building floors. This man knew how to work! By 1967, Mr. Lewis had completed his bachelor's degree in religion and philosophy from Fisk University. Is there a more "American" story we can imagine?

Mr. Lewis used his abilities to organize and to connect with people to be a key part of the 1963 poor peoples' March on Washington for Jobs and Freedom, with over 250,000 in attendance and ending with Dr. King's most famous "I Have a Dream" speech. This momentum, and the passage of the Voting Rights Act of 1965 (a year after I graduated from Killingly High School) offered hope for Black citizens to become part of the voting process, and therefore have real input on legislation and maybe even run for office. Can readers imagine being born here with many of your previous generations enslaved, but still risking violence and institutional obstruction of your constitutional right to vote? Or even to register to vote?

That was the world in John Lewis' South in 1965 when he was part of a 54-mile peaceful march to the Edmund Pettus Bridge on the way to the state capitol in Montgomery, Ala. These peaceful marchers were met with state troopers, and sheriff's posse members who used whips, tear gas and clubs to injure more than 50 of the marchers. John Lewis' skull was fractured. Federal troops, weeks later, gave protection as the marchers led by Dr. King completed the full march for Black voting rights, which was the law of our land.

Prior to this quietly courageous, although bloody, success, in June of 1964 (about the time that I graduated from Killingly High School), the Freedom Summer Voter Registration Campaign brought about 1,000 mostly white students from northern states to Mississippi. Of their own free will and out of their patriotic sense of right and wrong, these white students and activists worked alongside Black activists to help Black residents register to vote.

They were met with violent opposition by those whose job was to enforce laws. Instead, churches were burned, Black

residents were denied voter registration, the KKK terrorized the Black population, and among the tragedies of that summer were the brutal killings of James Chaney, Andrew Goodman and Michael Schwerner. James was a Black activist from Meridian, Mississippi; Andrew and Michael were white volunteers from New York City. They were murdered by "law enforcement" and buried underneath a dam. On the 41st anniversary of these murders the final participant, Klansman Edgar Ray Killen, was convicted (of manslaughter) and sentenced to prison—in 2005.

Other white people whose names are undoubtedly not noted in our history classes gave their lives during the 1964-65 voting rights campaigns in the South. I want to recognize them here also: William Moore, former Marine from Binghamton, N.Y.; Rev. Bruce Klunder from Cleveland, Ohio; Rev. James Reeb from Washington, D.C.; Viola Gregg Luzzo, housewife and mother of five children from Detroit, MI; and seminary student Jonathan Daniels from Keene, NH. All were brutally murdered during this effort.

This could be an even longer accounting of many others who gave their time, their hearts, and sometimes their lives to bring about voting justice for our most vulnerable citizens. (No, I will not address here the accusations of non-citizens in our state cheating and figuring out how to vote illegally. Maybe another time.) Further, a strong case can be made that our WWII veterans fought and died for us to keep the right to vote instead of blindly acquiescing to the lies and demands of dictators like Hitler and Hirohito. We do not have a democratic republic if any U.S. citizens are wrongly denied the right to register and vote. My dad, a Navy veteran, fought in the Pacific theater to keep my right to vote, and I will always remember that—every time I vote. There is still plenty of time to register to vote in the upcoming November election. There is plenty of time to find out who is running, what their stated priorities are, and to question them about how they expect to accomplish those priorities.

Don't be a bystander in these crucial times for our country. People died so that you can vote. Please honor their sacrifice and do your part to keep power with the people—with us.

Earth — Still recognizable, but different

To the Editor:

Ten thousand years ago, as the Stone Age was coming to an end and the traces of modern civilization were just beginning to form. the entire planet held only four million people, slightly larger than the population of Connecticut. The mass of humanity equaled less than one percent of the total mass of all vertebrate animals on the planet. We were significant, but still a small sliver of Earth's biodiversity.

Today, we add four million of us humans and an additional 1.5 million head of livestock to the planet every three weeks. Man and our domesticated animals now equal 96 percent of vertebrate animal mass on Earth—nearly the whole pie. In the competition Charles Darwin described as "the survival of the fittest," man is the ultimate victor. Gone are our closest competitors: Cro-Magnon man and Neanderthals, as well as countless other species. By the end of the 19th century, the great American buffalo herds that once numbered 50 million strong had been reduced to a few dozen. What remains today is a mere fraction of a fraction of what used to be.

The Earth has never seen as many humans as we have now. Once, after giving my multimedia presentation called Earth2026, someone in the audience correctly pointed out that the Earth's carrying capacity is actually greater than today's eight billion humans. Scientists generally believe the Earth can accommodate up to ten billion of us. We'll reach that mark in only 24 years, so we'll soon find out if their calculus was good.

I don't know if the calculus reflects humanity's ever-expanding ecological footprint, but I do know that things have changed dramatically since my parents were kids. Just one indication of that can be seen in our homes, which have doubled in size since the 1950s, when there were only 2.5 billion of us sharing the planet.

The explosion of consumerism in my own lifetime is equally astounding. With our relentless appetites for more, we continue to trade our planet's living environment for data centers, Amazon warehouses, and those ubiquitous self-storage facilities that 40% of Americans now rent to store the abundance of stuff that won't fit into their ever-larger homes. No doubt, we have more and bigger—of everything! But how much of nature can we afford to keep trading for it? And have these trades actually made us any happier?

I recently read that half of the Earth's trees and an even larger percentage of green space (wetlands, savanna, grassy

plains) have been removed from the Earth by man. In his remarkable film "A Life on Our Planet," Sir David Attenborough, now 100 years old, states: "Only 35 percent of Earth's wilderness remains." He ought to know. He's been documenting Earth's natural places for 75 years.

Recently, Elon Musk announced his plans for SpaceX and Tesla to collectively build the largest building on Earth, near Houston, Texas. The microchip factory, called Terafab, will have a footprint of nearly four square miles. Musk bragged (as billionaires like to do) that Terafab will be more impressive than Apple's headquarters and also worth a lot more. Terafab's microchips are to be used in Tesla's Optimus robots and self-driving cybercabs, as well as SpaceX's planned data centers. Doesn't that just make you feel even happier?

The Earth has been changed so dramatically by human activity that we may have to rethink our assumptions about its carrying capacity. In his remarkable book, titled "Eaarth" (an intentional misspelling of "Earth"), Bill McKibben writes that, due to human activity, "Earth has changed in profound ways, ways that have already taken us out of the sweet spot where humans so long thrived." He goes on: "The world hasn't ended, but the world as we know it has—even if we don't quite know it yet." Yes, our planet is still recognizable, but fundamentally different.

If we're not in the sweet spot anymore, where are we? According to Dr. Mathis Wackernagel, President of the Global Footprint Network, "rates of resource harvesting and waste generation deplete nature faster than it can regenerate." This means we are in a state of "ecological overshoot," and we don't know how long we can remain there before something really bad happens.

More people today are beginning to think about their own ecological footprint and how to make it smaller to help preserve our world. But few believe this shift is happening fast enough. I worry about what will remain of the Earth when my kids are grown and want a family of their own. Will Eaarth be able to support 10 billion of us living like we do today? Overwhelming evidence suggests it won't—unless we profoundly change the way humans live, and fast!

Please do your kids a favor and watch David Attenborough's "A Life on Our Planet." It may be the most important thing you ever do for them.

How the dismantling of America’s food safety agencies is making us sick

To the Editor:  
“Eating food in the United States is like playing Russian Roulette!” Cyclospora. Salmonella. E. coli. Listeria. These food born illnesses are more prevalent than ever under the current administration. Many factors impact food safety like supply chains, mega farms, and mass reductions in force at agencies responsible for food safety. Unfortunately, The Trump Administration has affected all three. It has been reported that the Trump administration has significantly undermined food safety with the mass reduction in force of most agencies meant to identify and reduce food related health issues before the food reaches our plates and stomachs.

Data from the U.S. Office of Personnel Management shows a complete picture of staff losses at federal agencies responsible for food safety and public health. (Food Safety)  
The U.S. Department of Agriculture lost 19,984 staff in 2025 and another 2,269 so far in 2026. The Food Safety and Inspection Service was reduced by 874 and 39 personnel in 2025 and 2026, respectively; the Agricultural Research Service by 1,932 and 73, respectively; and the Animal and Plant Health Inspection Service by 2,017 and 15, respectively. The USDA’s workforce has decreased in size more than any other federal agency since 2015, with net losses of more than 17,400 staff (the vast majority of these losses occurring in 2025–2026).  
The U.S. Food and Drug Administration was reduced by 3,859 and 473 in 2025 and 2026, respectively.  
The U.S. Centers for Disease Control and Prevention was reduced by 2,499 and 390 in 2025 and 2026, respectively.

Many staff losses were DOGE-driven reductions in force of the people who actually do the work of reviewing, inspecting and testing our food. The FDA suspended testing for the Food Emergency Response Network, a system of roughly 170 laboratories that test food for pathogens. (Forbes)  
Critics say political loyalists prioritized over scientists and expertise are running agencies responsible for our food. Food-safety experts warn it will take years to restore the lost capacity as a result of decades of experience and knowledge cut from the food safety and public health agencies.  
In 2022, the FDA finalized the Food Traceability Rule, a regulation designed to do exactly what didn’t happen fast enough this summer: shrink outbreak investigations from an average of about 35 days to five or six days, get contaminated product off shelves faster, and make recalls precise. It was supposed to take effect in January 2026. Instead, the Trump FDA proposed

and finalized a 30-month delay, pushing the compliance deadline to July 20, 2028. Americans will have to wait at least two more summers for the rule to take effect to protect our food. Congress restricted the FDA from using appropriated funds to enforce the rule before that date.  
This year’s recall may read like your grocery list:  
Lettuce has been tied to Cyclospora outbreak. 10,930 illnesses across 17 states, 454 hospitalizations and two deaths.  
Blueberries linked to E. coli outbreak.  
Eggs linked to Salmonella outbreak.  
Soft cheese tied to Listeria outbreak.  
Jalapenos recalled over Salmonella and triggered secondary recalls of meat & poultry products containing peppers.  
Deli meat recalled over Listeria contamination.  
Seeds for sprouting recalled due to Shiga toxin-producing E. coli (STEC).  
Prepared/frozen foods (spinach, pre-cooked pasta, baked goods & pancake mixes) recalled for Listeria, Salmonella or undeclared allergens.

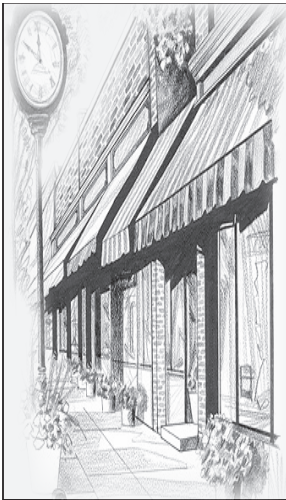
The FDA’s outbreak-investigation tracker shows 21 active investigations in 2026, about 40 percent above the 2022-2025 average.  
As if a gutted inspection system and delayed traceability rule aren’t enough, Trump announced on Aug. 21 he is allowing 300,000 tons of ground beef to be imported into the U.S. with no requirement to tell us where it came from in an attempt to win the mid-term elections with three months of lower priced beef. As one South Dakota farm advocate put it, “without Mandatory Country of Origin Labeling, we do not even know where the beef is imported from.”  
“Here we are in the middle of a public health crisis over imported lettuce and now the President is OK importing beef in abundance.” (National Agricultural Law Center)  
Fewer inspectors, fewer lab scientists, a revolving door of political leadership at agencies meant to be insulated from politics and the delayed traceability rule, have made it hard to ignore the impacts on our food. Americans are getting sick. We are less equipped under this Administration than ever before to catch the next outbreak before it reaches our plates.

Contact your senators and representatives in Congress and tell them to fund and enforce the FDA’s Food Traceability Rule and support small farms and businesses. Remember when you vote, who is looking out for you and your family’s health and food safety.

for Connecticut School Nutrition Programs

The Thompson Public Schools announced today its policy for determining eligibility of children who may receive free or reduced-price meals served under the National School Lunch Program (NSLP) and School Breakfast Program (SBP), or free milk served under the Special Milk Program (SMP).

Local school officials have adopted the U.S. Department of Agriculture's (USDA) Income Eligibility Guidelines (IEGs) for family size and income criteria for determining eligibility. The following income guidelines will be used in Connecticut from **July 1, 2026, to June 30, 2027**, for determining participant's eligibility for free and reduced-price school meals and free milk in the Child Nutrition Programs (CNP).

Income Guidelines for Child Nutrition Programs: July 1, 2026, to June 30, 2027

The income calculations above are based on the following formulas:

- monthly income is calculated by dividing the annual income by 12;
- twice monthly income is computed by dividing annual income by 24;
- income received every two weeks is calculated by dividing annual income by 26; and
- weekly income is computed by dividing annual income by 52.

All numbers are rounded upward to the next whole dollar.

Students residing in households with income at or below the levels shown in the chart above are eligible for free or reduced-price school meals or free milk through the SMP. Applications are being sent home to all families with the Welcome back Newsletter from the superintendent. Additional copies are available on our school website or can be obtained by the school secretaries. To apply for free or reduced-price school meals or free milk through the SMP, households should fill out the application and return it to the school. Only one application is required per household and an application for free or reduced-price school meals cannot be approved unless it contains complete eligibility information as indicated on the application and instructions.

The information provided on the application is confidential and will be used only for the purposes of determining eligibility and for administration and enforcement of the lunch, breakfast, and milk programs through the SMP. Additionally, all school-aged students in income-eligible households can receive school meal benefits regardless of a student's immigration status and the district/school does not release information for immigration-related purposes in the usual course of operating the CNPs. Note that the district *may* share your eligibility information with education, health, social service, and nutrition programs to help them evaluate, fund, or determine benefits for their programs, auditors for program reviews, and law enforcement officials to help them look into violations of program rules. This information may also be verified at any time during the school year by school or other program officials. Applications may be submitted at any time during the year.

No application is required if the district directly certifies a student based on a household member receiving assistance from the Supplemental Nutrition Assistance Program (SNAP) or the Temporary Family Assistance (TFA) program. All students in these households are eligible for free school meals or free milk through the SMP. The school district will notify households receiving assistance under the SNAP/TFA programs of their eligibility and all enrolled students residing in the household will be offered free school meals or free milk through the SMP unless the household notifies the determining official that it chooses to decline benefits. If any students were not listed on the eligibility notice, the household should contact the district or school to have free meal or milk benefits extended to those students. Households receiving SNAP or TFA benefits for their children should only submit an application if they are **not** notified of their eligibility by September 11, 2026.

Some students *may* be directly certified for free or reduced-price meals or milk through the SMP based on HUSKY A (Medicaid). No application is required if the district directly certifies a student based on participation in HUSKY A (Medicaid). Students in these households are likely eligible for free or reduced-priced meal or milk benefits and will be notified of their eligibility and their children will be offered free or reduced-price school meals or milk through the SMP, unless the household notifies the determining official that it chooses to decline benefits. If any students were not listed on the eligibility notice, the household should contact the district or school to have free or reduced-price school meals or milk benefits extended to those students.

Additionally, some students may be eligible for free or reduced-price meals or free milk through the SMP if the students were determined to be eligible for Summer Electronic Benefits (S-EBT). No application is required if the district determines that a student is eligible for free or reduced-price meals or free milk due to participation in S-EBT. Students in these households are likely eligible for free or reduced-priced meal benefits and will be notified of their eligibility and their children will be offered free or reduced-price school meals or free milk accordingly, unless the household notifies the determining official that it chooses to decline benefits. If any students were not listed on the eligibility notice, the household should contact the district or school to have free or reduced-price school meals or milk benefits extended to those students.

If a student is not directly certified, the household should complete and submit a free and reduced-price meal application form. The application for households receiving SNAP or TFA benefits require the SNAP or TFA client ID number and the households may be asked to provide proof of the SNAP or TFA client ID number. The signature of an adult household member is also required.

Students in households participating in the Special Supplemental Nutrition Program for Women, Infants and Children (WIC) may be eligible for free or reduced-price school meals. Please complete and submit a free and reduced-price meal application or contact the determining official for more information. For a tutorial on how to complete the application, visit [How to fill out the Application for Free and Reduced-price Meals or Free Milk and Summer EBT](#).

When known to the district/school, households will be notified of any student's eligibility for free school meals if the individual student is "Other Source Categorically Eligible" because the student is categorized as either: homeless; runaway as defined by law and determined by the district's or school's homeless liaison; or enrolled in an eligible Head Start or pre-kindergarten class as defined by law. Households with students who are categorically eligible under Other Source Categorically Eligible Programs should complete and submit a free and reduced-price meal application and check off the relevant box. Questions should be directed to the determining official. For any student not listed on the eligibility notice, the households should contact the school or determining official about any student also eligible under one of these programs or should submit an income application for the other students.

Households notified of their children's eligibility must contact the determining official or school if it chooses to decline the free school meal benefits. If households/students are **not** notified by the district/school of their free meal benefits and they receive benefits under qualifying public assistance programs or under Other Source Categorically Eligible Programs, the parent/guardian should contact the determining official for their school.

Foster children that are under the legal responsibility of a foster care agency or court, are categorically eligible for free school meals. A foster parent does not have to complete a free/reduced-price school meal application if they can submit a copy of the legal document or legal court order showing that the student is a foster child. Additionally, a foster child may

be included as a member of the foster family if the foster family chooses to also apply for benefits. If the foster family is not eligible for free or reduced-price school meal benefits, it does not prevent a foster child from receiving free school meals. A foster child's eligibility for free school meals does not automatically extend to all students in the household. Free and reduced-price school meals application forms for all other households require a statement of total household income, household size, and names of all household members. The last four digits of the social security number of an adult household member must be included or a statement that the household member does not have one. The adult household member must also sign the application certifying that the information provided is correct.

Under the provisions of the policy for determining eligibility for free and reduced-price school meals, the Director of Food Services, Debra Mita, [dmita@thompsonpublicschools.org](mailto:dmita@thompsonpublicschools.org), will review applications and determine students' eligibility for free or reduced-price school meals. If a parent/guardian is dissatisfied with the ruling of the determining official, they may wish to discuss the decision with the determining official on an informal basis. If they wish to make a formal appeal, a request either orally or in writing, may be made to Melinda Smith, Superintendent, 785 Riverside Drive, North Grosvenordale, CT 06255, 860-923-9581 ext.12013 for a hearing to appeal the decision.

The policy contains an outline of the hearing procedure. Each school and the central office of the school district has a copy of the policy, which may be reviewed by an interested party.

# Dr. Edward F. Perry — Physician, World War I veteran, and first Commander of American Legion Post #13

For nearly a quarter century, Edward F. Perry was one of Putnam’s best-known doctors, caring for families throughout the community and surrounding countryside. When his country entered World War I, he temporarily exchanged his civilian clothes for an Army uniform and volunteered his medical skills for military service in France.

When he returned home, Perry became one of the local veterans who helped establish what would become the Mayotte-Viens Post #13 of the American Legion. He was a charter member and served as their first Commander.

Perhaps most remarkable is that Perry left behind an unusually candid account of his military experience. His Connecticut Military

Service Record preserves not only the dates and places of his service, but also his personal thoughts about Army life. His answers reveal an intelligent, experienced and occasionally frustrated physician who desperately wanted to make a greater contribution to the war effort than the Army bureaucracy permitted him to make.

Edward Franklin Perry was born in Pomfret on Oct. 8, 1871, the son of Franklin White Perry and Cornelia Maria (Williams) Perry. His family moved to Putnam while Edward was young, and his father became a prominent local businessman and eventually served as mayor.

Perry attended Putnam’s public schools before continuing his education at Norwich Military Academy in New Hampshire. He later entered Amherst College with the Class of 1896. Among his classmates was another young

New Englander destined for prominence, future President Calvin Coolidge.

He later studied medicine at Long Island College Hospital in Brooklyn, receiving his medical degree in 1897. His post-graduate hospital experience included service at St. John’s Hospital in Yonkers and Brooklyn Hospital.

Perry initially established a medical practice in Wellfleet, Mass., then in 1905, he returned to Putnam. He was associated with Day Kimball Hospital as a surgeon and served as a medical examiner for the US Public Health Service. He was also active in the American Medical Association, CT State Medical Society and Windham County Medical Society, eventually serving as president of the latter.

Perry had married Edith Lillian Smith of Washington, Connecticut, in New York City on Feb. 17, 1899. They eventually had four children: Edward Franklin Jr., Ruth Beeman, Alice Cornelia and Myron Albert Perry.

When the US entered WWI in April 1917, Perry was already 45 years old and an established physician with a wife, children and a thriving medical practice. He nevertheless volunteered his professional services, and on Aug. 8, 1917, Perry received his commission as a First Lieutenant in the Medical Corps. After his initial training, he was sent to France in June of 1918.

He soon became frustrated: “I found my duties trivial, monotonous, and unprofitable. Having had many years’ experience in hospital surgery, I asked for frontline work, and was assigned to a wood camp.”

Perry served as a medical officer with 20th Engineers in the Landes region of southwestern France. This unit performed an essential but largely unsung mission – providing lumber. Timber was required for barracks,

hospitals, railroads, bridges, docks, warehouses, trenches, roads and countless other military necessities. The 20th Engineers operated sawmills and logging camps in France to keep the enormous American war machine supplied. Perry’s job was to keep those soldiers healthy. It was important work. It simply wasn’t the work he wanted.

The war ended on Nov. 11, 1918, and on Jan. 5, 1919, after nearly seven months overseas, Lieutenant Edward F. Perry returned home and was discharged on Jan. 18, 1919.

Perry was an unusually candid veteran. The Connecticut Military Service questionnaire asked veterans to reflect upon how military service had changed them. Many surviving World War I questionnaires contain predictable expressions of patriotism and duty. Perry’s answers were different. Asked why he had volunteered, he listed several motives: “Desire to be of service, for adventure, change, experience, and professional improvement and advancement.” Perry did not pretend that a single lofty motivation had driven his decision. Patriotism and service were there, but so were curiosity, adventure and professional ambition.

Then came his final verdict: “When I have made up my financial losses incident to my service, and regained my lost practice, I shall be satisfied to remain a civilian for the rest of my life.” Ironically, Perry’s declaration that he intended to remain a civilian would not prove entirely permanent. He later served in the National Guard.

Perry returned home to a country transformed by the war. Returning veterans began organizing what would become one of the most influential organizations in American history—the American Legion. Putnam veterans soon organized their own post, and

Dr. Edward F. Perry was a charter member and the first Commander of the Anselm Mayotte Post #13, American Legion. The post was named for a local serviceman who had lost his life during the war. It would later become the Mayotte-Viens Post #13.

Perry left a legacy that extended well beyond medicine. As its first Commander, he helped lay the foundation for generations of Putnam veterans who would follow him. More than a century later, Mayotte-Viens Post #13 remains part of Putnam’s civic life.

Medicine and veterans affairs were only parts of Perry’s interests. He was active in Putnam’s Second Congregational Church and belonged to Quinebaug Lodge, A.F. & A.M., the Masonic Club and Israel Putnam Lodge of the Independent Order of Odd Fellows. He had also been the first Commander of the George W. Child Camp of the Sons of Veterans.

Perry possessed a lifelong interest in books, history and literature. He enjoyed writing and even worked for a time as Putnam correspondent for the Worcester Evening Gazette and the Hartford Times.

His Final Illness: By 1929, Perry’s health was failing. During the spring he was treated at the Naval Hospital in Newport, RI, he was also treated at Day Kimball Hospital. Later that year he entered medical care in Hartford. His condition progressively deteriorated.

Dr. Edward Franklin Perry died on Dec. 19, 1929, at the Hartford Retreat. He was 58 years old. The Windham County Observer reported the primary cause of his death as chronic myocarditis, with chronic hypertensive nephritis as a secondary cause. Putnam had lost one of its most prominent physicians. Its veterans had also lost one of their own. Dr Perry was

buried with full military honors at the Grove Street Cemetery in Putnam.

Edward Franklin Perry’s military career was not filled with battlefield heroics. He never claimed that it was. In fact, when Connecticut asked whether he had seen combat, Perry made certain that future generations would know the truth: “Saw none of it.” That honesty is part of what makes his story worth remembering.

Wars are not fought only by the soldiers carrying rifles in the trenches. Behind them stand doctors, nurses, engineers, railroad troops, stevedores, mechanics, clerks, cooks, lumbermen and thousands of others whose work makes combat operations possible. Perry was one of them.

At 46 years old, with an established medical practice and four children at home, he left Putnam and crossed the Atlantic during wartime because he believed he could be useful. He treated American servicemen suffering from poison gas. He cared for soldiers working in the immense forestry operations of southwestern France. He served until the war was over and then returned home to rebuild the medical practice he had left behind.

And when Putnam’s veterans needed an organization of their own, Dr. Edward F. Perry stepped forward again. He became a charter member and first Commander of American Legion Post #13.

Today, more than a century after Perry and his fellow World War I veterans organized the Post, his legacy remains woven into the history of the Mayotte-Viens Post #13 and the community it serves. Dr. Edward Franklin Perry was a physician, surgeon, soldier, veteran, writer, student of history and community leader. Above all, he was one of Putnam’s Hometown Heroes.

ORDINANCE

Article V **Exemption for Vehicles Owned by Persons with Disabilities § 285-7 Definitions.**

As used in this article, the following terms shall have the meanings indicated:

**DISABLED INDIVIDUAL**

An individual who requires a specially equipped and/or modified motor vehicle as hereinafter defined as a result of the individual's medical incapacitation and/or disability.

**SPECIALLY EQUIPPED AND/OR MODIFIED MOTOR VEHICLE**

A vehicle which is modified, equipped and/or fitted with special equipment to accommodate a disabled individual who is incapable of operation of a motor vehicle on his or her own, to use or operate the same for transportation and/or to transport a disabled individual as hereinbefore defined. By way of example, special equipment shall be, but is not limited to, hand controls, lifts, ramps, special seating, braking or acceleration mechanisms for manual operation, physical alterations to accommodate medical equipment, i.e., oxygen tanks, mechanical respirators.

**§ 285-8 Eligibility.**

Any specially equipped and/or modified motor vehicle registered in the Town of Putnam owned by a disabled individual or owned by the parent or guardian of a disabled individual shall be exempt from property tax provided the application requirements set forth below are met.

**§ 285-9 Application; proof of disability; filing.**

**A.** The owner of a specially equipped and/or modified motor vehicle described herein may apply to the Assessor of the Town of Putnam on a form prepared by the Assessor to request a property tax exemption for such specially equipped and/or modified motor vehicle.

**B.** At the time the owner makes application to the Assessor, the owner must attest that the motor vehicle has been equipped or adapted for use by a disabled individual as hereinbefore defined and present the vehicle for physical inspection by the Assessor.

**C.** At the time that the owner makes application to the Assessor, the owner shall attest to the individual's need for a specially equipped and/or modified motor vehicle as here in before defined.

**D.** Applications for such exemptions shall be filed between October 1 up through and including December 31 following the assessment date with respect to which such exemption is claimed, commencing with the Grand List of October 1, 2023. Failure to file such application in such manner and form within the time limit prescribed shall constitute a waiver of the right

to such exemption for the assessment year.

**§ 285-10 For-profit vehicles.**

The exemption shall not apply to equipped motor vehicles operated for profit.

**§ 285-11 Expiration.**

The exemption shall expire when the equipped motor vehicle ceases to be used by the disabled owner or parent or guardian of a person with disabilities. Also, the exemption shall expire when the vehicle is sold or transferred and not used for the use intended.

**§ 285-12 When effective.**

This article is to take effect 21 days after publication.

ORDINANCE  
Zoning Citations

**Purpose.**

The purpose of this chapter is to establish penalties for violations of the Town's Zoning Regulations, establish procedures for issuance of citations to violators and for collections of fines and to have the Town's citation hearing procedure apply to citations hereunder issued.

**Issuance of orders and citations.**

The Town's Zoning Enforcement Officer or agent is authorized to issue cease-and-desist orders or other appropriate orders to a violator of the Town's Zoning Regulations or of any approval or permit issued by the Town Planning and Zoning Commission. If such violation has not been remedied either immediately or within 10 days of the date of issuance of the cease-and-desist order or other appropriate order, as provided in the order, the Zoning Enforcement Officer, or such other Town official or employee designated by the Mayor of Putnam to issue citations, unless such time has been extended for good cause by the Zoning Enforcement Officer, shall issue a citation to the violator which shall invoke the Town's citation hearing procedure set forth in § 172-6 of the Town Code. However, in the case where a violation is found by the Zoning Enforcement Officer or agent to be willful, penalties may be assessed from the date such violation has been committed.

**Penalties for offenses; hearing.**

The penalty for each violation of the zoning regulations or approvals or permits issued shall be \$100 for each day that such violation continues beyond the compliance date in the cease-and-desist order. Notwithstanding the preceding, in instances of willful violations and instances where the violation is not corrected within such manner and time period stipulated in the order, fines may be assessed from the date such violation has been committed.

**Procedure.**

The procedure to be followed with respect to all citations issued under this chapter shall be the citation hearing procedure set forth in § 172-6 of the Town Code.
