LEICESTER – Like almost all other facets of education, Project 351 had to be reinvented this year due to COVID-19. But even with the changes, student ambassadors like Vivian Giles will still find plenty of ways to give back.

Giles, an eighth grader at Leicester Middle School, was chosen by staff members to represent her school and town in Project 351. Each year, the program inducts one outstanding student from all 351 cities and towns in the Commonwealth. The ambassa-

dors then travel to Boston on the Saturday before Martin Luther King, Jr., Day for an afternoon of service.

“When I found out I was chosen as a Project 351 ambassador, I was really shocked by it. I’m honored to be able to represent my town and community,” Giles said. “I think it is an amazing opportunity for me to grow while being able to help others through a variety of service work.”

With COVID-19 still rampaging through the state, Project 351 leaders decided to schedule a virtual launch day for the program on March 7. Officials look forward to

Spencer officials work to address vaccination concerns

SPENCER – The COVID-19 vaccine rollout has been fraught with frustration and confusion, but town health officials are working hard to provide answers.

The Spencer Health Department recently launched an online form that helps residents stay current on the vaccine distribution process. If you are a Spencer resident or an employee who works in town, you can complete the form and receive notifications on vaccine access in the area.

Once you send in the online form, you will be notified when a vaccine clinic becomes available to you. Residents can also fill out the form on behalf of

another individual.

Officials at the municipal and state levels have been flooded with questions related to priority groups, eligibility, restrictions, and vaccine availability. Many residents have attempted to navigate state-run websites and resources, only to find themselves even more confused than they started. Others seeking the vaccine have discovered that the current supply isn’t sufficient to accommodate them, or there are no clinics within several miles of their homes.

The process has been particularly frustrating for seniors. Residents who are age 75 or older are now eligible to receive the vaccine, but questions over supply availability and logistics are keeping many

seniors stuck at home for now.

For Spencer Health Agent Lisa Daoust, strong lines of communication are critical to a successful vaccine rollout. The online form will go a long way toward keeping residents in the know.

“The form is basically another way for residents to be informed of any upcoming vaccination clinics that the town may offer once vaccines become available,” Daoust said. “In addition, I send out weekly Reverse 911 calls to residents, as well as updating the website daily with the most up-to-date information as it becomes available.”

The COVID-19 vaccine notification form has been posted on the main page of

the town’s Web site (www.spencerma.gov), as well as the Board of Health page, the Fire Department page, and the town’s Emergency Management page.

Residents can also find on the town’s website a link to Harrington Hospital, which is a statewide vaccination site. Moreover, residents will find a link to Big Y, which is expected to begin offering vaccinations to priority groups this month.

“In these trying times, I understand the frustration and confusion that the residents have. I am here to support and help anyone with any questions and concerns,” Daoust said.

Leicester dropped from Central MA Public Health Alliance

LEICESTER – Officials were forced to establish a new system for health services after Leicester was recently dropped from the Central Massachusetts Regional Public Health Alliance.

Run by Worcester’s Division of Public Health, the Health Alliance is a coalition comprised of six other municipalities (Grafton, Holden, Millbury, Shrewsbury, West Boylston, and Worcester). The

intent of the regionalized partnership is to provide cost-effective, labor-efficient public health services to member towns.

Last year, Worcester officials announced that the city would not renew Leicester’s Health Alliance contract, which originally expired on June 30. An extension was granted to allow for a continuation of services through the end of the year, but the extension expired on Jan. 31.

The unexpected decision in

Worcester left Leicester officials in a lurch, forced to pivot to a new health system at the height of the COVID-19 crisis.

“We were surprised when the Alliance informed us that they would not be renewing our regional agreement. Much of the time spent during the extension period involved discussing options with the Alliance,” said Leicester Town Administrator David Genereux. “We were concerned with attempting to develop a new model for health

services in the middle of a pandemic, but they were clear that they wanted to go in a different direction.”

Genereux asked the Health Alliance to consider billing Leicester on a month-to-month basis while negotiations continued into 2021. When talks fell through, town leaders scrambled to find alternative solutions in a different regional model.

“We examined the possibility of forging another regional partnership, but could not find

SPENCER – As local families begin to make their education plans for next year, Spencer-East Brookfield Regional School District leaders invite parents to consider school choice.

For the 2021-22 academic year, the SEBRSD school choice program has openings for students at all three levels: elementary school, middle school, and high school. Before parents make their choices for the upcoming year, district officials wanted to introduce them to several new offerings in the SEBRSD.

“As a gateway community, we are excited to open our doors to those from surrounding communities that are seeking a new opportunity, and welcome new students to our district through the school choice program,” read a statement released by SEBRSD Superintendent Paul Haughey.

Most local students attend school in their home districts, but the school choice program allows parents to enroll their kids in public schools outside of their districts.

Operating schools in both Spencer and East Brookfield, the SEBRSD is currently accepting applications for students in preschool, kindergarten, and grades 1-12. The close-knit school community is always eager to welcome students from surrounding towns who can augment the learning environment.

“At SEBRSD, the positive relationships between parents, students, and teachers are the foundation of our learning environment, and we encourage ongoing communi-

cation to ensure your child’s success,” read Superintendent Haughey’s statement. “We constantly strive and are committed to creating an environment in which every student is supported to achieve the highest levels of success. Our educators are focused on the consistent individual growth of the students so that they are college, career, and life ready.”

At all grade levels, the SEBRSD offers a curriculum designed to meet the following objectives: focus on comprehensive literacy, content literacy, and information literacy; teach basic communication, cognitive, and computational skills; promote mathematical and scientific awareness; cultivate an awareness of history, geography, government, and the humanities; foster creativity; instill an appreciation for the arts; develop occupational competency; and encourage an understanding of multicultural values.

“We provide an extensive network of caring and supportive staff, as well as the resources needed to deliver outstanding educational instruction and opportunities for all of our students,” Haughey said. “We nurture, encourage, and challenge each student to reach their full potential by offering the resources and support needed in a diverse and ever-changing environment.”

At David Prouty High School, career readiness isn’t merely a vision but a mission. Whether students have college, military, or career ambitions out of high school, the DPHS

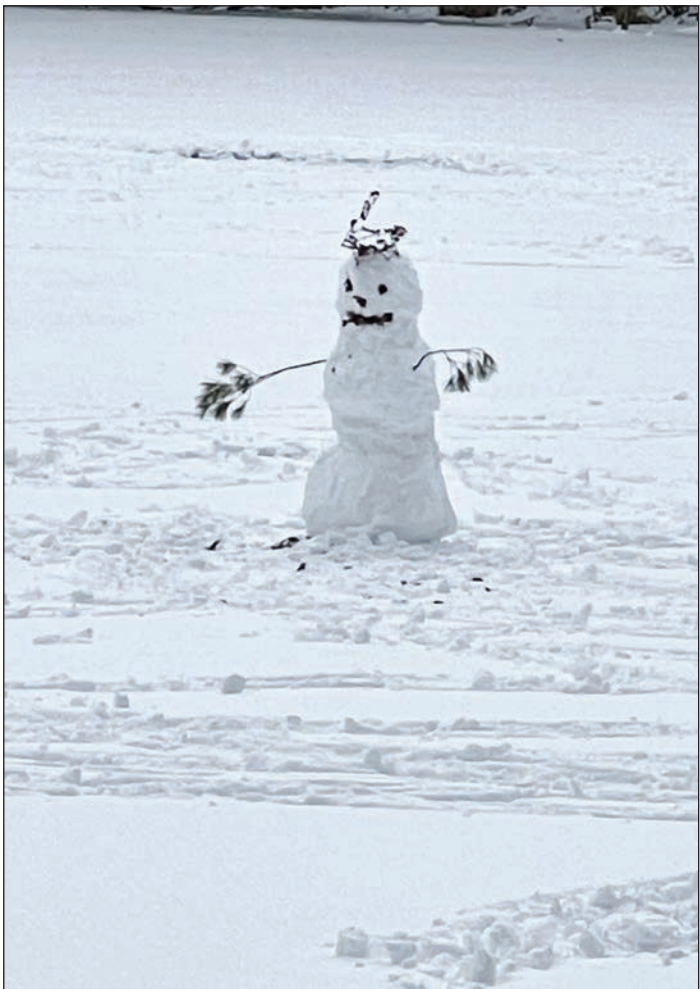

Designer sought for DPHS building project

SPENCER – School officials are in the process of hiring a designer before entering the next phase of the David Prouty High School building project.

The Spencer-East Brookfield Regional School District is working with the Massachusetts School Building Authority (MSBA) to move the project forward. The DPHS building project is currently in Module 2 of the process, which includes securing an owner's project manager and designer services.

"As a School Building Committee, we are looking forward to continuing our work in partnership with the MSBA and our owner's project manager, Colliers, so we may secure an architect and move into Module 3, feasibility study," read a statement released by SEBRSD Superintendent Paul Haughey.

The owner's project manager will lead several aspects of the project, including planning, design, construction, commissioning, and closeout phases.

The district has posted a request for services to obtain bids from architectural design specialists. Once the designer

is secured, the project will be able to move forward in the process.

During the upcoming third phase, the project team will submit a preliminary design program and a preferred schematic report. Approval by the MSBA Board of Directors is required for all projects to proceed into the fourth module (schematic design).

The district is also being consulted in the process by the Massachusetts Association of Regional Schools, which assists school leaders throughout the state with strategic planning services. Organization representatives will continue to work with members of the DPHS project team through the upcoming steps.

"In this next phase, we will take a deep dive into the condition of the building and determine which direction we want to go – whether it's a renovation or a new school," said Stephen Hemman, a consultant with the Massachusetts Association of Regional Schools.

If the Prouty project is approved for the fourth phase, the team would develop a final design program to establish the scope, budget, and schedule.

Educators and staff members would contribute significant input to guide the project.

District leaders are pleased with the progress thus far, and they look forward to the next steps.

"These are exciting times for not only David Prouty High School, but our entire district," read the statement issued by Haughey. "We are so grateful for the partnership and support we share with our local communities, as well as the Commonwealth."

To help keep residents current on the project, a detailed PowerPoint presentation was posted to the Spencer website. Moving forward, DPHS staff members will be heavily involved in every phase of the process as the vision becomes clearer, officials said.

According to current projections, Spencer and East Brookfield residents could be asked to authorize borrowing for the project by November 2022. Construction could last between one and two years, beginning in 2023 if all prior timeline goals are met.

The Town Meeting will take place at 7 p.m. Five days later, the election is set for 7 a.m. to 8 p.m.

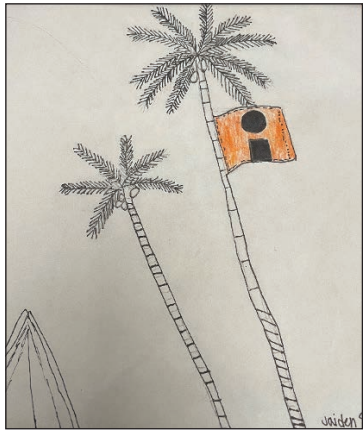

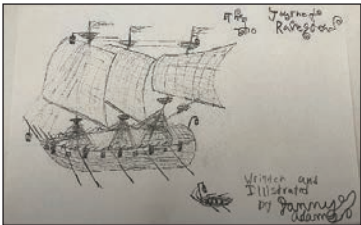
Survival

## Strategies to Drive Safely in the Snow

Hot on the heels of a classic Nor'easter, it's time once again to review our annual winter driving tips to keep safe while navigating icy, snowy roadways. When the wintry weather finds you slip sliding away this season, keep in mind these common sense strategies to up your odds of a safe trip.

**\*\* Accelerate slowly to reduce wheel spin.** If starting from a standstill on slick snow or ice, start in second gear so the vehicle is less likely to spin the tires. The transmissions on some vehicles have a winter mode that automatically starts in a higher gear.

**\*\* On snowy or slippery roads, decelerate slowly too.** It helps to increase your following distance to five to six seconds.

**\*\* Reduce your speed and drive smoothly.** In slippery conditions, tires lose their grip more easily, affecting all aspects of your driving: braking, turning, and accelerating. The key is to drive as smoothly as possible, avoiding sudden actions or rapid movements of any kind. Drive as if you have a bowl of water in your lap and don't want to spill any.

**\*\* Don't lock your wheels when braking.** Locked wheels can make the vehicle slide or skid. If you have a vehicle without an antilock braking system (ABS), you may need to gently apply the brakes repeatedly to avoid having them lock up the wheels.

**\*\* Know your brakes:** Whether you have antilock brakes or not, keep the heel of your foot on the floor and use the ball of your foot to apply firm, steady pressure on the brake pedal

**\*\* Perform one action at a time when accelerating, braking, and turning.** Asking a vehicle to do two things at once—such as braking and turning, or accelerating and turning—can reduce your control. When taking a turn, for instance, slowly apply the brakes while the vehicle is going straight. When it's at the right speed to take the turn, let up on the brakes and smoothly turn the steering wheel. After you're through the turn, slowly depress the accelerator to regain your speed.

**\*\* Tackling the Hills:** Don't power up hills. Applying extra gas on snow-covered roads will just make your wheels spin. Try to get a little inertia going before you reach the hill and let that inertia carry you to the top. As you reach the crest of the hill, reduce your speed and proceed downhill slowly

**\*\* Clear Clogs:** Make sure the exhaust pipe is not clogged with snow, ice or mud. A blocked exhaust pipe can cause deadly carbon monoxide gas to leak into the passenger compartment of the

vehicle while the engine is running.

**\*\* Did you know tires are your most important weapon against slipping and sliding?** Take into account these top tire tips:

**\*\* Cold temperatures decrease the air pressure in tires, which adds to the rolling resistance caused by snow and slush.** So be sure to check tire pressure regularly, especially after there has been a sharp drop in temperature.

**\*\* When buying allweather or snow tires have them installed on all four wheels.** This provides even traction all the way around and gives you top notch steering and stopping.

**\*\* Can't replace all four?** If you can only afford two snow tires, some tire experts suggest you get them mounted in the rear. Here's why: If your front tires skid, you can still maintain some control over the car by steering those wheels. But if your rear tires lose contact with the road, it's much harder to control where the car goes. For that reason, the tires with the greatest amount of traction are supposed to go on the back

**\*\* Make sure you have enough tread on your tires.** The drive tires must provide traction to push your vehicle over wet pavement and through snow. The steer-

ing tires must have traction to steer the vehicle. Experts say you should have at least one eighth inch of tread to plow through snow effectively.

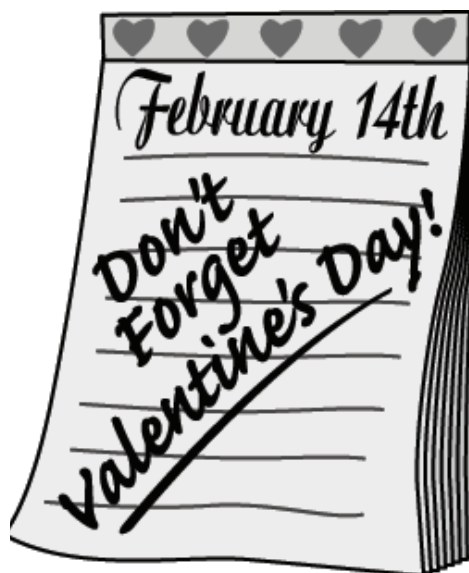

If you’ve been investing for many years and you’ve owned bonds, you’ve seen some pretty big changes on your financial statements. In 2000, the average yield on a 10-year U.S. Treasury security was about 6 percent; in 2010, it had dropped to slightly over 3 percent, and for most of 2020, it was less than 1 percent. That’s an enormous difference, and it may lead you to this question: With yields so low on bonds, why should you even consider them?

Of course, while the 10-year Treasury note is an important benchmark, it doesn’t represent the returns on any bonds you could purchase. Typically, longer-term bonds, such as those that mature in 20 or 30 years, pay higher rates to account for inflation and to reward you for locking up your money for many years. But the same downward trend can be seen in these longer-term bonds, too – in 2020, the average 30-year Treasury bond yield was only slightly above 1.5 percent.

Among other things, these numbers mean that investors of 10 or 20 years ago could have gotten some reasonably good income from investment-grade bonds. But today, the picture is different. (Higher-yield bonds, sometimes known as “junk” bonds, can offer more income but carry a higher risk of default.)

Nonetheless, while rates are low now, you may be able to employ a strategy that can help you in any interest-rate environment. You can build a bond “ladder” of individual bonds that mature on different dates. When market interest rates are low, you’ll still have your longer-term bonds earning higher yields (and long-term yields, while fluctuating, are expected to rise in the future). When interest rates rise, your maturing bonds can be reinvested at these new, higher levels. Be sure you evaluate whether a bond ladder and the securities held within it are consistent with your investment objectives, risk tolerance and financial circumstances.

Furthermore, bonds can provide you with other benefits. For one thing, they can help diversify your portfolio, especially if it’s heavily weighted toward stocks. Also, stock and bond prices often (although not always) move in opposite directions, so if the stock market goes through a down period, the value of your bonds may rise. And bonds are usually less volatile than stocks, so they can have a “calming” effect on your portfolio. Plus, if you hold your bonds until maturity, you will get your entire principal back (providing the bond issuer doesn’t default, which is generally unlikely if you own investment-grade bonds), so bond ownership gives you a chance to preserve capital while still investing.

But if the primary reason you have owned bonds is because of the income they offer, you may have to look elsewhere during periods of ultra-low interest rates. For example, you could invest in dividend-paying stocks. Some stocks have long track records of increasing dividends, year after year, giving you a potential source of rising income. (Keep in mind, though, that dividends can be increased, decreased or eliminated at any time.) Be aware, though, that stocks are subject to greater risks and market movements than bonds.

Ultimately, while bonds may not provide the income they did a few years ago, they can have a place in a long-term investment strategy. Consider how they might fit into yours.

known as a “short-squeeze.”

In a properly functioning market, people could bet on whether a stock would go up or down and it would go up or down based on the realities of its business. What we witnessed with GameStop and others (Nokia, AMC Theaters, and Blackberry) was not that their businesses improved, but people bought the stock with the goal of manipulating the market in order to cause massive losses from Wall Street hedge funds and hopefully use financial markets to create a transfer of wealth to them. This is coordinated market manipulation but what might surprise people is that it isn't illegal – Wall Street firms do it all the time. Normally though, they manipulate the market to bilk the little guy and enrich the 1 percent.

It is kind of funny to see dead companies bleeding money worth more now than they were in their prime. It is kind of fun watching rich people cry and getting beat at their own damn game. We are hearing Wall Street complain about market manipulation, which was just retail investors taking advantage of a situation they created by being sloppy and greedy with their out market manipulation. It is truly outstanding mental gymnastics.

We then saw an institutional backlash we've never seen before.

Robinhood, a commission-free discount brokerage catering to young retail investors with an average age of 31 halted buying GME, BB, NOK, and AMC. At one point, Robinhood was auto-selling GME for customers (thanks...). Discord (group chat/videoconferencing service) banned the Wallstreetbets server citing “hate speech”. People called on the government to intervene and it exposed an amazing double-standard. Market manipulation by Wall Street firms is all well and good but if a cadre of scrappy volunteers targets a Wall Street firm or create a scheme of their own, it must be stopped!

Market manipulation, betting on companies' demise, creating bubbles in hopes of profiting while bankrupting others, and leveraging returns by trading options add nothing of value to the economy and only introduce volatility while smart people try to game each other, playing with real peoples' jobs and savings. If we don't want this type of thing we ought to pass robust Elizabeth Warren style regulation. If we want to give the 1% carte blanche to screw with financial markets, we shouldn't be surprised when a bunch of millennials using a smartphone app as a broker band together to hit back!

Something is very fishy with Robinhood... Why did they halt all trading on the stocks in question? Well, Robinhood's chief investor is heavily invested in Melvin Capital which the short-squeeze threatened to bankrupt

and caused a multi-billion dollar loss. Robinhood claims they didn't have enough credit with clearinghouses to settle the transactions during a float period, but I call BS. If Robinhood ran into funding problems, why did they only shut down the stocks that were threatening the billionaire investors and owners of Robinhood? Why didn't they shut down the entire brokerage to wait for their orders to settle?

Finally, it seems we might have a truly bi-partisan issue. AOC and Ted Cruz seem in agreement that Wall Street firms used unacceptable muscle in shutting down legal activity from small investors. It will be interesting to see if America, through inaction, basically says, “market manipulation by the top 1% to bilk retail investors is OK but if the scheme goes the other way it is not OK.” I suppose true freedom could mean Robinhood, Charles Schwab, Fidelity, and Morgan Stanley have the freedom to intervene to protect their investors and hedge funds... I mean, there's nothing stopping me from starting my own hedge fund and joining the oligarchy...except of course \$1 billion I don't have.

Now the question is, can we get the Ted Cruz fans to band together with the AOC fans and solicit Elizabeth Warren to write some long-overdue regulation for our financial markets?

represent himself Pro se...

In his first impeachment trial about 1 year ago, Republicans argued that the purpose of the impeachment was to overturn the 2016 election and not about his crimes to use the power of the presidency extort a foreign power into generating dirt on his chief opponent. To that date, there had never been a more serious offense by a sitting president – abusing his power like a mob boss to torpedo the candidacy of his chief opponent. The Republicans then said that impeachment was inappropriate, Trump “learned his lesson,” and we should let the people speak. This logic makes one wonder what offense would be impeachable. The people spoke on Nov. 3, 2020 and by a sizeable margin chose Joe Biden.

Now they are arguing that impeachment is unconstitutional and moot because Trump is no longer president. There was also an emoluments case which was recently dismissed as moot because he is no longer president. Both of these claims are ridiculous. We charge people with statutory rape or child abuse even if the victim turns 18 before the trial begins. We charge people with shoplifting even if they returned the goods before the trial. We charge people with murder even when the case is cold and they’ve lived a virtuous life since. We can’t send the message, even with the emoluments case, that all a president needs to do to shield himself from crimes is run the clock out until its moot.

Why is it that you continue to bring up Hillary Clinton and her “ricochet” off the infamous “glass ceiling?” I understand you didn’t choose her for president in 2016, but it is 2021 and it seems you are still upset that a woman even tried to run for president. From an energy security standpoint, should the middle east cut us off, Canadian oil will still be there. From a long-term stability standpoint, letting middle east oil wells run dry first seems like it would give us the upper hand.

The reason for \$2/gal gas was because of the massive collapse of demand due to the pandemic. As we recover, so will prices. Gas prices have been rising since before the election. We have been in a recession for the last year of Trump’s presidency, U.S. GDP shrank in 2020 by the most we’ve seen since we de-mobilized from WWII. Is that Obama’s fault? Biden’s? The U.S. econ-

omy is still in terrible shape from the mismanaged pandemic and that will likely dog Biden for years.

Mr. Robillard – I wish I had an imagination as wild as yours. Yes, it is time to purge. Just like Germany de-Nazified after WWII it is time to de-Trump the United States. Some showed up with helmets and body armor – I wonder why... They beat people with flag poles, crutches, fire extinguishers, and crowd control devices. When the mob is big enough, the mob itself is the weapon. There were people with handcuffs and there was a gallows out front and they were chanting about hanging specific government officials... Is that a specific enough threat?

Why no National Guard? Are you serious? Because D.C. is a territory, its National Guard report to the President, not the Mayor. The Pentagon restricted the commander of the D.C. Guard two days before the Capitol riot, prohibiting the DC Guard from deploying with weapons, helmets, body armor, or riot control agents without specific and explicit approval from the Acting Secretary of Defense (Trump fired Sec. Mark Esper weeks prior). Normally, the Commander of the D.C. Guard can deploy if there is an imminent threat to life or property, but his wings were clipped on Jan. 4...

Trump finished his remarks at 1:11 p.m., and the crowd started walking towards the Capitol. Mayor Bowser requested Guard troops at 1:34 p.m., and again on a conference call with the Pentagon at 2:22pm. The building is breached at 2:10 p.m., and shots were fired to literally protect House members from the mob at 2:44pm, killing an insurrectionist from California. Acting Secretary of Defense finally authorized activation of the DC Guard at 3:04 p.m. The D.C. Guard didn’t get there until 5:40pm. At 6:01 p.m., Trump tweeted to his supporters that “These are the things and events that happen when a sacred landslide election victory is so unceremoniously & viciously stripped

away from great patriots who have been badly & unfairly treated for so long. Go home with love & in peace. Remember this day forever!”

Of course the Army needs to be purged of Trumpist holdouts. Not purged of people who preferred Donald Trump on Nov. 3, purged of people who don’t recognize Joe Biden as the legitimate president of the United States. We need soldiers who have a demonstrated loyalty to the Constitution of the United States, not Donald Trump (now a private citizen).

It is fine and healthy to have an opposition party, the key is loyal opposition. Loyal to the United States even if they disagree with specific actions and policies of the current government. placed on the street by his three or four buddies--all laughing and happy-looking young men like him and all wearing the same kind of army shirt with a similar unit patch--and disappearing into the madding crowd. It was clear what shared life experience had brought them together for this day. As I watched him walk away, without the aid of crutches, but with an ungainly, head-bobbing stride, I wondered, where do we find such men? I couldn't help but, upon reflection, compare this new-found hero of mine, with another horribly injured war veteran, the Marine, Ron Kovic, who returned from Vietnam in a wheelchair and understandably consumed with bitterness and rage, and whose book, "Born on the Fourth of July" was made into the movie starring Tom Cruise. Kovic has been an anti-war leftist for the remainder of his life, but I wonder if even he could see that perhaps my triple-amputee hero was out there for a good reason: to support President Trump, the single-most anti-war president of my life. 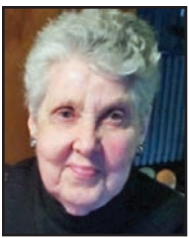

health nurse are projected to cost an additional \$9,100 annually, but Genereux said the town has available funding in the municipal budget to cover the anticipated costs.

Still, many town officials are worried that Leicester will wind up paying more for reduced services compared to those offered by the Health Alliance partnership. Among several other services, the Alliance pledges to help communities address statutory responsibilities, enforce codes, and assure compliance with public health regulations.

“I am concerned about what this is going to cost us now that we’re not

Selectman Brooks said Leicester’s partnership with the Health Alliance has worked well for six years, with several services and resources offered. Despite the town no longer receiving those services moving forward, Genereux said there will be benefits to having a health agent dedicated specifically to the needs of Leicester residents.

“We believe that offering full-time health services will offer enhanced benefits to our residents,” Genereux said. “The pandemic has resulted in a new focus being placed on public health, and cities and towns throughout

staff is committed to preparing them for immediate success.

DPHS currently offers the following course levels: non-weighted, applied learning, standard college prep, honors, and advanced placement. Additionally, Prouty’s seniors can take advantage of the school’s Dual Enrollment Program and the 12th Year Program, which collaborate with Quinsigamond Community College (QCC) to offer an opportunity to complete high school graduation requirements through concurrent enrollment in college-level courses at QCC. Moreover, the DPHS Work-Study Internship allows students to receive course credits for gainful employment that offers work experience related to their career choices.

The district also offers a Life Skills program for students with intellectual disabilities. The program provides opportunities for students to develop academic, daily living, occupational, and interpersonal skills.

Athletically, Prouty offers the following sports: football, basketball,

Added Genereux, “We are grateful for the services the Alliance provided for the past six years, but we are confident that this new direction is in the best interest of the Town.”

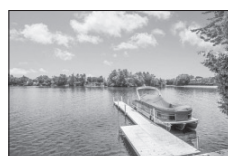

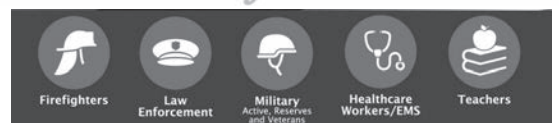

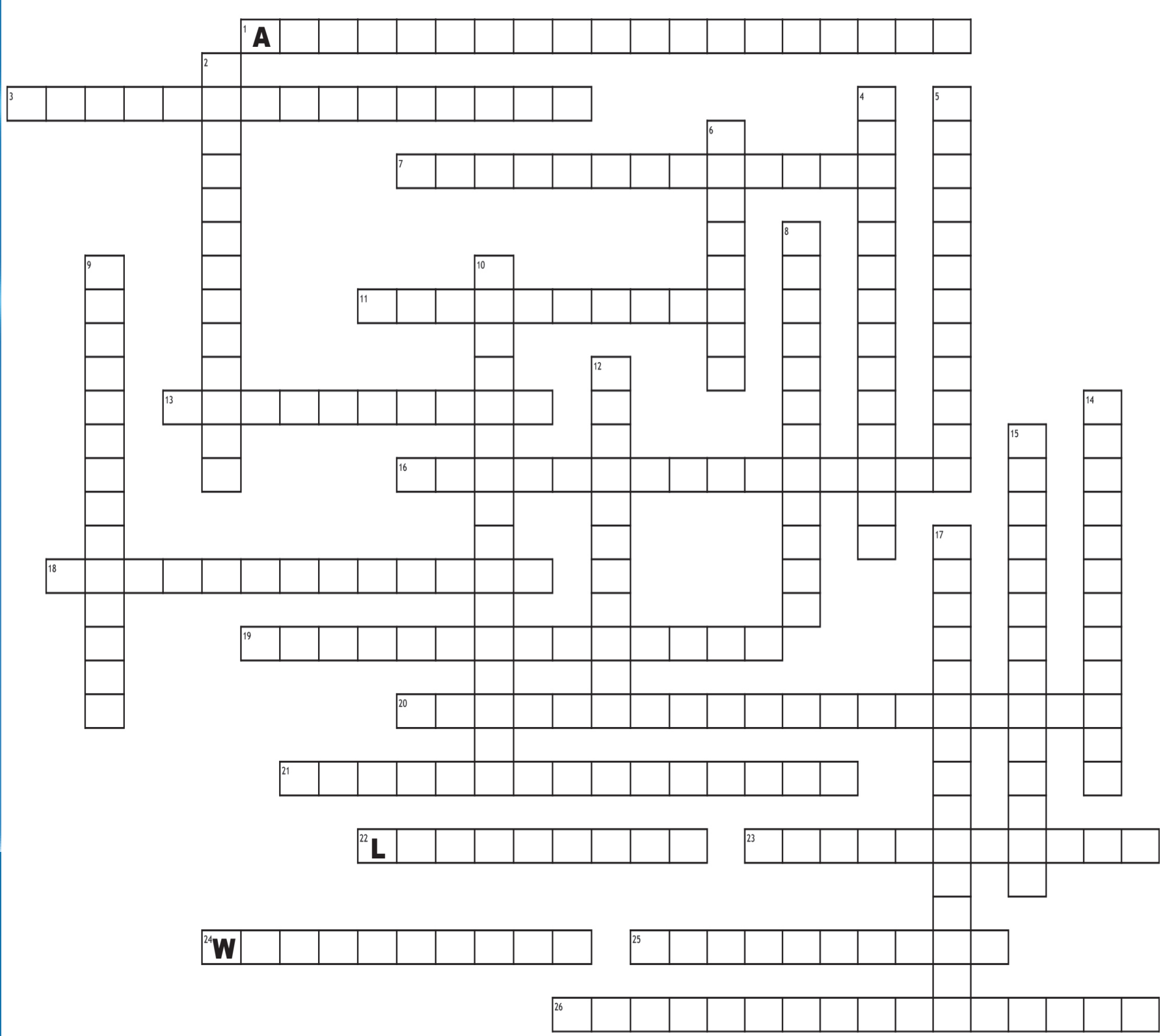

# Grow quick, easy and nutritious microgreens

Add fresh flavor to your meals year-round with microgreens. These easy-to-grow greens need minimal space and no special equipment for a flavorful and nutritious harvest in little more than a week.

Use microgreens on salads, soups, pizzas, omelets, in stir fries or as a snack. These tiny seedlings are packed with more nutrition than their mature counterparts.

Add a bit of spice to soups and

sandwiches with radish and mustard microgreens. Try red cabbage, chard, beets and amaranth for some added color. Sunflower's somewhat nutty flavor makes it perfect for snacking. Let some of your pea microgreens grow a bit taller to use in stir fries.

Fill a shallow container with a two-inch layer of moist potting or seed starting mix. Sprinkle seeds over the soil surface and lightly

cover with potting or seed starting mix. Water gently to ensure good seed-to-soil contact.

Continue to water often enough to keep the soil slightly moist. Reduce your workload and keep the planting mix consistently moist by covering freshly planted containers with plastic. Once the greens break through the soil, remove the cover and move the container to a sunny location or under artificial lights.

Increase the fun and success with a microgreen growing kit like the Organic Herb and Microgreens Grow Kit from Gardener's Supply ([www.gardeners.com](http://www.gardeners.com)). This set up is the perfect size for your countertop or other small space. The full spectrum light is adjustable so you can raise or lower it as needed whether growing short microgreens or taller herbs.

Or skip the growing mix and mess with a Jute Microgreens Starter Kit. Set the jute mat in the shallow tray, add seeds, and water. Then compost the jute mat after harvesting your greens.

Follow the planting directions on the seed packet. You typically need two to three tablespoons of seeds for an 11-by-21-inch tray. Buy enough seeds to make additional plantings every week or two to ensure a constant supply. Microgreens like most vegetables taste best and are most nutritious when eaten fresh. And these tasty bundles do not last long in storage.

The microgreens are ready to harvest once the plant forms the first set of true leaves. These are the leaves that resemble those of the mature plant. This takes anywhere from 7 to 14 days, depending on the room temperature and type of microgreens you are growing.

Use scissors to clip the greens off at ground level. If you prefer to use the whole seedling, roots and all, you will need to wash off any of the seed starting mix clinging to the roots.

Once you harvest all the greens, it is time to replant. Save money and be kind to the environment by composting the used planting mix and reusing containers. Convert

shallow fast-food containers into planting trays. Disinfect these or other planting trays before using them for subsequent plantings. Just soak the containers in a 10% bleach and water solution for ten minutes. Then rinse in clear water before planting.

Gardening doesn't get much easier than this. You will enjoy the fresh flavor all winter long as you wait for the outdoor growing season to begin.
