



Dudley-Charlton School District issues statement on teacher arrest

DUDLEY/CHARLTON — The Dudley-Charlton Regional School District Superintendent has issued an official response following the arrest of a teacher for child endangerment.

Dudley and Taunton police confirmed the arrest of Shepherd Hill Regional High School music teacher Thomas Wilson on child endangerment charges on Oct. 3, including possession of child pornography. The incident stemmed from an interaction in September when, according to news reports from Wilson’s court appearance, Wilson approached a 14-year-old Taunton woman at her home after meeting her online and believing she was 18. The school district had not issued any official written statement after the arrest, but on Oct. 8 Superintendent Steven Lamarche presented a statement to the School Committee seeking to ease any concerns regarding the incident and the district’s hiring process.

In the statement Lamarche acknowledged the arrest and assured parents and students that the district has processes in place to properly vet and hire. He also stated that the minor involved in the incident is not believed to be a Dudley or Charlton student.

“To our knowledge, based on our direct and ongoing collaboration with law enforcement, there is no indication of any connection between the current, ongoing investigation and our students or staff,” said Lamarche. “As a parent of teenagers myself, I relate to the fear, the worry, and the questions that moments like this bring. I carry the same profound weight of concern that many of you feel

Keep Charlton Beautiful celebrates continued success

CHARLTON — The Keep Charlton Beautiful Committee continues its mission to preserve and protect Charlton’s natural beauty after a successful year that saw the group earn significant financial backing through the Department of Environmental Protections Recycling Dividends Program.

Committee Chair Debbie Marquis provided an update to the Board of Health in September where she touted the group’s continued work to promote recycling, antilittering, and beautification

initiatives in Charlton. The main takeaways from the meeting were a desire to produce more awareness and buy in for the town’s pay as you throw agreement with Spencer and that the community received thousands from the Recycling Dividends Program that will help continue the committee’s mission.

Marquis first discussed how the organization received credit through the Recycling Dividends Program which translates to funding. The town can reach certain requirements that result in points that the state uses to determine money payouts that then support further Keep

Charlton Beautiful initiatives. Marquis said the last year was extremely successful for Charlton.

“Our point total has increased every year, and we believe this year we’ll be receiving around \$6,500 which is almost double what we got last year,” said Marquis.

The discussion then moved to the pay as you throw program, an agreement that allows residents of Charlton to dispose of trash in Spencer provided they purchase a sticker from the Spencer Water Board. Marquis said many citizens have benefited from the program, but they would like to see

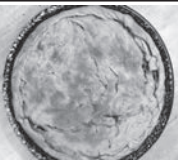
Mandeville and Richards are a married couple who entertain

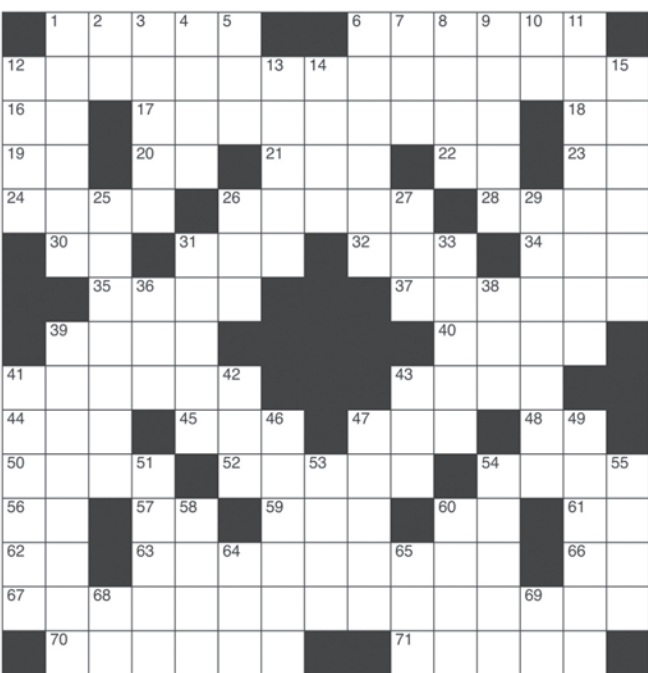

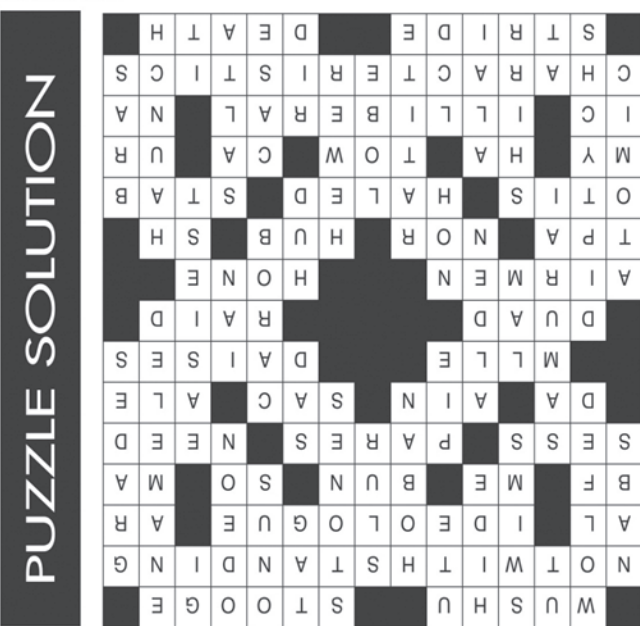

DA to host upcoming event on
holistic approaches to substance use
disorder treatment and recovery

SHREWSBURY — Worcester County District Attorney Joseph D. Early, Jr. is hosting a free event for the public focused on holistic approaches to substance use disorder (SUD) treatment and recovery on Thursday, Oct. 23, from 8 a.m. to noon at Veterans Inc., 59 South St., Shrewsbury.

This event, presented by the Prevention and Support Network, will feature keynote speaker Linda Geraghty, a trauma-informed yoga instructor and dedicated family recovery specialist prominently featured in the award-winning documentary “Our American Family.”

Ms. Geraghty will share insights into the role of mindfulness, movement, and self-compassion when exploring generational addiction and trauma. Her work emphasizes the importance of integrating mind-body practices into traditional recovery pathways to promote long-term healing for individuals and families impacted by substance use disorder.

The event will also include a panel discussion featuring professionals in wellness, nutrition, and fitness, further exploring how holistic strategies can complement traditional recovery supports. Refreshments, networking, and resource tables will take place from 8 – 9 a.m. The program will begin promptly at 9 a.m.

District Attorney Early is dedicated to addressing the root causes and impacts of the polysubstance use crisis, as well as the effects of trauma, especially on children. In 2015, he formed

the Central Massachusetts

Opioid Task Force, now known as the Prevention and Support Network, which has more than 800 members in the network. Additionally, Mr. Early launched the Critical Incident Management Systems (CIMS) software in 2020, which allows police throughout Worcester County to track overdose incidents as they occur and promptly follow up with survivors to assist them in obtaining treatment. In 2021, Mr. Early also established the Worcester County Drug Endangered Children's Alliance to identify and support children who have experienced a traumatic event. Federal grant funding was awarded in 2022 to support the expansion of the Alliance and the implementation of the Handle With Care programs in schools throughout the county, through which schools are notified by local police when a student has experienced a trauma such as viewing a drug overdose, enabling the school to reach out to the affected child.

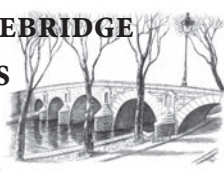

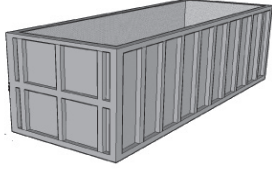

Collect and save some heirloom vegetable seeds

Be a part of history and save money when planting next year's garden. Collect and save the seeds from your favorite heirloom tomatoes, peppers, beans and peas this fall.

Seeds of heirloom plants have been collected and passed along for generations, producing offspring identical to the parent plant. Hybrids on the other hand involve crossing different plants to create a unique or improved variety. Saved seeds from hybrid plants do not grow into plants with all the same characteristics as the parent plant.

Heirloom peas and beans are generally self-pollinated, so they form seeds that will grow into plants like the parent plant. Allow the peas and beans you plan on saving to dry on the plant. Once the pods turn brown and the seeds rattle inside, they are ready to harvest. This is about six weeks after you harvest snap beans for eating and about four weeks after the normal picking stage for peas.

Protect plants from frost or pull them out of

the ground and hang them in a cool dry location, so the pods can finish drying if needed. Remove the pods from the plants, spread them out and allow them to further dry indoors for about two weeks.

Remove the seeds from the dried pods, store in an airtight opaque container in a cool dark location. You may want to store different varieties separately in paper packets and all the packets in one large airtight container. Label the seeds with the varietal name and date they were collected. Store in a cool location.

Saving seeds from tomatoes requires a bit different preparation. Once the fruit is fully ripe scoop out the gelatinous center. Place this in a container of water set in a warm location to ferment. Swirl or stir the contents twice a day. After about a week the good seeds will sink to the bottom of the container.

Remove and compost the layer of fermented tomato waste and the inferior seeds floating on the surface. Pour the

remaining water and the good seeds sitting on the bottom of the container through a fine mesh strainer. Rinse the seeds, removing any of the gelatinous material that may remain. Spread the seeds on a piece of paper to dry.

Once dry, place the seeds in an envelope labeled with the date and variety and set in a sealed jar or plastic container. Store in the refrigerator or other consistently cool location until it's time to start them for next season.

Use your saved seeds the following year for the best results. Then repeat each season.

Start with these and then consider trying other open-pollinated vegetables, flowers and even tree and shrub seeds. You'll find helpful

information in books, online and on the Seed Savers Exchange website. Saving your own seeds can help you save money while preserving and planting a bit of gardening history.

tonight. Please know that I approach these responsibilities not only as a Superintendent, but also as a father who wants every child in this community to be safe, supported, and able to thrive. I understand the public's concern. I share that concern and I want to reassure you that our protocols are in place, that they worked as designed."

The district puts all employees through background checks, including fingerprinting, CORI (Criminal Offender Record Information) checks, and SORI (Sex Offender Registry

Information) checks, in accordance with Massachusetts law. There has been no report that Wilson had any prior criminal arrests or had any violations on records at his time of hire. The district also provides oversight, training, and monitoring regarding potential incidents. When situations do arise, the district has its protocols and Lamarche said they responded accordingly putting Wilson on administrative leave.

"When a personnel matter arises, particularly one that involves the safety or well-being of students, the district acts swiftly, methodically, and in accordance with both state law and School Committee policy," said Lamarche. "We immediately collaborate with law enforcement, take steps to remove staff from active duty when appropriate, and implement continuity measures so that student learning is not disrupted. These are not decisions taken lightly, but they are taken firmly and decisively."

Police have confirmed that the investigation into the incident is ongoing. During his court appearance, Wilson was ordered held on \$10,000 bail and, if released, must wear a GPS monitoring device in public, and is not to interact with anyone below the age of 18 unsupervised.

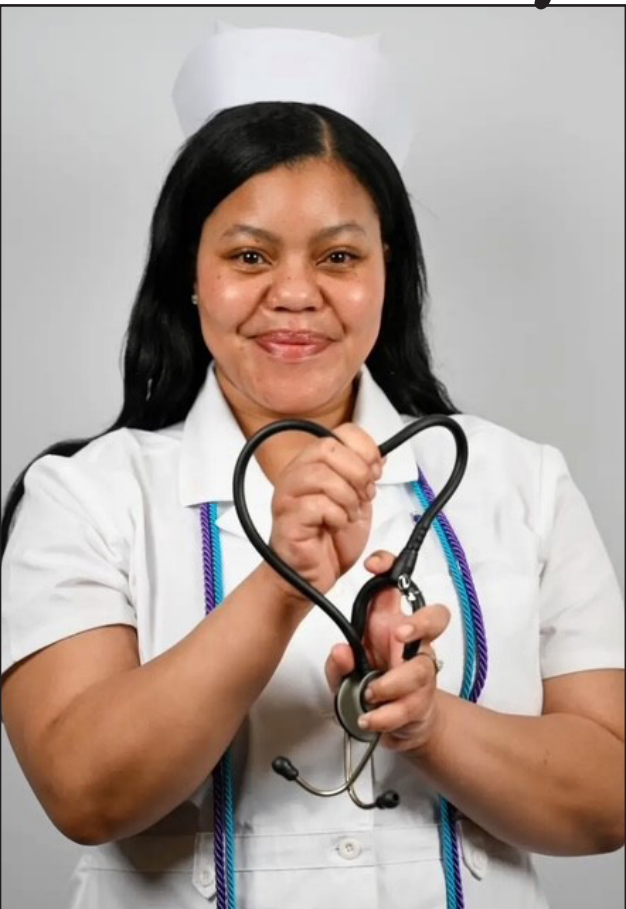

The need is growing, and with that comes increased expenses. With 200 people pledging \$50 each, we can meet our goal of \$10,000 by Oct. 31. A donation of \$10 can mean 500 pounds of food for the pantry to distribute! We are open Tuesdays 9 a.m.-1 p.m. and Thursdays 4-7 p.m. so monthly shoppers in need can obtain food to supplement their groceries.

This fall, as the nights stretch longer and the air sharpens, maybe the best resolution isn’t about what we argue over but what we build quietly together: a habit of small kindnesses, carried out close to home.

Prayer boxes confirm you matter

Last Tuesday, during our Bible exploration session (1 to 2 p.m. at CCUMC – open to any who wants to experience and explore the Bible), our facilitator started the session by reading some of the prayer requests that were submitted into prayer boxes by members of the Charlton area community.

The range of needs presented on the various prayer request cards reminds us how many burdens our fellow townspeople and neighbors shoulder – financial challenges, health issues, loss of loved ones, all manner of abuse, concerns about loved ones – the list is long.

The cards in each box give us at our church the opportunity not only to pray for each person, whether named, or associated with the request, but gave pause to think about the level of trust each individual has placed on us – taking it at face value that we will as a church honor our commitment to pray for, think about, and feel for that person.

And make no mistake about it – we do honor that commitment. It is a powerful statement of trust when someone – anonymously or face to face – asks for prayer, for help, and in the process admits grief, a loss, need.

It gives those of us who do and will pray for others the opportunity to affirm to that individual and those we pray for that they matter – to God and to us. Whether we say it directly, or by inference as evidenced by our regularly tending to the prayer boxes, prayer emails, or verbalized in church prayer requests – we want to help make lighter the load of those who are hurting.

Prayer is always one of the ways. But other outreach efforts exist as well – our food pantry, thrift shop, donations to local outreach efforts – a church primarily exists to share what God wants us all to know....that we matter to Him and to our faith family. And that includes you the reader.

Perhaps you may not be aware that there are pray boxes around the Charlton area in various businesses. Next to them are blank cards where you can fill in what you would like our church, which is to say our prayer warriors and prayer ministry members to pray on your behalf. It can be anonymous, or first name or however you wish. Regardless how you ask, just know you will be prayed for.

So if you place a prayer request in our prayer box be assured you matter to us, to God, and we will pray on your behalf.

Does prayer matter?

Ask the many people who have filled our prayer boxes over the many months we have been doing this ministry. Ask the people who feel a blessing from being prayed for or with.

To be sure, for some, perhaps folks trying to figure out God and faith, prayer may be a “hail Mary” a here goes nothing from a place of desperation. That’s ok. Reaching out to our Creator is a good thing. Next step might be sitting in the back of the sanctuary in one of the good houses of worship in our area, or walking the nature prayer trail at CCUMC.

Yes there are those who have scoffed at the offer people of faith provide when coming across someone who has experienced a loss, as if saying “I will pray for you,” or “may I pray for you,” are mere polite reflex responses. Nothing could be farther from the truth. It is an offer of much value – a gift, a promise that you matter, and that you are cared about, and that time will be expended to pray on your behalf.

Make no mistake about it – prayer is powerful, and a gift. It is also something most religions teach. It is a practice as old as history can record.

As a physician I know from my patients – some of whom have asked me to pray with them – that prayer is comforting, powerful.

Science shows that people who pray, who rest their hope on their Creator, often enjoy improved mental health, blood pressure, and are calmer, more at peace.

Medically – God may answer the prayer with a cure, or with the peace to handle the illness even if the person doesn’t recover. And sometimes it is in the praying that people come together, and families strengthened.

Sometimes, prayer helps us focus and quiet the noise of chaos that can envelop us; whether we pray alone or with others.

Prayer also gives us the opportunity to focus less on our selves, and more on the needs of others, and to let them know they matter.

Most of all, prayer is about relationship – calling our Heavenly Father on the ultimate 5 G network. It is a means of restoring that relationship, much as we do when we regularly communicate with friends and family.

Jesus gives us many examples throughout His ministry the power of prayer. Jesus often prayed and for many different reasons and in a variety of situations – sometimes for help from Above, sometimes for clarity, and always with gratitude.

Too often, we think prayer is just to ask for stuff, as if God were a celestial ATM machine doling out what we ask for. No doubt God does provide blessings to us on a daily basis if we take the time to look for them. But prayer in its simplest form is a phone call between us and God, a means to grow and keep the relationship as we would with anyone we cared about – we’d regularly communicate.

If you could experience the heart and feelings, the shared joy and anguish in our church prayer time, or the exchanges between our prayer warrior team – yes our church has a dedicated group ‘on call’ that can in fact be called upon to pray throughout the week – the help, love and support for those who reach out to us in times of need....you would know prayer is much more than a reply or group of words. It is a very deep and personal connection, and commitment to care.

In a world that is ever increasingly being made impersonal, how often are any of us made to feel like we matter? Perhaps that is one of the powers

Open enrollment: What to know before you enroll

For many people, fall brings an important opportunity: open enrollment. While it may not sound as exciting as planning for the holidays, taking a careful look at your workplace benefits now could save you hundreds or even thousands of dollars next year.

Open enrollment is the period when you will choose your medical and other workplace benefits for the year ahead. Most employers hold it in the fall, with elections taking effect in January. Once the window closes, you usually can’t make changes unless you experience a major life event like marriage, divorce, the birth of a child or when a dependent has become an emancipated adult.

While it may be easy to simply renew last year’s choices, that could be a costly mistake. Your employer’s plans, providers or costs may have changed. It’s also possible your own circumstances are different than they were a year ago—for example, if you had a baby, got married or expect new medical needs. Taking a fresh look helps ensure your benefits match your life today.

Here are a few tips for navigating open enrollment.

Compare health plans carefully. Employers often offer more than one health, dental or vision option. Look at differences in provider networks, prescription coverage and premiums. If you and your spouse both have coverage options, compare plans across employers. Just be mindful that some companies charge a fee if you enroll a partner who has their own workplace coverage. Many plans offer wellness discounts on monthly premiums based on your personal health condition.

Check your life insurance. Many employers provide a base level of life insurance, with the option to buy more. If your family has grown or your financial responsibilities have increased, now is the time to make sure you have enough coverage to protect your loved ones.

Consider disability coverage. A short-term disability plan can help cover income gaps for up to 12 months during recovery from surgery, illness, or childbirth. Long-term disability insurance offers protection if you’re unable to work again for an extended period up to age 65. Ideally, coverage should replace up to 60% of your pre-tax income.

Understand supplemental options. Some employers also offer accidental death and dismemberment (AD&D) insurance. While it can provide peace of mind, remember that it’s not a substitute for life or disability insurance, since it only covers specific accidents.

Take advantage of tax-friendly accounts. Flexible spending accounts (FSAs) and health savings accounts (HSAs) let you use pretax dollars for eligible medical expenses. If you have young children or other dependents, ask whether your employer offers a dependent care FSA to help offset care costs. Note that these are use-it-or-lose-it, so contribute only what you expect to spend every year. HSAs, available with high-deductible health plans, are more flexible since unused funds roll over from year to year and can even serve as long-term savings.

Review your retirement savings. While your retirement plan usually isn’t part of open enrollment, this is a good time to revisit it. Make sure you’re contributing enough to earn your employer’s match. Small increases can make a big difference over time.

Open enrollment may not be the most thrilling item on your fall to-do list, but it could be one of the most important. Taking a little time now to review your employee group benefits could give you greater financial security and extra savings throughout the year.

Idea in the mind!

Andrew Carnegie was born on Nov. 25, 1835, in Dunfermline, Scotland. In 1848, his family crossed the Atlantic and squeezed into a single rented room near Pittsburgh. Machines had wiped out his father’s weaving trade. His mother took in mending and sold bread to keep them alive.

No money. No connections. Schooling cut short. Odds of success? Near zero.

At 13—before child labor laws or safety nets—he was expected to earn a living. He worked from dusk till dawn for \$1.20 a week. Just enough to keep the rent paid.

He clawed his way to a telegraph office—first as a messenger, then as an operator, sending messages across the wire faster than any train.

It opened a door to the Pennsylvania Railroad. There, for the first time, he saw the inner workings of power. He watched the men at the top. He took notes. And somewhere along those tracks, he made a quiet decision: He wouldn’t just ride the rails—he’d own them.

He moved forward with that idea, built a steel empire, and became the

wealthiest man alive.

Carnegie then turned to a bigger question: What creates success?

In 1908, he met a young reporter named Napoleon Hill and dared him to find the answer. He opened doors to tycoons and inventors, told Hill to study them, and to write the playbook.

Years later, Hill delivered it—first in “The Law of Success,” then in “Think and Grow Rich.” That book went on to sell over 70 million copies—and it’s still reprinted and read around the world.

Of all the ideas Carnegie gave Hill, one grips me most. He reportedly said: “Any idea that is held in the mind—emphasized, feared, or revered—begins at once to clothe itself in the most convenient and appropriate form.”

Burn that into your mind! Let’s break it down. “Any idea held in the mind...”

What does it mean to hold an idea? It means you keep it alive. You see it in your mind every day. You write it down. You say it out loud. You paste it on your fridge. You carve time for it. You take small, doable steps now—not later.

“...Emphasized, feared, or revered...”

To emphasize means to want it deeply. You think about it often. You’re willing to give up comforts and distractions to chase it.

To fear it means the right kind of fear—the voice that whispers, “If I don’t act, this dream will die.” It gets you out of bed. It drives you to do the hard thing first.

To revere it means to honor it. You treat it like a calling. You protect it from doubt, from cynics, from your own excuses.

What happened to Carnegie when his dream began to clothe itself? The world began to respond. A skill put him near railroad men. A boom in demand met him on the tracks. A new way to make steel found him. Partners appeared. Doors opened. Setbacks drove him forward.

The idea became motion, then matter. It put on names, places, timing, and tools—until it wasn’t an idea anymore. It was his life.

Now you ask: When will my dream

happen?

When farmers plant seeds, they don’t demand a harvest tomorrow. They water. They weed. They walk the rows before sunrise. They fight off the pests, mend broken fences, pray for rain, and rise again.

When a child is conceived, no mother asks, “Why isn’t the baby born yet?” She nourishes it for nine months, knowing its time will come.

So it is with your dream.

One of the great teachers of human potential, Bob Proctor, taught that you may not know a dream’s gestation time, but you can shorten it through focus and concentration.

Show up when it’s boring. Work when it’s hard. Believe when no one sees. Be patient like a farmer. Fierce like a parent. Steady like the sun.

If you hold the picture in your mind, and you move your feet—

If you believe through the silence, Work through the doubt, Stay lit by a desire that doesn’t dim—Then one day, your dream, dressed in real life, will walk out to meet you.

Thrift shop finds



Many readers of this column enjoy attending estate sales or stopping when they see a “yard sale” sign. Some of you also like hunting for bargains at estate sales. In today’s column, I’ll share some exciting thrift shop, estate sale, and yard sale finds that took place this year, along with some shipwreck treasures that were recently discovered.

Some thrift shop buyers post their finds online on Reddit, and Yahoo! News recently shared a few. One buyer paid \$40 for a gold ring that was estimated to be worth \$162. Elsewhere, a Canadian woman found a diamond and pearl ring in a “store grab bag” from a Canadian thrift store which could also sell in the low hundreds of dollars. They said they were the third person to enter the sale and there were about 200 people waiting to come in. The dealer posted images of a statue which was titled “Dying Gaul” priced at \$8. There was what looks to be a Victorian era figural incense burner marked for \$5. The buyer said that they bought a Chinese vase for \$1 and had already been offered \$2,500 for it. The dealer estimated that their \$3,000 in purchases would yield \$30,000.

An Ohio couple had a great unexpected find when they decided to stop at a thrift shop while driving home. As they were leaving the shop, a gold frame caught the woman’s eye, according to the “U.S. Sun.” She purchased it for \$2.90. When she got in the car, she noticed a label that said “Johann Berthelsen.” She at first thought Berthelsen was a local painter, but her

research later showed he was a well-known artist. She consigned it to a local auction house, and it brought \$2,267.

Switching gears to the seas, coins from a 1715 Spanish shipwreck were just discovered in Florida, according to NBC News. Over 1,000 gold and silver coins were aboard the ship when a hurricane sank it off “Florida’s Treasure Coast.” The coins include pieces of eight, which could be broken into eight pieces and then spent individually. The coins are estimated to be worth \$1 million. Other items like a gemstone and gold necklace were also pulled from the wreck. Whether you’re diving 100 feet down into the ocean or diving into a thrift store jewelry box, you may be lucky enough to find some treasures too.

Every dollar counts when it comes to keeping kids warm

To the Editor:

It’s that time of the year again, fall is here, the nights are getting cooler, and before we know it the white stuff will be covering the ground.

For the last few years, our Knights of Columbus Council 199, in Southbridge, has been raising money to purchase and donate new children’s winter coats to Holy Trinity’s coat closet to be given away free to local children. Since 2022 we also donated 48 coats each year to Charlton St. School and 48 coats to West St. School, and coats are donated, as needed, to Catholic Charities, because of all these needs our supply of coats, once again, has been badly depleted.

This year, the cost for kids’ coats went up from \$248 per case of 12 to \$284 per case, the teen size coats went from \$304 per case of 12 to \$340 per case, despite the increase we already purchased 12 cases of kid size coats and two cases of teen coats. The total cost to purchase 13 cases of coats last year was \$3,387; this year, the 14 cases cost \$4,081 and we will need your help, even more, to cover the expense. If you’re a business or civic group, maybe you could donate \$284 and we could pay for one case; if

that’s too much to ask for, two donations of \$142 will cover a case, a person or a family could donate \$23 which we could put towards purchasing 1 coat. Maybe we won’t hit our goal of paying for the 14 cases, but whatever we do raise will put a new coat on someone’s child that might otherwise go cold this winter if we don’t.

We will also be holding a pasta & chicken dinner, raffles, and a turkey shoot on Nov. 8 at 5:30 p.m. at the La Salle Tuscan room to help defray the cost, tickets are just \$15 each with kids under 10 free. Raffles and the turkey shoot will be at a small additional cost.

These kids could be a neighbor’s child or most likely be someone you’ll never know or meet, but we could all get a warm feeling if we pitch in and help keep our kids warm this winter.

If you can help, checks would be payable to K of C Council 199 and can be dropped in the collection basket at St John Paul II Parish with a note on the envelope saying “Coats for Kids” or just mail them to us, our address is PO Box 176 here in Southbridge. Please don’t think that you won’t make a difference because every dollar counts, and it just takes \$23 of them to buy a coat.

“It’s nice that it’s a transfer station so there’s a lot more they can bring there like wood, cardboard, and plastic. It’s a great deal, but Charlton is a big town, so if you live on the Webster side, a lot of those people want to go to the Webster station, or if you’re a big family and you want to have barrels at your

house, I understand that, but we keep trying,” said Marquis.

She admitted that the service may only be convenient or suitable for a certain part of the Charlton population and while they want to see more usage, the average number sits at around 80 to 90 users showing that at least part of the population is benefiting from the option. Pay as you throw also helps contribute to the points total that earned Charlton that estimated

\$6,500.

Soon Keep Charlton Beautiful is hoping to have the town included in North Brookfield’s Hazardous Waste Day after failing to join Southbridge’s program. The committee is also hoping to recruit new volunteers, especially younger individuals, who can help Keep Charlton Beautiful continue to grow its mission towards preserving the beauty and image of their town.
