Brooklyn finalizing membership for Town Administrator Search Committee

BROOKLYN — The Town of Brooklyn is working on finalizing the membership for a new committee which will lead the search for a Town Administrator.

Talks of the new position, which would serve as the Chief Operating Officer of the town, began thanks in part to a recommendation by Brooklyn’s Town Governance Committee and have quickly progressed in the first half of the year.

Brooklyn has contracted with search firm Randi Frank Consulting, LLC to help with the process and plans to comprise the search committee of officials from the different town boards and committees. According to minutes from the Brooklyn Board of Finance’s June 17 meeting, the town approved the transfer of \$20,000 for the contract.

On July 7, First Selectman Joe Bellavance provided an update to the rest of the Board of Selectmen indicating that the search will include input from a variety of stakeholders.

“We’re reaching out to members of our boards and commissions for input. This is not to be part of the search, but the firm is going to be interviewing members of our commissions by some of our supervisors and town employees because we have a draft of a job description that’s built,” said Bellavance. “What they’re going to do at this point in time is collect information from all of us and all of those key constituents to better understand from all these different perspectives what we’re looking for in a town administrator.”

The search committee membership will include all three Selectmen and two members each from the Board of Finance and Town Governance Committee. While they had previously considered the inclusion of an employee on the committee, Bellavance gave a good reason why they chose not to embrace that option.

“I think we discussed this before and all agreed we don’t want to have an employee on there that makes it feel like somebody’s got a leg up on who the new boss may be and such. So, the committee will be just the seven members,” the First Selectman explained.

No solid timeline for the hiring process has been made public. The town administrator’s salary is expected to be around \$120,000 to \$150,000.

Before beginning his coaching career, Osbey was a standout player at Nichols College, where he earned a Bachelor of Science in sports management. During his time with the Bison, he served as team captain and helped lead the program to its first NCAA Tournament appearance, first NCAA Tournament victory, and first Sweet 16 berth in school history. Osbey was part of teams that won the 2015–16 ECAC Championship and the 2016–17 Commonwealth Coast Conference Championship, marking one of the most successful stretches in Nichols College basketball history.

Public survey to help guide Killingly superintendent search

KILLINGLY — The Killingly Public School District has completed a survey designed to increase public input into their ongoing superintendent search.

The survey was officially launched in June 2026, and ran through July 8 as a tool to help guide the Board of Education and their consultants in finding a new long-term leader for the district.

The link brought participants to a series of questions asking their relationship to the town, including whether their a resident, parent, of staff member, and asked for input on strengths of the district and the most significant challenges Killingly faces for the future.

It also asked about what leadership experience should be considered for the position, such as prioritizing principals, classrooms teachers, administrators, or experienced superintendents, and what kinds of specific expertise and qualities stakeholders are looking for in a new school leader.

“The purpose of this survey is to provide the Killingly Public Schools Board of Education with a broad perspective of community opinion about the most desirable attributes for a new superintendent of schools,” the survey read. “Your responses to the survey items will enable the Board to create a profile of these attributes that will guide the recruitment To SEARCH page A10

Pomfret Historical Society hosts program on “Witnessing Hidden Patriots”

POMFRET — On Aug. 1, the Pomfret Historical Society (PHS) will host a program about the military legacy of one Connecticut family from the Revolutionary War to World War II. The program will take place at Pomfret’s historic Old Town House, 11 Town House Dr., at 3 p.m.

Pat Wilson Pheanious of Ashford will share the journey of her family from an enslaved couple in Guilford to her father, Lt. Col. Bertram Wadsworth Wilson, a Tuskegee Airman who served in WWII, Korea, and Vietnam. The family military legacy and their commitment to education and Civil Rights is an American story deserving a place in the 250th celebration of the Declaration of Independence.

A Connecticut native and E.O. Smith graduate, Pat Wilson Pheanious holds degrees in English Literature, Social Work, and Law from the University of Connecticut. A lawyer since 1981, her career has spanned academia, social service administration, and public policy. She served as Connecticut’s Commissioner of Social Services (1999–2007) and represented Ashford, Tolland, and Willington in the Connecticut House of Representatives (2018–2022).

Pheanious’ commitment to education about Black History is deeply personal. She had long cherished her father’s legacy as a Tuskegee Airman but had no idea that her history

reached far into America’s past in pre-revolutionary Connecticut. However, in 2017, research by The Witness Stones Project founder Dennis Culliton revealed five generations of her family history that had been lost to time. That discovery reshaped her life and inspired a new direction in public service. Pat became Chair of the Witness Stones Project Board in 2019 and its Executive Director in 2024. In September 2025, she led the Project’s transition to Historic New England, where she became Director of the Stopping

Stones Program. The Program now includes the Witness Stones Project as its educational arm.

As Director of the Stopping Stones Program, Pheanious works with communities across the country to research, acknowledge, and commemorate the lives of enslaved people through permanent memorials that restore their names, honor their humanity, and recognize the essential role their labor played in building towns, institutions, and prosperity throughout the North and across the nation.

“Witnessing Hidden

Patriots from the Revolution to the Tuskegee Airmen” is a personal testimony about finding one’s place in American history and a lesson for all of us about what it means to be an American.

Folkerts is majoring in Physics at Bates.

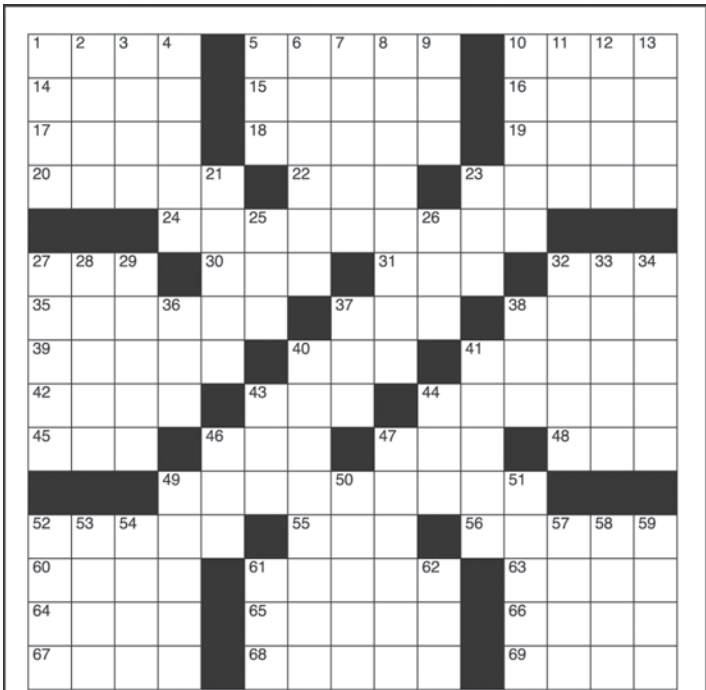

A community’s voice matters most

The search for a school superintendent is one of the most important responsibilities any Board of Education will undertake. Budgets can be adjusted, buildings can be renovated, and curricula can evolve, but the person chosen to lead a school district sets the tone for years to come. That is why Killingly’s decision to actively seek public input before making its choice deserves recognition.

Too often, superintendent searches happen largely behind closed doors. While personnel matters must remain confidential, the qualities a community wants in its educational leader should never be a mystery. Parents, teachers, staff, students, taxpayers and business owners all have a stake in the future of the district. Inviting them to help shape the profile of the next superintendent is not simply good public relations. It is good governance.

The survey recently conducted by Killingly Public Schools asked thoughtful questions. Rather than asking residents to weigh in on individual candidates, it focused on the district itself. What are Killingly’s strengths? What challenges lie ahead? What experience should the next superintendent bring? Those are exactly the conversations a community should be having before resumes are reviewed and interviews begin.

Every district has its own personality. Some communities may prioritize financial management. Others may be looking for an instructional leader, a skilled communicator, or someone with experience navigating changing enrollment and state mandates. There is no universally perfect superintendent. There is only the right superintendent for a particular district at a particular moment.

Killingly appears to understand that distinction.

The district is also fortunate that this search is not taking place during a crisis. Dr. Susan Nash departed on good terms to accept another superintendent position, allowing the Board of Education time to organize a deliberate search rather than scrambling to fill an unexpected vacancy. By appointing veteran educator Ken DiPietro as interim superintendent, the board has created stability while giving itself the opportunity to be selective instead of rushed.

That patience may ultimately prove to be one of the board’s greatest assets.

Across Connecticut and the nation, experienced superintendent candidates are increasingly difficult to find. The demands of the position continue to grow as school leaders balance academic achievement, special education, staffing shortages, budgets, mental health concerns, safety planning, technology and community expectations. Finding someone with the right mix of experience, leadership and communication skills requires more than posting a job opening. It requires a clear understanding of what the community values.

Of course, collecting public input is only the first step. The greater challenge is demonstrating that those voices were heard. While the board cannot publicly discuss individual applicants, it can explain how community feedback influenced the characteristics it prioritized during the selection process. That transparency builds trust, even when every resident may not agree with the final choice.

The next superintendent will inherit both opportunities and challenges. Killingly has dedicated teachers, supportive families and students capable of remarkable achievements. Like many districts, it also faces financial pressures, evolving educational expectations and the ongoing work of preparing students for a rapidly changing world.

No superintendent will solve every problem overnight. Success will depend not only on the individual selected but also on the willingness of the community to support that person once the search concludes.

A superintendent should never be viewed as a miracle worker or a lightning rod. The position is most effective when the community, administration, faculty and Board of Education move in the same direction with shared goals and mutual respect.

Killingly has taken an encouraging first step by asking an important question: “What kind of leader do we need?”

The answers may vary from one resident to another, but the willingness to ask the question sends an important message. Strong schools are built not only by strong leaders, but also by communities that understand their voices matter.

We must be vigilant for attempts to hijack our local governments

To the Editor:

In many small towns, longstanding traditions of cooperative local governance are being disrupted by a new wave of hyperadversarial tactics. What may look like isolated conflicts over solar projects or school policies is part of a coordinated national strategy. Over the past several years, conservative and MAGA-aligned organizations have shifted their focus to “hyperlocal capture,” training activists to weaponize municipal procedures to stall or derail community initiatives.

Groups such as the Leadership Institute, Citizens for Sanity-aligned networks, and Moms for Liberty have published playbooks that encourage flooding meetings, filing excessive FOIA records requests, and exploiting minor procedural technicalities to force delays. These tactics are

especially effective at undermining timesensitive projects like municipal solar installations, where even a few months of litigation can cause developers to withdraw.

Fortunately, many communities are responding. Nonpartisan civic groups across New England are organizing to counter misinformation, restore constructive public engagement, and ensure that the broader majority participates when forced referendums occur. Local governance works best when residents show up, stay informed, and refuse to let coordinated disruption drown out community priorities.

I remember moving to Pomfret several decades ago and thinking what a great place to live, thrive, and raise a family. Perhaps I’m naïve, but I still believe Pomfret is a great place to live, thrive, and raise a family. From the time I moved here there has been political discord to some degree. However, folks could argue their position vehemently then go and sit down and catch up on family or anything else that may come up in conversation. There are people that I feel are on the completely opposite end of the political spectrum from me, but I would not hesitate to ask that person for help or offer that person help if needed. Isn’t that what a community is supposed to be about.

Recently, Pomfret passed a solar array, with 55 percent of the voters agreeing with the referendum question. There was a great deal of back-and-forth discussion prior to the vote. A town official went so far as to bring a lawsuit against the town. There was a discussion that since a Town official has a fiduciary responsibility to work in the best interest of the Community they serve and if the referendum failed this individual could be held liable for funds that the town would lose. I’m not saying I agree with this, but it’s a terrible thought to even consider. What I am curious about is why, in a community that has never experienced a Freedom of Information request, there are now six of these requests on file with the Town. I’m curious as to why folks keep questioning the things mentioned in the FOI’s knowing full well, that once the requests are made there is a procedure that must be followed prior to giving an answer to the specific question. By raising the issue and not waiting for the answer, folks seem to be making the Town officials out to be liars who are with-

holding information. I’m curious as to why some questions have been asked and answered, yet folks keep asking the questions as if they haven’t received an answer. A perfect example of this has to do with ARPA funding.

By federal law, the Board of Selectmen had sole authority to spend those funds. The first thing the BOS did was arrange for an independent agency to review all funding spent, to ensure transparency and accountability. Then the BOS set up a committee of Boards and Commission members, along with local Business leaders, to offer suggestions and discuss the best way to spend this money and do it within the time frame outlined by the Federal Government. One of the things suggested was \$30,000 to set up a zoom meeting network for, the Community Center, PCS, and the local Library. Through judicious review, the BOS was able to get some work done at PCS for only \$2,800. After the pandemic, the need for Zoom meetings was eliminated. This project was accomplished at a minimal investment, that allowed the town to use the funding for other needed projects, while being transparent and judicious in not wasting the funds entrusted to our town by the federal government.

I’m curious. I would love to see Pomfret remain a great place to live, thrive, and raise a family. Can we do that under the current circumstances? Or are we going to become a place where people will accuse their local officials, most of whom have faithfully served our community for decades, of being nefarious individuals?

I vote to turn down the rhetoric, and everyone remembers to be nice.

Her impressive height and lanky build make her transformation a convincing one, and it isn’t long before she finds herself confronting the horrors of war head-on.”

On July 11, I had the pleasure of helping with the open house at the historic Cady-Copp Cottage on Putnam Heights (Killingly Hill until 1855). Thank you to everyone who helped in any way and to all those who attended. Built circa 1745 by wealthy Killingly resident Joseph Cady for the family of his daughter Damaris and her husband Reverend Perley Howe, it is a treasure for traveling back in time to the 18th century. Owned by the Aspinock Historical Society, it has never been modernized. It has no electricity, no indoor plumbing except for the fittings for a hand pump in the pantry/buttery, and no heat. It was donated to the Society by the late Barbara Peckham, has been placed on the National Register of Historic Places, and is a Connecticut State Archaeological Preserve. In 1992 an archaeological survey was done on the site which unearthed over twenty-five thousand artifacts including over 800 nails, shoe buckles, cuff links, buttons, ceramic shards from various periods of occupation. “Toys include an iron mouth harp, an iron jack dating to the 19th to early 20th century, a bone-saucer shard from a child’s tea set, slate board fragment and slate pencil fragments.” “Tea-drinking is evidenced by cups, saucers, creamers, and tea pots.” “Seven of the marbles were found on the north side of the house directly below a kitchen window, indicating that this nook bordered by the pantry and kitchen was a play area.” A detailed list of artifacts from the dig can be found at the Aspinock Society rooms in the Putnam Municipal Complex. (See the State Archaeological Preserve Booklet for additional information. Unless other sources are given, most information in this article can be found in that booklet).

Rev. Howe had been the pastor in Dudley, Mass., where a number of his children were born, but unfortunately several died at a very young age. He was apparently a giant of a man for his time, being 6 feet 7 inches tall. I looked at the low ceilings in the Cady-Copp Cottage and thought surely he had to bend to go in the cellar or to the second floor. He must have bumped his head more than once. Fortunately, some of the children of Rev. Howe and Damaris Cady Howe did live to maturity--- daughter Damaris and sons Isaac Cady Howe, Perley Howe, Joseph Howe and Samson Howe. Unfortunately, Reverend Perley Howe did not live to see his children reach adulthood. He died on March

Earth — we are the ones!

To the Editor:

Well, America is now 250 years old! Though still young by global standards, it feels special to us Americans. It’s easy to forget that in 1776, independence was far from a popular cause. Many colonists remained loyal to Britain, while others simply wished to stay out of the conflict altogether. Only a determined minority believed enough in different vision of the future to risk everything for it.

You could argue that America’s most important military victory occurred right in the beginning, when George Washington led the tiny Continental Army across the icy Delaware River on Christmas night in 1776. Those ill-equipped and freezing men then marched nine miles through the darkness toward Trenton, leaving bloody footprints in the snow. Arriving early in the morning, they launched a surprise attack against the Hessian mercenaries, among the most feared professional soldiers in the world, and won a stunning victory.

That incredible triumph sent shock waves across the Atlantic to England and throughout the thirteen colonies. Suddenly, more Americans joined in imagining a different future—independence. We owe so much to those brave unknown soldiers.

This Fourth of July, I found myself thinking about the stories that came to life for me over the 13 years I lived in Philadelphia, particularly the immense sacrifice of the Continental Army. They made everything we modern Americans enjoy today possible, and, if we’re honest, take for granted.

Thinking about this made me wonder what those unknown soldiers who survived the Crossing of the Delaware, or the brutal Valley Forge winter of 1777-78, would think if they could see us today. What would a half-starved, half-frozen, unpaid soldier, carrying his own rifle into battle, think of modern America and all we have? And, how would he compare Donald Trump to George Washington?

Few today realize that Washington funded himself and all his military expenses for the entire eight and half years of the Revolutionary War, with no guarantee of reimbursement. All the while, leading his men from the front, sharing the hardships of his soldiers, living in the same camps, and repeatedly placing himself in mortal danger. It is remarkable that he survived the war at all with bullets piercing his coat in battle. This was real leadership and his men practically worshipped him for it.

What would these men make of President Donald Trump—who received five military deferments during the Vietnam War? What would they think of the extraordinary wealth Trump has gained while serving as president, of his lavish lifestyle, accepting a \$400 million jet from Qatar and Nobel Peace Prize someone else had won, of the ballroom? Of tax policies that overwhelmingly benefit the Epstein Class while cutting programs that helped poor Americans. Of open influence-buying from billionaires who sat in the front row of his inauguration? Of the wanton destruction of the natural environment (which of course, belongs to us all), to make a few CEOs ever richer? Would the Continental soldiers believe their sacrifices had been worth it?

America owes an immeasurable debt to its founders, but especially to Washington and the ordinary soldiers who secured our political independence. In 2026 however, we face a different challenge requiring a different kind of courage. Scientists today are now, in many respects, the new defenders of humanity’s future. Their battlefield is not fought with muskets but with research, evidence, and innovation. They work to understand the complex and miraculous web of life here on Earth and protect it from man’s relentless development and climate change. Yes, the stakes today, are every bit as profound as those faced by the Continental Army. Our future is at risk. But

will enough of us see this in time?

Just as many Loyalists resisted independence in 1776, many people today resist the alarming findings of scientists and the changes they tell us are necessary. Of course, change has never been comfortable. Yet refusing to adapt has often proven far more dangerous than embracing it.

Take Donald Trump, who has repeatedly argued against highly efficient, inexpensive clean energy technologies—even criticizing wind turbines simply because he dislikes how they look. Have you ever seen a coal power plant or oil refinery? Talk about ugly! Is a pollution-belching industrial coal plant and sprawling fossil fuel infrastructure really more beautiful than the elegant sweep of a modern wind turbine powered only by the air? I think not.

Clean energy is, in many ways, the very embodiment of the independence the

Continental Army fought for. Every rooftop covered with solar panels shifts power away from authoritarian petrostates and multinational oil companies and places it into the hands of “We the people.” Russia, Saudi Arabia, Iran, and the world’s oil companies all seek to preserve the old energy system because it keeps your money flowing to them. Yes, installing solar panels on your own roof is more than an environmental decision—it is an act of independence! Not only does it save you money, it reduces your dependence and vulnerability, and reduces conflicts driven by fossil fuels, which in turn strengthens our national security. It also leaves a healthier world for our children. That’s real independence!

The Continental Army soldiers were the ones who secured America’s first independence. Today, we are the ones entrusted with securing its future. By embracing

science, protecting our environment, and investing in clean energy we can give our children a new kind of independence. If we do, future generations of Americans—and people around the world—will look back with the same gratitude that we owe those unknown soldiers who crossed the Delaware.

If you felt proud to be an American on our 250th anniversary, then perhaps the greatest way to honor those unknown heroes is not simply blowing up some fireworks, but to continue their work for independence. The ultimate act of patriotism is the protection of our children’s natural inheritance—our fragile living planet. Without that, there will be no great celebration 250 years from now.

Protecting the integrity of our elections is an American responsibility

To the Editor:

Remember hanging chads and butterfly ballots? After the chaos of Bush v. Gore, Congress came together in 2002, Republicans and Democrats alike, to pass the Help America Vote Act (HAVA). Connecticut’s own Senator Chris Dodd was a principal author of the Act. The goal was to assure all American citizens that their vote counted and restore their faith in the legitimacy of our elected government. The Act created the U.S. Election Assistance Commission (EAC): a bipartisan agency that certifies voting machines, runs the national voter registration form, standardizes poll worker training, and hands out federal grants so states can run clean elections. By law, no more than two of its four commissioners can belong to the same party.

On Thursday, July 9, Trump fired all of the EAC Commissioners. The two Democratic commissioners were fired by email. The lone remaining Republican received a call and was asked to resign. (The other Republican had resigned to join the Heritage Foundation.) The EAC now has zero commissioners, zero quorum, and zero ability to do its job, four months before Americans vote in the midterms.

Two weeks earlier, the Supreme Court’s Trump v. Slaughter decision tore up a 91-year-old rule that let presidents remove independent agency officials only for cause. Trump wasted no time purging the independent EAC. In Justice Kagan’s dissent, the shadow docket decision transfers government authority from Congress to the President and reshapes the Nation’s separation of powers.

“President Donald Trump’s decision to remove all members of the U.S. Election Assistance Commission just months before the midterms threatens to ‘undermine’ trust in American democracy and sets a “dangerous precedent,” experts told Newsweek. The Trump Administration has sought to restrict voter registration, limit mail-in ballots, collect voter data and relitigate the 2020 election, which Trump has baselessly claimed he won. (The Hill)

Across the political spectrum alarms are sounding. As one election law scholar put it, a Republican president reaching for federal control over what’s traditionally a states’ rights issue “defies my understanding of how Republicans work and what they’re interested in and where they want the locus of power and authority to be.” Election experts have been blunter still, calling the president himself the single biggest threat to the integrity of elections, not as a partisan jab, but as a statement of fact.

Americans of every political persuasion should agree on one principle: public confidence in free, fair, and transparent elections is essential to our democracy.

This is not a spectator moment. Here’s what we can do:
Vote – Participate in record numbers. A hobbled EAC makes every vote matter more, not less.

Call your senators and representatives. Demand they push to confirm new, bipartisan and independent EAC commissioners immediately, and demand oversight hearings on the EAC firings.

Demand Congress reform the Supreme Court which has lost public trust. It needs term limits, restrictions on the shadow docket, a binding ethics code and cameras in the courtroom.

Demand Congress reassert its authority. HAVA was Congress’s law. Congress can act to protect it and should do so.

Support state and local election officials. Volunteer to be an election worker. They’re the ones who’ll be running your polling place this fall with less federal support than before.

Regardless of political party, protecting the integrity of our elections is an American responsibility. Our elections belong to us, not to any one president. Our Democracy depends on independent election oversight. So, say so, to your newspapers, your neighbors, and your representatives. Encourage everyone to get out and vote for candidates who will protect our elections this November.

One citizen, one vote continued

To the Editor:

This requires more than a brief statement, so please bear with me. We cannot understand the electoral college without understanding our history as a nation. It was not actually big states vs. small states but slave-holders (south) vs. non-slave-holders (north).

Enshrined in the US Constitution on Sept 17, 1787, was the three fifths rule when electing the President. At that time, nearly 1/3 of the country’s populations were slaves. So each state would count all of the free people, then add a count of three fifths of its slaves. Thomas Jefferson, a slave holder, was elected because of this rule which gave southern states more votes. In fact ten of the first twelve presidents were slave-holders, and worked to keep the white males in power. This amounted to a ‘pro-slavery’ bias on the electoral college system.

Today, 175 years after our civil war, the electoral college system still violates the principle of one person, one vote, because smaller population states’ electoral votes count more than larger population states. For instance, one electoral vote in Wyoming might account for around 194,000 people, while an electoral vote in Texas, Florida or California might account for over 700,000 people. The ‘winner take all’ philosophy

erases millions of votes for a state’s ‘loser’ even before electoral ballots are cast in the nation’s Capitol. If you live in a ‘blue’ state and vote red; or if you live in a ‘red’ state and vote blue, your vote doesn’t really count. And losers of the national popular vote - as in 1888, 2000, and 2016 - become president.

Today’s citizens, are an unimaginably wide variety of people. And no state - large nor small - should take priority over one citizen, one vote.

The “National Popular Vote Inter-State Compact” empowers its state electors to award their votes to the winner of the national popular vote. It lets the people pick the president...every vote equal, every vote matters. Currently Connecticut is one of 18 states to have signed the NPVIC, which only goes into effect after enough states, representing 270 electoral votes, sign on. So far, they have 82 percent of that number. But every citizen in the USA should have the opportunity to have their vote for president counted.

To get a remarkably clear investigation of this topic, check out a PBS Independent Lens special [youtube.com/watch?v=T7m-M8q70iUw](https://www.youtube.com/watch?v=T7m-M8q70iUw). It is an hour well spent.

Everyone taking it personally and flipping out on social media that they weren’t hired in this go-round apparently fails to understand that time is on Uline’s side. We must do better than our current President

He also outright cheated to overturn a World Cup decision obliterating the good will that the American people created in graciously hosting their global counterparts.

Local residents graduate from Eastern in 2025-26 academic year

WILLIMANTIC — More than 800 Eastern Connecticut State University students received undergraduate and graduate degrees in the 2025-26 academic year, culminating this past May in two commencement ceremonies at the conclusion of the spring 2026 semester.

Among the graduates are: Roger Brodeur of Putnam, who graduated with a Bachelor of Arts in Art.

Jack Lomax of Putnam, who graduated with a Bachelor of Science in Business Administration. Julia Trainor of Putnam, who graduated with a Bachelor of Arts in English.

From first-generation college students to seasoned professionals pursuing advanced degrees, the Class of 2026 hails from nearly all of Connecticut’s 169 towns, 24 U.S. states, and 28 foreign countries. The graduates range in age from 19 to 81, with 28% being

the first in their families to graduate from college and 11% being NCAA Division III student athletes. Women make up 60% of the class, and approximately 30% of students identify as people of color.

The graduates went through the University’s School of Arts and Sciences, School of Education and Professional Studies, and Graduate Division. Popular undergraduate majors included business administration, psychology, English, health sciences, and art. At the graduate level, students received advanced degrees in applied data science, management, accounting, education (early childhood, elementary, secondary), special education, and educational studies/technology.

During her keynote speech at the undergraduate commencement ceremony, Beth Regan ‘79, justice and chairwoman of the Mohegan Tribal Council of Elders, urged the graduates

to be flexible as they enter their careers. “The universe may have other plans,” she said. “When those moments are presented to you, embrace them. If you allow yourself that flexibility, you may experience the best adventure you never could have imagined.”

President Karim Ismaili offered his congratulations to the Class of 2026. “What you have accomplished is no small thing,” he told the graduates. “You have navigated deadlines and exams, long nights and early mornings, work, family responsibilities, leadership roles, internships, athletics, and all the unexpected realities of life.”

U.S. Senator Richard Blumenthal was among the special guests. “We live in difficult, sometimes dark and daunting, times. ... We have been through tough times before. We are a resolute and resilient nation, and it is you whose service and dedication will help get us through.”

During his remarks at the graduate ceremony, World Bank Executive Harold Tavares, recipient of Eastern’s second annual Distinguished Public Service Award, told the graduates to lead with courage and to pave the way for others. Reminding them that they are in the minority of Americans with an advanced degree, he said, “Doors are opening for you. Be sure to hold them open for those around you. Each of you has the power - and the responsibility - to improve the human condition.”

Eastern alumnus James Woulfe ‘09, chief of staff for the mayor of the City of Hartford, welcomed the graduates to the University’s alumni family. He reminded the graduates that they are not alone on this journey. “Tonight, you become a part of the Eastern alumni family. Stay connected. Lean on one another, and lean on us.”

10, 1753 in his 43rd year of consumption leaving his widow and young children.

The Cady-Copp Cottage also became the home of Reverend Howe’s successor, Reverend Aaron Brown. Rev. Aaron Brown, of Windsor, was a 1749 graduate of Yale, who was ordained pastor of the First Congregational Church of Killingly on January 19, 1754. Exactly where he lived when he first arrived on Killingly Hill is unclear. Did he board with the widow Damaris Howe and her family? Did he stay at Felshaw’s Tavern at the four corners? Did he stay with Dr. Thomas Moffitt’s family (across from the present Putnam Heights Cemetery but in an earlier house)? Did he stay in a house nearer the meetinghouse? By the end of 1754 he was a resident of the Cady-Copp Cottage for on Nov. 21, 1754, Rev. Brown married Damaris Howe, widow of Rev. Perley Howe. Find-a-Grave lists children Abeline Brown and Elizabeth Brown, who are buried in Aspinwall Cemetery, but they did not live to reach adulthood. Poor Damaris buried so many children.

Like many ministers, Rev. Aaron Brown tutored the area’s promising young men who wished to go to college. It is known that he tutored his stepson, Joseph Howe, who graduated from Yale in 1765 and went on to become pastor of the New South Church in Boston in the 1770’s. He also tutored Manasseh Cutler, another Yale graduate and later a minister in (Ipswich) Hamilton, MA and co-author of the Northwest Ordinance of 1787 that prohibited those states from becoming slave states. A third student was Amasa Learned, a “Killingly representative to Connecticut’s Constitutional ratification convention and later a member of Congress. According to a tradition...the youths were prepared for their college studies in the second-floor south room of the Cady-Copp house.” (State Archaeological Preserve booklet).

Rev. Brown also taught at least one of his granddaughters, Sarah, daughter of Perley Howe (Jr.), according to a letter in the pension files of a Thompson African-American named Mingo Pollock. Mingo’s future wife, Molly Pegan (Piggen) was also a resident of the Cady-Copp Cottage as a child according to Sarah, “I was frequently at his house & I lived at his house when young & went to school. He brought up a coloured girl named Molly Piggen who I knew very well. When Molly was about 18 years old she was courted by a black man from Thompson and my Grandfather was

opposed to having Molly marry him & he by means of a ladder went(?) to visit her unbeknown to most of the family & it was said in the time that he married her & went to live with him in Thompson.” (extracted by Marcella H. Pasay, author of Full Circle). Sarah Howe later married Luther Warren who eventually owned the former Felshaw Tavern stand.

Rev. Aaron and Damaris Brown would have been most active in the community, helping all in their times of need. The 1770’s became especially difficult even before the war. A number of long-time residents died in 1773, perhaps of smallpox which was hitting New England. Sadly, daughter Abilene Brown died on January 25, 1773, age 17.

The Boston Tea Party of December, 1773 and the subsequent closing of the Port of Boston heightened awareness for potential danger. In 1774 a liberty pole was erected on Killingly Hill so signals could be sent if needed. Then in January 1775 Rev. Brown and his stepson Samson Howe deeded what is now the Putnam Heights common for a Killingly militia training field. In April of that year many local men answered the call to arms with the Lexington Alarm. Killingly Hill became busier than ever, but that’s another story.

Rev. Aaron Brown did not live to see our nation’s independence. His stepson Joseph, a minister in the New South Church in Boston, had moved to Hartford, CT following the British occupation of Boston as people fled the city and the church closed (probably to be near his fiancé). Joseph died Aug. 25, 1775. Reverend Brown went to the funeral but took ill and died in Ashford on his way home on Sept. 12, 1775. I think the grief-stricken widow/mother could take no more. She lived only a few months and passed away February 4, 1776. (Larned, Ellen D. History of Windham County CT, Vo. II, Swordsmith ed., p. 132,133; Hale Cemetery Collection, Aspinwall Cemetery). The Cady-Howe-Brown era had ended. David Copp, his family and descendants would be the next owners of the cottage. This old house has many other tales to tell.

income deduction. The QBI deduction generally allows eligible pass-through business owners to deduct up to 20 percent of qualified business income, and OBBBA made that deduction permanent after it had been scheduled to expire at the end of 2025. That permanence gives many pass-through owners more clarity, but it does not eliminate the need for planning. Entity structure, taxable income, compensation, retirement contributions, and the timing of income all still matter.

OBBBA also affects high-income taxpayers through changes to itemized deductions, including limitations that may reduce the after-tax value of deductions for those in the top bracket. For owners who use charitable giving, state and local tax planning, or other deductions as part of their personal strategy, that makes coordination between the business plan and the household tax plan even more important.

For some founders and growth-oriented owners, the expanded qualified small business stock rules may also change the calculation. QSBS treatment can make certain C-corporation structures more compelling, particularly where a long-term exit is part of the plan, but the rules are technical and should be evaluated carefully with tax and legal professionals.

The practical point is this: tax law should not drive the entire strategy, but it can meaningfully affect the order of operations.

The primary ways business owners achieve wealth extraction

There are several ways business owners commonly move value from the company into their personal financial lives. Each has tradeoffs.

While they do hope to fill the position before the end of the year, they have an established plan in place to ensure the district doesn’t miss a beat. In June, the Board of Education announced it had secured stable temporary leadership in Ken DiPietro, a former Superintendent from Plainfield with more than 50 years in public education. He will lead the district as Interim Superintendent through at least the next school year.

Salary and bonuses can provide predictable income and may support retirement plan contributions, but they also create payroll tax considerations and must remain reasonable based on the role performed. Distributions from pass-through entities may be more flexible, but they depend on business structure, profitability, and basis. Dividends may be relevant for C-corporations, but they can create double-taxation concerns.

Fringe benefits, retirement plans, deferred compensation, and insurance strategies can also help align business cash flow with personal goals. For owners nearing a sale or succession event, equity monetization may become part of the plan through a partial sale, management buyout, ESOP, recapitalization, or third-party transaction.

None of these tools is automatically “best.” The right mix depends on the owner’s tax profile, business structure, cash flow durability, succession timeline, and personal financial independence target.

Reinvestment should meet a higher standard

Business owners are naturally inclined to reinvest. That instinct often built the company in the first place. But not every dollar reinvested creates transferable value.

A disciplined owner should ask: Will this investment improve margin, reduce key-person dependency, strengthen recurring revenue, deepen the management team, or make the business more attractive to a future buyer? Or is it simply making the business larger, more complex, and more dependent on the owner?

Growth is not the same as value. Revenue is not the same as transferable enterprise worth. The investments that matter most are the ones that improve durability.

Build wealth in parallel
The strongest business-owner plans usually build wealth on two tracks. One track continues to strengthen the business. The other steadily builds personal liquidity, retirement assets, taxable investment accounts, estate planning structures, insurance protection, and diversified income sources.

That parallel approach gives the owner more choices. It can reduce pressure to sell during an unfavorable market. It can make succession planning more flexible. It can also allow the owner to make better strategic decisions because their family’s entire financial future is not dependent on one transaction.

A practical planning

framework

Start with a clear estimate of how much of your net worth is tied to the business. Then stress-test that number. What happens if the valuation multiple is lower than expected? What happens if a sale takes longer than planned? What happens if taxes, debt, or working capital needs reduce net proceeds?

From there, determine a personal wealth extraction floor: a disciplined amount or percentage of free cash flow that moves outside the business each year. Then set reinvestment hurdles, so capital only stays in the business when it is expected to create value above a reasonable risk-adjusted threshold.

The owners who tend to navigate this best are not the ones who choose business growth or personal security. They are the ones who coordinate both.
