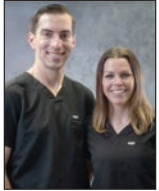

Local Scoutmaster honored for decades of service

DUDLEY — The Dudley Board of Selectmen honored a longtime leader of local Boy Scout Troop 237 earlier this month as her decades of service as scoutmaster comes to an end.

Diane Anderson has dedicated 30 years of her life to Scouting, 28 as scoutmaster for Troop 237 in Dudley.

After announcing her retirement from her scoutmaster post earlier this year both state and local leaders sought to recognize her many years of dedication presenting her with compliments and commendations during the Board of Selectmen’s Oct. 6 meeting.

Anderson was presented with citations from the Board of Selectmen and both the State House and Senate. State Representative

John Marsi and the Board of Selectmen praised her devotion to scouting and its role in the maturing and growth of local youth.

Selectman Jason Johnson said Anderson has been a vital part of Troop 237’s success.

“As she’s decided to step down and still be involved with scouting and help with the transition, we wanted to get some folks to come and celebrate all that hard work

and dedication not only to the boys of Troop 273, but all the great work that she’s done for the town as well,” said Johnson.

He then read the citation from selectmen which complimented her for “making the town a better place.” Selectman Steve Sullivan added that Anderson has been an “unbelievable asset” to the community.

State Rep. Marsi, a former Dudley selectman whose

own kids have benefitted from scouting, added to the praise.

“To say that Diane has touched a lot of people’s lives and helped a lot of people’s kids, including my own, is an understatement,” he said.

While Anderson is retiring from scoutmaster duties she still plans to be involved and remain a dedicated volunteer for Troop 237.

All Saints Academy students join in art and storytelling to celebrate Indigenous Peoples Day

WEBSTER — First and sixth grade students at All Saints Academy came together for a special collaborative art project in observance of Indigenous

Peoples Day that combined creativity, culture, and storytelling. Students sat together to create relief paintings of Native American symbols, honoring the rich traditions and history of Indigenous people.



As an introduction to their artwork, students learned about Native Americans’ use of pictographs and oral histories in sharing their history, beliefs, and everyday life. It was from these that they were able to discover that before written language existed, Indigenous people shared knowledge and traditions through symbols carved or painted on rock surfaces, as well as stories passed down from one generation to the next.

After samples of Native American pictographs, students were challenged to create their own original stories utilizing the ancient symbols. With imagination and teamwork, first and sixth-graders created their stories—each symbol representing a person, place, or idea important to their story. To depict their tales, students created colorful relief paintings with pastel crayons and watercolors. The finished artwork not only showcased students’ artistic talent but also their understanding and appreciation of Indigenous cultures and oral traditions.

The project was a beautiful reminder of how art and storytelling bring individuals together across cultures and generations—a wonderful way to celebrate Indigenous Peoples Day at All Saints Academy.

Safe boating certificate course scheduled at Milford High School

MILFORD — The United States Coast Guard Auxiliary Tri-State Flotilla, Massachusetts will be instructing a boating safety class Saturday, Nov. 8 from 9 a.m.-5 p.m. that meets current state mandated educational requirements.

The Boat America Course is offered in a one-day format developed to provide the skills and confidence needed to explore the coast and inland waters by boat. Basic knowledge and skills are needed to have safe and enjoyable boating experiences.

This course is perfect for families that have just purchased any type of boat or are planning to in the future, and for the boater keeping up with changes to boating regulations and laws. Basic marlinespike seamanship (knots etc.) will also be included. Successful completion of the course will certify any minor, from 12 to 16 years of age, to operate a powerboat, including a Personal Water Craft / Jet Ski (for 16 & 17-year-old operators), on all Massachusetts waters; in conjunction with the Mass. Environmental Police. Approved by National Association of State Boating Law Administrators (NASBLA) it will also cover the requirements to operate a vessel in most other states & many countries where boating safety education is mandatory including Rhode Island and Connecticut.

The Hanson-Milone Boater Safety Act, signed into Mass. Law January 8, will now require ALL Mass. motorboat operators to complete an approved Safe Boating Certificate course before April 1, 2026 for anyone born after Jan. 1, 1998, and by April 1, 2028 for boaters born before Jan. 1, 1998. Enforcement of the new law will begin on Sept. 1, 2026.

This course meets the future Mass. requirement. Most boating insurance companies offer a discount on premiums for successful completion of this course.

Participants 16 years old and under must be accompanied, in person, by a registered parent/guardian. Space is limited, so register soon:

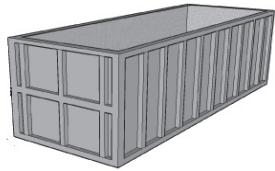

EDITORIAL

The gift of ordinary days

There’s a certain pressure, in the modern age, to make every moment feel remarkable. We rush toward milestones and spectacles—the fireworks over Webster Lake, the parades down Oxford’s Main Street, the first snow that dusts Auburn’s rooftops. Those moments matter, of course, but they’re not what give a community its soul. The real character of a town is written in the quiet, dependable rhythm of ordinary days.

Look closely, and you’ll see how much happens without fanfare. The teacher who straightens desks before dawn. The DPW crew that clears storm drains before the rain hits. The library volunteer who spends her Tuesday afternoon alphabetizing books no one will ever know she touched. It’s easy to overlook this kind of work because it asks for nothing. It isn’t flashy. It doesn’t trend online. But without it, a community starts to fray.

We live in a time that celebrates disruption and rewards spectacle—where noise often drowns out nuance. Yet the things that keep a town strong are rarely loud. They’re the patient habits that go on repeating themselves, season after season. The neighbor who checks in when your mailbox piles up. The crossing guard who still waves to every driver after twenty years. The shopkeeper who leaves the lights on a few extra minutes for the late commuter. These moments are invisible architecture. They build trust, and trust is what allows everything else to stand.

There’s also humility in the ordinary day—a quiet understanding that community isn’t built by a few grand gestures, but by countless small ones. Nobody gets a headline for returning a lost wallet or helping a stranger carry groceries. But those are the acts that make a place feel like home. They create a shared expectation that we’ll look out for one another, even when no one’s watching.

This fall, as the pace slows and the air cools, it’s worth remembering that steadiness is a form of strength. We don’t need constant novelty to feel alive or connected. What we need is consistency—the rhythm of familiar faces, reliable hands, and the reassuring hum of a town that takes care of itself.

The truth is, most of what sustains a community isn’t remarkable at all. It’s the repetition of good work done quietly and well. And that, in the end, may be the greatest gift our ordinary days have to offer.

In the last article, the history of the semiprofessional Auburn Cyclones exhibit was highlighted. In this article the person who started the Cyclones, William Edward May, known as Billy May, will be the focus.

Billy was born on April 7, 1908, in Worcester to Oliver Willcot May and Isabell Hogg.

They were married on Jan. 13, 1908, in Manhattan, New York City. In the 1910 census they were living at 20a Hope Ave in Worcester and his father was running a grocery store. Billy’s father did register for the World War I draft but didn’t serve. His mother immigrated from Ireland in 1889. Billy had a brother, Samuel Aldrich, who was born Jan. 20, 1910.

By the 1930 census, the May family was living in Auburn and was farming at 60 Old Common Road where Oliver remained until he died Dec. 11, 1970. He was a meat cutter at the Metropolitan State Hospital in charge of nine employees. Oliver also registered for the WWII draft April 26, 1942.

All this shows that Billy came from a hard-working family, which helps to explain the dedication to the Cyclone Football team for a decade.

Billy graduated from South High School in Worcester in 1926, as there was no high school in Auburn at that time, so students had to take the trolley into Worcester.

He then attended Becker Business School, which became Becker College, in Worcester. When he was 19, he organized the Cyclone Football team. It was a pickup team for fun, but it quickly became a serious contender for central Massachusetts football league. It was very popular on Sunday afternoons to watch this team play, with reports of six thousand fans attending home games and it wasn’t unusual to have 2,000 to 3,000 fans follow them to away games. As the team improved, Billy went from being a player to coaching, to business manager. The team had to pass the hat at the games to get funding as there was a law against charging admission. As the team progressed, publicity improved, and college football players wanted to be on the

team. The Cyclones needed them because other teams that they were playing against were using college players.

This is when Billy decided to work at the business end of the team and let Tom Callan a Holy Cross star, be the player coach. When the team disbanded in 1938 it was due to the present players wanting to move on and the new players wanted to be paid more. The Cyclones had an ending record of 72 wins, 14 losses and five ties.

Billy May met his wife, Mary White, at a Cyclone football game when she was a nurse for the Auburn school system, in the early 1930s. They were married in 1935 and had three children, William, Charles and Susan. Life after the Cyclones involved youth and sports. In 1947, he formed a youth football team in his neighborhood. Billy was also involved with youth ice hockey and according to a 1977 article by Nick Manzello, Billy was the first to bring youth ice hockey to Auburn and Auburn High School. The first appearance of the high school team in the yearbook was 1954. There is a picture of Billy with his son, Chuck, in a Red Wing hockey uniform from the 1960s at the Auburn Historical Museum.

Billy was a mailman delivering the mail by motorcycle for 18 years. He also worked for the George F. Blake Company in Worcester for 33 years when he retired in 1973. He was an active member of the Masons Lodge and was past master of the Joel H. Prouty Lodge in Auburn. He served on many committees as a long-time member of the First Congregational Church of Auburn.

Billy and Mary moved to Hayward California where he died in 1997 from cancer. Both Billy and Mary are buried at the Hillside Cemetery in Auburn.

Simulation Theory

During an interview years ago, Elon Musk famously claimed there’s a “one in billions” chance that this is base reality. In other words, he believes it’s far more likely that we’re living in some simulation than in the original, foundational universe.

But what kind of simulation? A digital computer program? A spiritual matrix? That idea may sound bizarre—after all, everything feels real, doesn’t it?

Yet this isn’t just late-night dorm room talk. Some of the world’s most respected thinkers are taking the idea seriously. It’s not about rejecting science—it’s about following it to its farthest, strangest conclusions.

Let’s start with String Theory. It’s a theoretical framework in physics proposing that the fundamental building blocks of the universe aren’t particles, but tiny vibrating strings. These strings, depending on how they vibrate, give rise to all particles and forces—even gravity.

The math checks out, even if we haven’t proven it experimentally yet. It’s one of the best candidates for a “Theory of Everything” that could unify quantum mechanics with general relativity.

At the 2011 Isaac Asimov Memorial Debate titled “The Theory of Everything,” theoretical physicist Sylvester James Gates, Jr. dropped a bombshell. He revealed that he found something astonishing embedded in the equations of string theory: patterns of “error-correcting codes”—the same kind used in computer programming to detect and correct mistakes.

Sitting next to him, astrophysicist Neil deGrasse Tyson reacted with stunned amazement: “You’re blowing my mind right now!”

Why would error-correcting codes appear in the fabric of the cosmos? Gates himself admitted he doesn’t know the implications yet. But the mere presence of such codes leads to a wild yet serious question: Could the universe itself be structured like a vast, intelligent computation?

That’s where the idea of the simulation arises.

On late-night television, when asked if he thought we were living in a simulation, Neil deGrasse Tyson replied, “I wish I had a good argument against it, but I don’t…”

And while the science doesn’t prove this, it pushes our imagination into territory that philosophers, mystics, and spiritual traditions have been exploring for millennia: that reality is deeper than it appears.

It doesn’t mean we live in a video game controlled by aliens.

It might mean that the universe is information-rich, consciousness-infused, and governed by principles far beyond our current understanding.

My friend, physicist and laser pioneer Dr. Mani Bhaumik, wrote about this in his book “Code Name God.” He argues that modern physics, far from disproving a creator, points toward a transcendent source of intelligence.

That’s a powerful idea: that our minds are just beginning to awaken to truths already embedded in nature.

Dr. David Selbie, interpreting the implications of quantum physics, has emphasized: Our choices and behavior as conscious observers—not the accumulation of material goods—are what matter. Those things are transient illusions. True immortality lies in evolving consciousness beyond the physical hologram.

Similarly, Dr. Amit Goswami, a quantum physicist known for his explorations of consciousness, has stated: “Contrary to what they tell you, you are not a limited material being.”

This idea echoes something timeless. Whether through the lens of physics or philosophy, the message is the same: You are more than you think you are.

Quantum physics shows us that particles don’t even exist in fixed states until observed. They remain in a state of possibility. In a strange and very real way, attention shapes outcome. This isn’t just a metaphor—it’s physics, though interpretations vary.

So what does this mean for us?

It means we live in a participatory universe. That our focus, our awareness, our very act of observation—matters. That we are not passive passengers in reality, but active participants.

No, quantum physics doesn’t promise we can manifest Lamborghini with our thoughts. But it does suggest something far greater: that we are wired into the very structure of existence, and our consciousness has weight in the world.

And that, perhaps, is the most hopeful message of all.

We are not powerless. We are not accidents. We are not limited.

We are participants in something vast, intelligent, and alive.

The universe is not outside us. We are part of it. And the deeper we look, the more we realize: We are more than we think we are.

Mark the location of late emerging perennials

Butterfly weed (*Asclepias tuberosa*) has red, orange, or yellow flowers and can be late to emerge in spring.

These late emerging perennials may have you worried they died overwinter. Linger winter weather and cooler than normal spring temperatures can further delay their appearance. Be patient and know this adaptation allows them to avoid damage from late spring frosts as they wait for the soil to warm and begin growing.

Hardy hibiscus, balloon flower (*Platycodon*), leadwort (*Ceratostigma*), Crocosmia, Red-hot poker (*Kniphofia*), whirling butterflies (*Gaura lindheimeri*), Butterfly bush (*Buddleia*), Russian sage (*Perovskia atriplicifolia*), and blue spirea (*Caryopteris x clandonensis*) are a few you may have growing in your garden. Many native plants like butterfly weed (*Asclepias tuberosa*), swamp milkweed (*Asclepias incarnata*), black-eyed Susan (*Rudbeckia*), Culver’s root (*Veronicastrum*), Indian pink (*Spigelia marilandica*), Joe-pye weed (*Eutrochium* spp. formerly *Eupatorium*), asters, liatris, and goldenrods can also be late to emerge. It’s easy to accidentally weed these out during spring clean-up. These plants are worth the wait

since they add extra color to our mid and late season gardens. They extend the beauty, pollinator appeal and food source for many insects, and songbirds visiting your gardens.

Try leaving the stems or a portion of the stems of these plants intact until the new growth emerges. Unfortunately, many of us have accidentally removed these, too.

Plant tags will identify the plant and mark their location but can be unsightly. Try placing a colorful dowel rod, golf tee or short bamboo stake at the base of these plants. Number each and mark them on your garden plans to help track the plant’s identity.

Stones or shells, where they are abundant, can be placed next to or surrounding these plants to mark the location. These tend to stay put and may be less obtrusive than plant tags. Just be sure to alert anyone helping in the garden of their purpose and that they need to stay put.

Or mark their spot with bulbs. Plant spring flowering bulbs like daffodils, hyacinths and alliums next to these plants to extend your garden’s bloom time and help prevent damage to the perennial plants.

Avoid tulips, crocus and other bulbs that animals love. Squirrels, chipmunks, rabbits and deer may move or eat your marker.

Consider using a mix of early, mid and late spring flowering bulbs to further extend the color in your garden. Or skirt these late emerging plants with early spring blooming perennials like woodland and creeping phlox, candytuft or rockcress. You’ll enjoy the added color as you wait for the other plants to make their appearance later in the spring.

When spring arrives, exercise patience as you wait for the return of beautiful, late emerging perennials.

Master Masons celebrate 250-year anniversary of “Knox Noble Train of Artillery”

STURBRIDGE — On Sunday, Oct. 12, the Sturbridge common was packed with spectators to watch the Master Masons celebrate one of the most pivotal episodes in American military history, leading to the founding of this great nation 250 years ago. In the winter of 1775-1776 Colonel Henry Knox’s Noble Train of Artillery passed through this area in Massachusetts on the way to Boston. Here is a little bit of history.

On Nov. 16, 1775, General George Washington sent Colonel Henry Knox to Fort Ticonderoga in upstate New York to retrieve cannons and munitions from the Green Mountain Boys led by Ethan Allen and Benedict Arnaold. Colonel Henry Knox was only 25 years old and traveled 300 miles in the dead of winter of 1775-1776 from Fort Ticonderoga to Boston. Knox selected 58 cannons that was transported by oxen-drawn carts in what became the “Knox Noble Train of Artillery.” After 56 days of traveling, Knox and his troops erected fortifications over Dorchester Heights overlooking Boston. The British were driven out of Boston to a flotilla of ships heading for

Nova Scotia. General George Washington claimed his first victory of the American Revolution, in a large part due to Colonel Henry Knox’s Noble Train of Artillery.

To commemorate Brother Knox’s achievement and contribution to American independence, a public celebration hosted by the Grand Lodge of Masons in Massachusetts of Boston and the Major General Salem Towne Lodge AF & AM, of Southbridge MA, was held on the Sturbridge Town Common. This celebration included guest speakers by the Grand Master of Masons of Massachusetts’ Most Worshipful Brother George F. Hamilton. A guided walking tour of the old burial ground highlighting the grave sites of the Revolutionary war veterans. This includes Boston Tea Party participant Samuel Hobbs (1752-1785). There was firing volley demonstrations of revolutionary war era muskets by the Sons of the American Revolution and the firing of a revolutionary war-era cannon by the Grand Lodge of Massachusetts Henry Knox Noble Train Artillery cannoners.

Local civic organizations that participated in this event included the Sturbridge Historical Society, and both chapters of the Sons and Daughters of the American Revolution. The Charlton Grange No. 92 and the Rainbow Girls Assemblies of Oxford, Barre, and Worcester were on hand to share their role in supporting the community. Members of the Major General Salem Towne Masonic Lodge from Southbridge had a booth set up handing literature out to people who wanted to know more about Freemasonry and selling hot dogs.
