# Southbridge celebrates new rail trail

SOUTHBRIDGE - The Southbridge community had much to celebrate on Friday, Nov. 7 at its Ouinebaug Valley Rail Trail (QVRT) Ribbon-Cutting.

Decades in the making, the QVRT is in its final stages of construction thanks to \$2.6 million in Economic Development Administration funds, \$1.5 million in MassDOT funds, and \$500,000 in Mass Trails funds. Last Fall the Town of Southbridge began construction of this picturesque route along the Quinebaug River and they are now seeing the finishing touches added over the next six months to complete the connection between Dudley and Sturbridge.

## Wings of Song sings of night, moon, and stars

STURBRIDGE — Night. Darkness. Silence. In the sky on a clear night, our Moon may be riding high. Our sibling planets may be seen piercing the darkness with clear, unblinking points of light: Venus, Jupiter, Mars... Stars suns like ours, but at unimaginable distances-send their light out, visible on Earth perhaps many centuries later.

In late December in Earth's Northern Hemisphere, nights are long and cold. For millennia, humans have gathered to mark this time with fires and dances and singing and musical instruments and stories and revelry: to tell the dark and the cold that our spirits are undaunted, and to celebrate the lengthening of days that begins at this time.

Wings of Song—a community chorus centered in Sturbridge and drawing its fifty active members from a large number of towns in south-central Massachusetts and northeastern Connecticut—celebrates both Christmas and the Winter Solstice in song this year with a focus on night, moon, and stars: the darkness from which light is born,

The celebration takes the form of two concerts: one at St. Joachim Chapel, 16 Church Street in Fiskdale (part of Sturbridge), on Saturday, Dec. 13 at 7:30 p.m., and the other at the Elm Street Congregational Church, 61 Elm St. in Southbridge, on Sunday, Dec. 14 at 3 p.m. As always, both concerts are free to the public, with a freewill offering collected. As always, both venues are handicap accessible. As always, yummy refreshments will be served after each concert. And as always, folks are advised to come early to be sure of a seat.

Music Director Nym Cooke provides this glimpse into what you'll hear: everything from an operatic quartet by Baroque composer Jean-Philippe Rameau (1683-1764) to the bluegrass gospel song "Beautiful Star of Bethlehem"; from "Moon is Walking" by Joseph Shabalala of Ladysmith Black Mambazo to the world premiere of "Notte" by Wings of Song tenor Gianni Davilli; from the tender Danish Christmas song "Among the Stars of Midnight" to John Rutter's magnificent choral setting of "O Holy Night"; from the shape-note song 'Star in the East' to Henry VIII's "Green Grow'th the Holly"... Audiences will join us in singing three Christmas classics that feature stars: "The First Nowell," "O Little Town of Bethlehem," and "We Three Kings of Orient Are."

People are strongly encouraged to bring stars or moons, to be held or hoisted aloft at key points in the proceedings. More than one moon is fine, in the spirit of celebration.

Many came out for this special event to remember all those who came before them to help make this project a reality. Tom Chamberland helped advocate for a regional trail system as far back in the 1980s. The Commonwealth of Massachusetts purchased the Southbridge spur from the Providence and Worcester Railroad in 2004 to establish a community-based rail trail, thanks to efforts from the late Representative Mark Carron, whose recent passing was recognized with a moment of silence. Only now in 2025 can Southbridge finally celebrate this momentous occasion, an accomplishment made possible thanks to its grant funders and the tremendous support of its Town Officials. The QVRT will help promote economic development along and near the rail trail and offer the region a new trail experience, one with views of the historic downtown and serene natural beauty along the river eventually leading to the Quinebaug River Reservoir at the Dudley town line to the southeast and the Westville Dam to the northwest.

## Marsi champions change to M.G.L language referring to disabilities

BOSTON — The State House of Representatives on Beacon Hill has approved an amendment that will replace language referring to those with intellectual, physical and developmental disabilities in Massachusetts General Laws removing what many consider offensive and outdated terminology.

The amendment, H. 4704, was championed by the House Committee on Ways and Means which includes 6th Worcester District Rep. John Marsi, a former Dudley selectman whose district includes Dudley and Charlton. Marsi presented his inaugural speech on the issue on Nov. 5, helping lead the charge towards a 152-0 vote of the House to approve the amendment.

The rule will now replace the language of "disabled persons"

to "persons with disabilities" and cate for a special needs child. considered a derogatory term for individuals with disabilities. those with disabilities.

leaders of the Commonwealth it's up to us to set the tone for how individuals with disabilities are referred to and how they are treated," said Marsi in his speech on the House floor, which he also shared on social media.

Giving to charity feels good but understanding the tax benefits can benefit both the charity fies. To claim a deduction, you and you. You'll only benefit from itemizing if your total deductions, including charitable gifts, exceed these amounts.

rules and their results. The people who go far - the ones we admire — aren't necessarily smarter or luckier. They're just the ones who decided certain rules didn't apply to them.

Stephen King ignored the publishing world's "one book a year" rule. He wrote so fast that his publisher couldn't keep up, so he created a pseudonym-Richard Bachman-to release more. When readers discovered the truth, both names became bestsellers, and the rule was never taken seriously again.

Or take Jeff Bezos, who in Amazon's early days answered customer emails and support calls at 2 a.m., believing connection mattered more than sleep. That obsessive rule-breaking focus on customers became the DNA of one of the world's biggest companies.

Or Ed Sheeran, who played dozens of free or low-pay gigs in a single year, sleeping on couches and busking on street corners. Friends said he was devaluing his art - but those nights built the loyal fan base that later filled stadiums.

Or Elon Musk, who broke Silicon Valley's "focus on one thing" rule. While most founders were told to master one company at a time, he was building rockets, cars, and solar panels

Each one of them broke a rule that sounded smart but wasn't serving the dream.

I'm not suggesting that people should work 24/7, but I am saying that sometimes you need to work 24/7. Knowing when to be flexible with your work-life balance can change your entire future. It's knowing the difference between a guardrail and a cage.

Discipline isn't always about sticking to the same schedule forever; sometimes the boundaries need to bend. The rules that once protected your peace can, at a different season of life, start protecting your comfort instead. And comfort is a silent thief of momentum.

Every ambitious person reaches a point where "balance" becomes an excuse. Where the rule that once made sense starts standing in the way, the truth is, you can't build an extraordinary life while staying entirely within ordinary limits.

Add a bit of life to your holiday gatherings with the help of succulents. You and your guests will enjoy the easy-care beauty of succulents. Their subtle colors and dramatic form make them great gifts and decorations now and throughout the year.

Small-scale succulents provide a multitude of opportunities for incorporating them into your holiday celebrations. Just select containers that complement, but don't overpower their charm.

Create a succulent garden to use as a centerpiece for the table. A shallow container filled with a variety of succulents with different shapes and colors is sure to capture everyone's attention. Set the container on a saucer to protect the table and add a complementary

table runner for even greater impact.

Water thoroughly but only when the top few inches of soil are dry and just often enough to keep the plants from shriveling. These winter-growing conditions often encourage a spring display of colorful and unique flowers.

Share these directions with your guest and if possible, the name of the succulent. This helps your guest keep the plants alive to enjoy for years to come.


Additionally, in August, QCC received a \$5,000 Military and First Responder Grant from CSX Transportation, which will also be used to support the transition

Equipped with skills in EMR/EHR systems, infection control, and vital signs monitoring, he is eager to contribute to the healthcare community with compassion and professionalism.







Let me give you a little history about this Traveling Chainmail Armor Apron. This beautiful heavy chain link apron was made by brother Michael Sgariglia of the Quinebaug Masonic Lodge with the permission of Brother Robert Schremser, who was our District Deputy Grand Master (DDGM) in 2010. Brother Mike Sgariglia made chainmail armor as a hobby before he became a Master Mason. Because of this he was inspired to make the apron. He got the idea when he was at another Lodge of Instruction class and saw that lodges gave out a prize for the most attended and thought of something personal for the 24th District. Brother Sgariglia made it with a pair of pliers in each hand. It took about 30 hours and 3500 rings to make the Chainmail Armor Apron. It consists of silver and blue stainless-steel rings. The apron weighs approximately five pounmds and can be worn. The brethren from the Major General Salem Towne Lodge (MGST) are proud to exhibit this apron until the next L.O.I. class. This is why the members of the (MGST) Lodge try to attend the L.O.I. classes in large numbers. The highest attendance from each lodge keeps this Chainmail Armor Apron. At this meeting of the L.O.I. the (MGST) Lodge had the most brethren in attendance. They were able to take this Chainmail Armor Apron home where it was made and originated from until the next L.O.I class.
