



Inaugural exhibition “Secret World of Elephants” to open in Worcester March 7!

The exhibition features a life-size model of an African elephant—the largest living land animal. A video projection on one side of the African elephant model shows the skeleton of this massive mammal and provides an inside look at how it processes the huge amount of food it eats—about 300–500 pounds per day—and elephant gestation, which can last for nearly two years, longer than any other living mammal.

WORCESTER — “The Secret World of Elephants” exhibition opens at the EcoTarium at 11 a.m. on March 7, marking a new chapter for the Museum.

This is the first major national science exhibition to visit Worcester in the 200-year history of the EcoTarium. As the inaugural exhibition in the Museum’s new Stoddard Exhibition Hall, the “Secret World of Elephants” is projected to bring over 100,000 visitors from across New England to experience the lives and conservation of Asian and African elephant species.

“EcoTarium visitors, both adults and children, will love this awe-inspiring exhibit and the chance to learn about these intelligent and beautiful creatures,” said EcoTarium President and CEO Noreen Smith. “The EcoTarium is proud to be the only Museum in the region to host this new science exhibition developed by the American Museum of Natural History in New York City.”

The Secret World of Elephants is a world-class exhibition that explores the remarkable lives, abilities, and history of the world’s largest land mammals. Through immersive storytelling and cutting-edge research, the exhibition reveals new scientific insights into how elephants think, communicate, and shape entire ecosystems while also highlighting the urgent challenges they face today.

On view for a limited time from March 7 through Sept. 7.

A special Opening Day celebration will be held on Saturday, March 7 at 11 a.m. with ticket reservations encouraged.

The exhibition features life-size models, including a scientifically-accurate woolly mammoth alongside touchable teeth casts, multimedia experiences, and interactive displays that highlight elephants’ extraordinary senses and behaviors. Visitors will discover how elephants hear through vibrations in their feet, and use the 16 muscles in their trunks. Learn about how elephants form and maintain complex social bonds in the herd. Exhibit highlights include:

A life-size African elephant model with internal anatomy projection showing feeding, digestion, and the nearly two-year gestation period.

Hands-on stations exploring infrasound communication, ear-flapping thermoregulation, and how elephants engineer their habitats.

A woolly mammoth model shedding its winter coat, along with dwarf elephant reconstructions and touchable teeth casts.

Interactive stations on elephant intelligence, vocalizations, family structure, and social behavior.

Conservation exhibits examining climate impacts, human-elephant coexistence, and the global ivory crisis, plus a documentary about Reteti, a community-run elephant sanctuary in Kenya.

The exhibit also explores the long relationship between elephants and humans—from their roles in war and work to their presence in religion and cultural symbolism. Notable objects on display include Vietnamese puppets of the legendary Trung sisters and a large figure of the Hindu god Ganesh.

EDITORIAL

The quiet importance of public safety
Most days in Webster, Dudley, Oxford and Auburn pass without incident. Children board school buses. Commuters head to work. Seniors gather at local centers. Shops open their doors.

It is easy to take that normalcy for granted. Behind it stands a network of public safety professionals and volunteers whose work is often unseen. Police officers patrol neighborhoods in the early morning hours. Firefighters train repeatedly on equipment and response protocols that, ideally, they will not have to use. Dispatchers answer calls that range from routine to life altering.

When something goes wrong, these departments are expected to respond immediately and flawlessly.

Public safety rarely draws sustained attention unless there is a crisis. Budget discussions about cruisers, apparatus, training and staffing can seem technical or routine. Yet those line items represent preparedness. They represent the difference between reaction and readiness.

In small towns, public safety is not abstract. Residents know the officers who coach youth sports or attend community events. They recognize firefighters who also work full-time jobs and answer calls at all hours. They see emergency vehicles parked at the grocery store or at a school function.

That familiarity fosters trust, but it also places pressure on departments to maintain high standards with limited resources.

Across Massachusetts, public safety agencies are confronting familiar challenges: recruitment and retention, evolving training requirements, mental health calls, and rising equipment costs. Volunteer and call firefighter models, common in smaller communities, depend on residents willing to balance family, employment and emergency response.

That model works because people step forward.

There is also a broader conversation about public safety that deserves thoughtful attention. Communities expect professionalism, accountability and transparency. Those expectations are appropriate. At the same time, the scope of calls for service has expanded. Police officers and firefighters are often the first to respond not only to fires or crimes, but to medical emergencies, mental health crises and social service needs.

That expanded role requires support. It requires adequate training, updated equipment and ongoing evaluation of how services are delivered. It also requires community understanding that public safety work is complex and, at times, unpredictable.

In Webster and its neighboring towns, residents regularly demonstrate appreciation for their first responders. Open houses at fire stations draw families. School visits introduce children to safety protocols in ways that build comfort rather than fear. Fundraisers and community events often highlight the connection between departments and the neighborhoods they serve.

Those connections matter. Public safety is not solely about response times or statistics. It is about relationships. When residents feel comfortable approaching an officer with a concern, or confident that a fire department will arrive prepared, it strengthens the fabric of the community.

As municipal budgets are discussed and priorities weighed, public safety will remain a central line item. It should be examined carefully, as all spending should. But it should also be viewed through the lens of preparedness and prevention.

The absence of major headlines is often a sign that systems are working.

In towns like Webster, Dudley, Oxford and Auburn, the quiet consistency of public safety professionals allows daily life to unfold with confidence. That quiet work, though rarely celebrated at length, is foundational to everything else a community hopes to build.

The sound of a real conversation

The other morning, I found myself at a local diner, the kind of place where the coffee arrives before you've fully settled into the booth. The waitress called everyone "hon," and nobody seemed to mind. The grill hissed, forks clinked against plates, and someone near the window was explaining, in great detail, how to fix a snowblower carburetor.

It was a symphony of ordinary life.

At the table behind me sat a father and his teenage daughter. He had the newspaper folded in quarters. She had her phone propped against the sugar dispenser, eyes fixed on the screen, thumbs moving at a speed that suggested great urgency.

The father tried.

"So, big game Friday?" he asked.

"Mmm-hmm," she said, not looking up.

"You starting?"

"Probably."

He sipped his coffee. Cleared his throat. "That's good."

I felt for him. I've been on both sides of that exchange over the years. I've been the distracted one, and I've been the one hoping for a few more words than "probably."

After a moment, the waitress came by and refilled their cups. She looked at the girl and said, "You playing shortstop again? You made that great throw last week."

The girl's head came up. "You saw that?"

"Of course I did. Whole place was talking about it."

And just like that, the phone went face down on the table.

For the next five minutes, the girl described the play in full color. The slow roller. The scoop. The throw to first. Her father leaned in, smiling in a way that made him look ten years younger. The waitress nodded like she was reviewing game tape.

What changed? Not the setting. Not the menu. Just attention.

There is something powerful about being noticed. Not in the loud, public way that comes with likes and shares and digital applause, but in the quiet, steady way that says: I saw you. I remember. It mattered.

In small-town Massachusetts, we still have the advantage of proximity. Our towns are not so large that we disappear entirely into anonymity. The librarian may know what you read last summer. The clerk at Town Hall may recognize your signature. The barber may remember how you like the back trimmed.

These details are not accidents. They are

the result of paying attention.

And attention, these days, feels like a scarce resource.

I understand the pull of the phone. It offers news from around the globe, weather updates down to the minute, photos from family miles away. I am grateful for that. I like knowing my daughter made it home safely. I like being able to check in with my son without waiting for the long-distance

rates to drop after 9 p.m., as we once did. But I sometimes wonder whether we are trading depth for volume. We hear from more people than ever before, yet speak less to the ones sitting across from us.

I remember when conversation had a certain rhythm. You asked a question, and you waited. You listened long enough to hear not only the answer but the tone behind it. If someone paused, you didn't rush to fill the silence. Silence had a purpose. It let thoughts settle.

Now, silence seems to make us nervous. We reach for a device at the first lull, as if quiet were something to be avoided.

My mother, God bless her, had a way of making you feel like the only person in the room. When she asked how you were, she meant it. You could not slip by with a quick "fine." She would tilt her head slightly and wait. That small gesture told you she had time for your answer.

Time is another thing that feels squeezed thin.

Yet I suspect we have more control over it than we admit. We may not be able to slow the news cycle or quiet the endless stream of notifications. But we can choose, in a diner or a market or on a walk down Main Street, to look up.

The father and daughter at the diner left a little while later. As they stood to go, he put his hand briefly on her shoulder. She was talking animatedly now, phone forgotten in her jacket pocket. They stepped out into the cold morning together, still mid-conversation.

The diner returned to its usual soundtrack: dishes, laughter, the scrape of chairs. Nothing dramatic had happened. No speeches were made. No lessons announced.

Just a girl who felt seen. A father who got more than one-word answers. A waitress who took the time to remember a throw from last week.

Sometimes, the sound of a real conversation is the most hopeful thing you can hear.

Financial considerations when changing jobs

Are you changing jobs soon? If so, you'll obviously be interested in your new salary — but you'll also want to look at other financial considerations.

Here are some of the most important ones:

401(k) — If you had a 401(k) plan through your previous employer, you'll need to decide what to do with it once you've joined a new employer. You could just cash it out, but you'd pay taxes and possible penalties. You could leave your 401(k) with your previous employer, if allowed, and if you have been happy with your plan's performance. Or you could move your 401(k) into your new employer's plan, which might be a good choice if the new plan has lower fees and attractive investment options. You'd also want to ask whether the new employer offers matching contributions. Finally, you could roll over your old 401(k) into a traditional IRA, which would give you more investment choices.

HSA/FSA — If your new employer offers a health savings account (HSA) as part of a high-deductible health plan, you may want to take advantage of it. Your contributions are made with pre-tax dollars, your earnings generally grow tax deferred and your withdrawals are tax free, as long as they're used for qualified medical expenses. Plus, you can carry unused funds through retirement, when you can still use them for qualified medical expenses. Your employer might also offer a flexible spending account (FSA), which can pay for a variety of health care costs, such as deductibles, co-payments and co-insurance. Generally, if you're contributing to an HSA, you can't fund an FSA in the same year, except for a limited purpose FSA.

Waiting period for health benefits — You'll want to ask your new employer if there's a waiting eligibility period to enroll in its benefits plan — health insurance, dental, vision, and so on. If so, you may need to get COBRA coverage for a few months to stay in your old plan, unless you can be added to a spouse's plan. When you go on your new employer's health care plan, make sure you know what it covers. Depending on your situation, you might want to add supplemental health insurance.

Life insurance — When you leave a job, your employer-sponsored life insurance will end, unless you have the option to convert your group term life policy into an individual permanent cash value policy. So, you'll want to be sure your new employer offers at least the same insurance coverage as your old one. But you should also determine whether the group policy offered by your employer is sufficient for your needs. Depending on several factors, such as your income, spouse's income and family size, you may need to supplement your employer's policy with an individual term life insurance policy.

Other benefits — Review your new employer's benefits package carefully to see what's available. Many employers offer tuition reimbursement for their employees, and some even provide college planning assistance for employees' children. For example, your employer might offer matching contributions to a tax-advantaged 529 education saving plan, which can be used for college, some K-12 expenses and some trade/vocational school programs.

Changing jobs can provide you with an opportunity to expand your career, learn new skills and broaden your social network. And it can certainly be financially rewarding, too — so make sure you know all the benefits involved.

QCC's legislative breakfast shows powerful impact of supporting higher education

WORCESTER — Quinsigamond Community College recently energized the campus with a legislative breakfast that brought together state and community leaders from across the region to spotlight how public investment opens doors for students. The real showstoppers were the students themselves, earning standing ovations as they shared powerful stories of perseverance, ambition, and the success they're already achieving.

The event focused on major statewide initiatives shaping the future of Massachusetts higher education including

the free community college model (MassEducate and MassReconnect), the proposed BRIGHT Act, equitable pay for community college faculty and staff, and the SUCCESS Program, which provides wraparound support to underserved students.

Massachusetts Lt. Gov. Kim Driscoll highlighted how these initiatives are vital to our education system, which positions the Commonwealth as a leader in areas such as healthcare, education and innovation.

"Education is our state's competitive advantage. People from across the world come to our institutions of higher education

because they know they are on the cutting edge of innovation and research. It's why we've proposed major investments to modernize our college campuses and why we have prioritized making higher education more affordable, including making community colleges like Quinsigamond free for all," said Driscoll.

Rep. Jim McGovern spoke on the difficulties that educational institutions currently face, such as threats to Pell Grants and Federal Work-Study, and praised QCC for its community impact.

"The opportunities and services that Quinsigamond provides have made our

local economy strong, and none of us in elected office take that for granted. Access to education makes this society better," McGovern said.

QCC student Fakhria Azimi spoke at the breakfast about how grateful she was to receive assistance to attend college and rebuild her life after her world was turned upside down. Azimi is from Afghanistan and was attending college and running a business with her sister when the Taliban took over. She was no longer allowed to work or go to school, so she came to the U.S. to pursue a life with more freedom.

"Without MassReconnect, continuing my education would have been extremely difficult, if not impossible. I could improve my English, gain confidence and truly believe in myself again," said Azimi, who still works two jobs while attending college. "My goal is to complete my education and rebuild the business I once lost. I want to become a positive, educated and supportive member of the community here."

The free community college programs MassReconnect and MassEducate have helped to bring QCC's enrollment to its highest in over a decade. QCC President Dr. Luis Pedraja noted that getting students enrolled is

the first step, but increasing support services, improving faculty and staff compensation, and updating infrastructure are needed to get students to graduation.

"It's important to remember that community colleges serve half of the undergraduate population in the Commonwealth. These are the people who are going to work here and make their homes here. We need to invest more in community colleges," Pedraja said.

Throughout the breakfast, QCC officials emphasized that the state's educational initiatives are reshaping pathways to higher education and helping students from all backgrounds succeed. More than 1,750 students who received free community college funds have graduated since 2023, and students in the SUCCESS Program are being retained at higher rates than their peers.

One such student is Jazlyn Alas, a nursing major who told attendees that the relationship with her SUCCESS advisor has helped her persist towards her goal of making a difference in people's lives through healthcare.

"College is more than just attending classes. It's not easy managing school, work and being a mom, but it's not impossible," Alas said.

From laundry room to RN

BAY PATH ALUMNA REACHES NEW HEIGHTS IN NURSING CAREER

BRIMFIELD — In the world of healthcare, there are those who study the field, and then there are those who live it from the ground up. Carleen Berthiaume, RN, a 2019 graduate of the Bay Path Practical Nursing Academy, has officially reached a major milestone in her decade-long climb, successfully passing the NCLEX-RN (take one!) and obtaining her Registered Nurse license this February 2026.

For Berthiaume, the path to "RN" was paved with grit, determination, and a deep-seated commitment to service. Her journey began nearly 18 years ago in 2008, when she first entered the healthcare environment not in a clinical role, but in housekeeping and laundry.

A legacy of excellence at Bay Path Practical Nursing Academy

Long before her transition to Registered Nurse, Berthiaume established herself as a standout leader within the Bay Path Practical Nursing Academy Class of 2019. Her time at the Academy was defined by a relentless drive for both academic and clinical mastery.

During her tenure at Bay Path, Berthiaume was:

- A decorated scholar: Inducted into the National Technical Honor Society and selected as a recipient of the prestigious Horatio Alger Scholarship.

- A competitive champion: She proved her clinical mettle under pressure, earning Silver Medals as both a District and State Champion in the SkillsUSA First Aid/CPR competitions.

- A specialized practitioner: Even as a student, she sought advanced training, earning certifications in Infusion Therapy/Central Line Care, Mental Health First Aid, and participating in SafeTALK suicide alertness training.



Her commitment to the "holistic nurse" model was evidenced by her nomination for the Clinical Excellence Award and her receipt of the Community Service Award.

A heart for the community

Berthiaume's impact at Bay Path extended far beyond the classroom. As an officer of the UNICEF Club, she championed global causes, but her local volunteerism was equally staggering. From the Charlton Senior Center BP Clinic to the Medical Reserve Corps (MRC), Berthiaume was a constant presence at community health events. Her volunteer portfolio included the Paxton Health Fair, FAFSA Day, Safety Fairs, and multiple educational fairs for Mass EdCo and Bay Path RVTHS.

The long climb

Berthiaume's career is a masterclass in professional evolution. After working as a Certified Nursing Assistant (CNA) starting in 2012, she sought to deepen her clinical knowledge by enrolling in Bay Path Practical Nursing Academy. Following her graduation in 2019, she began her career as an LPN at Quaboag Rehabilitation just as the global COVID-19 pandemic began—a "trial by fire" that solidified her resilience.

In 2022, she transitioned to the medical-surgical floor at UMass Memorial Harrington Hospital. There, she became a trained preceptor and resource/charge

nurse, specializing in advanced skills like ultrasound-guided IV insertion.

Determined to learn
In December 2025, Berthiaume completed the accelerated LPN-to-RN Bridge program at Quinsigamond Community College.

"It's been a long climb to be where I am, and I've learned so much along the way," Berthiaume reflected. Quoting Zig Ziglar, she added, "If you are not willing to learn, no one can help you. If you are determined to learn, no one can stop you. I'm determined."

A humbling mission

With her new RN credentials, Berthiaume has accepted a high-stakes Float Pool position at Harrington, cross-training in the Emergency Room and the ICU. Despite her advanced skills, she remains grounded in the philosophy of service.

"The best way to find yourself is to lose yourself in the service of others," she said, quoting Gandhi. "It's a humbling field that I'm proud to be a part of."

Berthiaume is already looking toward the next horizon, with plans to enter a BSN program within the year. For the faculty, staff, and alumni at Bay Path Practical Nursing Academy, her story is a powerful reminder that with a foundation in practical nursing and a heart for service, there is no limit to how high a nurse can climb.
