Saint Joseph School students embark on memorable Washington, D.C. journey

WEBSTER — During April Vacation week, students in Grades 7 and 8 from Saint Joseph School embarked on an enriching and faith-filled trip to Washington, D.C., combining history, culture, and fellowship into a truly unforgettable experience.

The group gathered in the early morning hours on Monday, April 20, meeting at the school at

4:30 a.m. before departing by coach at 5 a.m. for the nation's capital. Upon arrival, students immediately immersed themselves in American history with a visit to Arlington National Cemetery, where they observed the solemn Tomb of the Unknown Soldier and the Changing of the Guard. The day continued with visits to iconic memorials, includ-

ing the Lincoln Memorial, Vietnam Veterans Memorial, and Korean War Veterans Memorial.

Tuesday offered a meaningful blend of civic and spiritual experiences. Students toured the grounds of the United States Capitol and visited the magnificent Basilica of the National Shrine of the Immaculate Conception. A highlight

of the trip was Mass at the Saint John Paul II National Shrine, where Headmaster Fr. Richard Polek served as a concelebrant. Following Mass, students were warmly greeted by Sister Veritas Green of the Sisters of Our Lady of Mercy, who presented each student with a Divine Mercy prayer card featuring the image revealed to Saint Faustina Kowalska. She then spent time speaking with the students about the message and significance of Divine Mercy, offering a meaningful moment of reflection.

The afternoon

included a visit to the National Museum of African American History and Culture, along with photo stops at the White House and the Washington Monument. Students concluded the day by visiting additional memorials honoring Dr. Martin Luther King, Jr., Franklin D. Roosevelt, and Thomas Jefferson.

Wednesday's itinerary continued to bring history to life. Students visited Ford's Theatre, gaining insight into the life and legacy of President Abraham Lincoln. The group then traveled to Virginia to explore the

Lydia Burke then recited an original patriotic poem written by the seventh-grade class, titled "Where I'm From," celebrating the history, values, and pride of being American. The program continued with a flower presentation led by Graceanne Troiano, during which students presented red, white, and blue flow-

Dudley fifth graders grow plants for community

DUDLEY — The fifth graders at Dudley Middle School recently participated in a project called From Our Hands to Your Hearts. recipients wrote thank you notes, others sent emails through family members, and one wonderful recipient crocheted more than 40 mini thank you baskets that she filled with candy for the fifth graders. It has been amazing to see how such a small act of kindness has had a ripple effect throughout the community.

Four fifth graders were also able to present the project to the Dudley-Charlton School Committee on April 8. The fifth grade team looks forward to continuing and expanding this project in the future to show just how important the older members in the community are to the town of Dudley.

With many single mothers struggling to afford basic necessities, this initiative seeks to collect diapers, clothing, hygiene products and other items to ensure mothers and children have a safe and healthy start.

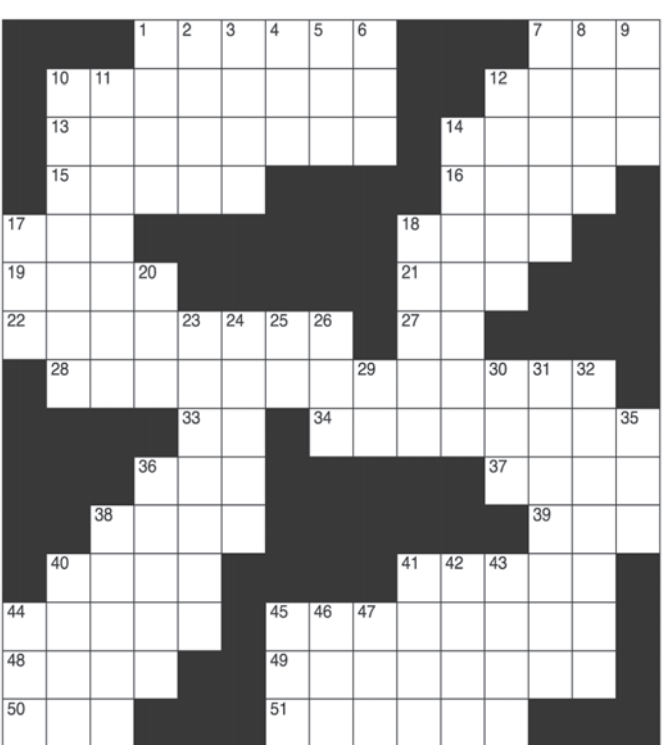
Community members are invited to drop off new and unopened items at the church office, from Tuesday to Friday, from 9:30 a.m. to 1 p.m., or Sunday morning before 1 p.m. The drive is specifically focusing on collecting high-need items, including: Crib sheets, diapers, clothes (newborn to 12 months) including sets, baby bassinets, baby securi-

ty blankets, unscented baby wipes, baby grooming kits, Dreft detergent, feeding (formula: unopened, non-expired, bottles, nipples, bibs, and burp cloths), hygiene (diaper rash cream, baby wash, lotion, and shampoo), Mom Care Packages (nursing pads, nipple cream, toiletries [shampoo, conditioner, lip balm], and body lotion).

All donations will benefit the Visitation House in Worcester. Visitation House offers a program in Worcester County which provides women with unplanned pregnancies a path to cherish and sustain the life of their babies. They provide each woman a welcoming home and opportunities to develop the skills, confidence, and self-knowledge necessary to create a beautiful future for her and her baby. The House opened its doors on May 31,

2005. Since that time, they have welcomed over 300 women and their children.

EDITORIAL

A lesson in loyalty, a moment of unity

There are moments in a school year that go beyond academics, beyond schedules and routines, and remind us what education is truly about. The recent Loyalty Day celebration at All Saints Academy was one of those moments.

In a time when the word “community” can sometimes feel abstract, this event made it tangible. Students, veterans, educators, and local residents gathered not for a lesson in a textbook, but for something far more lasting: a shared understanding of service, sacrifice, and gratitude.

Loyalty Day itself is a national observance, but its meaning comes alive only when it is brought into local spaces like this one. At All Saints Academy, that meaning was not simply explained, it was lived. From the opening prayer to the final blessing, each part of the ceremony reflected a careful intention to honor those who have served while helping young people understand why that service matters.

What stands out most is not any single moment, but the way the entire program was shaped around participation. Students were not passive observers. They led the Pledge of Allegiance. They shared poetry rooted in their own voices. They created and presented flowers, each color tied to a deeper value: courage, purity, trust. These are not small gestures. They are formative experiences that teach lessons no worksheet ever could.

For the veterans in attendance, the event was clearly meaningful. But for the students, it may prove even more significant over time. When young people are given the opportunity to look directly at those who have served and hear their stories, the idea of service becomes real. It gains weight. It becomes something to respect, and perhaps one day, something to emulate in their own way.

Equally important is the tone of unity that carried through the day. In a world that often feels divided, especially in conversations about patriotism and national identity, this event struck a different chord. It focused not on differences, but on shared values. Freedom. Responsibility. Respect. These are ideals that can bring people together when they are approached with sincerity and care.

Schools play a unique role in shaping how the next generation understands those values. Events like this remind us that education is not only about preparing students for careers, but about preparing them for citizenship. That means fostering awareness, encouraging reflection, and creating opportunities for meaningful connection with the broader community.

It is also worth noting the role of tradition. Loyalty Day may not receive the same attention as other holidays, but its quiet presence offers something important. It invites reflection without spectacle. It asks for gratitude without expectation. In many ways, it is exactly the kind of observance that fits naturally into a school setting, where learning and reflection go hand in hand.

The success of this event speaks to the dedication of the educators and organizers who made it possible. It also reflects a broader truth about our local communities: when schools open their doors and invite others in, something powerful happens. Generations connect. Stories are shared. Values are passed on.

At its core, the Loyalty Day celebration at All Saints Academy was a reminder that respect for service is not something that should be reserved for a single day. It is something that can, and should, be woven into the fabric of everyday life.

If there is a takeaway here, it is a simple one. Moments like this matter. They shape how young people see the world and their place in it. And in doing so, they help ensure that the values we hold dear are not only remembered, but carried forward.

In the end, that may be the most meaningful form of loyalty of all.

The quiet way our mothers shape us

There's a certain quiet to a Sunday morning in May that feels different from the rest of the year. Maybe it's the way the light comes in softer, or the way people seem to move a little slower, a little more thoughtfully. Or maybe it's just that we all know what the day is, even before we say it out loud.

Mother's Day has a way of doing that. It doesn't need much announcement. It settles in gently, like a familiar song you haven't heard in a while but still remember every word to.

I was thinking the other day about how we tend to mark time in our lives. We remember the big things, of course, the graduations, the weddings, the first jobs. But when you really sit with it, it's often the smaller, quieter moments that come back the clearest. And more often than not, there's a mother somewhere in the middle of those memories.

Not always in the foreground, mind you. Sometimes she's just off to the side, making sure everything is running the way it should. Packing lunches, folding laundry, reminding someone about an appointment, or standing in a doorway watching the whole thing unfold.

It's funny how much of that work goes unnoticed at the time. Not unappreciated, exactly, just... assumed. Like the sun coming up in the morning. You don't always stop to think about it because it's always been there.

I can remember, years ago, coming home after a long day, the kind where nothing seems to go quite right. You're tired, maybe a little irritated with the world, and not particularly good company. And there she is, asking how your day went, as if she's got all the time in the world to listen to the answer.

And she means it. That's the part that sticks with you.

There's a steadiness to mothers that's hard to put into words. Not all of them are the same, of course. Some are quiet, some are talkative, some are firm, some are gentle. But there's usually a thread that runs through all of them, a kind of quiet determination to make things better for the people they care about.

You don't always see it when you're young. In fact, I'd say most of us miss it entirely at the time. We're too busy growing up, figuring things out, making our own mistakes. It's only later, when life has had a chance to knock a few corners off us, that we start to understand what was really going on.

I've come to believe that a lot of what we carry with us into adulthood, the good habits, the sense of right and wrong, the way we treat other people, has roots that go back to those early days. To kitchens and living rooms and car rides where lessons were taught without ever feeling like lessons.

And if you're lucky, those roots hold firm. Mother's Day, for all the cards and flowers and phone calls, isn't really about any of that, at least not entirely. Those things are nice, and they matter, but they're more like symbols than anything else. What the day really does is give us a reason to pause.

To notice. To think about the people who shaped us in ways we didn't always recognize at the time. To pick up the phone if we can. To say thank you, even if it feels a little overdue.

And for those who can't make that call anymore, it's a day to remember. To sit with those memories and let them come as they are, sometimes warm, sometimes a little bittersweet.

I don't think there's a right way to spend the day. Some folks gather with big family dinners, full tables and loud conversations. Others keep it quiet, maybe a visit, maybe a walk, maybe just a moment to themselves.

But however it's spent, there's something steady about it. Something that reminds us that no matter how much the world changes, some things remain constant.

The care. The patience. The way someone showed up, day after day, whether we noticed or not.

You don't need a grand gesture to recognize that. Sometimes it's enough just to stop, look around, and understand, maybe a little better than we did before, what was given to us along the way.

And if you happen to find yourself on Main Street this weekend, passing by the shops and the familiar faces, you might notice something else too. A few more people carrying flowers. A few more smiles exchanged. A few more quiet moments tucked into an otherwise ordinary day.

That's Mother's Day, I suppose. Not loud, not showy. Just present, the way it's always been.

And if you ask me, that feels about right.

Academic con game?

To the Editor:

In case you missed it, there was what might be described as an Educational Miracle right here in the Commonwealth of Massachusetts.

In 2025, “Boston’s four-year graduation rate was the highest in the district’s history,” according to city officials. Boston’s High School graduation rates increased by 1.6 percent over 2024, and 400 more graduated in 2025 than in 2024. The graduation rate for 2025 was up to 81.3 percent.

How did this happen, you might ask? Did some new pedagogical revolution take place? Did massive funding fall from the sky in 2025 resulting in a sudden surge in academic achievement?

According to Boston Mayor Wu in the Boston Globe, “We didn’t get here by lowering any expectations for students who might be experiencing challenges or moving the goal posts and making it easier for people to get by.”

Didn’t move the goal post, Mayor Wu? How about you tilted the field, removed the goal posts and turned the scoreboard off?

What Boston did was ban teachers from giving failing grades. “... instead requiring them to hand out ‘incomplete’ marks, allowing students to recover the grades later in often softer settings, such as through online courses.” Then, of course, Massachusetts in 2024 removed the requirement for high

school students to pass state tests in order to receive a diploma, saying it was a “barrier to graduation.”

Gee, what was a kiddo to do? It required an almost Herculean effort to fail at the district level, and now there was no state requirement. By virtue of just hanging around, one was pretty much guaranteed a diploma.

Before anyone thinks that the Boston model is the way to go consider that several Boston test scores actually fell. Public records state that, “Low-income students saw math scores decline by 5 percent between 2017 and 2025, yet that group’s graduation rate rose by 12 percent in that same time period. Meanwhile, English language learners saw a 9 percent decline in reading scores and a 13 percent decline in math achievement, even as their graduation rate soared by 21 percent.”

Yes, miracles may well have occurred for individual students, but system wide this looks like an academic con game if ever there was one. The victims are the students and their parents who have been tricked into thinking their diplomas are the real thing.

Don’t Massachusetts students deserve better?

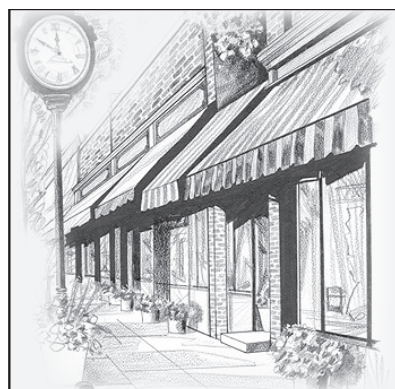

Steven F. Udvar-Hazy Center, part of the Smithsonian Institution. This stop proved to be a favorite among students, many of whom enthusiastically participated in flight simulators and explored historic aircraft. Another highlight was the National Museum of the United States Army, where hands-on STEM activities engaged students in interactive learning. The day concluded with visits to the Pentagon Memorial and the John F. Kennedy Center for the Performing Arts.

While visiting the Kennedy Center's terrace, students were treated to a breathtaking sunset overlooking the city. With sweeping views of Washington, D.C. as their backdrop, students captured memorable photos, taking in the beauty of the nation's capital in a truly special moment of reflection and joy.

On the final day, students visited The People's House—an interactive museum experience focused on the White House—where many enjoyed stepping inside a full-scale replica of the Oval Office.
