School Committee hears debate on mascot

NORTH BROOKFIELD – Continuing their deliberation over whether to retire the junior-senior high school's "Indian" nickname, School Committee members recently heard from residents and Native American leaders during a public hearing.

Among several other speakers at the Nov. 16 meeting, a panel of Native American leaders addressed the controversial topic remotely. School Committee members were eager to hear from a broad spectrum of presenters to help fully illuminate the Native American nickname controversy from all angles.

Many panel members have spent years educating school leaders and communities on why the use of Native American mascots offends tribes and their families. Panel members have led multiple outreach and education efforts throughout New England.

"The fact that racist ideas about native peoples in Massachusetts are deeply engrained and are reflected in sports teams' mascots should not have to be explained in 2020," said Melissa Ferretti, a member of the Herring Pond Wampanoag Tribe.

Ferretti said her family has dealt with racism throughout her life. Other presenters, including Faries Gray, have also struggled with the effects of racism. Each time they see a high school, college, or pro-

fessional sports franchise use Native American names and images as mascots, it only serves to reinforce racial stereotypes, presenters said.

"Some people think we should be honored, or they are honoring us. We are not honored – you are not honoring us. That is no way to honor a person, to use them as a mascot. We use animals and fictional characters as mascots, not human beings," said Gray, a sagamore (chief) representing the Ponkapoag Tribe. "We are not a trophy – we are a living, breathing people with feelings. There is no other race that has to deal with this – it's insane that we even have to have this conversation."

Presenters also decried the lack of educational opportunities and dialogue in public schools focusing on Native American history and culture. Sophia Hasenfus, who graduated from North Brookfield High School in 1999, wishes the current conversation had begun decades earlier.

"I have deep regrets about not bringing up the mascot issue back when I was in high school," said Hasenfus, who represents the traditional unceded territory of the Wampanoag Nation. "I know that people worry that now is not the time because the country is too divisive, but it's my hope that we can see that now is exactly the right time. Mascots like these perpetuate negative stereotypes

EBES adjusting well to hybrid learning approach



EAST BROOKFIELD – If parents and teachers had been quizzed about hybrid learning models this time last year, many would have found themselves stumped. One chaotic year later, however, and the entire school community is well-versed on the combination of in-person and remote learning.

With every pothole and sharp curve presenting itself along the road through the COVID-19 pandemic, the East Brookfield Elementary School community has stepped up to navigate the challenge. After classes were called off last March and didn't return until September, teachers, administrators, and district leaders spent the summer implementing state guidance and readying their building.

Now, with the first month of hybrid learning in the books for the full EBES student body, everyone is adjusting to the new normal. The school year began with students in grades

4-6 operating on a fully remote schedule, but they were welcomed back to school in mid-October.

"To see my students skipping into the room on that first day and saying hello to their friends in person after seven months of not being in the classroom was priceless," said EBES sixth grade teacher Christine Lavin.

District leaders have been impressed by the cooperation and willingness of students, staff, and parents to make the adjustments necessary to keep schools open. Relying heavily on masks, social distancing, and extensive sanitation procedures, the Spencer-East Brookfield Regional School District has not seen a single COVID-19 case among students and staff.

Teachers have also put in several hours of extra work each week to support both their in-person and remote learners. With many families in all schools opting for the

fully remote format this year, teachers have been committed to ensuring that those students don't fall behind.

"I am teaching live to my remote students and students in the classroom via Zoom," Lavin added. "The kids never complain about wearing their masks. They seem to have all taken it in stride."

Students and parents certainly miss the days when homework, quizzes, and tests were the most stressful aspects of school. Now, in addition to their focus on academics, the overarching commitment for the entire school community is safety.

"They are extremely conscientious about following all of the social distancing rules and basic rules such as using hand sanitizer or washing down their desks multiple times a day," Lavin said of her students. "I

West Brookfield cancels White Christmas event

WEST BROOKFIELD – Joining a long list of local events lost to the COVID-19 crisis this year, the White Christmas in West Brookfield celebration has been canceled.

Event organizers made the announcement several months ago, but they want to remind residents and families who were still instinctively gearing up for the program. The beloved town tradition brings together the entire community for a day of celebration – rain or shine – but the town center will not bustle with holiday merriment in 2020.

For many families who mark the event on their calendars each year, the cancellation of White Christmas came as a great disappointment, especially after the loss of the Asparagus Festival in May and other town favorites throughout the year. Still, most residents have since expressed their understanding and support for the volunteers who make the event possible.

Usually occurring on the first Sunday in December, the daylong White Christmas celebration typically draws guests from throughout the area. Local businesses, municipal offices, town departments, and churches also take part each year. But with the many challenges of 2020, organizers did

not want to risk the potential for COVID-19 transmission in an event that features mostly indoor activities.

"We understand the disappointment; however, when you factor in all of the planning and businesses and activities that go on during the event, we could not in good conscience carry it out," event organizers wrote on social media. "For the safety of the community and our volunteer committee, we feel this is the best decision. We hope that those of you who value this event so much will join the committee when we meet again next year."

The organizing committee has found a few alternate ways to celebrate the season. The White Christmas Committee recently announced that it will sponsor a Christmas decorating contest. All residents looking to register their homes for the contest must do so by December 6.

All voting for the contest will be done online. For more information about the event, or if you would like to register your home, please complete the form available on the White Christmas in West Brookfield Facebook page.

MIAA announces winter sports safety measures

REGION – Local student-athletes are looking forward to the return of winter sports, but they'll have to deal with several new safety measures.

Last week, the Massachusetts Interscholastic Athletic Association (MIAA) made multiple announcements following a meeting of its COVID-19 task force. After extensive deliberations, task force members presented an array of modifications and recommendations for winter sports to the MIAA board of directors.

Prior to making modifications, task force members collaborated with officials from the state's Executive Office of Energy and Environmental Affairs, as well as the Department of Elementary and Secondary Education.

"It is great to see that so many of our student-athletes will be able to take part in the sports they love this winter," said MIAA President Jeff Granatino. "Many coaches, athletic directors, principals, and superintendents worked hard over the past few weeks to ensure that we would be able to offer interscholastic opportunities for our students."

The MIAA board of directors voted to approve several sport-specific modifications for the winter season. All modifications are subject to changes from state leaders, depending on the severity of COVID-19 conditions as the winter progresses.

Locally, the decision for individual schools on whether to participate in MIAA-recognized winter sports will be determined by district officials and health leaders.

Currently, the high school winter sports season is set to begin on Dec. 14. Coaches, athletes, and parents are asked to review all sport-specific modifications prior to involvement. Also, be sure that your sport is still listed in the 2020-21 winter sports lineup, as several

sports were moved to the "Fall Sports II" season and the spring season.

"The pandemic has reshaped the way education is delivered across the country, and the same can be said about its impact on athletics," Granatino added. "Nonetheless, I am confident our student-athletes and coaches will adjust to the new expectations this winter and have an experience as fulfilling and as exciting as what we saw during the fall season."

Basketball and ice hockey athletes will see some of the most drastic changes to their sports. Masks must be worn throughout the game, and players must utilize social distancing during pregame and postgame activities.

Additionally, access to locker rooms and other venues will be tightly restricted.

For MIAA leaders, it was a challenge to create modifications that strike a balance between maximizing safety while maintaining the basic aspects of gameplay within each sport. Considering the close-contact nature of basketball, hockey, and other winter sports, it is impossible to facilitate social distancing on the playing surface. This means health measures in all other facets of the game must be ramped up, officials said.

MIAA leaders thank all contributors who came together to provide sport-specific guidance, health information, and recommendations.

"Promoting the health and safety of all participants is the association's imperative," said MIAA Executive Director Bill Gaine. "Our membership should be proud that our board's actions reflect allegiance to the MIAA mission."

Wrestling, indoor track, winter cheerleading, and dance have all been moved to other sporting seasons. Indoor track will take place during the newly created "Fall Sports II" season, which will begin later in the winter. This season will also include sports like football that were

postponed from the fall.

Wrestling, winter cheerleading, and dance were moved to the spring season.

For students and coaches who are gearing up for Fall Sports II, it will be a culture shock to prepare for football and other sports in the wintertime. Teams have been limited this fall in terms of practice availability and off-season preparation.

"We couldn't do everything that we normally do in practice, but we got some football stuff in," said Chris Barry, an assistant coach with the Leicester High School football squad. "Ultimately, it gave our team a purpose a few nights a week and allowed us to start building our team for Fall II."

LHS anticipates its football squad to feature about 60 players this year, an impressive feat considering the many challenges athletes are facing. Players can't wait for the projected Feb. 22 start date for Fall Sports II, but social distancing regulations will make it difficult to stay in game form this winter.

"We have been told we can work out and lift together, but our weight room is too small to properly social-distance with so many players and coaches," Barry said. "We typically have 25-35 players attend our lifting sessions in the off-season, but this just won't work under all the rules and restrictions."

LHS coaches have used an online platform to send players workouts they can complete at home, without any weights. Coaches and athletes are using similar systems in surrounding communities, with everyone hopeful that all sports seasons can be completed.

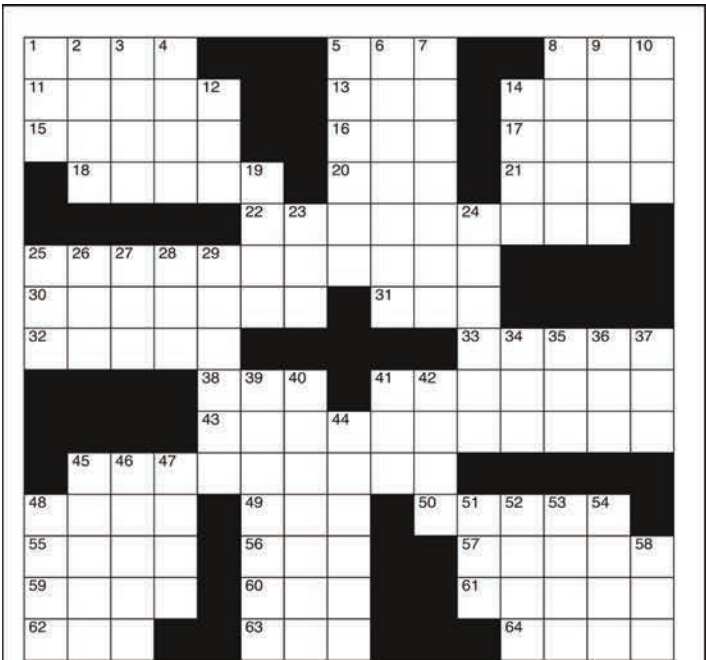

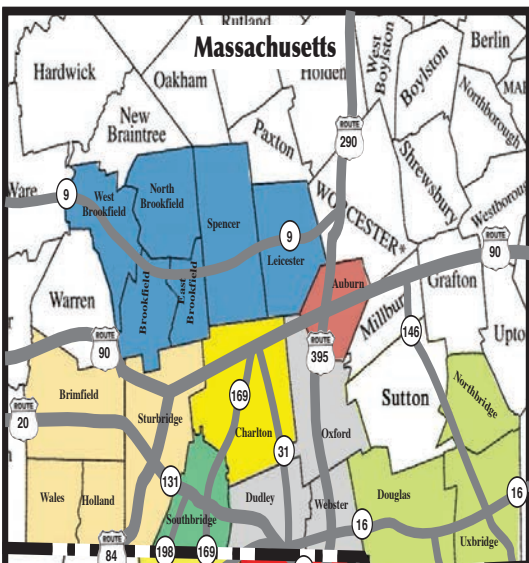

Public forum planned on North Brookfield’s West Side Infrastructure Plan

NORTH BROOKFIELD — The Town of North Brookfield will hold a public forum for the Town’s ongoing West Side Infrastructure Plan project on Tuesday, Dec. 15 at 6 p.m. at the North Brookfield Police Station, 55 School St. Socially distanced seating will be available. The forum will be broadcast live by North Brookfield Cable Access TV and video will be streamed on the North Brookfield Local Public Access Cable Youtube Channel. All documentation will be available on the town’s Web site, www.northbrookfield.net. Neighborhood residents and other interested parties are encouraged to attend or otherwise participate.

At the forum, the Town’s engineering consultant will discuss the initial results of its extensive field survey of drainage systems, water and sewer mains, roads, and sidewalks in the West Side Neighborhood. This neigh-

borhood is defined as the area bound by Spring Street, High Street, Mount Pleasant Street, North Main Street, and part of Bell Street near the town center. The overall goals of the project are 1) to evaluate existing infrastructure systems in the project area; 2) to develop concepts for improvement projects in key areas; and 3) to produce a final plan with prioritized and phased recommendations for implementation, for use in local planning and in seeking additional grant funds for detailed design and construction.

This part of North Brookfield is currently served by water, sewer and stormwater drainage systems dating to the early and middle 1900s. Water mains in parts of the neighborhood are undersized or made from hard-to-maintain materials. Some sewer lines are prone to clogs or suffer from infiltration or inflow. Stormwater infrastructure

is lacking in parts of the neighborhood and, where present, is not always adequate for today’s intense storms. Aside from aging subsurface infrastructure, surface elements such as roads, sidewalks and crosswalks in the area are generally older and are mostly not handicapped-friendly.

At the forum, residents and other stakeholders will have a chance to voice their concerns about infrastructure in the project area and will be able to review and comment on the engineers’ field evaluation work to date. The Town of North Brookfield invites residents who have knowledge of neighborhood infrastructure issues like flood-prone roadways, deteriorated sidewalks, or low water pressure to bring their local knowledge to the forum or to submit comments by email.

Lenard Engineering’s engineering team is the Town’s consultant for this

project. The project is funded through a FY 2019 Community Development Block Grant to North Brookfield from the Massachusetts Department of Housing and Community Development. This grant is administered on behalf of the town by the Central Massachusetts Regional Planning Commission (CMRPC). Holiday antique and auction news

Many holiday related stories have been featured in recent antique and auction news reports. Several Christmas related antiques recently brought strong prices at auction, according to the Antiques and Arts Weekly. A "red-robed Santa sitting in the gondola under a wicker dirigible with propellers on the side and holding his bag of toys" sold for \$7,800 at auction in November. "Santa in red robe riding a white fur nodding reindeer with orange decorative harness" went for \$13,200. "Santa riding a clockwork nodding donkey" with "a feather tree in one hand and the donkey outfitted in a vibrant harness" reached \$15,600. "Santa on nodding polar bear, 29 inches high with composition feet, hands and head with a mohair beard, the bear covered in rabbit fur" brought \$36,600. Antiques

and the Arts reported that the Santa and polar bear seller is a member of the Golden Glow of Christmas Past Collectors group (goldenglow.org). A "German composition Santa on sleigh behind six reindeer, all on a wheeled platform measuring 35 inches long" sold for well above the \$1,500 estimate, according to the same Antiques and the Arts Weekly article. The auctioneer believed that two factors which contributed to strong bidding on this piece were

that there were six reindeer, instead of the typical four, and that the reindeer were in different positions, instead of staring straight ahead as is typical. The antique Santa and reindeer toy sold for \$72,000 to a buyer in the United states.

A 46-year-old Army vet and his wife made an important discovery in a drawer of their newly purchased home in South Carolina, according to Fox Business. Fox Business writes that "the two cases (they found) contained 64 coins in total, including 46 gold \$5 liberty coins and 18 Morgan silver dollars. The Liberty \$5 coins were minted between 1849 and 1907, while the Morgan silver dollar was coined between 1878 and 1904." The estimated value of the coins is \$25,000. Exemplifying the holiday spirit, the couple immediately returned them to the elderly couple who had

Managing your
retirement plan
under a new
employer

Your employer-sponsored retirement plan is a valuable asset. But sometimes things happen that can affect the status of your plan. So, for example, if you work for a hospital that changes ownership, and you have been participating in a 403(b), 457(b) or 401(k) retirement plan, what should you do with it now?

Basically, you have four options:

Cash out your plan. You can simply cash out your plan and take the money, but you'll have to pay taxes on it, and possibly penalties as well. So, unless you really need the funds and you have no other alternative, you may want to avoid liquidating your account.

Roll your account into your new employer's plan. If it's allowed, you can roll over your old 403(b), 457(b) or 401(k) plan into your new employer's plan. Before making this move, you'll want to look at the new plan's investment options (which should be numerous) and fees (which should be low). If you move the money directly to the new plan, you won't be taxed at the time of the transfer, and your funds can continue to grow tax-deferred.

Leave your plan with your old employer. If your account balance is above a certain level, you may be able to leave your plan with your old employer's plan administrator. You won't be able to contribute any more money to the plan, but if you like the investment options you've chosen, keeping the money in your old plan might be a viable choice.

Move your account into a traditional IRA. One possible advantage to moving your 403(b), 457(b) or 401(k) into a traditional IRA is you'll open up a world of new investment options, because you can fund your IRA with virtually any type of vehicle, including stocks, bonds, mutual funds, certificates of deposit (CDs) and exchange-traded funds. And if you already have a traditional IRA, you can combine the new funds with the old ones, making it easier to track your holdings. As is the case with leaving your money in your old employer's plan or transferring it to a new plan, you'll continue to benefit from tax-deferred growth. Keep in mind, though, that IRAs have costs, too, possibly including transaction costs to buy or sell new investments. (One more thing to keep in mind: When you want to move a retirement plan to an IRA, you may want to make a direct rollover, so the old plan's administrator moves the money directly into the IRA, allowing you to avoid immediate taxes. If you were to make an indirect rollover, you'd get the money yourself, but your old employer would have to deduct 20 percent for federal taxes, and you'd have to deposit the entire balance, including the withholding, into your IRA within 60 days.)

Which of these choices is best for you? There's no one "right" answer for everyone. You'll want to consider all the options and possibly consult with your tax advisor and financial professional. But do all you can to protect your retirement plan – you've worked hard to build it, and you'll need to rely on it to help you pay for your years as a retiree.

masks as well as structured schools. The kids then go home at night and spread it to their respective families who then spread it elsewhere in the community.

Departing from my initial thought to High School teachers of "you reap what you sow" it seems that the best thing for our community at this point would be to have 100 percent of K-6 in-person 5 days/wk so that parents can work, the kids can learn, and we can limit community spread from informal childcare. Grades 7-12 should be 100% remote because they actually can get and spread COVID, they are better suited to remote learning, and they don't require childcare. We can then use our school buildings to appropriately space out the K-6 students. Knox Trail can use the entire building for 5th & 6th. Grades 3 and 4 can use Prouty. As for staffing all of these half-filled classrooms, how many furloughed teacher's aids do we have? Lunch ladies? Front office staff? Why can't we use these other staff members as teachers' aids?

We have seen disturbing statements of national values during this pandemic. of indigenous peoples and reduce entire cultures into a generic symbol. Hasenfus said there were never any educational conversations about negative stereotypes or Native American history while she was in school. She and the other presenters believe the process of change is long overdue, and they thanked the school community for being receptive to the discussion.

"We understand that some people are attached to their mascots because it's part of their memory, but this has to stop," Gray said.

Added Shawna Newcomb, a Mashpee Wampanoag Tribe member who teaches at Hanover Middle School, "Native Americans have a higher suicide rate than any other race in this country. Native American males, in high school, have an eight times higher suicide rate than any other [racial category]. I'm not saying that mascots are the reason for that, but it certainly does not help

Supporters of the current nickname and logo have frequently mentioned the costs associated with adopting a new mascot. The new name and logo would need to be applied throughout the building, as well as on equipment and apparel. Multiple residents and alumni members have submitted written comments to the School Committee supporting both sides of the controversy.

nations, and much of that comes from the fact that constitutionally we require the states to pick up the baton. While federalism has served us well, it led us to 51 separate pandemic responses (50 states plus the federal government which controls all territories).

While the current situation is unprecedented in our lifetimes, it is not unprecedented in the history of the United States. Thomas Jefferson once wrote at length of the dangers of disease in cities, going so far as to call for the reorganization of American cities to lower disease risk. George and Martha Washington spent the summers of 1793 and 1794 in away from the capital to avoid yellow fever outbreaks. Eight of the 13 original colonies adopted laws imposing harsh penalties, including death without clergy, on people who violated quarantines. The founders clearly were very concerned about pandemics. Congress even passed a “quarantine and health law act” in 1799.

Regulating health falls under the government’s “police power.” It is quite curious that those modern “patriots” who seem to fall over themselves with

love and support for law enforcement quite often advocate for violating pandemic related lawful orders. Under the American constitutional system, general police power resides with the states. Alexander Hamilton referred to the “domestic police of a state” in the Federalist papers in the context of “administration of the general government.” In *Gibbons v. Ogden* in 1824, the Supreme Court upheld police power, and the power to enforce quarantines, as residual power predating the Constitution that has been retained by the states.

Even after the 14th Amendment established the concept of individual rights against states, the Supreme Court continued to uphold state laws relating to epidemics. In 1905, the court upheld 7-2 Massachusetts’ mandatory smallpox vaccination program because states “may be justified in restricting individual liberty....under the pressure of great dangers.” The court further argued that mandatory immunization was not “arbitrary or oppressive” because “all civilized peoples” recognized the importance of vaccinations in eradicating disease.

The last time the United States faced a threat even remotely similar to COVID-19 was the 1918-1920 influenza pandem-

ic. There were several state level court cases affirming the states’ authority to control the pandemic through draconian means however few were appealed to the Supreme Court. The court cut its sessions short during the pandemic perhaps as both a “stop the spread” campaign as well as indirectly allowing the states sovereignty over pandemic related issues.

The question of the day, however, is what if a state’s pandemic response appears to violate a different, addressed, area of the constitution. This week religious organizations challenged New York Gov. Cuomo’s restriction on religious gatherings to 10 people in “red zones.”

We are now seeing the mark of Donald Trump and Mitch McConnell’s giant gambles with the court. In a 5-4 decision, with all three of President Trump’s nominees (Amy Coney Barrett included) in the majority, the court struck down New York’s restriction on religious services as violating the 1st amendment’s “free exercise” clause. Justice Gorsuch wrote at length about the dangers of treating religious institutions more harshly than secular ones with comparisons to liquor stores, outdoor parks, stores, etc. The Supreme Court’s action was to vacate all restric-

tions on religious gatherings.

Upon deeper examination, Gov. Cuomo actually was less restrictive to religious institutions than secular ones. In the red zones secular mass gatherings were outright banned whereas houses of worship were allowed 10 people. Places such as parks and stores are fundamentally different because they are transitory and not gatherings.

The McConnell court has taken us to a dangerous place. The obvious answer for governors is to issue no special orders for religious institutions and restrict them as they would all gatherings, all in-person meetings, theaters, sporting events, etc. This will functionally shut down religious gatherings until the pandemic is under control. Once that happens, religious leaders are likely to challenge the broad and general pandemic mitigation measures and either the governors win and we have a rubric for shutting down religious gatherings or the court vacates 244 years of precedent and declares that the United States, unlike other civilized people, is prohibited from managing infectious disease.

path"... "...leftists will bear responsibility for whatever transpires..." "... true Americans will not be herded into totalitarian railroad cars..." I know I'm dense, but that sounds like a call to arms to overthrow our duly elected government – the one that earned 80 million votes as opposed to the 75 million who won't accept that.

If Mr. McRae thinks my left-wing views and talking points are easily rebutted, then I invite him to do so.

Mr. Reed mentioned that Republicans did well nationally; except for the Presidential election which Joe Biden won. He is correct – Republicans picked up seats in the House, gained state-level offices, and will likely hold onto the Senate. Where he is incorrect is that there was no theft – Joe Biden won. This is going to be a case-study for decades if not centuries of how NOT to manage a pandemic. As it turns out shaming only serves to push socialization underground.

The pandemic is accelerating nationwide. We have more people hospitalized with COVID than at any time since the start of the pandemic. Hospitals are becoming overrun and care is being rationed on a localized basis essentially through tornado alley right now (West Texas to North Dakota) with the highest cases per capita in the world being North Dakota, highest deaths South Dakota, and El Paso, Texas and Tulsa, OK are literally out of room in the hospitals, erecting tents in parking lots, and are rationing care. North Dakota is allowing COVID positive staff to work in hospitals because they have no choice. More cities will be in the same boat by next week. The fictitious "death panels" used to scaremonger support away from the ACA in 2010 are a reality in the middle of the country, Trumpland.

To the people who have long said, "just protect the vulnerable" – that isn't possible. How do you think COVID ever got into nursing homes? The vulnerable interact with a lot of staff, the staff got it in the community, and the staff brought it into the facilities. The only way to "protect the vulnerable" is to prevent it from running rampant in the community. In Minnesota they literally have the National Guard staffing nursing homes right now because too many employees are out with COVID. As great of a short term solution the National Guard

staffing nursing homes is, camouflage fatigues don't prevent them from getting COVID themselves.

It has been 10 months and this is not sustainable. Epidemiologists do not actually recommend open ended lockdowns as a primary pandemic management strategy. They recommend short, sharp, and severe lockdowns to cause a rapid "reset" of the virus prevalence in the community and then re-opening. The U.S. never had the stomach for the "sharp and severe" part so instead it dragged out until now and is being ignored by many. Imagine how nice it must be for New Zealand – their Army enforced absolute lockdown ended in May and they are back to normal except for international travel.

Shaming and stigmatizing was never going to work – we needed (and still need) a short, sharp, and severe lockdown that is not voluntary to put this back in the bottle. Allowing ordinary people who clearly don't understand how pandemics work make decisions for themselves is causing us all to lose. Most people are unable to understand likelihoods, they want the world to be black and white – i.e.: Either I'll die from this or I won't.

The world watched the U.S. ahead of Thanksgiving with dread, disbelief, and bewilderment.

Joseph Stalin is reputed to have said,

"the death of one person is a tragedy; the death of one million is a statistic." Mother Teresa once said, "If I look at the mass, I will never act." It is sad, but it is well documented that the human mind reduces compassion and sympathy as the number of victims increases, likely as a defense mechanism against being overwhelmed by emotion. For some reason lesser tragedies have concerned Americans more than the COVID disaster and it seems as the death toll keeps ticking up people care less and less.

By the time you read this, there will likely have been 13,000 people who have died from COVID in America since I wrote this for a grand total of 275,000 and accelerating. We used to care about 55,000 people dying in Vietnam. We used to care about 3,000 people dying on 9/11. We used to care about 4 people dying in Benghazi. Now we have 275,000, increasing by more and more each week and it's old news/boring? In 2020 the US will see nearly 400,000 more deaths than we would see in a normal year and half the country doesn't care? Think of how many grieving family members, friends, colleagues...
