### Saint Joseph School students experience the beauty of music and language

The presentation, titled "The Memory and Glory of God in Nature," celebrated faith, music, and the beauty of God's creation—an experience the students thoroughly enjoyed and will long remember.

WEBSTER On Wednesday, Oct. 1, students from the PreK 3-year-old program through Grade 8 at Saint Joseph School were treated to a truly inspiring musical presentation titled "The Memory and Glory of God in Nature." The program was performed by Fr. Prof. Zbigniew Stępniak, Ph.D. Hab. and Maria Helena Czarnecka-Cieślak, M.A., two exceptionally talented musicians whose artistry brought together faith, music, and language in a way that captivated every

listener.

and conductor, is a graduate of the Institute of Church Musicology at the Catholic University of Lublin and currently serves as organist at Saint Joseph Basilica in Webster. Fr. Stępniak, a professor at the University of Warmia and Mazury, is a classically trained bass and musicologist who has performed in numerous countries and in over a dozen languages. Together, they offered a program that celebrated both the universality of music and the glory of God reflected through His creation.

The concert opened

Latin—a gentle and prayerful beginning that invited students to listen closely and reflect. As the program continued, students were encouraged to guess the language in which each piece was sung. This interactive format delighted the children, who eagerly raised their hands to identify languages such as German, French, Polish, Russian, and English.

Among the featured works were Beethoven's "Die Ehre Gottes aus der Natur" ("The Glory of God in Nature"), which set the tone for the concert's spiritual theme, and Franz a musicologist, organist, "Ave Maria" performed in Schubert's "Ständchen"

("Serenade"), a romantic German art song that filled the room with warmth and lyric beauty. Fr. Stępniak also performed Riccardo Cocciante's "Ave Maria Païen" from Notre Dame de Paris, Andrew Lloyd Webber's "Memory" from Cats, and Jerry Bock's "If I Were a Rich Man" from Fiddler on the Roof-demonstrating an impressive vocal range and expressive depth.

The concert concluded with a moving encore Schubert's

Maria," again sung in Latin, leaving students and staff alike in quiet awe.

Beyond its artistic merit, the presentation served as a valuable learning experience. Exposure to various languages through song helps children develop cultural awareness, listening skills, and an appreciation for the diversity of human expression. ### Dudley voters reject proposal to re-name board of selectmen

DUDLEY -While many communities in the Commonwealth embraced the modern shift to more gender-neutral labels for their executive boards, Dudley will remain with a Board of Selectmen after rejecting a proposal to change the name to "Select Board" at the fall special

town meeting on Oct. 20.

The article sparked brief debate over the potential change including cost and the value of tradition. The item was brought to the voters to allow Dudley to address an issue that has gained national attention with other local towns like Charlton and Sturbridge making the change to Select Boards in recent years and even the statewide Massachusetts Selectmen

Association changing its name to the Massachusetts Select Board Association in 2020. Dudley voters, however, chose overwhelmingly to maintain the historical label of the executive board.

While the conversation was brief, the exchange was, at times, heated. Resident John Briare kicked off the debate, noting many women have served the town of Dudley, including leading

### Atkins, Smith power Bartlett past Narragansett

Sophomore standout Jaesean Atkins did a little bit of everything last Friday night, scoring twice on the ground and picking off three passes as Bartlett held off a furious Narragansett rally to earn a 34-31 victory on Senior Night at Memorial Athletic Field.

The win improves the Indians to 6–2 and punched their ticket to the postseason, while the Warriors fall to 5-3.

Bartlett built a commanding 34–7 halftime lead, powered by its ground game. Lawrence Smith opened the scoring with a 7-yard touchdown run before Atkins followed with a 1-yard plunge and a spectacular 53-yard burst to make it 20-7 after one quarter.

Xavier Butler added a three-yard touchdown run in the second quarter, which

run by Atkins, and Smith later connected with Kenny Arpin on a conversion pass after his 34-yard touchdown run, giving Bartlett a fourscore advantage at the break.

Narragansett refused to quit, storming back behind touchdown runs from Jordan Baumann, Tazerian Tigs, and Mason MacDonald, trimming the deficit to just three points in the fourth quarter.

But as the Warriors threatened late, Atkins sealed the win with his third interception of the night, halting Narragansett's comeback bid.

Atkins finished with 278 rushing yards on 22 carries and eight tackles on defense, while Smith added 96 yards and two touchdowns on the ground. Butler and Arpin each contributed key plays

in short-yardage and defen-

sive situations. Defensively, Luigi Villegas and Kenny Arpin each tallied over seven total tackles, while Aiden Turner and Xavier Butler helped limit Narragansett's rushing attack early.

Bartlett totaled 417 rushing yards as a team, continuing its identity as one of Central Massachusetts' most physical rushing units.

The Indians will travel to #3 West Boylston Friday, November 7th for the MIAA Division 8 First Round matchup as they look to extend their postseason run.



### new program to help older adults remain safely at home DUDLEY - Tri-Valley, Inc., a local Aging Service Access Point,

announced the launch of the Older Adult Home Modification Program (OAHMP), funded through a new grant from the U.S. Department of Housing and Urban Development (HUD). This initiative is specifically designed to help adults age 62 and older make necessary modifications and improvements that enable them to age in place safely, whether they own or rent, by increasing the functionality of their homes.

Tri-Valley launches

"Through this program, older adults will have their homes assessed by licensed occupational therapists and have approved work completed by licensed contractors," said Joe Vaudreuil, program manager. "There is no cost for the OT assessment or for projects completed within HUD guidelines."

Examples of eligible modifications and accessibility devices include:

Grab bars and interior/exterior railings and handrails. Ground-graded, modular metal ramps.

Bathroom modifications such as tub cuts, installing handheld showerheads and grab bars, and providing shower chairs and raised

Repairing safety hazards like uneven floor transitions and stair treads/balusters.

Improving lighting and installing other accessibility devices around

OAHMP is not intended for major structural renovations like kitchen or bathroom remodels, new staircase risers, or wired electrical work. All modifications must meet programmatic and budgetary

OAHMP is open to residents who meet the following criteria:

Age 62 and older.

Meet income guidelines.

Reside in the home or apartment being modified (rent or own). Must live within Tri-Valley's 25-town service area.

passion over confrontation: "Not every battle in nursing is meant to be fought with words. Some are won through silence, grace, and steadfast professionalism... Because in the end, nursing is not just about clinical skill or knowledge

it is about the heart." She encouraged future nurses to embody this spirit: "We are not defined by how others treat us, but by how we continue to care, especially when it's hardest. Choose empathy. Choose growth. Keep moving for-

ward." Dr. Bolandrina expressed deep gratitude for her twelve years, calling Bay Path "a place where ordinary people became nurses and perseverance bloomed into purpose.'

New adventures await

While her chapter at the Academy closes, Dr. Bolandrina looks forward to exciting new adventures. She plans to spend time with her grandson, Tidus, visit her son Chef Gino's Worcester restaurant, KuruKuru Ramen, and tend to her extensive tropical and rare plant collection (@Gretheline\_ plants).

"Dr. Bolandrina's impact on the Academy and the nursing community will endure," said a PN faculty member. "Her leadership, kindness, and dedication leave a lasting legacy. The momentum she helped build will carry forward in every graduate who serves the community and the greater good. The best is yet to come."

### Correction

DUDLEY — The Webster Times would like to print the following correction and clarification to our story "Dudley Town Meeting approves borrowing for waterline" in our Oct. 31 issue.

In the article, it was stated that "the town and local company Gentex have agreed to share the blame" for the PFAS contamination in the Eagle Drive neighborhood and that in regard to the water line project approved at the fall town meeting in October "the two entities have agreed to split the remaining cost evenly with each party paying an estimated \$8.22 million toward the project." These statements are incorrect, and have been clarified by the Town Manager's office. We would like to apologize for any misunderstanding or confusion that may have occurred from

this oversight. The State DEP has named the town and Gentex as "potential responsible parties" so there is no agreement to "share blame," but instead actually an agreement is to cost share the mitigation. There is also no agreement at this time to share the cost of the water line project. The town would not have been able to negotiate an agreement with Gentex until town meeting approved borrowing for the waterline, which it now has.



### DA hosts event highlighting holistic approaches to recovery



WORCESTER — On Oct. 23, Worcester County District Attorney Joseph D. Early, Jr. welcomed community members, including recovery advocates, health and wellness professionals, and law enforcement personnel to Veterans Inc. in Shrewsbury for a half-day event organized by the Prevention and Support Network. This event focused on supporting individuals and families affected by substance use disorders (SUD) through holistic, mind-body approaches to recovery.

Keynote speaker Linda Geraghty, a trauma-informed yoga instructor and family recovery specialist featured in the award-winning documentary Our American Family, spoke about the deep connection between trauma and substance use. Drawing from both professional expertise and her own experience, she emphasized how recovery requires attention to one's entire system body, mind, and family – not just the symptoms of addiction.

"Addiction is relentless. We often try to hide it while our families get sicker. Engaging in open conversations is crucial to truly understanding this disease, and that understanding is vital for the family's healing,"

said Linda Geraghty.

Geraghty highlighted the ways in which stress and trauma can live in the body, and how practices like yoga, breathwork, and mindfulness can help release those patterns, restore regulation, and rebuild trust in oneself and others. Geraghty underscored the importance of supporting families, emphasizing that addiction affects loved ones as profoundly as those experiencing it firsthand, and that breaking generational cycles of trauma and addiction begins with compassion, communication, and consistent support. Her work integrates trauma-informed principles to help families navigate recovery with understanding, boundaries, and resilience - key themes that resonated with many in attendance.

A panel of local wellness professionals expanded on these ideas, offering practical insights into how holistic methods can complement traditional treatment and recovery path-

Panelists included Kellie Hamilton, founder of A Better Path to Wellness; Phil George, clinical biochemist; Jacqueline Monteiro, wellness practitioner and recovery coach; Anthony Bizzotto, president

and co-founder of Revive of the U.S.A., Inc.; and Heidi Moody, personal trainer and L3 CrossFit coach. Each spoke about the ways nutrition, movement, mindfulness, and community engagement contribute to sustainable recovery and overall wellbeing.

Throughout the attendees also took part in guided mindfulness exercises and movement breaks, offering moments to practice the very mind-body techniques discussed during the program. These activities encouraged participants to experience firsthand how mindfulness and movement can support focus, stress relief, and emotional bal-

District Attorney Early commended the speakers and attendees for their shared commitment to exploring new, compassionate approaches to supporting recovery throughout Worcester County. He noted that addressing addiction requires collaboration across every part of the community - treatment and health care providers, families, schools, clergy, law enforcement, and local organizations - working together to reduce stigma and create lasting change.

### Bay Path students receive InvenTeam grant to create technological solution to real-world problem



CHARLTON -Path Regional Vocational Technical High School (BPRVTHS) was recently awarded a Lemelson-MIT InvenTeam® grant in the amount of \$7,500 to create an invention geared towards helping people that are wheelchair-bound. This invention will allow them to visit areas that are otherwise inaccessible. BPRVTHS is one of only eight high schools nationwide to be selected as an InvenTeam this year. The BPRVTHS InvenTeam is inventing a solution to the inefficiency, compromised safety, and lack of comfort present in wheelchairs used to access sandy beaches. Through our invention, we seek to improve the beach-going experience, promote accessibility and independence for wheelchair-bound people with an efficient, safe, and comfortable wheelchair design. Kristine Wade, science teacher, at BPRVTHS initiated the InvenTeam application process during the summer and worked with the students to prepare the final proposal. A respected panel of university professors, inventors, entrepreneurs, industry professionals, and college students including former InvenTeam members now working in industry selected the grantees.

Over the next eight months, our BPRVTHS InvenTeam will develop a solution to the problem. Our team will build a working prototype that will be showcased at a technical review here locally in February, and then again as a final prototype during EurekaFest®, an invention celebration taking place in June.

"The InvenTeams initiative has been a grand MIT experiment and proven that all youth can invent when given the opportunity," says Leigh Estabrooks, Lemelson-MIT's Invention Education Officer. "Our 22 years of working with high school teams in their communities shows the extraordinary power of invention education. Teams will work extremely hard throughout this entire school year becoming experts in their self-selected problems as well as the technological solutions. It's an honor to work with such empathetic young people who care about making our lives safer, healthier, and more accessible."

The InvenTeams grants initiative has enabled 214 students to be awarded U.S. patents for their high school inventions. Hundreds more students have patent pending designations for their inventions. Intellectual property education is combined with our invention education offerings as part of the Lemelson-MIT Program's deliberate efforts to remedy historic inequities among those who develop inventions, protect their intellectual property, and commercialize their creations.

The ongoing efforts empower students from all backgrounds, equipping them with invaluable problem-solving skills that will serve them well throughout their academic journeys, professional pursuits, and personal lives. The program has worked with over 4,000 students across 312 InvenTeams nationwide and

### **EDITORIAL**

### A town's quiet salute to servic

Every November, when the mornings turn sharp and the last of the maples fade to bronze, our towns slow their rhythm. Veterans Day comes without fireworks or fanfare, asking something quieter from us remembrance. It's a day that invites reflection more than celebration, gratitude more than glory.

Here in Webster, Dudley, and Oxford, that reflection takes on a deeply local shape. These communities have sent generations of sons and daughters to battlefields around the world — from the trenches of France to the mountains of Afghanistan. Some came home to start families and businesses; others rest now beneath small flags that flutter in our cemeteries each November. Their names appear on plaques at town halls and granite memorials along our greens, but their real legacy is carried in the everyday freedom they defended.

Veterans Day reminds us that freedom is not a static thing. It is built and maintained by the steady courage of ordinary people who chose to serve. The sailor on the destroyer deck, the nurse tending to the wounded, the soldier standing watch in the rain — each gave a measure of their life so that ours could unfold in peace.

It is easy to say "thank you for your service," but harder to live those words. True gratitude looks like funding veteran services in our budgets and supporting the Webster-Dudley Veterans Council as they assist families in need. It looks like businesses hiring veterans not out of sentiment but respect for their skills. It looks like students in local classrooms hearing veterans tell their stories firsthand, realizing that courage has a local

In every parade along Main Street, we see that history continues. The veterans who march are joined now by younger faces - men and women who served in Iraq, Afghanistan, and peacekeeping missions across the globe. They march beside the older generation, the ones who remember Korea and Vietnam, bound together by duty that transcends time or politics.

When the rifles fire their salute and the sound rolls over Lake Chargoggagoggmanchauggagoggchaubunagungamaugg, there's a stillness that says more than any speech could. It is the stillness of a town remembering its own — those who stood guard so we might live freely, argue freely, and dream

So this Veterans Day, as flags rise over the cemeteries and bells toll at town centers, let us answer that quiet call to remember. Let us make sure the promises made to our veterans are promises kept — in care, in opportunity, and in the simple human act of gratitude.

Because honoring their service isn't something we do once a year. It's the way we choose to live every day — as citizens of a country built by their sacrifice, and as neighbors determined to keep faith with those who gave so much for us all.

### A bridge to God

You can't find a sharper contrast. Two men, living side by side, and yet their hearts and destinies could not be more different. One is a rich man, clothed in purple and fine linen, living each day in comfort, luxury, and self-indulgence. At his gate lies a man, poor, covered in sores, hungry, forgotten. His name is Lazarus, the only character in all of Jesus' parables given a name, which means "God is my help."

Every day, the rich man lives his luxurious life, yet whenever he leaves his house he passes by Lazarus. Does he pretend not to see him? Does he ever feel a twinge of pity? Or has his heart been hardened and numbed by his wealth and comfort that he doesn't even notice the pathetic man outside his gate? In a worldly sense, society would envy the rich man and his lifestyle. Yet, from the perspective of eternity, Lazarus is the one who enters paradise, not the rich man. Why?

Jesus does not tell us that Lazarus went to heaven because he was poor, nor that the rich man went to hell because he was rich. Wealth and poverty are not moral categories; they are spiritual tests. Our comfort or discomfort are not moral barometers, but spiritual trials!

Lazarus' poverty and suffering became the context in which he met God. Elder Aimilianos of Simonopetra, one of the contemporary spiritual elders we are studying in our Wednesday night class, notes that suffering is but "a bridge that carries us from this earthly and mortal existence to God."

In contrast to the trial of suffering, the rich man's wealth and comfort is another form of test. In response to this trial, the rich man allows his prosperity to make him numb, creating a wall that isolates him from God, from compassion, and from the suffering brother right at his doorstep.


Elder Aimilianos goes on to explain: "For the person of faith, an illness or some other life challenge is not simply an opportunity or gift from God, but it is the very presence of God Himself. Illness and suffering can be a blessing, but it all depends on how we respond. The spiritual life is not the avoidance of suffering. but its joyful acceptance. The question is whether we will accept or reject our suffering, which is another way of saying whether we will accept or turn away from God."

Elder Aimlianos offers a beautiful story to highlight this situation. Fr. Arsenios was a monk in his monastery who had a problem with his eyes. One doctor told him he would need cataract surgery, but that he should not do it right away, but instead wait for the condition to progress in order for the surgery to be done properly. Fr. Arsenios waited. And then suddenly he lost his eyesight completely. He went to another doctor who told him that the first doctor made a mistake and that he should have gotten his surgery right away. Now, it was too late. The monk would remain blind for the rest of his life. Fr. Arsenios didn't get angry or complain. He didn't blame the first doctor for his misdiagnosis. Instead, he simply said, "May it be blessed. God knows what's best for me. It was God who "blinded" the first doctor when he made his mistaken diagnosis." And until the day that he died. Fr. Arsenios never complained and never said a word against the first doctor, nor were his thoughts troubled by his predicament.

"May it be blessed!" Fr. Arsenios allowed his unfortunate circumstance to act as a bridge to a deeper communion with God. He trusted in God's loving providence even to the point of becoming blind and believed that his situation was not something to complain about and live with regret, but it was an opportunity to draw closer to his Lord.

This must have been Lazarus' response to his desperate situation. In his poverty and suffering, he remembered his name, that "God is my help." He trusted in the Lord and didn't despair, nor did he didn't condemn his rich

But what about the rich man. His problem wasn't that he was wealthy but that his wealth numbed his spirit of love. His comfort dulled his spiritual senses. His luxurious lifestyle led



Elder Aimilianos warns us that "The greatest tragedy is life is not to suffer, but to live comfortably without ever meeting God. To suffer with faith is to see God face to face; to live without love is to be blind, even if you possess everything.'

The rich man's limitless feasting blinded him. His extreme comfort deceived him with its false illusion. Even after death, the rich man still treats Lazarus like a servant when he asks "Father Abraham, send Lazarus to bring me a drop of water." He doesn't repent; he doesn't love; he doesn't know himself. The loneliness of a closed heart on earth gave him a foretaste of the loneliness of a closed heart in Hell itself.

Every trial in life, whether an unexpected sickness or tragedy, poverty or suffering, grief or misfortune, as well as the testing of wealth and riches and comfort, can act as a bridge or a barrier to God according to Elder Aimilianos. When we accept suffering with faith and humility, it becomes the bridge that carries us into the arms of God. When we curse our suffering as a punishment from God, or question His sovereignty in the midst of our challenges, it becomes the wall that keeps us far from the

Lazarus' sores and suffering became his bridge. The rich man's banquets and feasts became his wall.

The same can be true for us. An unexpected illness, a financial struggle, a disappointment or even a tragedy are not meaningless accidents. Each one is an opportunity for us to draw closer to God. Elder Aimilianos emphasizes, "God hides Himself in the circumstances of our life, so that by accepting them, we may find Him."

The parable also reveals that heaven and hell are not future destinations but realities that we begin experiencing here through the choices we make and how we handle the trials and challenges of life. When our hearts harden toward others, we begin tasting the isolation of hell. When our hearts soften with love and compassion, we begin to experience the peace of heaven.

Lazarus lay right outside the rich man's gate, trusting and hoping in God. In his poverty he experienced God's Presence. The rich man, in all his luxury and comfort, became numb to the Presence of God right outside his doorstep.

that are around us. Maybe someone in our family is lonely or sick. Maybe a friend struggles with depression or anxiety. Maybe a neighbor, someone we pass by every day, faces financial challenges. Do we notice them and how will we respond to them?

The parable of the Rich Man and Lazarus is not a story about two men long ago but is a mirror held up to each of us. Every illness and any hardship we face can become a bridge toward God if we walk across it in faith. When suffering comes, let us not see it as God's absence but as His mysterious presence.

Yet also take care to remain vigilant in the midst of our comfort and prosperity. Don't allow our pleasant circumstances to numb us and blind us to the needs of others. The Lazarus outside our doorstep is Christ Himself. In the end, our salvation is not determined by what we have or what we lack but by how we respond to whatever our circumstances are as a means to draw closer to God.

"If you accept your suffering with faith," says Elder Aimilianos, "you will find that your illness, your weakness, your trial — it is the very hand of Christ, stretching out to lift you to Himself."

May we walk across that bridge, and find ourselves, like Lazarus, resting in the embrace of Abraham — in the eternal comfort and love

### Remember the Ladies: Genevieve V. Kusian

This series will look at the women who served our country and the town of Auburn.

Genevieve V. Kusian was born Aug. 26, 1916, in Worcester. Her parents were John Louis and Claire M. [Decatur] Kusian. Her father was born in Canterbury, Connecticut and worked for the New York, New Haven, & Hartford Railroad for over 30 years. Her mother was Valrie M. Decatur of Putnam, Connecticut.

Genevieve graduated from South High School in Worcester, then attended Becker Business College. Genevieve was listed in an article of patrons for a prom at N.E. Institute, N.E. School of Accounting Seniors party on May 28, 1837. In 1941 the Worcester city Directory listed her as a cashier at F. W. Woolworth Co. and living with her parents on Kingsbury St. in

According to her headstone application, Genevieve enlisted in the Navy Feb 12, 1945. She went to WAVE Recruits Training School in Bronx NY March 31, 1945. In Nov. 1945 she was at the US Navy Receiving Station at Fort McHenry in Baltimore MD. Her rank was RM1 which is a Radioman responsible for transmitting, receiving radio signals, processing all forms of telecommunication, aboard ships, aircraft and shore facilities. Duties could also include message systems for generalized broadcasts and unit specific messages, proper handling & destruction of classified material. along with periodic maintenance of equipment to include transmitters, receivers & antennas.

The Muster Rolls for that time also showed that Genevieve was Senior Officer Present a Shore many times. According to the Naval Military Regulations; the Senior Officer present, unless some other officer has been so designated by competent authority, the "senior officer present" is the senior line officer of The Navy on active duty, eligible for command at sea, who is present and in command of any part of the Department of the Navy in the locality or within an area prescribed by competent authority, except where personnel of both If the Navy and the Marine Corps are present on shore and the officer of the Marine Corps who is in command is senior to the senior line officer or the Navy. In such cases, the officer of the Marine Corps shall be the senior officer

In March of 1954 Genevieve was part of the military delegation that attended the coronation of Queen Elizabeth II. This was confirmed by the passenger list landing in New York coming back from Southampton England. In her 25 years in the Navy, Genevieve served at the Pentagon in Washington, England, and Hawaii. Genevieve was an instructor at Quonset Point R.I., Newport R.I, Norfolk VA, and Baltimore MD in the junior officer boot

It was unfortunate that two months after her discharge, on Nov. 14, 1970, at age 54, Genevieve died of cancer. She is buried in Hillside Cemetery with her parents.

### **Food security**

When the stock market crashed in 1929, it didn't just erase fortunes-it erased certainty. Factories went dark. Payrolls vanished. The hum of American industry fell to silence, replaced by the hollow echo of empty stomachs.

By 1933, unemployment had soared to nearly fifteen million—more than one in five workers. Families who once counted on a paycheck now counted pennies, or borrowed bread from neighbors who were just as poor.

In city after city, long lines snaked around corners, men in threadbare coats clutching tin cups and children holding out chipped bowls. Hunger had no party, no region, no mercy.

And then came the dust.

As if economic ruin weren't enough, the early 1930s brought a second catastrophe. The Great

Plains—once called the nation's bread-**POSITIVELY** basket-became SPEAKING a wasteland. Years of drought and **TOBY** over-farming tore MOORE the topsoil loose, and winds carried

> it east in storms so dense they turned day into

> By 1934, one hundred million acres of farmland lay barren. Crops withered. Livestock suffocated. Entire families packed what they could onto rattling trucks and fled west, their lives reduced to dust and mem-

But out of that dust, compassion took root.

Ordinary citizens—neighbors, church groups, and volunteers-refused to wait for government relief that was still tangled in red tape. In living rooms and church basements, they poured kettles of soup, handed out bread loaves, and opened their doors to strangers. These homegrown soup kitchens ran on donations, not directives.

In Detroit, Capuchin friars opened a humble kitchen that would serve thousands each day, surviving on faith and flour. Even Chicago's most unlikely philanthropist, Al Capone, set up a soup line—not out of sainthood, of course.

Across the nation, gymnasiums became dining halls, union halls became food depots, and women's auxiliaries became engines of mercy. The system was imperfect and chaotic, but it worked.

No one knows exactly how many Americans were starving, but by 1932, a quarter of all families had no wage earner at all. Hunger was not a number—it was a cold morning, an empty pot, a mother whispering to her child, "We'll find something tomorrow."

Out on the plains, where the dust blotted out the sun, the same story unfolded. Farm wives gathered wild berries. Neighbors shared seed and sugar. Churches turned barns into relief depots. At train stations, small-town committees left buckets of milk and bread for migrants heading west. And in California's orchards, locals organized food drives for the endless wave of families who had lost everything but their will to survive.

By the late 1930s, those collective acts of kindness-migrant relief kitchens, church pantries, and conservation efforts—had begun to turn the tide. Fields were reseeded. Families found work. The wind still blew, but hope had returned to the soil.

Things may change by the

time you read this, but as of now, the federal government shutdown has halted the Supplemental Nutrition Assistance Program known to most as food stamps or EBT. More than 42 million Americans rely on that card to buy groceries and feed their families. A judge has ordered the administration to make the payments, but delays mean refrigerators are empty.

Wherever you stand on the issue, I hope we can all agree that when the system pauses, the people must not.

Throughout our history, when hardship struckwhether in the breadlines of the Great Depression or the barren fields of the Dust Bowl—it wasn't bureaucracy that saved us. It was we, neighbors, who refused to look away. Church volunteers stirring soup at dawn. Farmers who shared seed they could barely spare. Americans have always

filled the gap with compassion and courage, long before any program or policy could.

That's the tradition we inherit. That's what makes this country strong.

So go to the store. Pick up some rice, beans, noodles, pasta sauce, peanut butter, honey, and bread-whatever lasts and nourishes. Drop it off at your local food pantry. Share this with your friends and encourage them to do the same.

Please don't wait for permission or for Washington to solve it. The United States is swimming in food; no one should go hungry.

America's greatness has never come from government checks-it has come from human hands, and from hearts that move.

That's the American way.

### Monarch Orchard celebrates grand opening

CHARLTON — It's been quite a few years now since the previous owners of Charlton Orchard sought to sell the property, resulting in a controversy that divided the town of Charlton. However, years after the dust settled, the orchard now officially has new life, but this time serving as a uniting force for the community. Like a butterfly emerging from its slow transformation in a cocoon, Charlton Orchard is now officially reborn as Monarch Orchard.

The venue held its official grand opening on Oct. 25, with new owners Alanna and Justin Tomer welcoming guests to a special celebration including music, vendors, games, and more. Speaking about his new business venture, Justin Tomer said he fell in love with the property from the start and eventually he and Alanna decided to take a chance and purchased the property to continue its legacy as an orchard producing numerous different kinds of produce.

"We've been just putting in as much work as we can to open it up and clear a lot more land and make it available for people to come in an enjoy," Justin Tomer said. "It's amazing to see the people and it gives you goosebumps. You see how happy everybody is, and it brings another life to the orchard. It feels like something that's been needed."

Alanna Tomer spoke about how special the grand opening was as she greeted guests during a ceremony which included appearances by elected officials from the state and Charlton's Select Board.

"It's been a long road to get here and a lot of hard work, but today we have so much to celebrate," said Alanna. "Monarch Orchards was once just a scribble on a piece of paper, an idea, a dream, and now we are here standing proudly on this land seeing it all come to life."

Before the Tomer's came along, the fate of Charlton Orchard proved divisive among the people of Charlton. Prior to 2020, the potential sale of the property for use as what would have been one of the largest cannabis growth sites in the country resulted in lawsuits and heated debates, although many simply wanted to see the property remain as an orchard.

This controversy was referenced by state and local lawmakers, who kept their statements vague enough to recall the struggle, but focused more on the positive and what the orchard has since become.

"We know in this community some years ago this might have been used for something else and that caused a bit of a stir to say the least," said State Rep. Paul Frost, whose territory includes part of Charlton, including Monarch Orchard. "To have this go back to what it was originally here for and have them nurture this land and make it a jewel of the community is a great endeavor."

Charlton Selectman Steven Koronis agreed noting that while he wasn't on the Select Board during the years of the controversy, he was keenly aware of how important preserving the property was to the townsfolk.

"There were so many people that were saying why can't someone buy up the orchard and keep it an orchard. That was the common thread. Regardless of which side of the argument you were on, everybody wanted that and this is proof that sometimes it takes just a matter of time before someone is brave enough to do it," said Koronis.

Now the future looks bright for Monarch Orchard. Even as the fall and winter months approach, the family is hard at work preparing for exciting springs and summers ahead in 2026 and beyond steeped in local tradition and a desire to preserve and build upon the small town, pick-your-own-food aesthetic that many loved about the orchard for so many years.

the Board of Selectmen, and argued the town has no reason to change the name.

"This is our history. This is a part of who we are. You're wasting my time, and I am tired of history and our forefathers being chipped away a little bit at a time," said Briere.

In a rebuttal to Briere's comments, Selectman Steven Sullivan argued that the change is simply just about a name, and he felt it was hypocritical to bring historical preservation into the discussion, especially

when America has made several changes to tradition, even to the Constitution itself, that benefitted women over the decades.

"It's a simple title change, that's all it is. If you go to Select Board, what's the big deal?" asked Sullivan.

Another element of the debate was the potential cost. Earlier in the discussion Selectman Kerry Cyganiewicz had indicated that any potential change would not cost Dudley money, however Town Clerk Lori Smith contradicted that as she asked citizens to vote against the change due to the expense.

'We have general code

that updates our bylaws. They have to go through all of them, they have to go through and change that word in every single bylaw that we have - They said it would be up to \$2,985 to do this, and I know we don't have money to waste right now. And to me this would be wasting it," said Smith.

While there were other citizens interested in being part of the debate, a request to move the question sent it to a vote after only minutes of discussion. The outcome has likely put a pause on any further consideration to change the Board of Selectmen name for the foreseeable future.

• The western comedy "Go West" opens on November 1. Silent film legend Buster Keaton stars as "Friendless" and Fatty Arbuckle appears in an uncredited role.

• Sixteen people lose their lives in a small village in Wales when a dam bursts on November 2. The burst comes after five days of heavy rains.

• The Victrola Talking Machine Company introduces its new electrically-recorded phonograph records on November 2. The records can be played on the Victor Orthophonic Victrola, which cost around \$95 in 1925, or the equivalent of nearly \$1,700 in 2025.

• The film "The Pleasure Garden" is released on November 3. The release marks the directorial debut of English filmmaker Alfred Hitchcock.

• Italian Socialist Tito Zaniboni is arrested in a room at the Dragoni Hotel on November 4. The hotel is located across the street from the Chigi Palace in Rome, and Zaniboni is accused of renting a room with the intent of shooting Italian Prime Minister Benito Mussolini, who was scheduled to deliver a speech from the palace balcony.

• The National Hockey League awards a franchise to Pittsburgh, Pennsylvania, on November 7. The club is named the Pirates, which is also the name of the city's baseball team. The franchise moved to Philadelphia for the 1930-31 season before ceasing operations at the end of that campaign.

• The divorce trial of socialite Leonard "Kip" Rhinelander and Alice Jones begins in White Plains, New York, on November 9. At the urging of his family, Rhinelander sought an annulment of the marriage upon finding out that Jones was biracial. An annulment was never granted, but the marriage ultimately ended in divorce, and neither Rhinelander or Jones even remarried.






